# 1.7. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was the mode and channel with the highest output power that was determined to be IEEE 802.11ac VHT80 mode (Combined Antenna Chain0 and Antenna Chain1).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be IEEE 802.11ac VHT80 mode (Combined Antenna Chain0 and Antenna Chain1).

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/50Hz, recorded worst case.

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

# 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure 789033 D02 General UNII Test Procedures New Rules and KDB 662911 D01 Multiple Transmitter Output v02r01 is required to be used for this kind of FCC 15.407

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.407 under the FCC Rules Part 15 Subpart E.

#### 2.3. General Test Procedures

#### 2.3.1 Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.



## 5.2. Maximum Conducted Output Power Measurement

#### 5.2.1. Standard Applicable

#### For 5725~5850MHz

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.


#### 5.2.3. Test Procedures

The transmitter output (antenna port) was connected to the power meter.

According to KDB 789033 D02 Section 3 (a) Method PM (Measurement using an RF average power meter):

- (i) Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.
  - The EUT is configured to transmit continuously or to transmit with a constant duty cycle.
  - At all times when the EUT is transmitting, it must be transmitting at its maximum power control level.
  - The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- (ii) If the transmitter does not transmit continuously, measure the duty cycle, x, of the transmitter output signal as described in section II.B.
- (iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.

# 5.3. Power Spectral Density Measurement

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.



#### 5.3.3. Test Procedures

- 1). The transmitter was connected directly to a Spectrum Analyzer through a directional couple.
- 2). The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
- 3). Set the RBW = 300 kHz
- 4). Set the VBW ≥ 3\*RBW
- 5). Span=Encompass the entire emissions bandwidth (EBW) of the signal
- 6). Detector = RMS.
- 7). Sweep time = auto couple.
- 8). Trace mode = max hold.
- 9). Allow trace to fully stabilize.
- 10). If measurement bandwidth of Maximum PSD is specified in 500 kHz, add 10 log (500 kHz/RBW) to the measured result, whereas RBW (<500 kHz) is the reduced resolution bandwidth of the spectrum analyzer set during measurement.
- 11). If measurement bandwidth of Maximum PSD is specified in 1 MHz, add 10 log (1MHz/RBW) to the measured result, whereas RBW (< 1 MHz) is the reduced resolution bandwidth of spectrum analyzer set during measurement.
- 12). Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.



## 1) Sequence of testing 9 kHz to 30 MHz

#### Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna height is 0.8 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

- --- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).
- --- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

#### **Premeasurement:**

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.
- --- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm$  45°) and antenna movement between 1 and 4 meter.
- --- The final measurement will be done with QP detector with an EMI receiver.
- --- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. - --- The antenna height scan range is 1 meter to 2.5 meter.





According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range are listed as follows:

# 5.6.2 Block Diagram of Test Setup





# AC Conducted Emission of power by adapter @ AC 120V/60Hz @ IEEE 802.11ac VHT20 (worst case)




#### 5.7 Undesirable Emissions Measurement

#### 5.7.1 Limit

According to ξ15.407 (b) Undesirable emission limits. Except as shown in paragraph (b) (7) of this section. the maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

- (a) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (b) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (c) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (d) For transmitters operating in the 5.725-5.85 GHz band:
  - (i) All emissions shall be limited to a level of −27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.
  - (ii) Devices certified before March 2, 2017 with antenna gain greater than 10 dBi may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease by March 2, 2018. Devices certified before March 2, 2018 with antenna gain of 10 dBi or less may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease before March 2, 2020.
- (e) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
- (f) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in §15.207.
- (g) The provisions of §15.205 apply to intentional radiators operating under this section.
- (h) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency band edges as the design of the equipment permits.

#### 5.7.3 Test Procedure

- 1. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
- 2. Set the RBW = 1MHz.
- 3. Set the VBW ≥ 3MHz
- 4. Number of points in sweep  $\geq 2 \times \text{span} / \text{RBW}$ . (This ensures that bin-to-bin spacing is  $\leq \text{RBW}/2$ , so that narrowband signals are not lost between frequency bins.)
- 5. Manually set sweep time ≥ 10 x (number of points in sweep) x (total on/off period of the transmitted signal).
- 6. Set detector = power averaging (rms).
- 7. Sweep time = auto couple.
- 8. Trace mode = max hold.
- 9. Allow trace to fully stabilize.

The upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands or 2 dBi, whichever is greater.3 However, for devices that operate in multiple bands using the same transmit antenna, the highest gain of the antenna within the operating band nearest to the out-of-band frequency being measured may be used in lieu of the overall highest gain when measuring emissions at frequencies within 20% of the absolute frequency at the nearest edge of that band, but in no case shall a value less than 2 dBi be selected;
- 6. Over limit = EIRP Limit;

# 5.8. Antenna Requirements

## 5.8.1 Standard Applicable

For intentional device, according to FCC 47 CFR Section 15,203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited

And according to FCC 47 CFR Section 15.407 (a), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

#### 5.8.2 Antenna Connected Construction

## 5.8.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

#### 5.8.2.2. Antenna Connector Construction

The gains of antenna used for transmitting is 2.50dBi, and the antenna is a Monopole Antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.

Two same Monopole Antenna, support 2T2R MIMO technology, Antenna 0 only support WLAN, antenna 1 support BT and WLAN, maximum antenna gain are 2.50 dBi for both antennas.
