3.2 Measurement Procedure

The EUT was tested according to test procedure of "KDB789033 D02 General UNII Test Procedures New Rules"

26 dB Bandwidth

- a) Set RBW = approximately 1% of the emission bandwidth.
- b) Set the VBW > RBW.
- c) Detector = Peak.
- d) Trace mode = max hold.
- e) Measure the maximum width of the emission that is 26 dB down from the maximum of the emission. Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.


99% Occupied Bandwidth

The following procedure shall be used for measuring (99 %) power bandwidth:

- 1. Set center frequency to the nominal EUT channel center frequency.
- 2. Set span = 1.5 times to 5.0 times the OBW.
- 3. Set RBW = 1% to 5% of the OBW
- 4. Set VBW \geq 3 · RBW
- 5. Video averaging is not permitted. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used.
- 6. Use the 99 % power bandwidth function of the instrument (if available).
- 7. If the instrument does not have a 99 % power bandwidth function, the trace data points are recovered and directly summed in power units. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5 % of the total is reached; that frequency is recorded as the lower frequency. The process is repeated until 99.5 % of the total is reached; that frequency is recorded as the upper frequency. The 99% occupied bandwidth is the difference between these two frequencies.

4 Minimum 6dB Bandwidth

Test result: Pass

4.1 Limit

For systems using digital modulation techniques that may operate in the 5725 - 5850 MHz band, the minimum 6 dB bandwidth shall be at least 500 kHz.

4.2 Measurement Procedure

The EUT was tested according to test procedure of "KDB789033 D02 General UNII Test Procedures New Rules"

a) Set RBW = 100 kHz.

- b) Set the video bandwidth (VBW) \ge 3 x RBW.
- c) Detector = Peak.
- d) Trace mode = max hold.
- e) Sweep = auto couple.
- f) Allow the trace to stabilize.

g) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission. Note: The automatic bandwidth measurement capability of a spectrum analyzer or EMI receiver may be employed if it implements the functionality described above.

5 Maximum conducted output power and e.i.r.p.

Test result: Pass

5.1 Limit

For an outdoor access point operating in the band 5.15-5.25GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1W provided the maximum antenna gain does not exceed 6dBi.

The maximum e.i.r.p. at any elevation angle above 30 degrees from the horizon must not exceed 125mW (21 dBm). (For FCC)

For an indoor access point operating in the band 5.15-5.25GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6dBi. (For FCC)

For fixed point-to-point access points operating in the band 5.15-5.25GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1W. (For FCC)

For client devices in the 5.15-5.25GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250mW provided the maximum antenna gain does not exceed 6dBi. (For FCC)

For the 5.25-5.35GHz and 5.47-5.725GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250mW or 11dBm + 10logB, where B is the 26dB emission bandwidth in megahertz. (For FCC)

For the band 5.725-5.85GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1W. (For FCC&IC)

For Frequency Band 5150-5250 MHz, the maximum e.i.r.p. shall not exceed 200 mW or 10 + 10 log10B, dBm, whichever power is less. B is the 99% emission bandwidth in megahertz. (For IC)

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or 11 dBm + 10 log B, where B is the 99% emission bandwidth in megahertz. (For IC)

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, The maximum e.i.r.p. shall not exceed 1.0 W or 17 + 10 log10B, dBm, whichever is less. B is the 99% emission bandwidth in megahertz. (For IC)

If transmitting antennas of directional gain greater than 6dBi are used, the maximum conducted output power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

5.2 Measurement Procedure

The EUT was tested according to test procedure of "KDB789033 D02 General UNII Test Procedures New Rules"

For 802.11a and 802.11n(HT20) mode:

Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.
The EUT is configured to transmit continuously or to transmit with a constant duty cycle.
At all times when the EUT is transmitting, it must be transmitting at its maximum power control level.
The integration period of the power meter exceeds the repetition period of the transmitted

signal by at least a factor of five.


- (ii) If the transmitter does not transmit continuously, measure the duty cycle, x, of the transmitter output signal as described in II.B.
- (iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
- (iv) Adjust the measurement in dBm by adding 10 log (1/x) where x is the duty cycle (e.g., 10 log (1/0.25) if the duty cycle is 25%).

For 802.11n(HT40) and 802.11ac(VHT80):

- (i) Measure the duty cycle, x, of the transmitter output signal as described in II.B.
- (ii) Set span to encompass the EBW (or, alternatively, the entire 99% occupied bandwidth) of the signal.
- (iii) Set RBW = 1 MHz.
- (iv) Set VBW \ge 3 MHz.
- (v) Number of points in sweep $\ge 2 \times \text{span} / \text{RBW}$. (This ensures that bin-to-bin spacing is $\le \text{RBW}/2$, so that narrowband signals are not lost between frequency bins.)
- (vi) Sweep time = auto.
- (vii) Detector = power averaging (rms), if available. Otherwise, use sample detector mode.
- (viii) Do not use sweep triggering. Allow the sweep to "free run."
- (ix) Trace average at least 100 traces in power averaging (rms) mode; however, the number of traces to be averaged shall be increased above 100 as needed to ensure that the average accurately represents the true average over the on and off periods of the transmitter.
- (x) Compute power by integrating the spectrum across the EBW (or, alternatively, the entire 99% occupied bandwidth) of the signal using the instrument's band power measurement function with band limits set equal to the EBW (or occupied bandwidth) band edges. If the instrument does not have a band power function, sum the spectrum levels (in power units) at 1 MHz intervals extending across the EBW (or, alternatively, the entire 99% occupied bandwidth) of the signal.
- (xi) Add 10 log (1/x), where x is the duty cycle, to the measured power to compute the average power during the actual transmission times (because the measurement represents an average over both the on and off times of the transmission). For example, add 10 log (1/0.25) = 6 dB if the duty cycle is 25%.

6 Power spectrum density

Test result: Pass

6.1 Limit

For an outdoor access point operating in the band 5.15-5.25GHz, the maximum power spectral density shall not exceed 17dBm in any 1 megahertz band. (For FCC)

For an indoor access point operating in the band 5.15-5.25GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. (For FCC)

For client devices in the 5.15-5.25GHz band, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. (For FCC)

For the 5.25-5.35 GHz and 5.47-5.725GHz bands, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. (For FCC)

For the band 5.725-5.85GHz, the maximum power spectral density shall not exceed 30dBm in any 500kHz band. (For FCC&IC)

 \square For the 5.15-5.25GHz band, the e.i.r.p. spectral density shall not exceed 10 dBm in any 1.0 MHz band. (For IC)

For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. (For IC)

If the transmitting antenna of directional gain greater than 6dBi is used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi. If there have a beam forming type, the limit should be the less of original and original + (6 - antenna gain - beamforming gain).

6.2 Measurement Procedure


The EUT was tested according to test procedure of "KDB789033 D02 General UNII Test Procedures New Rules"

- Create an average power spectrum for the EUT operating mode being tested by following the instructions in II.E.2. for measuring maximum conducted output power using a spectrum analyzer or EMI receiver: select the appropriate test method (SA-1, SA-2, SA-3, or alternatives to each) and apply it up to, but not including, the step labeled, "Compute power...." (This procedure is required even if the maximum conducted output power measurement was performed using a power meter, method PM.)
- 2. Use the peak search function on the instrument to find the peak of the spectrum and record its value.
- 3. Make the following adjustments to the peak value of the spectrum, if applicable:
 - a) If Method SA-2 or SA-2 Alternative was used, add 10 log (1/x), where x is the duty cycle, to the peak of the spectrum.
 - b) If Method SA-3 Alternative was used and the linear mode was used in step II.E.2.g)(viii), add 1 dB to the final result to compensate for the difference between linear averaging and power averaging.
- 4. The result is the Maximum PSD over 1 MHz reference bandwidth.
- 5. For devices operating in the bands 5.15 5.25 GHz, 5.25 5.35 GHz, and 5.47 5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in Section 15.407(a)(5). For devices operating in the band 5.725 5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, "provided that the measured power is integrated over the full reference bandwidth" to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 kHz bandwidth, the following adjustments to the procedures apply:</p>
 - a) Set RBW $\geq 1/T$, where T is defined in II.B.I.a).
 - b) Set VBW \geq 3 RBW.
 - c) If measurement bandwidth of Maximum PSD is specified in 500 kHz, add 10 log (500 kHz/RBW) to the measured result, whereas RBW (<500 kHz) is the reduced resolution bandwidth of the spectrum analyzer set during measurement.</p>
 - d) If measurement bandwidth of Maximum PSD is specified in 1 MHz, add 10 log (1MHz/RBW) to the measured result, whereas RBW (< 1 MHz) is the reduced resolution bandwidth of spectrum analyzer set during measurement.
 - e) Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.

Note: As a practical matter, it is recommended to use reduced RBW of 100 kHz for steps 5.c) and 5.d) above, since RBW=100 KHZ is available on nearly all spectrum analyzers.

7.2 Measurement Procedure

For Radiated emission below 30MHz:

- a) The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b) The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c) Both X and Y axes of the antenna are set to make the measurement.
- d) For each suspected emission, the EUT was arranged to its worst case and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e) The test-receiver system was set to Quasi-Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.

NOTE:

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 9kHz at frequency below 30MHz.

For Radiated emission above 30MHz:

- a) The EUT was placed on the top of a rotating table 0.8 meters (for 30MHz ~ 1GHz) / 1.5 meters (for above 1GHz) above the ground at 3 meter chamber room for test. The table was rotated 360 degrees to determine the position of the highest radiation.
- b) The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c) The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d) For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e) The test-receiver system was set to quasi-peak detect function and specified bandwidth with maximum hold mode when the test frequency is below 1 GHz.
- f) The test-receiver system was set to peak and average detect function and specified bandwidth with maximum hold mode when the test frequency is above 1 GHz. If the peak reading value also meets average limit, measurement with the average detector is unnecessary.



- The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is ≥ 1/T (Duty cycle < 98%) or 3 x RBW (Duty cycle ≥ 98%) for Average detection (AV) at frequency above 1GHz.



For Radiated emission below 30MHz:




For Radiated emission 30MHz to 1GHz:










8.1 Measurement Procedure

Measured levels of ac power-line conducted emission shall be the emission voltages from the voltage probe, where permitted, or across the 50 Ω LISN port (to which the EUT is connected), where permitted, terminated into a 50 Ω measuring instrument. All emission voltage and current measurements shall be made on each current-carrying conductor at the plug end of the EUT power cord by the use of mating plugs and receptacles on the LISN, if used. Equipment shall be tested with power cords that are normally supplied or recommended by the manufacturer and that have electrical and shielding characteristics that are the same as those cords normally supplied or recommended by the manufacturer. For those measurements using a LISN, the 50 Ω measuring port is terminated by a measuring instrument having 50 Ω input impedance. All other ports are terminated in 50 Ω loads.

Tabletop devices shall be placed on a platform of nominal size 1 m by 1.5 m, raised 80 cm above the reference ground plane. The vertical conducting plane or wall of an RF-shielded (screened) room shall be located 40 cm to the rear of the EUT. Floor-standing devices shall be placed either directly on the reference ground-plane or on insulating material as described in ANSI C63.4. All other surfaces of tabletop or floor-standing EUTs shall be at least 80 cm from any other grounded conducting surface, including the case or cases of one or more LISNs.

The bandwidth of the test receiver is set at 9 kHz.





10 Antenna requirement

Requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

Result:

EUT uses used a permanently attached antenna to the intentional radiator, so it can comply with the provisions of this section.
