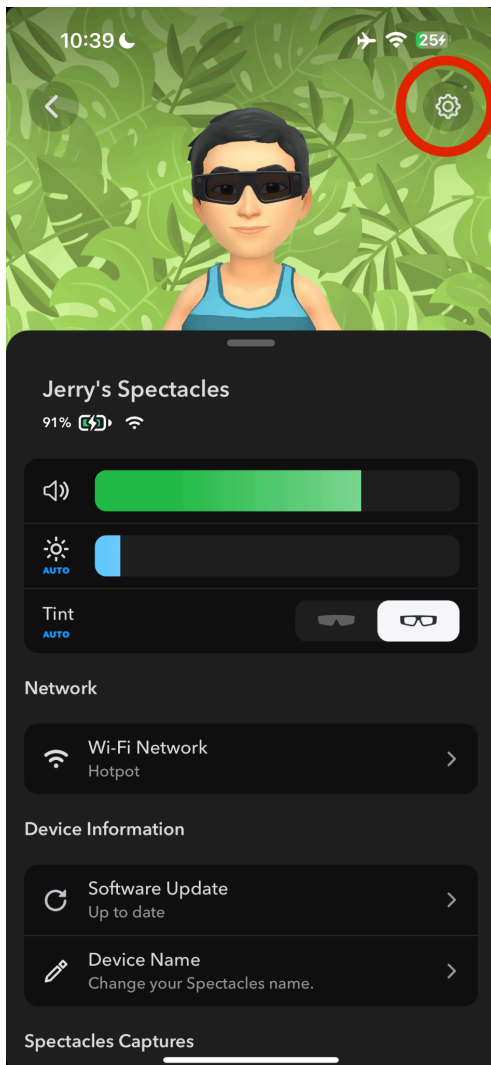
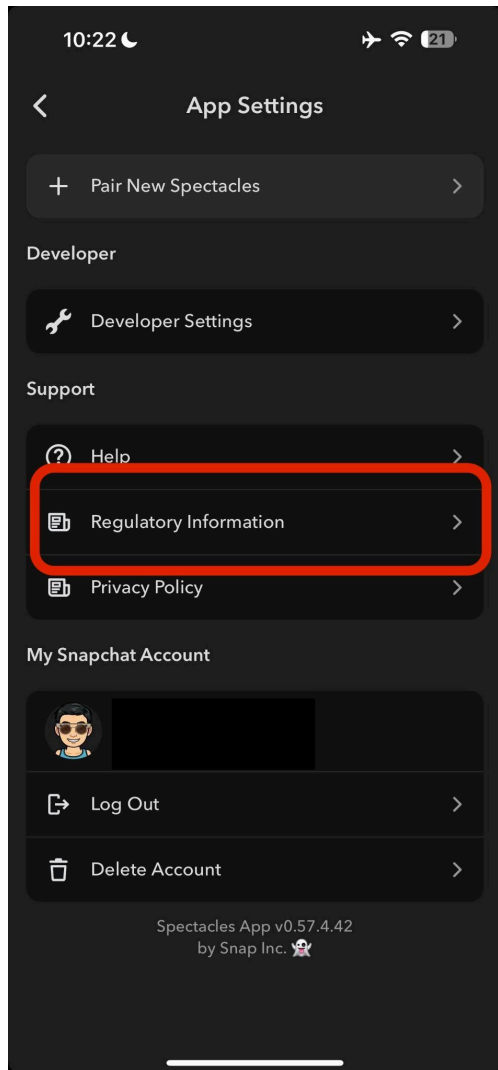

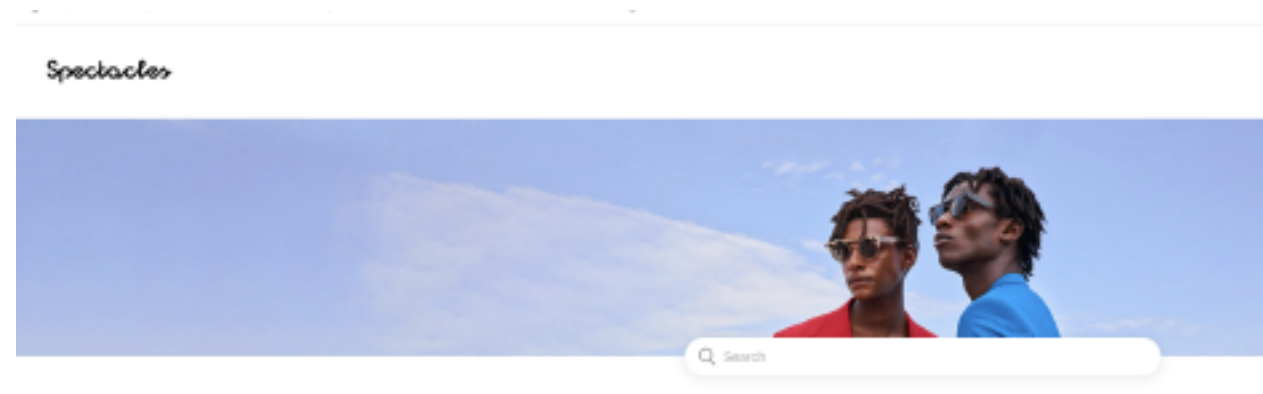
Step 1 On Home Screen, Click on Gear icon to load settings

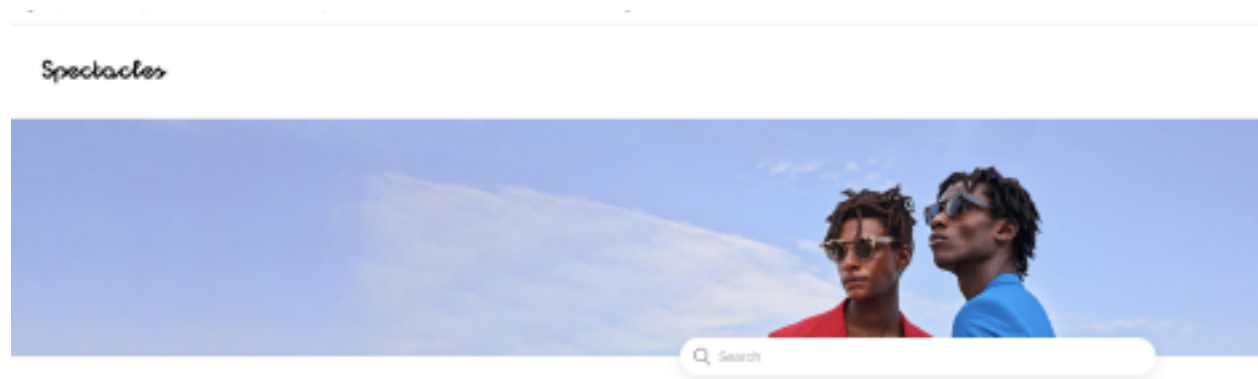
