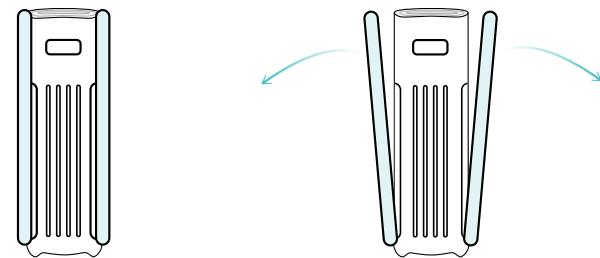




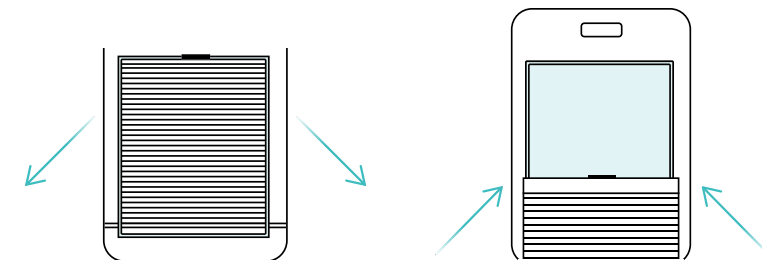
Step 1

Prepare Your Filters

Gently remove both side panels.



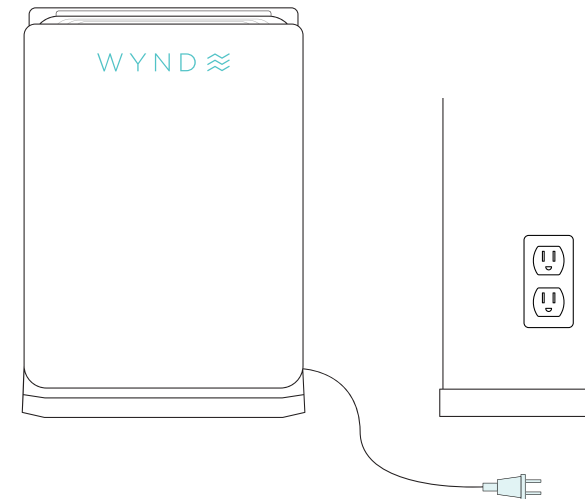
Remove, unwrap, and reinsert filters. Then reattach the panels.



Replace filters every 12 months.

Step 2

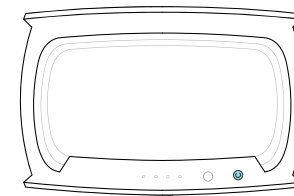
Plug in Your Home Purifier



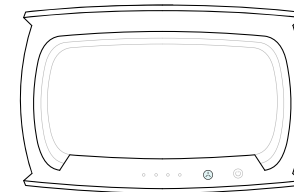
For those outside the US, install the relevant cable or adapter.

Step 3

Controlling Your Home Purifier



Tap the power button to turn on your purifier.
Hold the power icon for 3 seconds to connect to WiFi, enabling pairing to your smart devices. Your WiFi icon should blink when it is in pairing mode.



Tap the fan icon to switch between auto, low, medium, and max fan speeds.
Hold the fan icon for 3 seconds to switch on and off night mode, which will turn off the sound and LED lights. Your display icon should turn on and off to indicate display status.

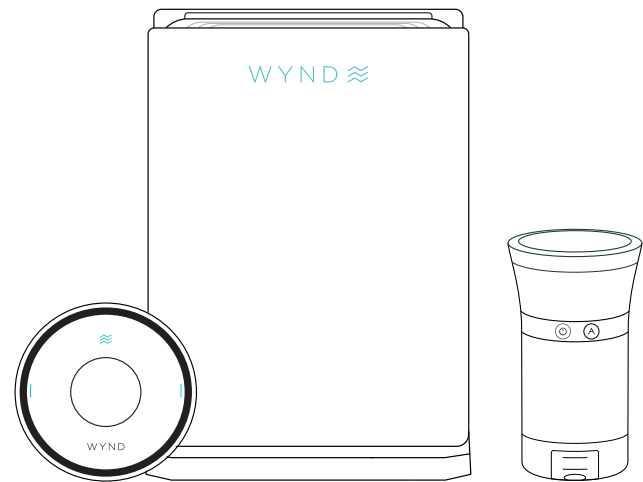

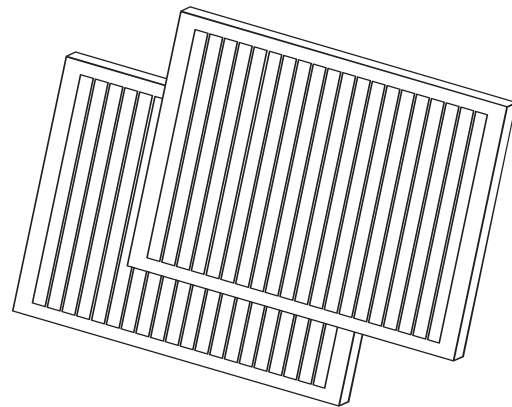
