User Guide

1. Connect with power
 (1) Insert power line into power interface which behind the camera. When the status indicator lamp turns green, shows the camera start working.

(2) Please make sure your phone has connected to internet.

2. Download 360 Smart Camera APP
 -from Google Play
 -or from Apple Store
 -or scan the barcode below

3. Add camera
 (1) Open 360 Smart Camera APP, click "register" button and start register an account. If you already have an account, login directly.

(2) After login, click "+" button which on the right-top corner of screen. Click on "connect to my camera" and follow the voice prompts to complete.

Remarks: During the connection, please pay attention to below tips:

- During acoustic matching, please keep away from noisy environment.
- Make sure the camera connect to 2.4GHz frequency band WiFi.
- Please turn off MAC Address Filter function in WiFi router, otherwise the camera may not be connected successfully.
- The camera temporarily not supports WPA/WPA2 enterprise-class WiFi, please select other options.
- Suggest connecting nonbridging contact Wifi.

(3) After adding successfully, start your discovery.

4. Fixed camera
 Option 1: Camera can be put on the table.
 Option 2: The bottom of the camera has a magnetic sticker can be stick to metal surface, such as refrigerator, metal window etc. Warning: Don't put camera on hard disk or computer.
 Option 3: Use 3M sticker to stick the camera on glass, ceramic glossy wall surface.
 Remark: Mounting accessories and 4 Meters USB cable are available in local Authorized Distributors.

 (1) 720P(1280*720) high definition provides superb performance and bright luminosity. Night vision mode can be automatically activated as need and the viewing window will be switched to black&white mode.
 (2) When night vision mode is switched on/off, a clicking sound will be heard as internal filter changes.
 (3) No visible light will be generated during night vision mode.

Q1: How many modes does the indicator have?
