

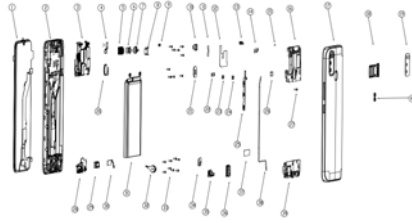

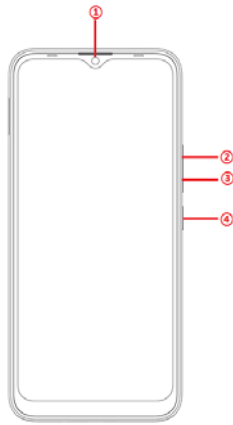

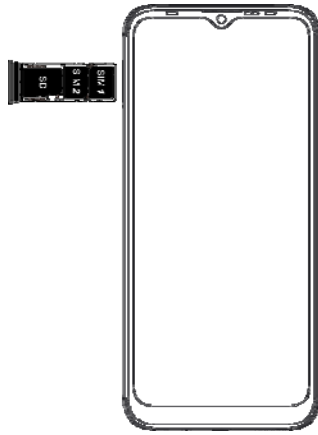
Know your phone

SIM/SD card installation

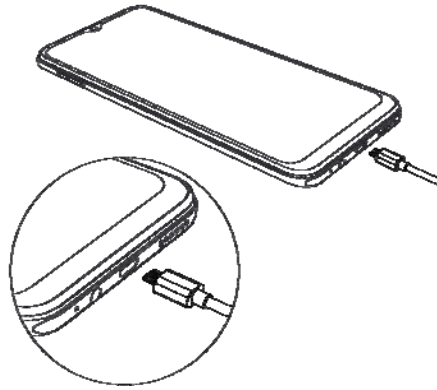
1. Power off mobile.

Charging the phone

You can charge your device using a charger or by connecting it to the computer using a USB cable (comes with the phone).

1. Please remind the front and back of the plug.
2. Use only INFINIX charger and cables. Other chargers or cables may damage the device. This will invalidate your phone warranty.



Emergency call

If any emergency arises, dial 112/911 (or other emergency call number) for emergency help.

The SAR limit of USA (FCC) is 1.6 W/kg averaged over one gram of tissue. Device types X657B (FCC ID: 2AIZN-X657B) has also been tested against this SAR limit. The highest reported SAR values for head, body-worn accessory, and product specific (Hotspot) are 1.00 W/kg, 0.75 W/kg, and 0.81 W/kg respectively. The Max simultaneous SAR is 1.21 W/kg. This device was tested for typical body-worn operations with the back of the handset kept 10mm from the body. To maintain compliance with FCC RF exposure requirements, use accessories that maintain a 10mm separation distance between the user's body and the back of the handset. The use of belt clips, holsters and similar accessories should not contain metallic components in its assembly.
