- 1. For AC power line conducted emission and radiated spurious emission (below 1GHz), pre-scan 802.11b, g, n modulation mode, found 802.11b modulation mode was worse case mode. The report only reflects the test data of worst mode.
- 2. Channel Low, Mid and High for each type band with rated data rate were chosen for full testing. The field strength of spurious radiation emission was measured as EUT stand-up position (H mode) and lie down position (E1, E2 mode) for these modes. Just the worst case position (H mode) shown in report.







4.3 Test Procedure

This provides a 50ohm/50uH coupling impedance for the measuring equipment. The peripheral devices are also connected to the main power through a LISN that provides a 50ohm/50uH coupling impedance with 50ohm termination. (Please refer to the block diagram of the test setup and photographs). Both sides of A.C. line are checked for maximum conducted interference. In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.10 on conducted measurement.


