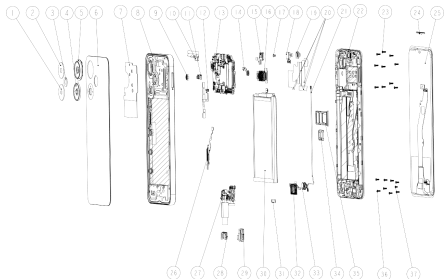

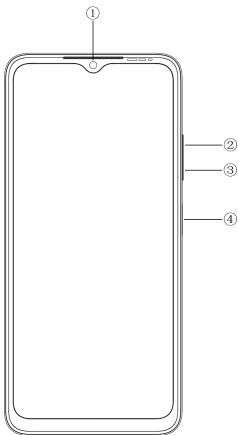

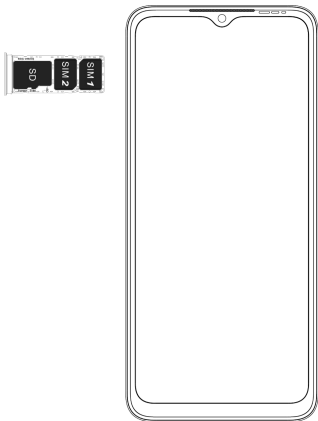

SIM/SD card installation

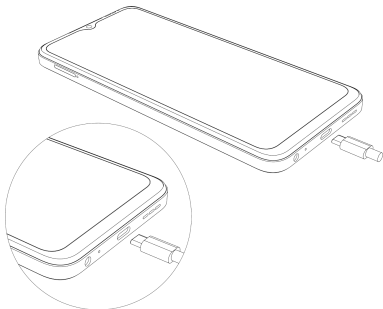
1. Power off mobile.

Charging the phone

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules. This device was tested for typical body-worn operations.
