(1) Download the following 4 progressive programming apps from the APP Store (iPad) or Abilix App Store (Android Tablet): Meet Krypton Krypton Project Programming Abilix Chart Abilix Scratch</p>	<p>(2) Slide the controller screen; find the "QR Code"; run the simplest "Meet Krypton 7" APP on the tablet; click icon  and scan the QR code; connect the tablet to the robot as the prompts go.</p> <p>(3) When the robot and the tablet are connected, Krypton 7 will run the "Krypton Project Programming" app automatically, and there will be an icon  on the screen.</p> <p>(4) If you write a program named "Program 1" with the "Krypton Project Programming" APP, and download it to the robot, you can find the icon . Congratulations! You made your first program. By this time, the icon is in a state of rest; click it and the star starts to rotate, it means the program is running; click again, the program stops; long press the icon, a delete confirmation will pop up.</p> <p>How to update? (1) Exit all the programming apps; connect the tablet to the network router and keep the password of which in mind (if there is one). (2) Find the "QR Code" in the controller; open the "Meet Krypton 7" App; click the icon ; scan the QR code; connect the robot to the tablet as the prompt goes, during which, the password of the router needs to be input in the APP, after that, the router info will be sent to the krypton 7 by the APP.
