



Button Descriptions

ON/OFF: Switch on/off.

- 1 (>): Short press for pause or answer.
 - 2 (+): Long press for volume increase, short press for next song
 - 3 (-): Long press for volume decrease, short press for last song
 - 4 (M): Short press for bt play/line in mode change automatically works first.
- If you have already paired with your phone, the connection will be provided automatically. If you are using your device for the first time, follow the next step for pairing.

First Time Matching

1. Turn on your device.
2. Select "Piranha-7823" from your phone in the BT devices list.
3. If your phone asks for a password, enter "0000"

Warning: We recommend that you charge your device before using it. There may be a disconnection when the battery is low.

Warning: Use the original charging cable that comes out of the box for charging.

TF Card Mode

You can listen to music by inserting a TF Memory Card through the TF Card Input of your device. This mode will run automatically when a USB Flash Disk is inserted.

Call Reception (Optional)

To respond to an incoming call, press the play / pause button (>) briefly.

To reject an incoming call, press and hold the same key for a long time.

To end the call during a conversation, press briefly.

You can call the recently dialed contact by briefly pressing the play / stop (>) button when not in music mode.

Switching Between Modes

You can switch between device modes by pressing (M).

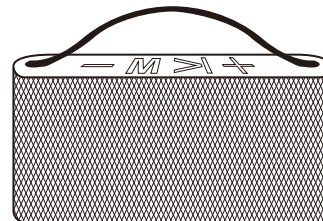
Charge

Beeps when the battery level of the device is low. With the help of the USB cable, Max. Charge your device via a 5V adapter or Computer. A low charge causes IT disconnection.
