## 11.1 Friis transmission formula: Pd= (Pout\*G)\ (4\*pi\*R²)

Where

Pd= Power density in mW/cm<sup>2</sup>

Pout=output power to antenna in mW

G= Numeric gain of the antenna relative to isotropic antenna

Pi=3.1416

R= distance between observation point and center of the radiator in cm

Pd the limit of MPE, 1mW/cm<sup>2</sup>, If we know the maximum gain of the nd total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.

This equipment should be installed and operated with minimum distance 20cm between the radiator & your body.
