The Intercom has up to a 1500 foot (500 m) range and allows multiple simultaneous conversations, using a 400-470 MHz secure digital radio link. The doorbell intercoms form an exclusive network and respond only to other intercoms in the network.

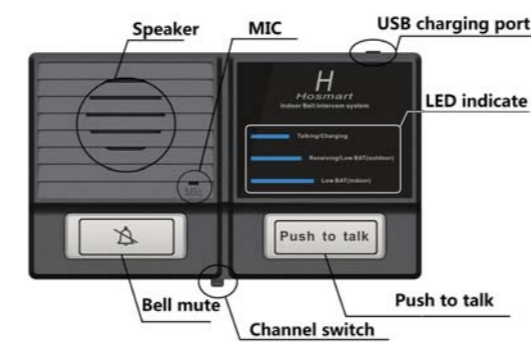

Operation & Features

1. Indoor Bell intercom



Push to talk Button

To talk, hold down the take button and all the intercoms in the same channel will receive the signal. When you holding down the take button on a different channel. A secure channel is created and the other intercoms in the network don't hear the conversation.

Bell Mute Button

When someone press the Bell Button in outdoor. The indoor bell will ring. Press the Bell Mute button will mute the Bell

chime in indoor intercoms.

Channel switch Button

You can select different channel to communicate with different intercoms.

Talking/Charging LED indicated

Receiving/Low BAT(outdoor) LED indicated

When the intercom is receiving. The LED will flicker. Or when the outdoor intercom battery was low. This LED would light.

Low BAT(indoor) LED indicated

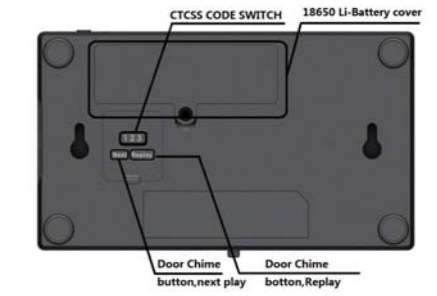
The indoor intercom battery was low if you used the 18650 Li-battery as a power supply.

Doorbell chime re-play.

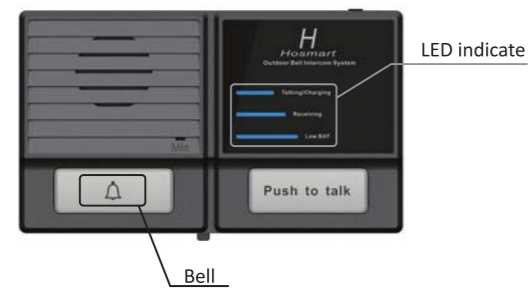
CTCSS CODE SWITCH

Unnecessary noises from nearby devices(CTCSS)

1/2/3/ code

If your intercom system setting is at "1" or "3" code and get lot of outside unnecessary voices or noises; you can change your intercom system (all units) to "2" or "3" code to avoid unnecessary noises from nearby devices.

2. Outdoor Bell intercom

A 18650 Li-battery was included in this outdoor intercom. This intercom also can support AC adapter as power supply. Before to mount this outdoor intercom. We need to charge this intercom with 5V/1A AC adapter for 4-5 hours to make sure the Li-battery was full. When it charged, The Talking/charging LED would light. When the Li-battery was full, the Talking/charging LED would turn off.

Push to talk Button

To talk, hold down the take button and all the intercoms in the same channel will receive the signal. When you holding down the take button on a different channel. A secure channel is created and the other intercoms in the network don't hear the conversation.

Bell Button

Push this button, the doorbell Chime will ring in the indoor intercoms.

Channel switch Button

You can select different channel to communicate with different intercoms.

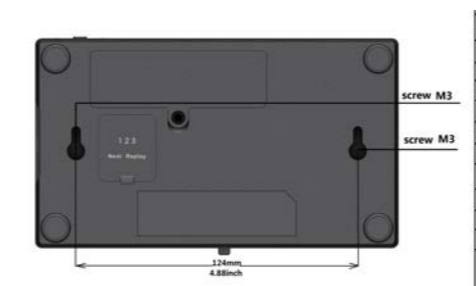


Before mounting the outdoor bell, Pls unscrew the battery cover and pick up the piece.
