#### 4.3 DESCRIPTION OF TEST MODES

The EUT has been tested under its typical operating condition.

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Those data rates (1Mbps for Bluetooth BR GFSK modulation; 2Mbps for Bluetooth EDR pi/4-DQPSK modulation; 3Mbps for Bluetooth EDR 8DPSK modulation ) were used for all test.

Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting and receiving mode is programmed.








#### 7 SETUP OF EQUIPMENT UNDER TEST

#### 7.1 RADIO FREQUENCY TEST SETUP 1

The Bluetooth with classic mode component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



#### 7.2 RADIO FREQUENCY TEST SETUP 2

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m.The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013

#### Below 30MHz:

The EUT is placed on a turntable 0.8meters above the ground in the chamber, 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.

#### Above 30MHz:


The EUT is placed on a turntable 0.8meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

## Above 1GHz:

(Note: the FCC's permission to use 1.5m as an alternative per TCBC Conf call of Dec. 2, 2014.)


The EUT is placed on a turntable 1.5 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

#### (a) Radiated Emission Test Set-Up, Frequency Below 30MHz






### (b) Radiated Emission Test Set-Up, Frequency Below 1000MHz



#### (c) Radiated Emission Test Set-Up, Frequency above 1000MHz




#### 7.3 CONDUCTED EMISSION TEST SETUP

The mains cable of the EUT (Perfect Share Mini) must be connected to LISN. The LISN shall be placed 0.8m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.


Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.8m.

According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

### 8 FREQUENCY HOPPING SYSTEM REQUIREMENTS

## 8.1 Standard Applicable

According to FCC Part 15.247(a)(1), The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.


- (g) Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.
- (h) The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hopsets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

#### 8.2 EUT Pseudorandom Frequency Hopping Sequence


The channel is represented by a pseudo-random hopping sequence hopping through the 79 RF channels. The hopping sequence is unique for the piconet and is determined by the Bluetooth device address of the master; the phase in the hopping sequence is determined by the Bluetooth clock of the master. The channel is divide into time slots where each slot corresponds to an RF hop frequency. Consecutive hops correspond to different RF hop frequencies. The normal hop is 1 600 hops/s.

The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage, and the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONEs; i.e. the shift register is initialized with nine ones. Number of shift register stages: 9

Length of pseudo-random sequence: 29-1 = 511 bits Longest sequence of zeros: 8 (non-inverted signal)

The system receiver have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shift frequencies in synchronization with the transmitted signals.

#### 8.3 Equal Hopping Frequency Use

All Bluetooth units participating in the piconet are time and hop-synchronized to the channel.

#### 8.4 Frequency Hopping System

This transmitter device is frequency hopping device, and complies with FCC part 15.247 rule.

This device uses Bluetooth radio which operates in 2400-2483.5 MHz band. Bluetooth uses a radio technology called frequency-hopping spread spectrum, which chops up the data being sent and transmits chunks of it on up to 79 bands (1 MHz each; centred from 2402 to 2480 MHz) in the range 2,400-2,483.5 MHz. The transmitter switches hop frequencies 1,600 times per second to assure a high degree of data security. All Bluetooth devices participating in a given piconet are synchronized to the frequency-hopping channel for the piconet. The frequency hopping sequence is determined by the master's device address and the phase of the hopping sequence (the frequency to hop at a specific time) is determined by the master's internal clock. Therefore, all slaves in a piconet must know the master's device address and must synchronize their clocks with the master's clock.

Adaptive Frequency Hopping (AFH) was introduced in the Bluetooth specification to provide an effective way for a Bluetooth radio to counteract normal interference. AFH identifies "bad" channels, where either other wireless devices are interfering with the Bluetooth signal or the Bluetooth signal is interfering with another device. The AFH- enabled Bluetooth device will then communicate with other devices within its piconet to share details of any identified bad channels. The devices will then switch to alternative available "good" channels, away from the areas of interference, thus having no impact on the bandwidth used.

## 9.1.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 9.1.4 Test Procedure

The EUT was operating in Bluetooth with classic mode mode and controlled its channel. Printed out the test result from the spectrum by hard copy function.

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously

Set RBW = 30 kHz.

Set the video bandwidth (VBW) =100 kHz.

Set Span= approximately 2 to 3 times the 20 dB bandwidth

Set Detector = Peak.

Set Trace mode = max hold.

Set Sweep = auto couple.

The EUT should be transmitting at its maximum data rate. Allow the trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 20 dB down one side of the emission. Reset the markerdelta function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is the 20 dB bandwidth of the emission.

If this value varies with different modes of operation (e.g., data rate, modulation format, etc.), repeat this test for each variation.

Measure and record the results in the test report.









#### 9.2 CARRIER FREQUENCY SEPARATION

#### 9.2.1 Applicable Standard

According to FCC Part 15.247(a)(1) and KDB 558074 D01 MEAS GUIDANCE V05r02

#### 9.2.2 Conformance Limit

Frequency hopping systems operating in the 2400-2483.5MHz band shall have hopping channel carrier frequencies separated by a minimum of 25kHz or the 20dB bandwidth of the hopping channel, whichever is greater.

In case of an output power less than 125mW, the frequency hopping system may have channels separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater.

The EUT must have its hopping function enabled. Use the following spectrum analyzer settings:

Sweep = auto

Detector function = peak

Trace = max hold

Allow the trace to stabilize. It may prove necessary to break the span up to sections, in order to clearly show all of the hopping frequencies.

#### 9.4.2 Conformance Limit

For frequency hopping systems operating in the 2400-2483.5MHz band, the average time of occupancy on any channel shall not be greater than 0.4s within a period of 0.4s multiplied by the number of hopping channels employed.

Test according to clause 7.1 radio frequency test setup 1

#### 9.4.4 Test Procedure

#### ■ According to FCC Part15.247(a)(1)(iii)

The EUT must have its hopping function enabled. Use the following spectrum analyzer settings:

Span = zero span, centered on a hopping channel

RBW = 1 MHz

 $VBW \geq RBW$ 

Sweep = as necessary to capture the entire dwell time per hopping channel

Detector function = peak

Trace = max hold

If possible, use the marker-delta function to determine the dwell time. If this value varies with different modes of operation (e.g., data rate, modulation format, etc.),






Average Time Of Occupancy (Dwell Time)

CH 0: 2402MHz GFSK DH1





#### 9.5.4 Test Procedure

## ■ According to FCC Part15.247(b)(1)

As an alternative to a peak power measurement, compliance with the limit can be based on a measurement of the maximum conducted output power.

Set Span = approximately 5 times the 20 dB bandwidth, centered on a hopping channel (about 10MHz)

Set RBW > the 20 dB bandwidth of the emission being measured (about 3MHz)



Maximum Peak Conducted Output Power Bluetooth with classic mode Channel 0: 2402MHz GFS





Maximum Peak Conducted Output Power Bluetooth with classic mode Channel 39: 2441MHz GFSK






Maximum Peak Conducted Output Power Bluetooth with classic mode Channel 78: 2480MHz GFSK





#### 9.6 CONDUCTED SPURIOUS EMISSION

#### 9.6.1 Applicable Standard

According to FCC Part 15.247(d) and KDB 558074 D01 MEAS GUIDANCE V05r02

#### 9.6.2 Conformance Limit

According to FCC Part 15.247(d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted, provided the transmitter demonstrates compliance with the peak conducted power limits.

#### 9.6.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 9.6.4 Test Procedure

The transmitter output (antenna port) was connected to the spectrum analyzer

#### ■ Reference level measurement

Establish a reference level by using the following procedure:

Set instrument center frequency to DSS channel center frequency.

Set Span = approximately 5 times the 20 dB bandwidth, centered on a hopping channel.

Set the RBW = 100 kHz. Set the VBW  $\geq$  3 x RBW.

Set Detector = peak. Set Sweep time = auto couple.

Set Trace mode = max hold. Allow trace to fully stabilize.

Use the peak marker function to determine the maximum Maximum conduceted level.

Note that the channel found to contain the maximum conduceted level can be used to establish the reference level.

## ■ Band-edge Compliance of RF Conducted Emissions

Use the following spectrum analyzer settings:

Span = wide enough to capture the peak level of the emission operating on the channel closest to the band-edge, as well as any modulation products which fall outside of the authorized band of operation Set RBW  $\geq$  1% of the span=100kHz Set VBW  $\geq$  RBW

Set Sweep = auto Set Detector function = peak Set Trace = max hold

Allow the trace to stabilize. Set the marker on the emission at the bandedge, or on the highest modulation product outside of the band, if this level is greater than that at the bandedge. Enable the marker-delta function, then use the marker-to-peak function to move the marker to the peak of the in-band emission. The marker-delta value now displayed must comply with the limit specified in this Section.

Now, using the same instrument settings, enable the hopping function of the EUT. Allow the trace to stabilize. Follow the same procedure listed above to determine if any spurious emissions caused by the hopping function also comply with the specified limit.

## Conduceted Spurious RF Conducted Emission

Use the following spectrum analyzer settings:

Span = wide enough to capture the peak level of the in-band emission and all spurious emissions (e.g., harmonics) from the lowest frequency generated in the EUT up through the 10th harmonic.(30MHz to

25GHz). Set RBW = 100 kHz Set VBW ≥ RBW

Set Sweep = auto Set Detector function = peak Set Trace = max hold

Allow the trace to stabilize. Set the marker on the peak of any spurious emission recorded. The level displayed must comply with the limit specified in this Section.
