Our products are designed to provide reliable wireless communication services for users across many industry sectors. In order to use the products safely and to achieve the best performance, they must be used as intended. - The product is used by users who have full knowledge of its RF exposure and can exercise control over their RF

To control your exposure and ensure compliance with the occupational/controlled environmental exposure limits, always adhere to the

Guidelines:

Operating Instructions:

- Transmit no more than the rated duty factor of 50% of the time. To transmit (talk), press the Push-to-Talk (PTT) key. To receive calls, release the PTT key. Transmitting 50% of the time, or less, is important because the radio generates measurable RF energy only when transmitting (in terms of measuring for standards compliance).
- Keep the radio unit at least 2.5 cm away from the face. Keeping the radio at the proper distance is important as RF
 exposure decreases with distance from the antenna. The antenna should be kept away from the face and eyes.

- 5. Do not dispose of the battery in fire.

- 7. Do not squeeze and penetrate the battery, nor remove its housing.





Charging the Battery

Use the approved charger to charge the battery.

Read the Safety Information Booklet before charging.

Before initial use, fully charge the battery to ensure optimum performance.

To charge the battery, do as follows:

- (1) Insert the output connector of the power adapter into the port on the back of the charger.
- (2) Plug the power adapter into a power outlet.
- (3) Place the battery into the charger, and then switch the power outlet on.

To determine the charging status, check the light-emitting diode (LED) indicator on the charger according to the following table:

LED Indication	Charge Status
Green	No Battery
Constant Red	The battery is charging.
Constant Green	The battery is fully charged.

You can also charge the radio with battery attached. It is recommended that your radio remain turned off during charging.

Type-C Charge

- Your radio supports the TYPE-C charging method. Connect the TYPE-C cable to the Type-C connector of the power supply unit and the battery.
- Ensure that the Type-C socket at the bottom of the battery is in good contact with the charging terminal of the cable.The charging indicator light at the bottom of the battery turns red and charging begins.
- 3. It takes approximately 2-5 hours to fully charge the battery. The charging indicator light at the bottom of the battery

is off - charging is complete.

When the charging indicator light at the bottom of the battery goes off, it indicates that the charging is complete. Remove the cable from the Type-C port at the bottom of the battery.

Baofeng recommends your radio is turned off while being charged.

Operations

Power on/off and volume adjustment

Rotate the [Power/Volume] knob clockwise to turn the radio on. Rotate the control clockwise /counter-clockwise to adjust the volume level as you prefer.

Rotate the [Power/Volume] knob to adjust the volume. Turn clockwise to increase the volume and counterclockwise to decrease the volume.

- ·To turn the radio off, rotate the control counter-clockwise till hearing a mechanical "click".
- ·If voice prompts are enabled, they will be accompanied by "Power on and channel number".

Select a Channel

The radios can store up to 16 channels, and the channel type allows programming to analog or/and encrypted.

In standby mode, turn the channel knob to select the channel you want. When the voice prompt function is enabled, the corresponding channel is broadcasted by voice.

·If the channel is encrypted, it will be accompanied by "Encryption and channel number".

Attention: It is necessary to set the members of the group on the same channel in order to communicate through radios.

Making a Call

To communicate, all radios in your group must be set to the same channel. Briefly press the [SK1] (Monitor key) to enable the Monitor feature in order to make sure that the frequency is not busy, and then press the [PTT] key. Release the [PTT] key to receive. Only one user at a time can talk during radio communications. Therefore, it is important not

to transmit when you are receiving a communication and use the transmission mode sparingly to allow other users to talk. Transmission consumes a significant amount of energy and should therefore be used sparingly to prolong the battery life. If you are unable to contact a station that you have no problems in receiving, the station may be using CTCSS tones or DCS codes.

Making a Encryption Call

-Select an encryption channel, Press and hold **[PTT]** key, the radios is in the transmitting state, and the red indicator light is constantly on. Then speak in a normal tone into the microphone.

After releasing the [PTT] key, the yellow light briefly flashes once, and the radio is in an acceptable state. When receiving a call, the yellow indicator light remains on.

Note: Set the group members on the same channel and encryption sequence (0-31) to achieve interconnection.

Monitor Function

Before using the monitor function, check whether it is an analog channel. The monitor function is only available for analog channels.

On analog channels, you can use [**SK1**] (Monitor key) to hear weaker signals that are difficult to hear during normal operation, and to adjust the volume when there is no signal on the channel you have selected.

In standby mode, press and hold [SK1] (Monitor key) to turn on the monitor function. Release [SK1] (Monitor key) to exit the monitor state.

One-touch access to battery level

In standby mode, long press [SK2] (Battery access) will be accompanied by a voice prompting the current battery level.

- -High battery level: sufficient battery level.
- -Medium battery level: average battery level.
- -Low power: insufficient power, please charge in time to replenish the power

Channel memory information access

In standby mode, press and hold [SK1] key and then press [SK2] key briefly, it will broadcast the parameter information such as transmit frequency, receive frequency, CTCSS/DCS, transmit power, etc. stored in the current channel.

Channel Scanning

Note: Scanning can only be realized by setting the channel's scanning add to on through the CPS program software and turn on the unit's scanning function.

The scan function is used to monitor to the signals programmed on the radio's channels. During scanning, the radio detects signals on each channel and stops only on channels that have signals.

Note: Channels that have not been added are not scanned.

The radio will remain on the communication channel until that signal disappears. Scanning will resume 5 seconds after the signal disappears unless a new signal is detected within that delay time.

Note: The scanning feature is only available if your local dealer has programmed at least two channels for the radios. In addition, at least two channels must not be programmed for Scan Delete. Consult your local dealer for details on how to use the Scan feature with Coded Squelch or Select Call.

- 1) Press and hold the [SK1] key to turn on the radio to enter channel scanning.
- 2) Enter analog scanning on analog channel, the indicator is flashing green. Enter encrypted scanning on encrypted channel, the indicator light is flashing yellow. When scanning is paused on a channel that is always lit, press and hold the **[PTT]** key will make a callback on the active channel.
- 3) At any time during scanning, you simply press the **[5K1]** key the radio pauses scanning. The radio returns to transmitting on the channel on which the last signal was received. If a valid signal is received during scanning, the radio returns to the channel on which scanning started and transmits.
- 4) Scanning Mode: In carrier scanning mode, scanning stops when a signal is scanned, and scanning continues after the carrier signal is lost for 5 seconds. After scanning the signal, the voice prompts the serial number of the channel scanned.

Prompt voice switch settings

The encoder is selected to the 10th channel. Press and hold the [PTT]+[SK1] to turn on the radio, and turn the prompt

voice on or off.

Turn on the prompt voice function, and there will be voice prompts when the encoder is turned on or operated. If you turn off the prompt voice function, there is only a "beep" prompt when you turn on or operate the encoder.

VOX

The VOX feature enables hands free conversations without using PTT: just speak in the direction of the microphone and the communication will be automatically activated. The VOX sensitivity can be adjusted in 5 different levels (1...5) through the programming software:

Level 2 is set by default and has the lowest VOX sensitivity, 5 is the lowest one.

prompted with a "beep" sound: Operate in sequence until channel 16.

With the programming software you can enable/disable the VOX feature and select the sensitivity levels.

NOTE: In channel 5, press and hold the [PTT]+[SK1] keys to turn on the radio and prompt "VOX on, welcome 5" to turn on/off voice control.

Frequency sweep function

Rotate the channel knob to Channel 1, press and hold the [PTT]+[SK1] key to turn on the radio. The voice will announce "Power On" to enter the sweep function and the green light will flash; Press the [SK1] key to prompt a "beep" sound and the green light remains on, and start scanning. After scanning, it will be automatically stored and prompted with two beeps. (The green light remains on during scanning, and the green light flashes when scanning is stopped) Rotate to channel 2, press the [SK1] key to continue scanning. After scanning, it will be automatically stored and prompted with a "beep" sound, with the indicator light as described above; Rotate to channel 3 and press the [SK1] key to continue scanning. After scanning, it will be automatically stored and

Complete the frequency sweep task, shut down and restart to exit the frequency sweep mode, and the frequency sweep task ends.

Quick group formation (Wireless clone function)

Rotate the channel knob to channel 2, press and hold the [PTT]+[SK1] key to turn on both the transmitter and receiver. The receiver and transmitter prompt "beep" to enter wireless replication. When the transmitter presses the [PTT] key, the red light remains on, and the receiver green light automatically remains on. Copy all the configuration parameters of channels 1-16 of the transmitter, and the receiver prompts "beep" twice to complete the replication. Both prompt lights turn off and automatically restart, the replication task has ended.

Voice frequency hopping

Set frequency hopping on/off for each channel through CPS software. When the frequency hopping function is enabled, it cannot communicate with the regular settings.

Note: Channels with frequency hopping function must be synchronously set with CTCSS or DCS.

CTCSS/DCS tones

CTCSS and DCS tones are similar to access codes and enable the radio to communicate only with the users that are tuned on the same channel and have set the same code. For each channel, you can set up to 51 CTCSS tones and 210 DCS codes. The CTCSS/DCS tones are a sort of "access codes" and enable the radio to communicate only with the other users set on the same frequency and on the same CTCSS/DCS tone.

Quick operation radio

Without CPS programming software, you can perform the following quick operations through the combination of IPTTI+ISK11:

- On the 1th channel, press and hold the [PTT]+[SK1] to turn on the radios, and the green light flashes to perform frequency scanning.
- On the 2th channel, press and hold the [PTT]+[SK1] to open the radios, which can be wirelessly copied to quickly group up.
- On the 5th channel,, press and hold the [PTT]+[SK1] to turn on the radio and turn the VOX function on or off.

Accompanied by a voice prompt VOX On or VOX Off.

- On the 10th channel, press and hold the [PTT]+[SK1] to turn on the radio and turn on or off the prompt voice function.
- On the 15th channel, press and hold the [PTT]+[SK1] to turn on the radio and switch the prompt language between Chinese and English.

-Channel scanning: any channel, hold down the [SK1] key to turn on the radio to enter scanning.

Trouble shooting guide

PROBLEM	SOLUTION
The radio doesn't switch on	The battery may be exhausted. Recharge it. Uncorrected installation.
Battery recharge doesn't last long	The battery pack is over. Change it with a new one. Battery pack is not completely charged.
Reception led turns on but no sound heard	Make sure the volume is not too low. Make sure to have the same CTCSS and DCS codes of your group
The keypad doesn't work	Keypad lock function hasn't been enabled
Reception of other group signal while transmitting	Change another CTCSS/DCS for your group
