Search "NOKTA-MAKRO" on your device and click it to pair, with voice prompt "Connected".</p> <p>Answer call: Short press MODE button to answer the call</p> <p>Refuse a call: long press MODE button about 1 seconds to ignore a incoming call.</p> <p>Call hang up: Short press MFB button to hang up the Call.</p> <p>Last number redial: Double click MODE button to call the last number when it connected with your cellphone.</p> <p>Music Playing: Press Mode button to stop and restart Music playing.</p> <p>Answer mode switching: During a call, long press V+ key about 1 seconds to switch between the headset and the mobile phone.</p> <p>Enter mute status: Short press "V+" and "V-" at the same time in calling status to open or close mute status.</p> <p style="text-align: center;">- 3 -</p>	<p style="text-align: center;">Function&Operation</p> <p>Voice dialing: Press MODE button for 1 seconds on Standby status to trigger voice dial, Turn on the phone voice assistant "Siri"</p> <p>Volume up: Press V+ to volume up and when it reach Maximum volume with voice prompt "du~".</p> <p>Volume down: Press V- to volume down and when it reach Minimum volume with voice prompt "du~".</p> <p>Track back: Press and hold "V-" button for 2 second to play previous song.</p> <p>Track forward: Press and hold "V+" button for 2 second to play next song.</p> <p>Change the voice prompt language: Press the "V-" button and "V+" button at the same time for 3 seconds in power-on status.</p> <p>Clear pairing: Long press MODE button and "V+" at the same time for 3 seconds in Power-on status to clear pairing information.</p> <p>Connect with two devices: 1. Turn off the Bluetooth function in the first cellphone when connected; 2. Then pair the headphone to the second cellphone; 3. Turn on the Bluetooth function of the first cellphone and connect to the Bluetooth by hand again.</p> <p style="text-align: center;">- 4 -</p>	<p>Charging status: The red light on headphone is on when charging and off when fully charged.</p> <p>Automatically connect: 1. In pairing range, the headphones will automatically connect to the last paired devices in memory. 2. When you walked away when it calling or playing and it disconnected, it will also automatically be reconnected when you enter in pairing range in 3 minutes.</p> <p style="text-align: center;">Safety Precaution</p> <ol style="list-style-type: none"> Do not tear down or modify the earphone.
