Channel 20:2.442GHz:



Channel 20:2.442GHz:



Channel 20:2.442 GHz:



Test Procedure:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.

The receiver scanned from the lowest frequency generated within the EUT to 25GHz.When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was

performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. 




