To DIN EN ISO/IEC 17025. Furthermore, component and process variability of devices similar to that tested may result in additional deviation. ## 1.7. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

802.11a Mode: 1 Mbps, OFDM.  
802.11n-HT20 Mode: MCS0, OFDM.  
802.11n-HT40 Mode: MCS0, OFDM.  
802.11ac20 Mode: MCS0, OFDM.  
802.11ac40 Mode: MCS0, OFDM.

Pre-test AC conducted emission at both power adapter and charge from PC mode, recorded worst case.

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/50Hz, recorded worst case.

Worst-case mode and channel used for 150 kHz-30 MHz power line conducted emissions was the mode and channel with the highest output power, which was determined to be IEEE 802.11a mode (Low Channel).

## **2. TEST METHODOLOGY**

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

### **2.1. EUT Configuration**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### **2.2. EUT Exercise**

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure 789033 D02 General UNII Test Procedures New Rules v01r03 is required to be used for this kind of FCC 15.407 UII device.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.407 under the FCC Rules Part 15 Subpart E.

### **2.3. General Test Procedures**

#### **2.3.1 Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### **2.3.2 Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.

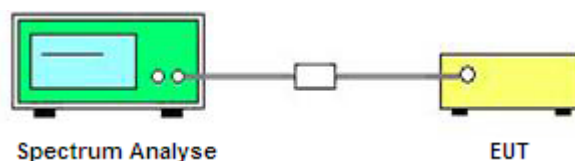

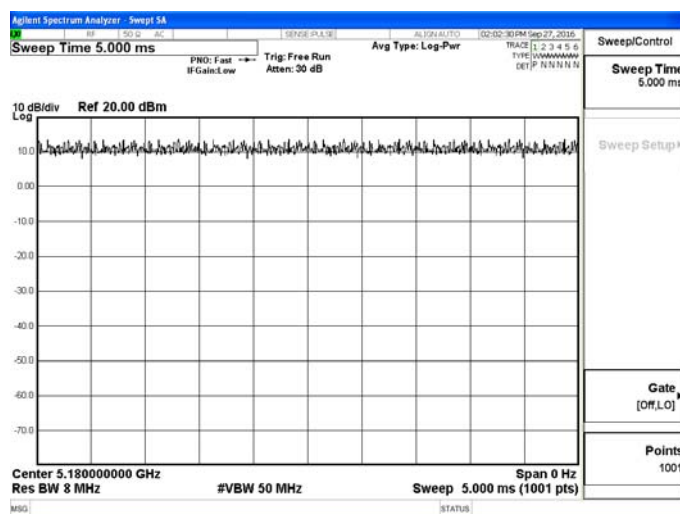

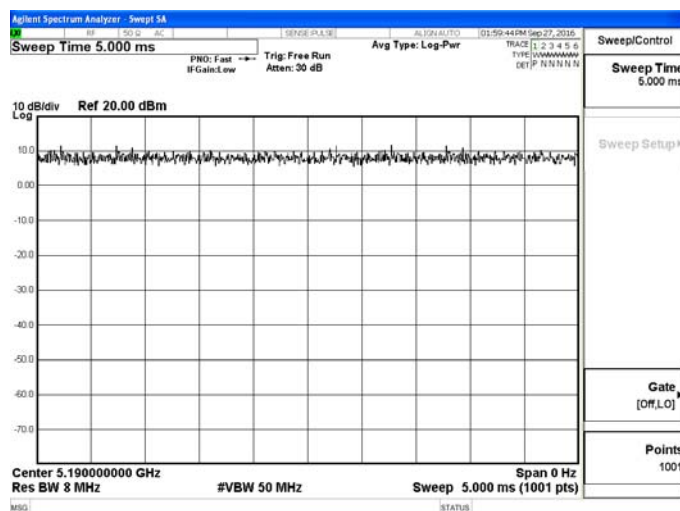

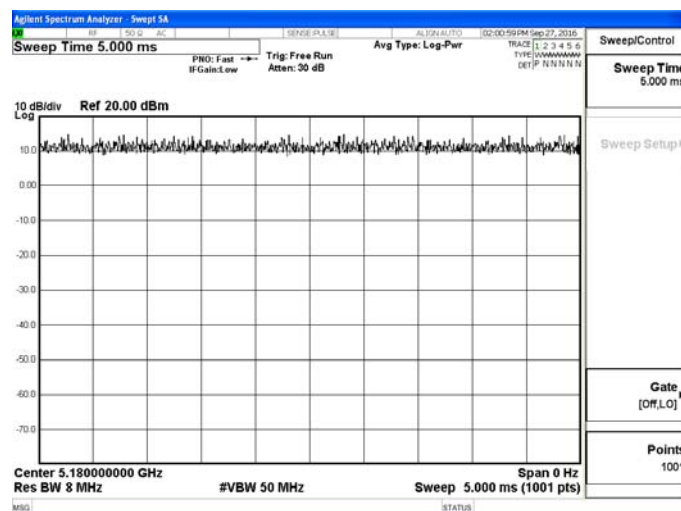
## IEEE 802.11n HT20



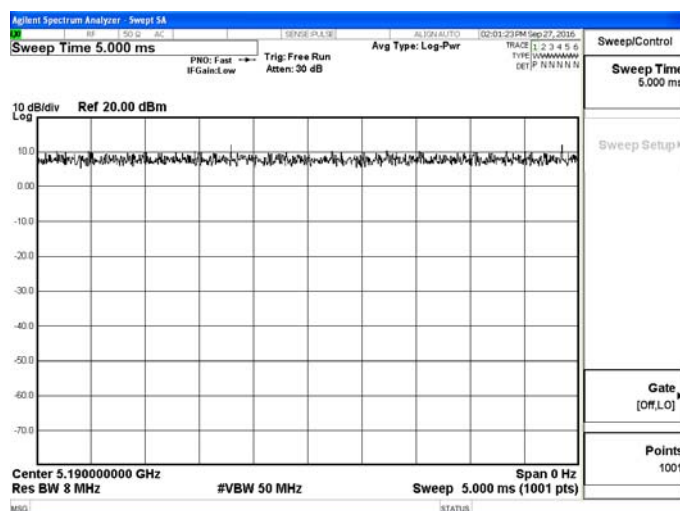

## 5.2. Maximum Conducted Output Power Measurement

### 5.2.1. Standard Applicable

#### For 5150~5250MHz

For client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

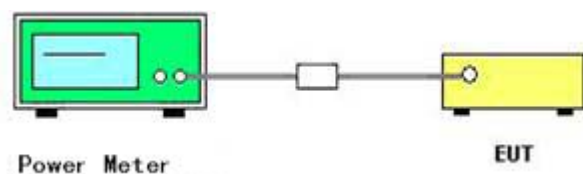
### 5.2.3. Test Procedures

The transmitter output (antenna port) was connected to the power meter.

According to KDB 789033 D02 Section 3 (a) Method PM (Measurement using an RF average power meter):

- (i) Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.
  - The EUT is configured to transmit continuously or to transmit with a constant duty cycle.
  - At all times when the EUT is transmitting, it must be transmitting at its maximum power control level.
  - The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- (ii) If the transmitter does not transmit continuously, measure the duty cycle,  $x$ , of the transmitter output signal as described in section II.B.
- (iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
- (iv) Adjust the measurement in dBm by adding  $10 \log (1/x)$  where  $x$  is the duty cycle (e.g.,  $10 \log (1/0.25)$  if the duty cycle is 25%).

#### 5.3.1. Standard Applicable

##### For 5150~5250MHz

According to §15.407 (a) (1) (ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

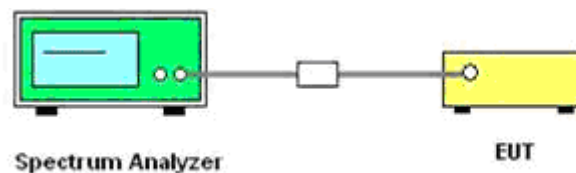
#### 5.3.2. Measuring Instruments and Setting

#### 5.3.3. Test Procedures

1. The transmitter was connected directly to a Spectrum Analyzer through a directional couple.
2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
3. Set the RBW = 1MHz.
4. Set the VBW  $\geq 3 \times$  RBW
5. Span=Encompass the entire emissions bandwidth (EBW) of the signal
6. Detector = peak.
7. Sweep time = auto couple.
8. Trace mode = max hold.
9. Allow trace to fully stabilize.
10. Use the peak marker function to determine the maximum power level in any 1MHz band segment within the fundamental EBW.

- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

### **Final measurement:**

- The final measurement will be performed with minimum the six highest peaks.

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 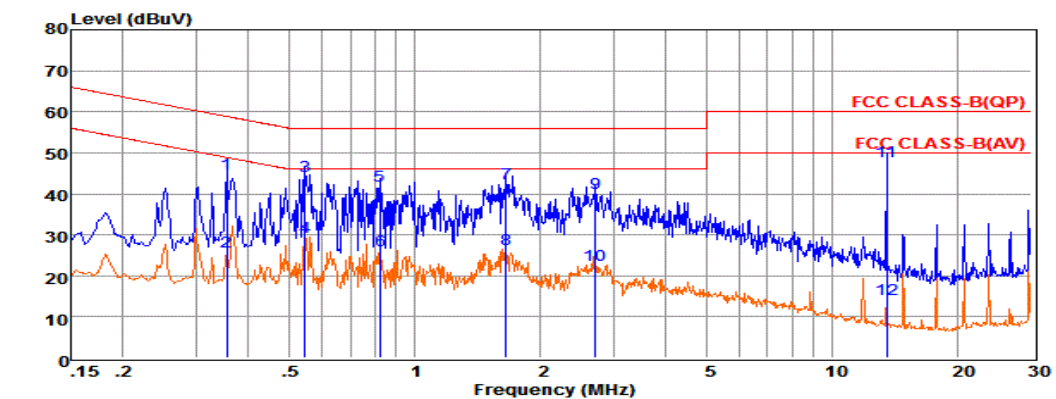
### 5.6.2 Block Diagram of Test Setup

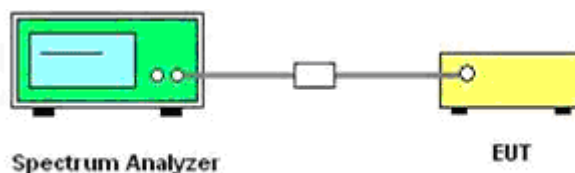
## 5.7. Undesirable Emissions Measurement

### 5.7.1 Test Requirements

According to §15.407 (b) Undesirable emission limits. Except as shown in paragraph (b) (7) of this section, the maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

- (1) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (2) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (3) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.
- (4) For transmitters operating in the 5.725-5.85 GHz band:
  - (i) All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.
  - (ii) Devices certified before March 2, 2017 with antenna gain greater than 10 dBi may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease by March 2, 2018. Devices certified before March 2, 2018 with antenna gain of 10 dBi or less may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease before March 2, 2020.
- (5) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
- (6) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in §15.207.
- (7) The provisions of §15.205 apply to intentional radiators operating under this section.
- (8) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency band edges as the design of the equipment permits.

### 5.7.3 Test Procedure

According to KDB789033 D02 General UNII Test Procedures New Rules v01 Section G: Unwanted Emission Measurement

1. Unwanted Emissions in the Restricted Bands
  - a) For all measurements, follow the requirements in section II.G.3. "General Requirements for Unwanted Emissions Measurements."
  - b) At frequencies below 1000 MHz, use the procedure described in section II.G.4. "Procedure for Unwanted Emissions Measurements below 1000 MHz."
  - c) At frequencies above 1000 MHz, measurements performed using the peak and average measurement procedures described in sections II.G.5. and II.G.6, respectively, must satisfy the respective peak and average limits. If all peak measurements satisfy the average limit, then average measurements are not required.

- d) For conducted measurements above 1000 MHz, EIRP shall be computed as specified in section II.G.3.b) and then field strength shall be computed as follows (see KDB Publication 412172):
  - (i)  $E[\text{dB}\mu\text{V/m}] = \text{EIRP}[\text{dBm}] - 20 \log(d[\text{meters}]) + 104.77$ , where E = field strength and d = distance at which field strength limit is specified in the rules;
  - (ii)  $E[\text{dB}\mu\text{V/m}] = \text{EIRP}[\text{dBm}] + 95.2$ , for d = 3 meters
- e) For conducted measurements below 1000 MHz, the field strength shall be computed as specified in d), above, and then an additional 4.7 dB shall be added as an upper bound on the field strength that would be observed on a test range with a ground plane for frequencies between 30 MHz and 1000 MHz, or an additional 6 dB shall be added for frequencies below 30 MHz.

## 2. Unwanted Emissions that fall Outside of the Restricted Bands

- a) For all measurements, follow the requirements in section II.G.3. "General Requirements for Unwanted Emissions Measurements."
- b) At frequencies below 1000 MHz, use the procedure described in section II.G.4. "Procedure for Unwanted Emissions Measurements below 1000 MHz."
- c) At frequencies above 1000 MHz, use the procedure for maximum emissions described in section II.G.5., "Procedure for Unwanted Maximum Unwanted Emissions Measurements Above 1000 MHz."
  - (i) Section 15.407(b) (1-3) specifies the unwanted emissions limit for the U-NII-1 and 2 bands. As specified, emissions above 1000 MHz that are outside of the restricted bands are subject to a peak emission limit of -27 dBm/MHz. However, an out-of-band emission that complies with both the average and peak limits of Section 15.209 is not required to satisfy the -27 dBm/MHz dBm/MHz peak emission limit.
  - (ii) Section 15.407(b) (4) specifies the unwanted emissions limit for the U-NII-3 band. A band emissions mask is specified in Section 15.407(b) (4) (i). An alternative to the band emissions mask is specified in Section 15.407(b) (4) (ii). The alternative limits are based on the highest antenna gain specified in the filing. There are also marketing and importation restrictions for the alternative limit.
- d) If radiated measurements are performed, field strength is then converted to EIRP as follows:
  - (i)  $\text{EIRP} = ((E \times d)^2) / 30$ 

Where:

    - E is the field strength in V/m;
    - d is the measurement distance in meters;
    - EIRP is the equivalent isotopically radiated power in watts;
  - (ii) Working in dB units, the above equation is equivalent to:
 
$$\text{EIRP} [\text{dBm}] = E [\text{dB}\mu\text{V/m}] + 20 \log(d [\text{meters}]) - 104.77$$
  - (iii) Or, if d is 3 meters:
 
$$\text{EIRP} [\text{dBm}] = E [\text{dB}\mu\text{V/m}] - 95.2$$

## 5.8. Antenna Requirements

### 5.8.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.407, For client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

### 5.8.2 Antenna Connected Construction

#### 5.8.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

#### 5.8.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 0.5dBi, and the antenna is an internal antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.

The WLAN and Bluetooth share same antenna.

#### 5.8.2.3. Results: Compliance.
