Wired Network Connection Set Up

The Outdoor Camera works with a network connected cable. You can plug in your working cable to the socket of the device.

Add Outdoor Camera to your account

- Please make sure your Outdoor Camera is in the same network with your Smart Station.
- Log in LifeSmart App, click **“Setting”**-**“Advanced Settings”**-**“Add Configured Smart Device”**-**“Search”**, then click on the searched IP address.

Add Outdoor Camera to your Smart Station

- After configuration of the Smart Station, choose **“Add Device to Smart Station”** and choose a Smart Station, wait until your Outdoor Camera is discovered, choose Outdoor Camera and click confirm to complete setup.
