Thus the module test results were leveraged in this report and additionally reporting the spot check results in this report.
- In normal mode, Conducted power was verified to be consistent with the original modular approval, so the output power level in the original modular grant is referenced in this report for determining ERP of this host product, and verified the TX switching mode of Radiated Spurious Emission and Conducted power.



| Remark | The mark "v " means that this configuration is chosen for testing The mark "-" means that this bandwidth is not supported. The device is investigated from 30MHz to 10 times of fundamental signal for radiated spurious emission test under different RB size/offset and modulations in exploratory test. Subsequently, only the worst case emissions are reported. For modulation of 256QAM, the maximum power of 256QAM is lower than other modulation (QPSK/16QAM/64QAM), therefore, according to engineering evaluation, we choose higher power (QPSK/16QAM/64QAM) to perform all tests and show in the report. 3.2 Conducted Output Power Measurement and ERP

3.2.1 Description of the Conducted Output Power Measurement and ERP Measurement

A base station simulator was used to establish communication with the EUT. Its parameters were set to transmit the maximum power on the EUT. The measured power in the radio frequency on the transmitter output terminals shall be reported.

The ERP of mobile transmitters must not exceed 3 Watts for LTE Band 14.

According to KDB 412172 D01 Power Approach,

 $EIRP = P_T + G_T - L_C$, ERP = EIRP - 2.15, where

 P_T = transmitter output power in dBm

 G_T = gain of the transmitting antenna in dBi

 L_{C} = signal attenuation in the connecting cable between the transmitter and antenna in dB

3.2.2 Test Procedures

- 1. The transmitter output port was connected to base station.
- 2. Set EUT at maximum power through base station.
- 3. Select lowest, middle, and highest channels for each band and different modulation.
- 4. Measure and record the power level from the system simulator.







For radiated test below 30MHz




For radiated test from 30MHz to 1GHz

4.1.2 Test Result of Radiated Test

Note:

The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported.

There is adequate comparison measurement of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site v01r01, and the result came out very similar.



4.2 Radiated Spurious Emission

4.2.1 Description of Radiated Spurious Emission

The radiated spurious emission was measured by substitution method according to ANSI / TIA-603-E. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least 43 + 10 log (P) dB.

For operations in the 758-775 MHz and 788-805 MHz bands, all emissions including harmonics in the band 1559–1610 MHz shall be limited to -70 dBW/MHz equivalent isotropically radiated power (EIRP) for wideband signals, and -80 dBW EIRP for discrete emissions of less than 700 Hz bandwidth. For the purpose of equipment authorization, a transmitter shall be tested with an antenna that is representative of the type that will be used with the equipment in normal operation.

The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

4.2.2 Test Procedures

The testing follows FCC KDB 971168 D01 v03r01 Section 7 and ANSI / TIA-603-E Section 2.2.12.

- 1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
- 3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
- 4. The height of the receiving antenna is varied between one meter and four meters to search the maximum spurious emission for both horizontal and vertical polarizations.
- 5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, Sweep = 500ms, Taking the record of maximum spurious emission.
- 6. A horn antenna was substituted in place of the EUT and was driven by a signal generator.
- 7. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission.
- 8. Taking the record of output power at antenna port.
- 9. Repeat step 7 to step 8 for another polarization.
- 10. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
- 11. The limit line is derived from 43 + 10log(P)dB below the transmitter power P(Watts)
