

3 TEST TYPES AND RESULTS

3.1 OUTPUT POWER MEASUREMENT

3.1.1 LIMITS OF OUTPUT POWER MEASUREMENT

27.50(c)(10) Portable stations (hand-held devices) in the 600 MHz uplink band and the 698-746 MHz band, and fixed and mobile stations in the 600 MHz uplink band are limited to 3 watts ERP.

3.1.2 TEST PROCEDURES

EIRP / ERP MEASUREMENT:

 G_{T} = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);

Lc = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

CONDUCTED POWER MEASUREMENT:

- a. The EUT was set up for the maximum power with LTE link data modulation and link up with simulator.
- b. Set the EUT to transmit under low, middle and high channel and record the power level shown on simulator.

3.2 FREQUENCY STABILITY MEASUREMENT

3.2.1 LIMITS OF FREQUENCY STABILIITY MEASUREMENT


The frequency stability shall be sufficient to ensure that the fundamental emissions stay within the authorized bands of operation.

3.2.2 TEST PROCEDURE

- a. Device is placed at the oven room. The oven room could control the temperatures and humidity. Power warm up is at least 15 min and power applied should perform before recording frequency error.
- b. EUT is connected the external power supply to control the DC input power. The test voltage range is from minimum to maximum working voltage. Each step shall be record the frequency error rate.
- c. The temperature range step is 10 degrees in this test items. All temperature levels shall be hold the ±0.5°C during the measurement testing. The each temperature step shall be at least 0.5 hours, consider the EUT could be test under the stability condition.

NOTE: The frequency error was recorded frequency error from the communication simulator.




3.3 OCCUPIED BANDWIDTH MEASUREMENT

3.3.1 LIMITS OF OCCUPIED BANDWIDTH MEASUREMENT

The width of a frequency band such that, below the lower and above the upper frequency limits, the mean powers emitted are each equal to a specified percentage 0.5 % of the total mean power of a given emission.

3.3.2 TEST SETUP

- a. The conducted occupied bandwidth used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer.
- b. Use OBW measurement function of Spectrum analyzer to measure 99 % occupied bandwidth.




3.4 PEAK TO AVERAGE RATIO

3.4.1 LIMITS OF PEAK TO AVERAGE RATIO MEASUREMENT

In measuring transmissions in this band using an average power technique, the peak to-average ratio (PAR) of the transmission may not exceed 13 dB


3.5 BAND EDGE MEASUREMENT

3.5.1 LIMITS OF BAND EDGE MEASUREMENT

The power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least 43 + 10 log (P) dB. Compliance with this provision is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kilohertz or greater.

However, in the 100 kilohertz bands immediately outside and adjacent to a licensee's frequency block, a resolution bandwidth of at least 30 kHz may be employed.

3.5.3 TEST PROCEDURES

- a. The EUT was set up for the maximum peak power with LTE link data modulation. The power was measured with R&S Spectrum Analyzer. All measurements were done at 2 channels (low and high operational frequency range.).
- b. The band edge measurement used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer.
- c. The center frequency of spectrum is the band edge frequency and span is 1~5 MHz. RBW of the spectrum is 50kHz and VBW of the spectrum is 200kHz. (LTE bandwidth 5MHz)
- d. The center frequency of spectrum is the band edge frequency and span is 1~5 MHz. RBW of the spectrum is 100kHz and VBW of the spectrum is 300kHz. (LTE bandwidth 10MHz)


3.6.1 LIMITS OF CONDUCTED SPURIOUS EMISSIONS MEASUREMENT

The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least $43 + 10 \log 10(P) dB$. The limit of emission equal to -13dBm

3.6.2 TEST PROCEDURE

- a. The EUT makes a phone call to the communication simulator. All measurements were done at middle operational frequency range.
- b. Measuring frequency range is from 30 MHz to 7.2GHz for LTE Band 17. 10dB attenuation pad is connected with spectrum. RBW=1MHz and VBW=3MHz are used for conducted emission measurement.

3.7 RADIATED EMISSION MEASUREMENT

3.7.1 LIMITS OF RADIATED EMISSION MEASUREMENT

The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least $43 + 10 \log 10(P) dB$. The limit of emission equal to -13dBm

3.7.2 TEST PROCEDURES

- a. Substitution method is used for E.I.R.P measurement. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
- b. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to "Read Value" of step a. Record the power level of S.G
- c. EIRP = Output power level of S.G TX cable loss + Antenna gain of substitution horn.
- d. E.R.P power can be calculated form E.I.R.P power by subtracting the gain of dipole, E.R.P power = E.I.P.R power 2.15dBi.

NOTE: The resolution bandwidth of spectrum analyzer is 1 MHz and the video bandwidth is 3 MHz.
