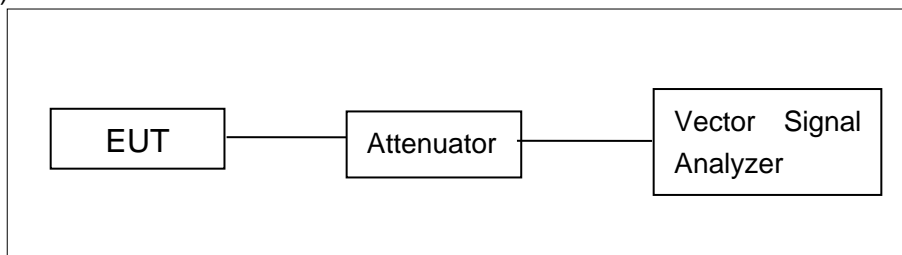
## **ANNEX A: Detailed Test Results**

### **Test Configuration:**

The measurement is made according to ANSI C63.10.

### **Conducted Measurements**

- 1). Connect the EUT to the test system correctly.
- 2). Set the EUT to the required work mode.
- 3). Set the EUT to the required channel.
- 4). Set the spectrum analyzer to start measurement.
- 5). Record the values.

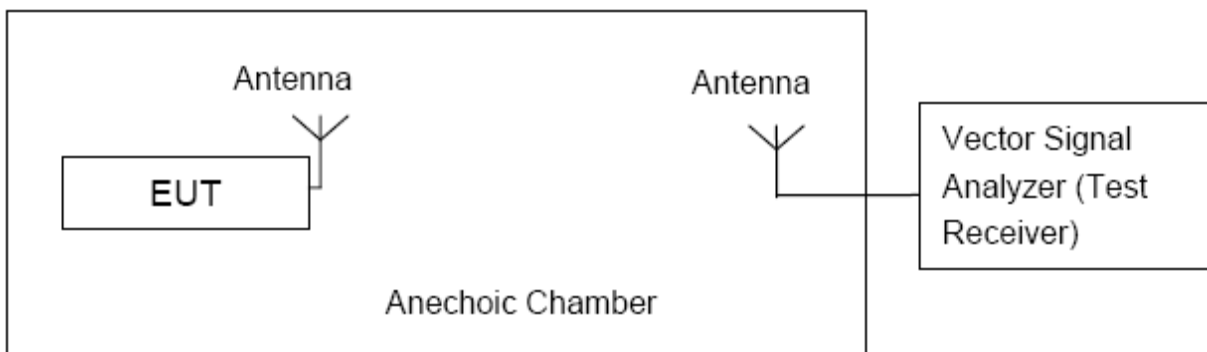


### **Radiated Emission Measurements**

In the case of radiated emission, the used settings are as follows:

Sweep frequency from 30 MHz to 1 GHz, RBW = 100 KHz, VBW = 300 KHz;

Sweep frequency from 1 GHz to 26 GHz, RBW = 1 MHz, VBW = 10 Hz;



The measurement is made according to KDB 789033.

The radiated emission test is performed in semi-anechoic chamber. The distance from the EUT to the reference point of measurement antenna is 3m. The test is carried out on both vertical and horizontal polarization and only maximization result of both polarizations is kept. During the test, the turntable is rotated 360° and the measurement antenna is moved from 1m to 4m to get the maximization result.



**A.0 Antenna requirement**

**Measurement Limit:**

The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. The RF transmitter uses an integrate antenna without connector.**

Method PM-G is a measurement using a gated RF average power meter.

Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Because the measurement is made only during the ON time of the transmitter, no duty cycle correction factor is required.

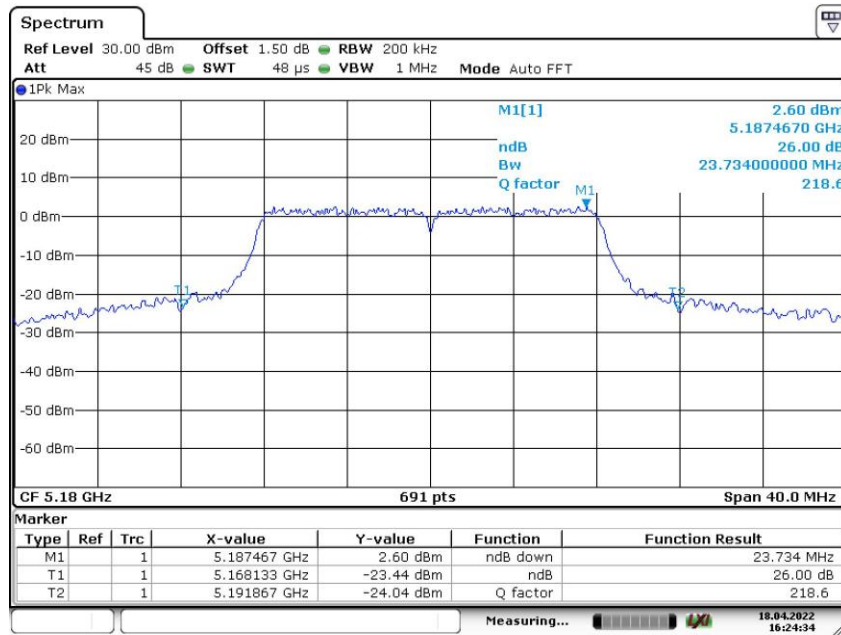

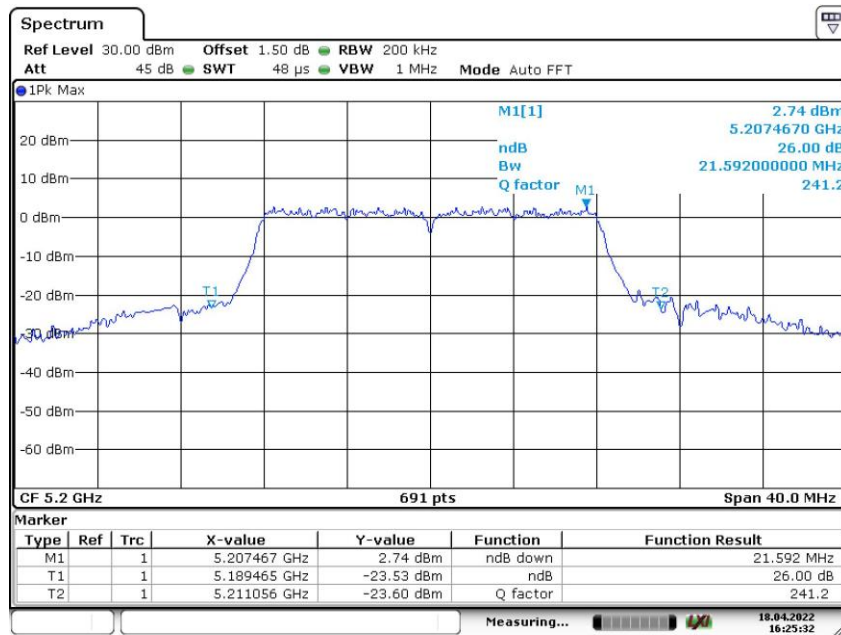

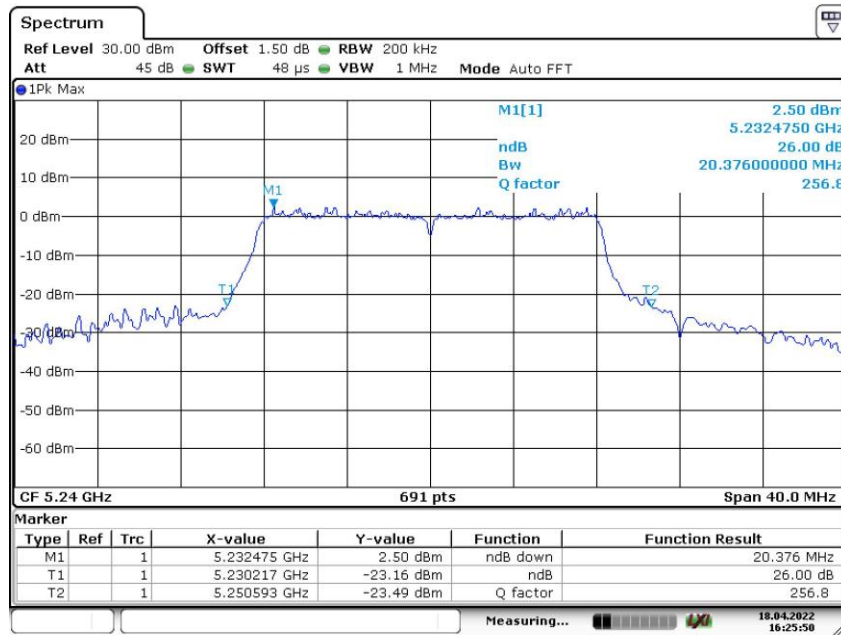

**Fig. 1 Occupied 26dB Bandwidth (802.11a, 5180MHz)**



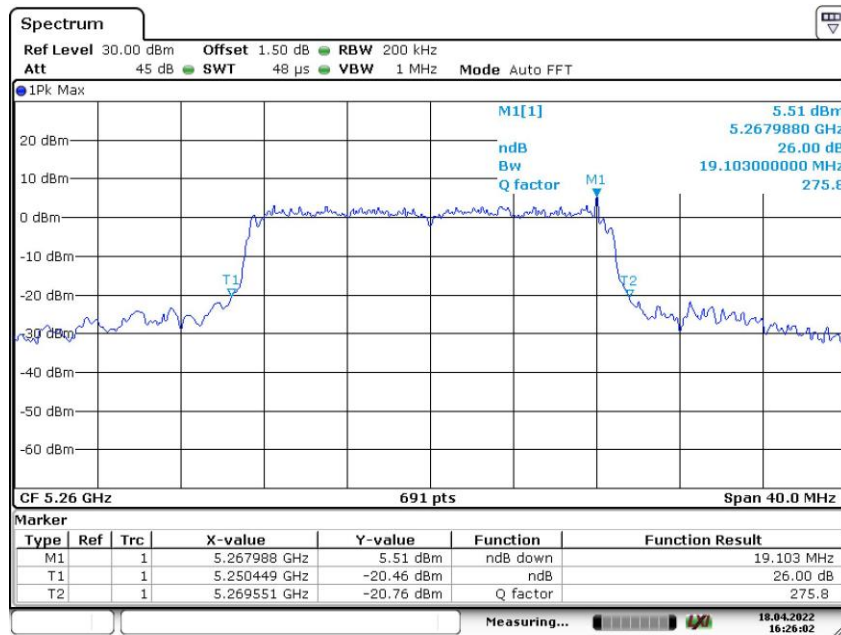

**Fig. 2 Occupied 26dB Bandwidth (802.11a, 5200MHz)**



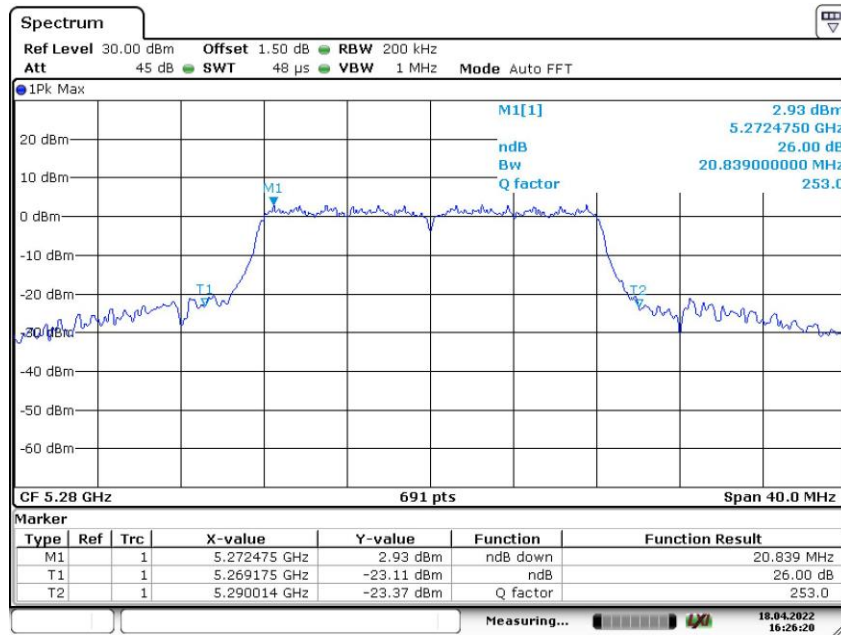

**Fig. 3 Occupied 26dB Bandwidth (802.11a, 5240MHz)**



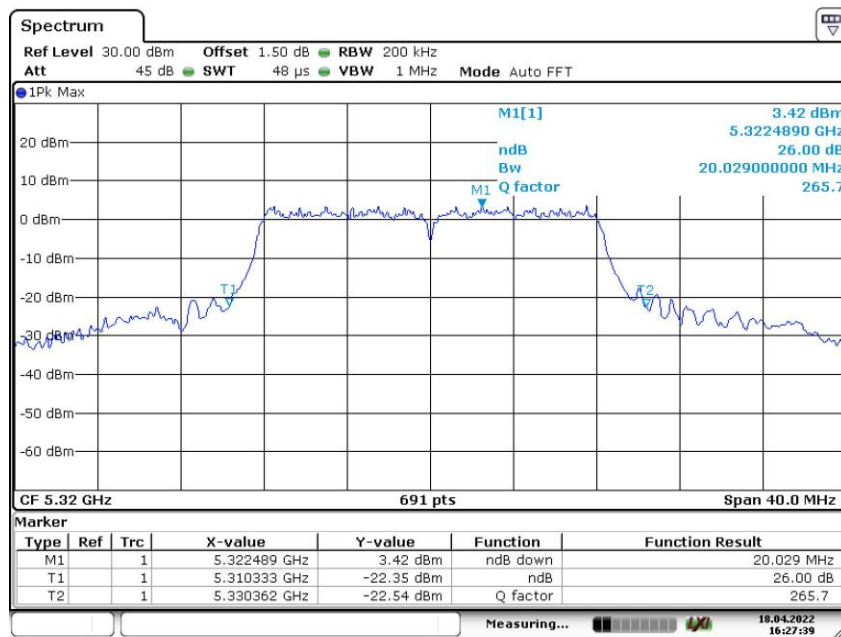

**Fig. 4 Occupied 26dB Bandwidth (802.11a, 5260MHz)**



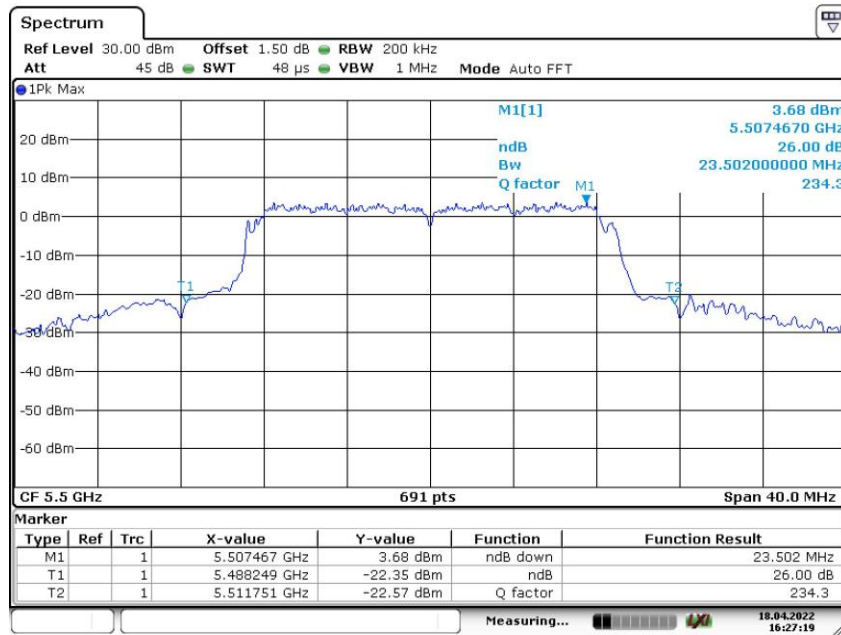

**Fig. 5 Occupied 26dB Bandwidth (802.11a, 5280MHz)**



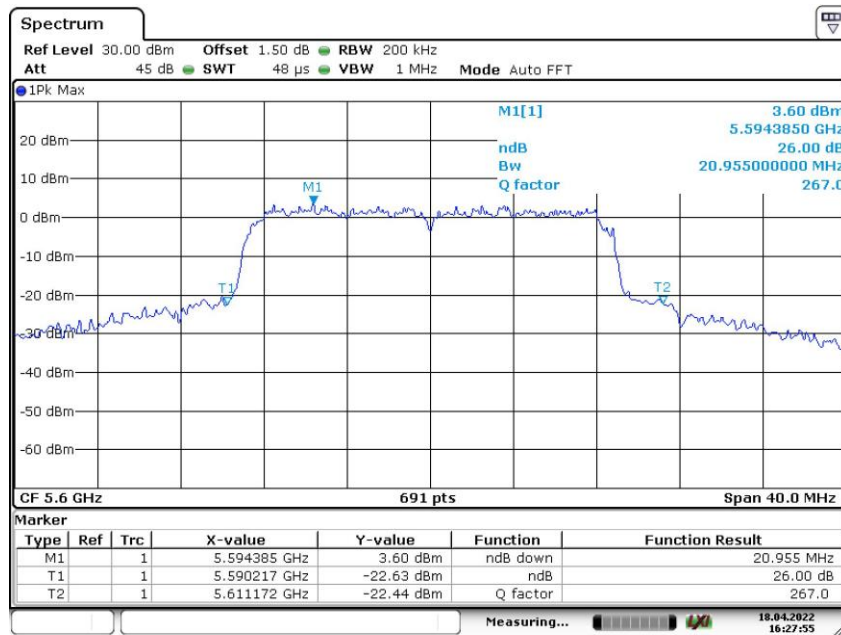

**Fig. 6 Occupied 26dB Bandwidth (802.11a, 5320MHz)**



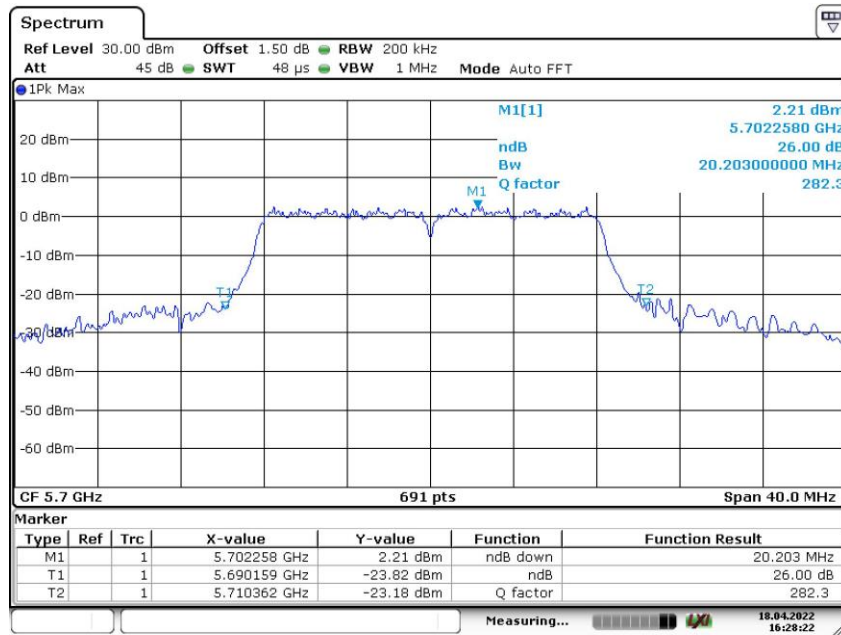

**Fig. 7 Occupied 26dB Bandwidth (802.11a, 5500MHz)**



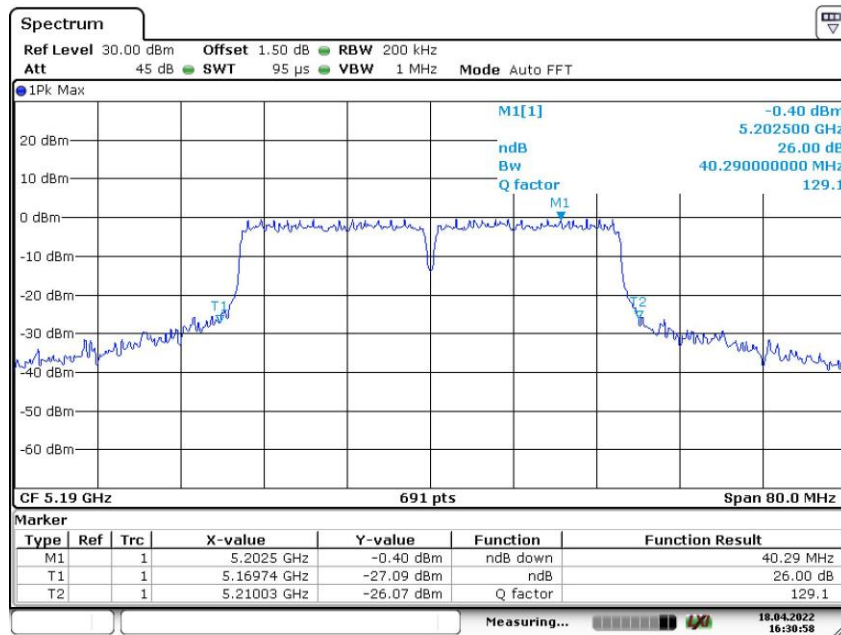

**Fig. 8 Occupied 26dB Bandwidth (802.11a, 5600MHz)**



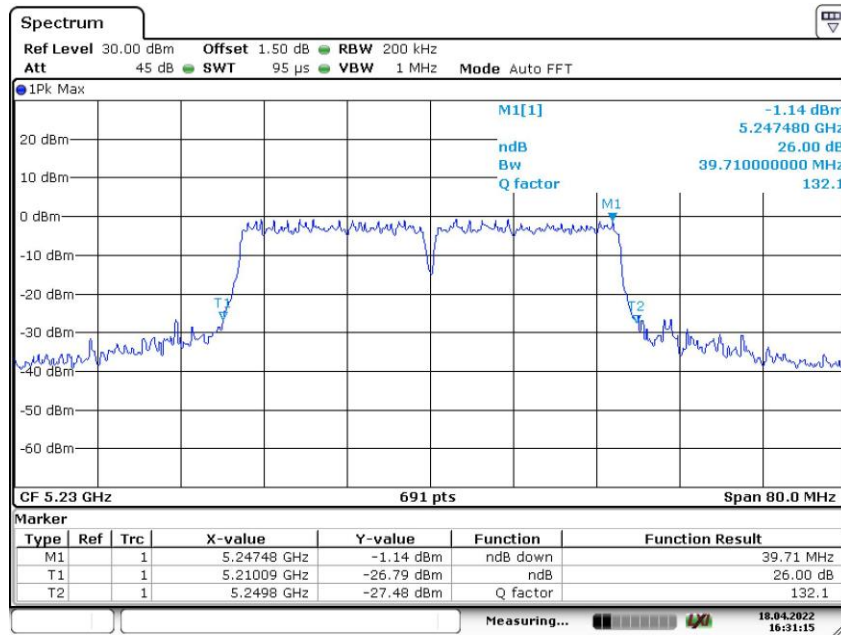

**Fig. 9 Occupied 26dB Bandwidth (802.11a, 5700MHz)**



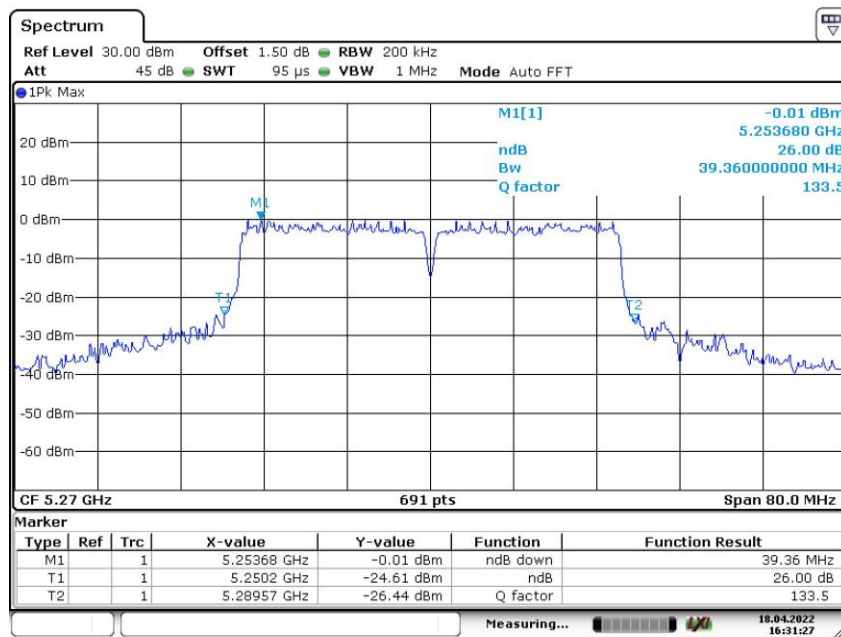

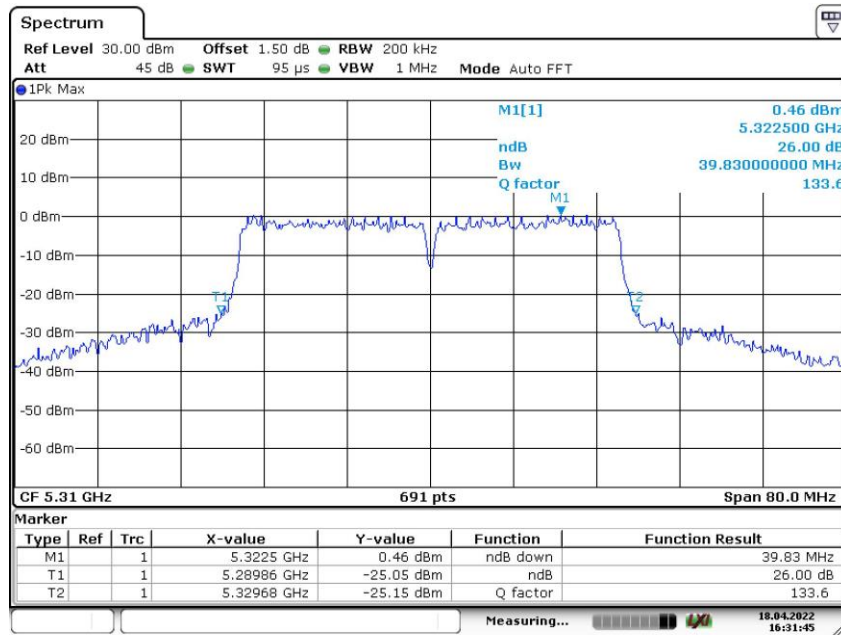
**Fig. 11 Occupied 26dB Bandwidth (802.11n-HT40, 5230MHz)**

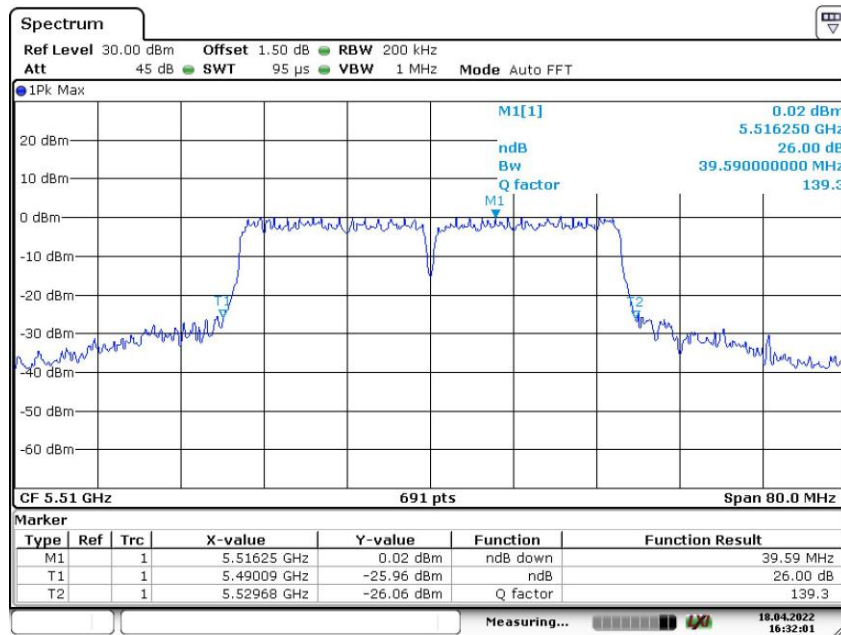
**Fig. 12 Occupied 26dB Bandwidth (802.11n-HT40, 5270MHz)**





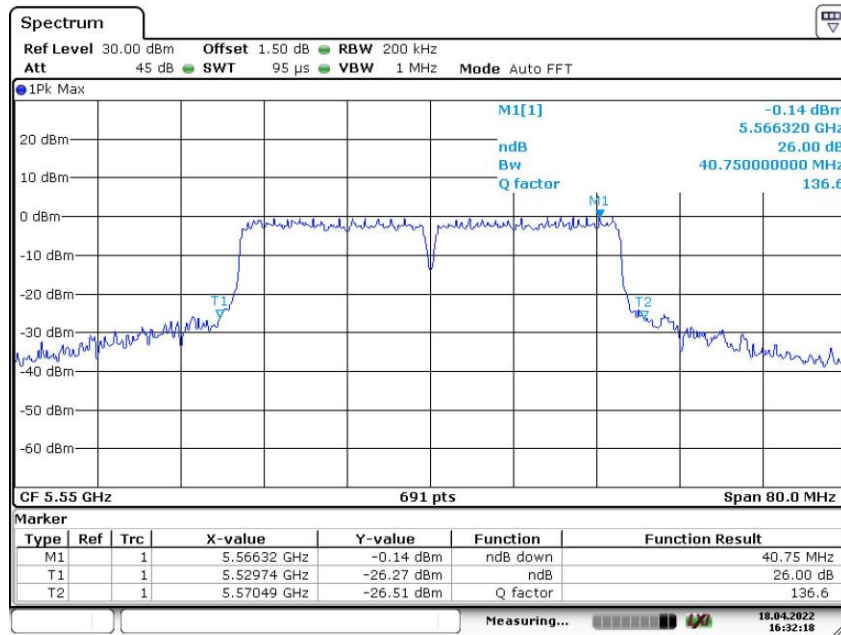

**Fig. 13 Occupied 26dB Bandwidth (802.11n-HT40, 5310MHz)**



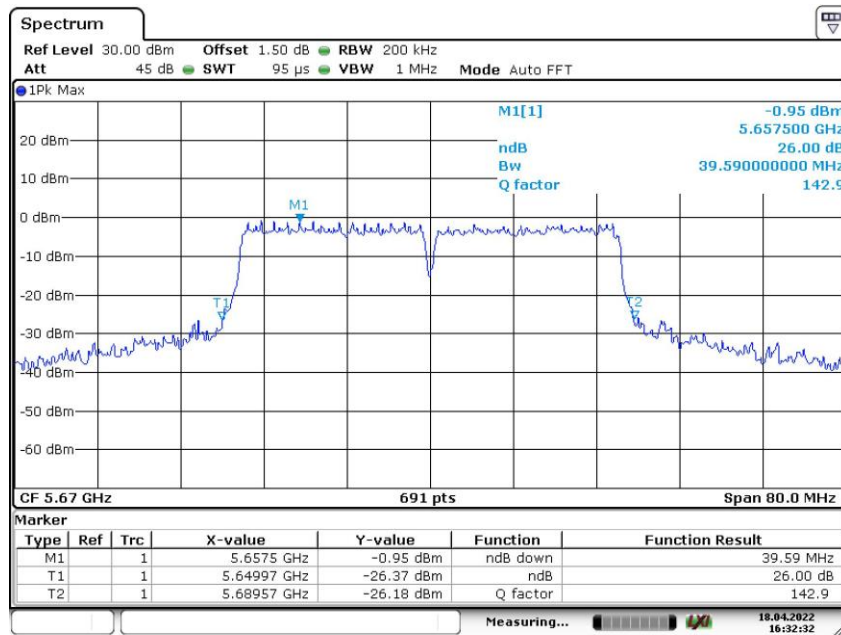

**Fig. 14 Occupied 26dB Bandwidth (802.11n-HT40, 5510MHz)**



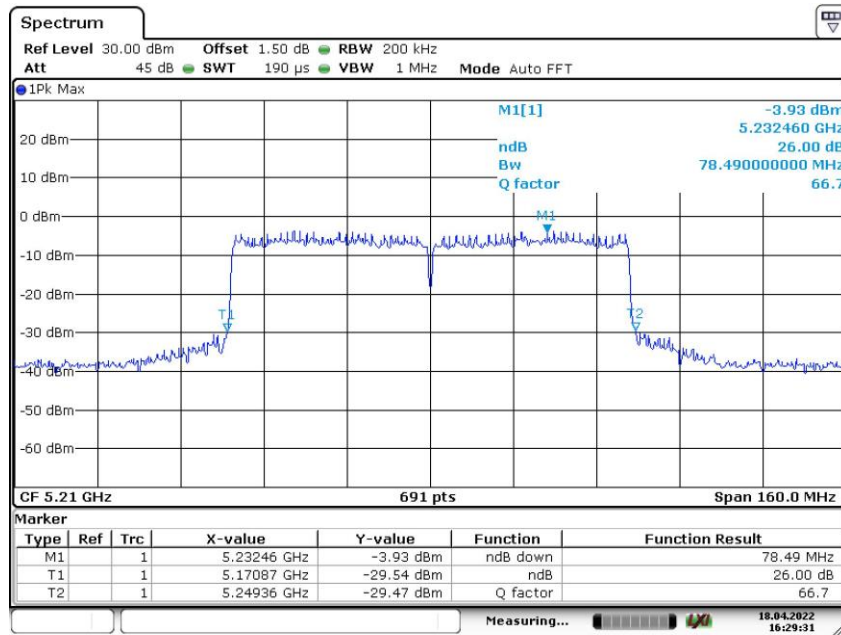

**Fig. 15 Occupied 26dB Bandwidth (802.11n-HT40, 5550MHz)**



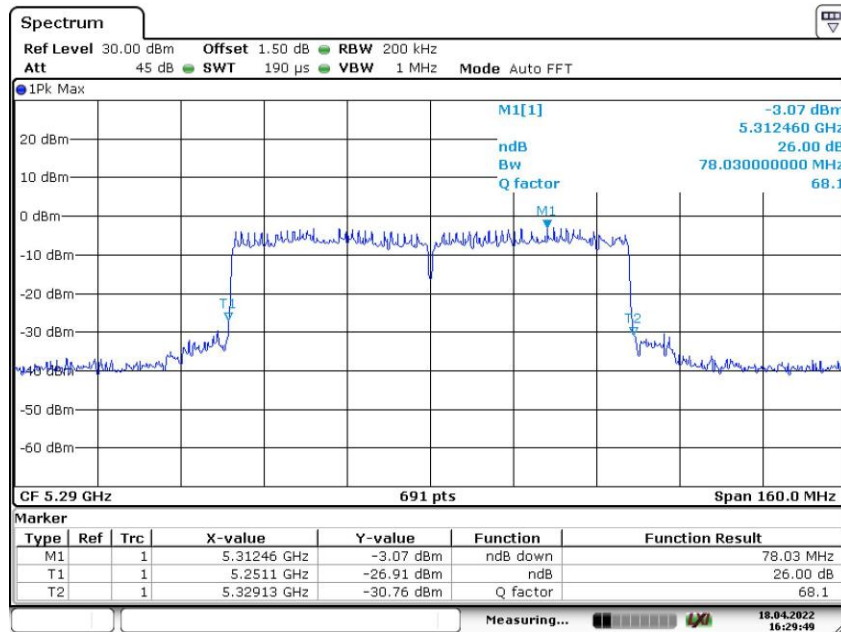

**Fig. 16 Occupied 26dB Bandwidth (802.11n-HT40, 5670MHz)**



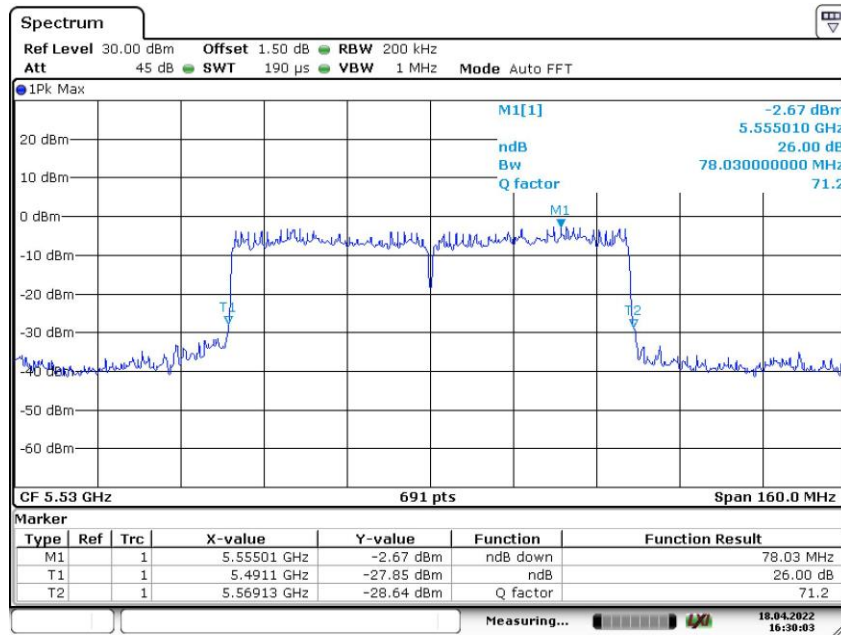

Fig. 17 Occupied 26dB Bandwidth (802.11ac-VHT80, 5210MHz)



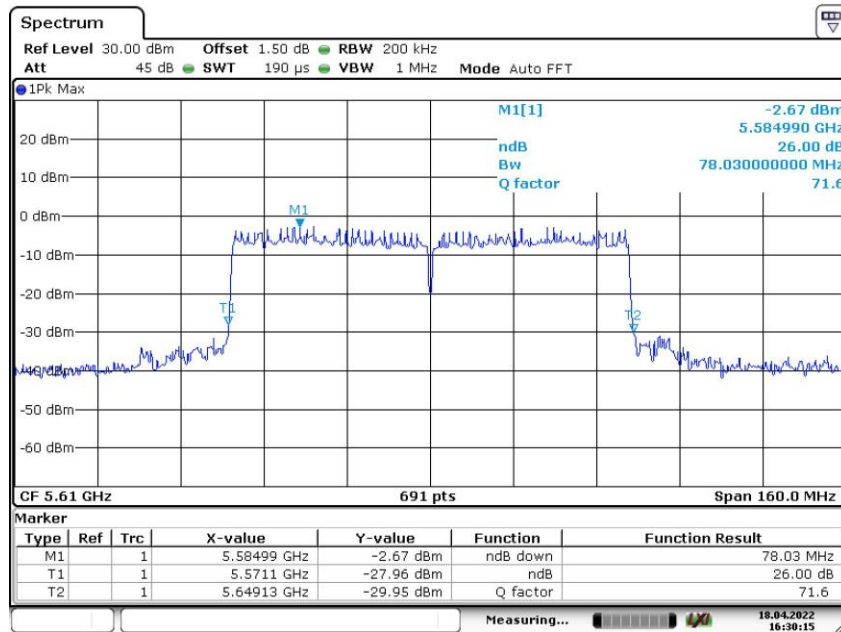

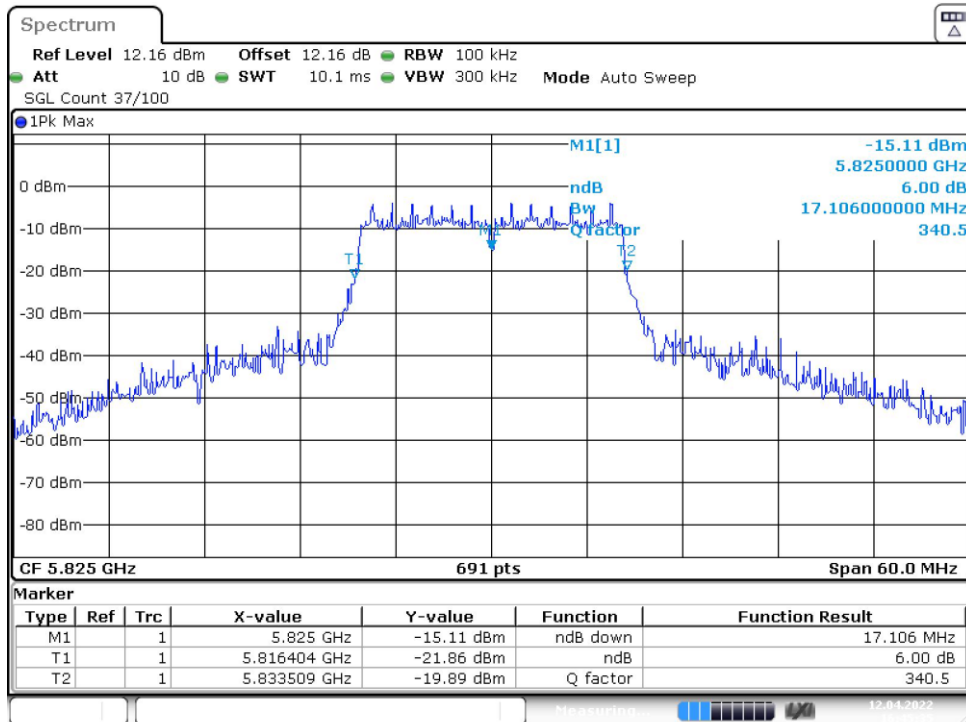

Fig. 21 Occupied 6dB Bandwidth (802.11a, 5745MHz)



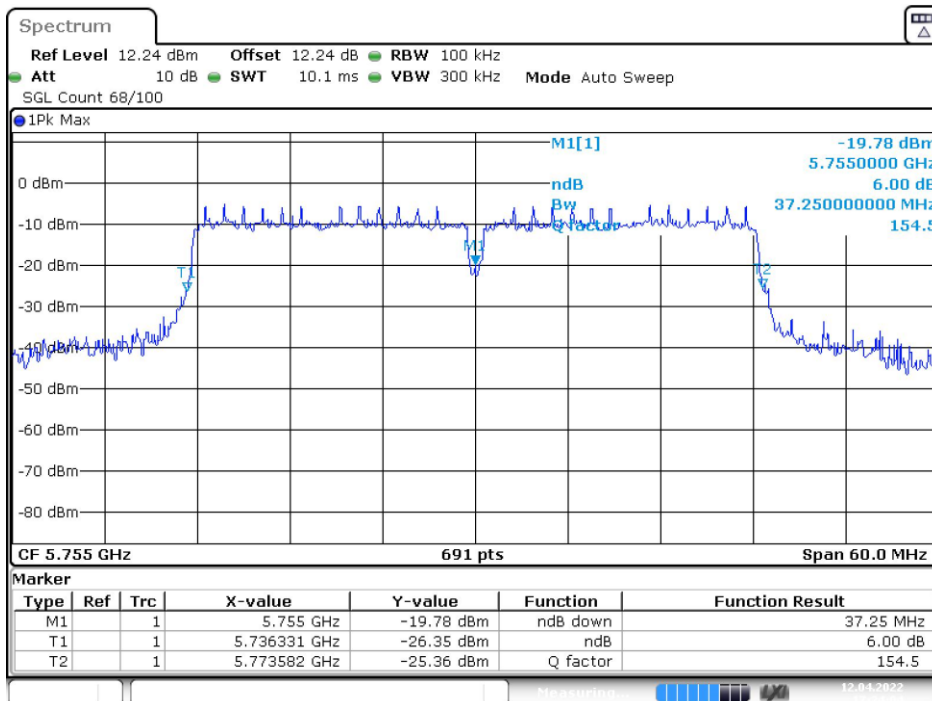

Fig. 22 Occupied 6dB Bandwidth (802.11a, 5785MHz)



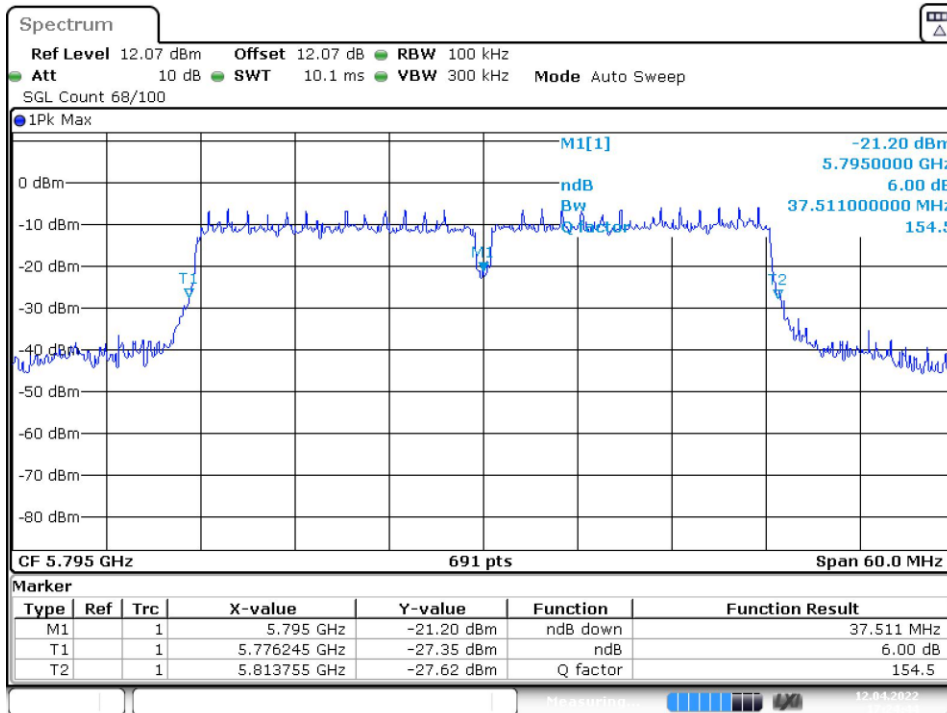

**Fig. 23 Occupied 6dB Bandwidth (802.11a, 5825MHz)**



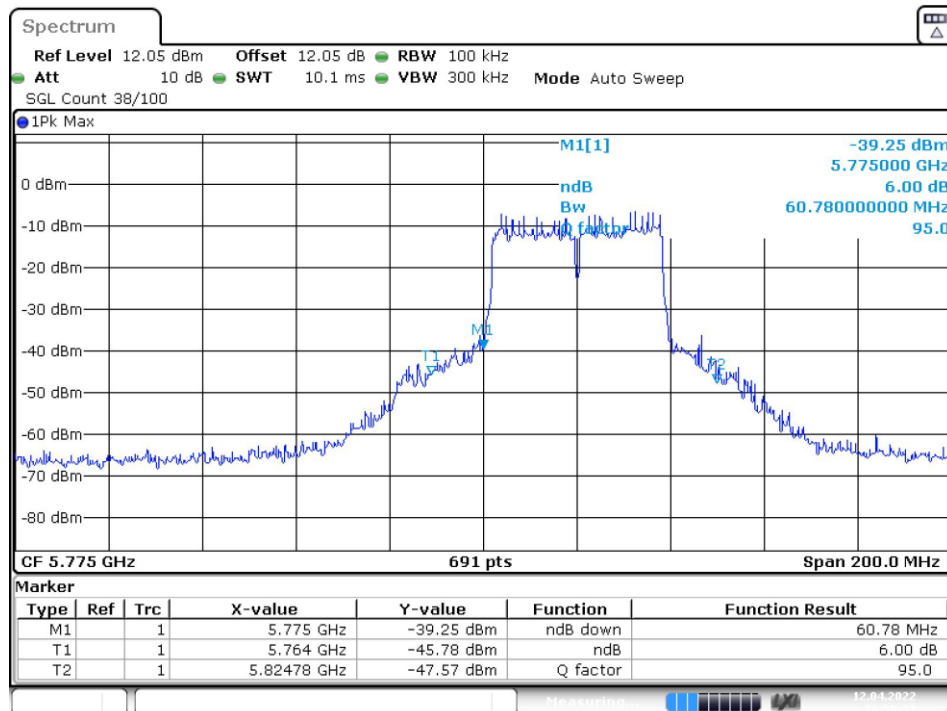

**Fig. 27 99% Occupied Bandwidth (802.11a, 5180MHz)**



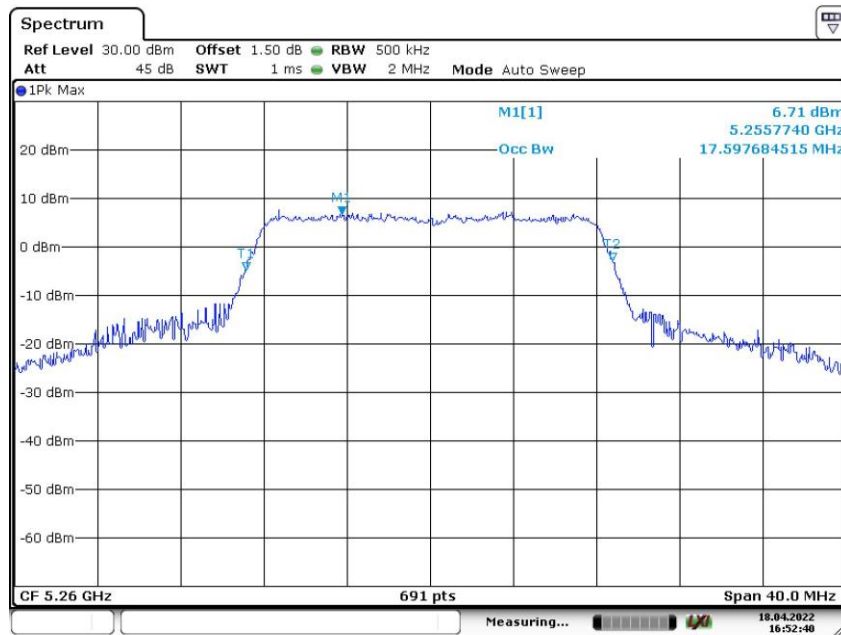

**Fig. 28 99% Occupied Bandwidth (802.11a, 5220MHz)**



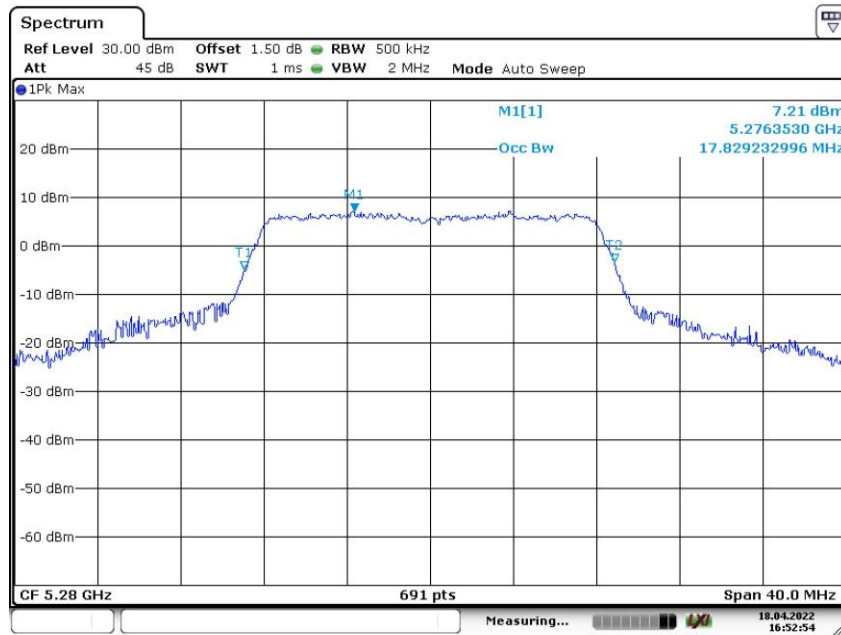

**Fig. 29 99% Occupied Bandwidth (802.11a, 5240MHz)**



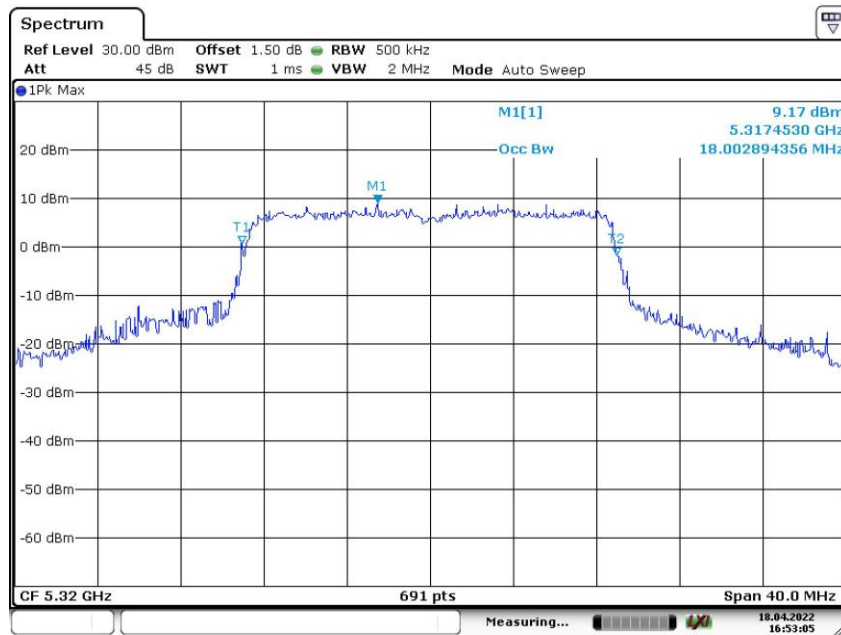

**Fig. 30 99% Occupied Bandwidth (802.11a, 5260MHz)**



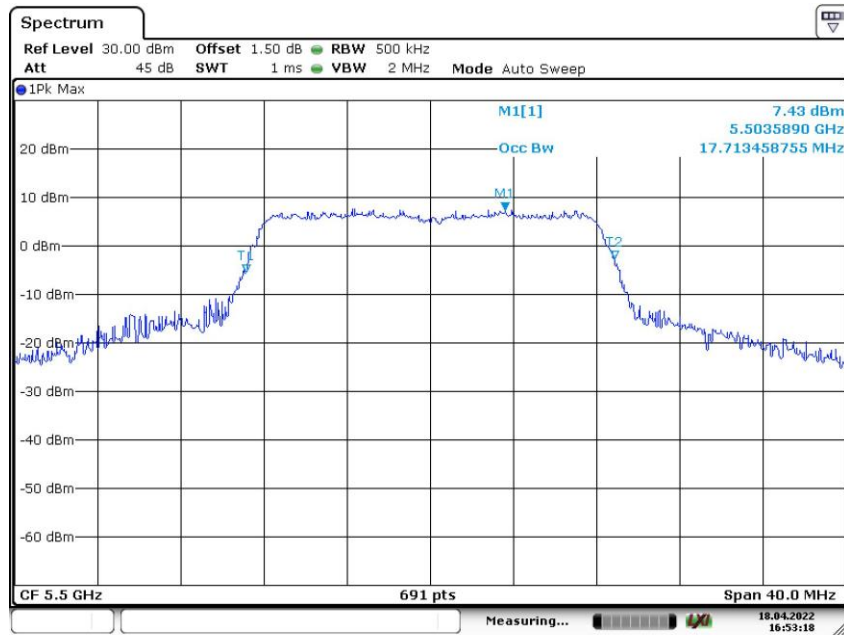

**Fig. 31 99% Occupied Bandwidth (802.11a, 5280MHz)**



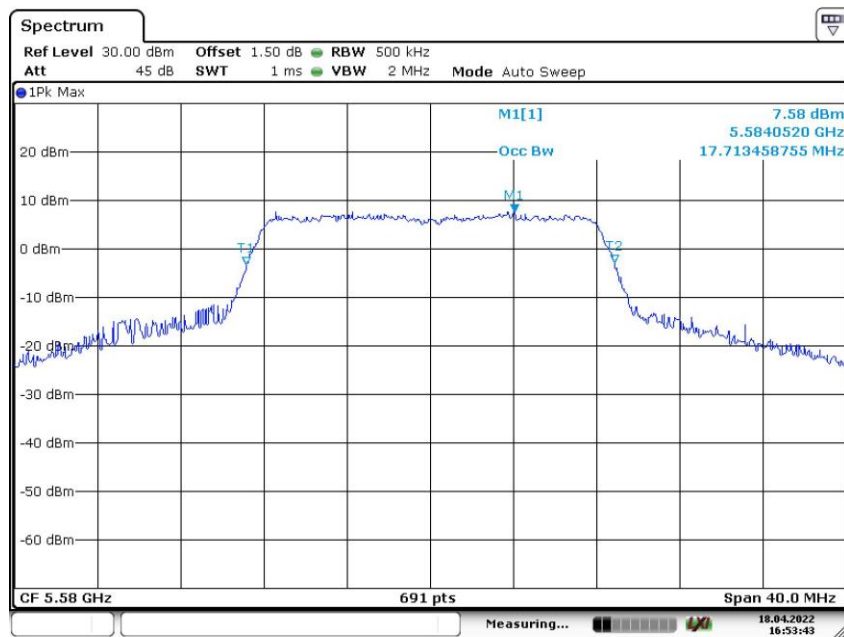

**Fig. 32 99% Occupied Bandwidth (802.11a, 5320MHz)**



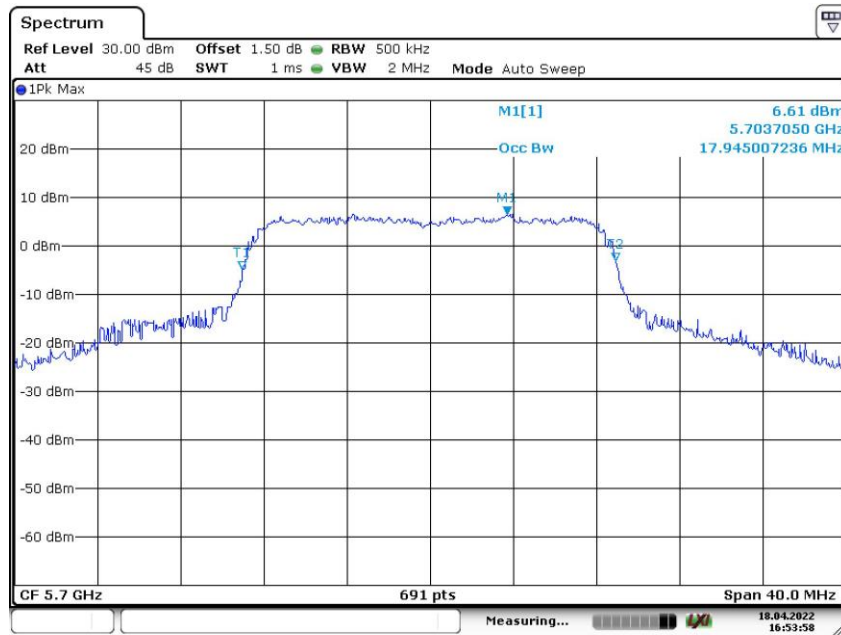

**Fig. 33 99% Occupied Bandwidth (802.11a, 5500MHz)**



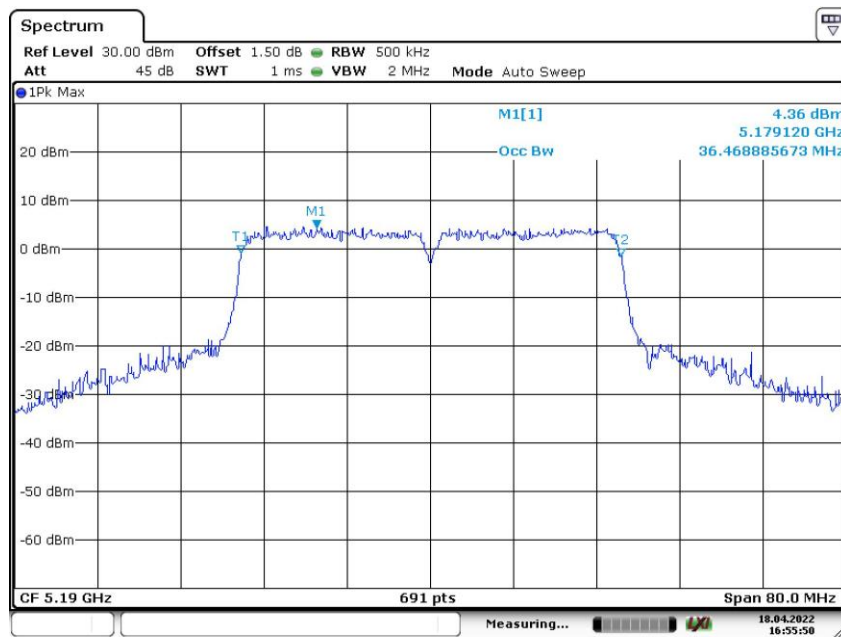

**Fig. 34 99% Occupied Bandwidth (802.11a, 5580MHz)**



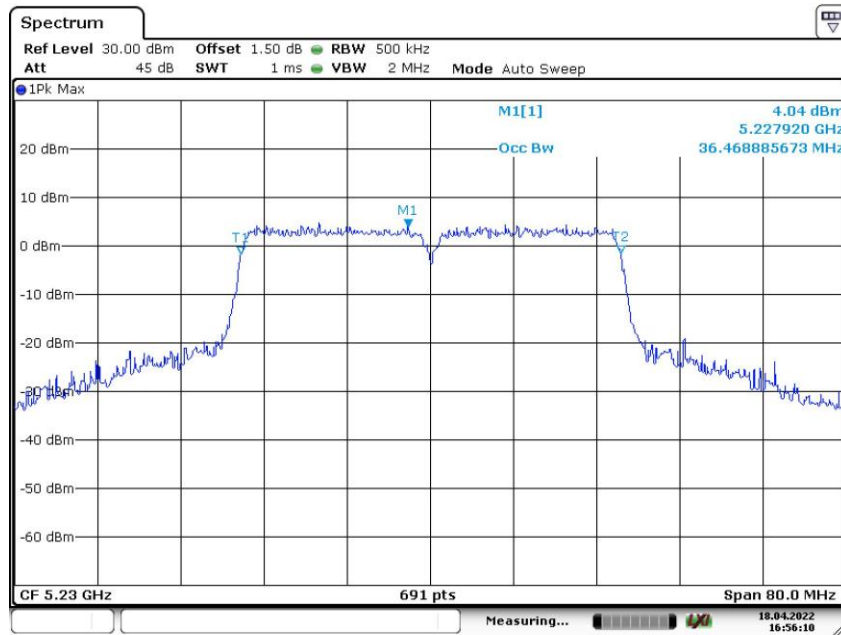

**Fig. 35 99% Occupied Bandwidth (802.11a, 5700MHz)**



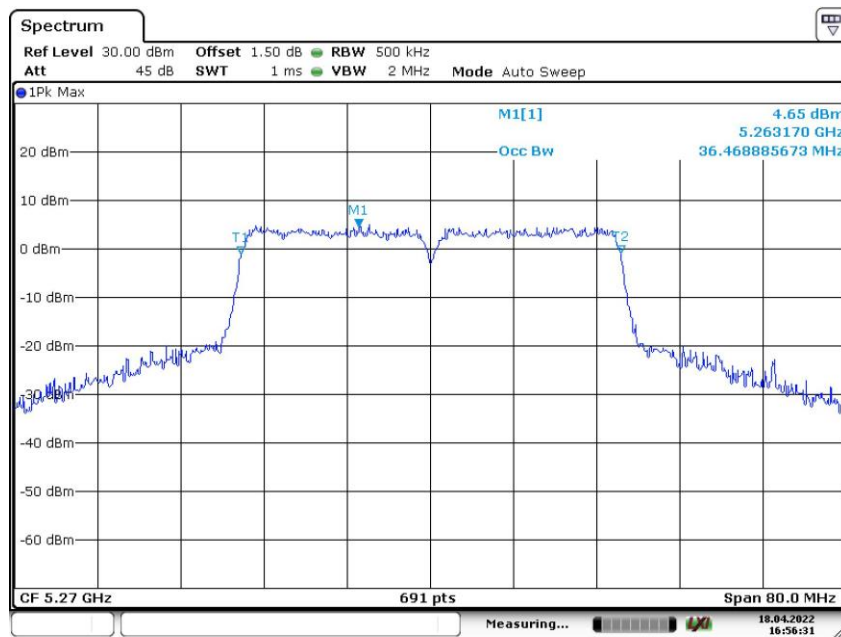

**Fig. 36 99% Occupied Bandwidth (802.11n-HT40, 5190MHz)**



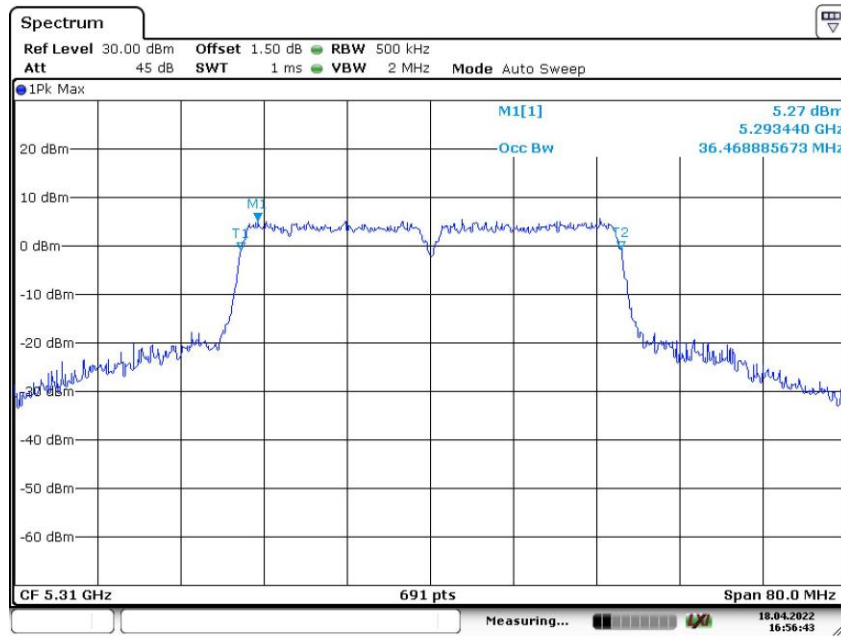

**Fig. 37 99% Occupied Bandwidth (802.11n-HT40, 5230MHz)**



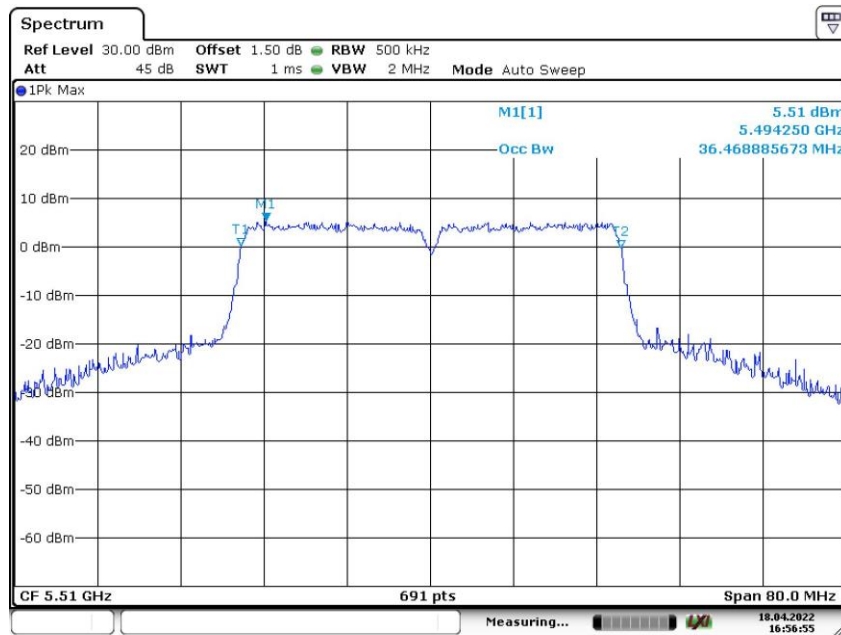

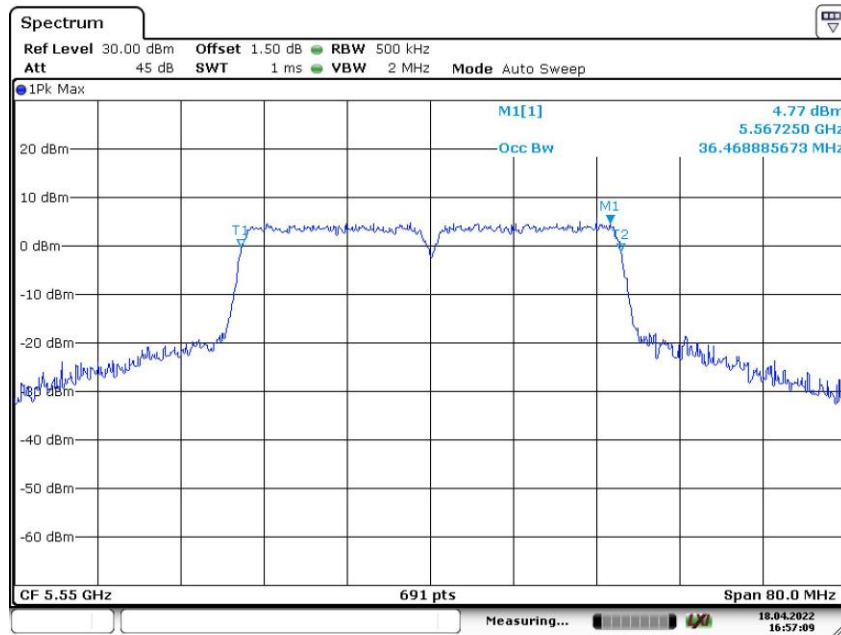
**Fig. 39 99% Occupied Bandwidth (802.11n-HT40, 5310MHz)**

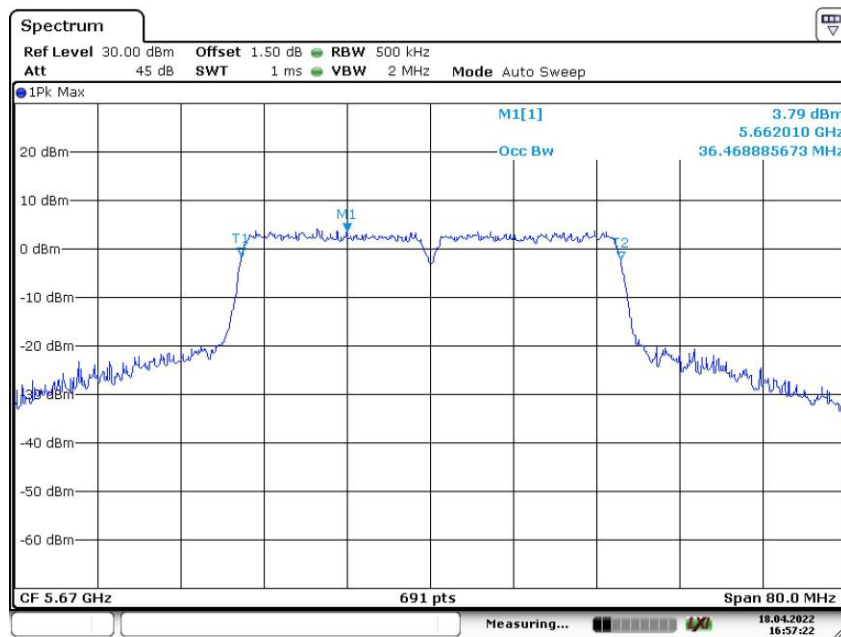
**Fig. 40 99% Occupied Bandwidth (802.11n-HT40, 5510MHz)**





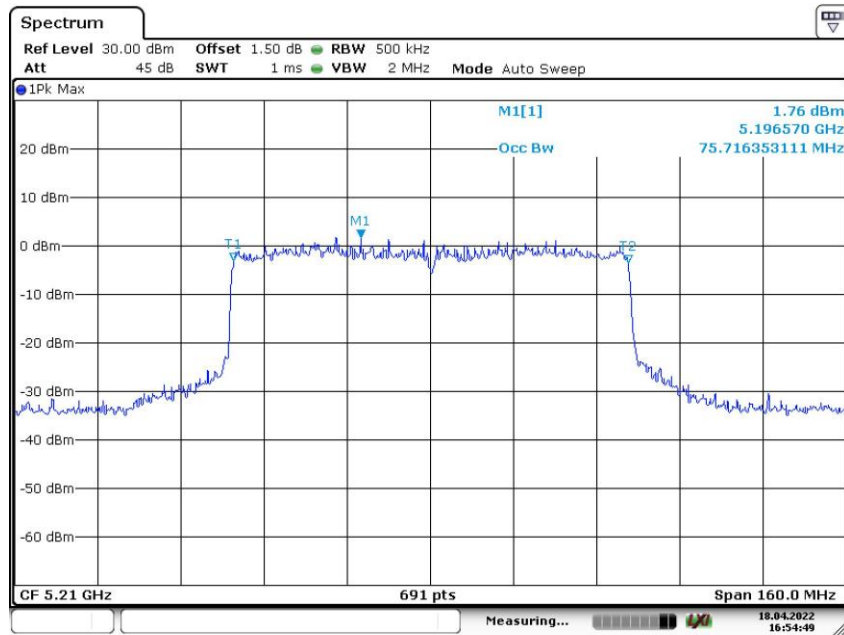

**Fig. 41 99% Occupied Bandwidth (802.11n-HT40, 5550MHz)**



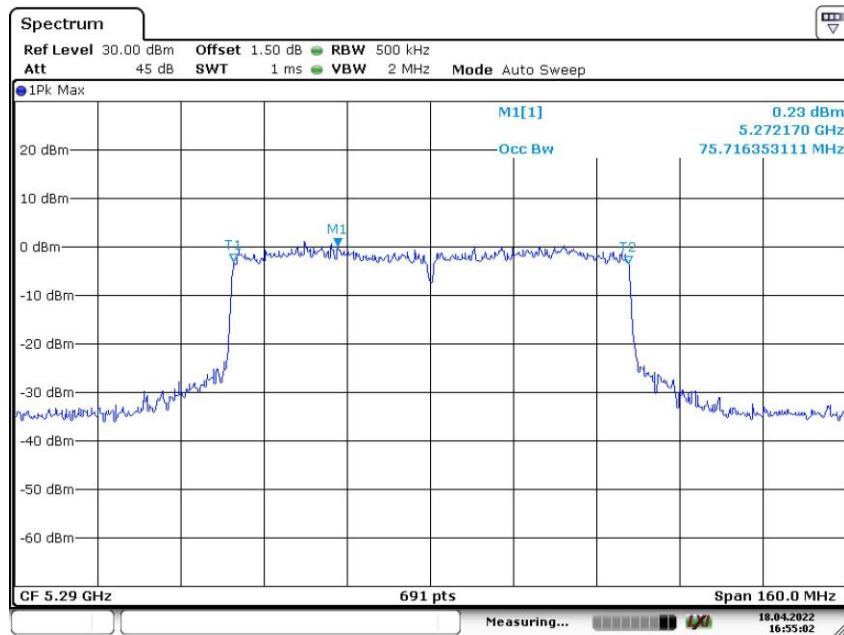

**Fig. 42 99% Occupied Bandwidth (802.11n-HT40, 5670MHz)**



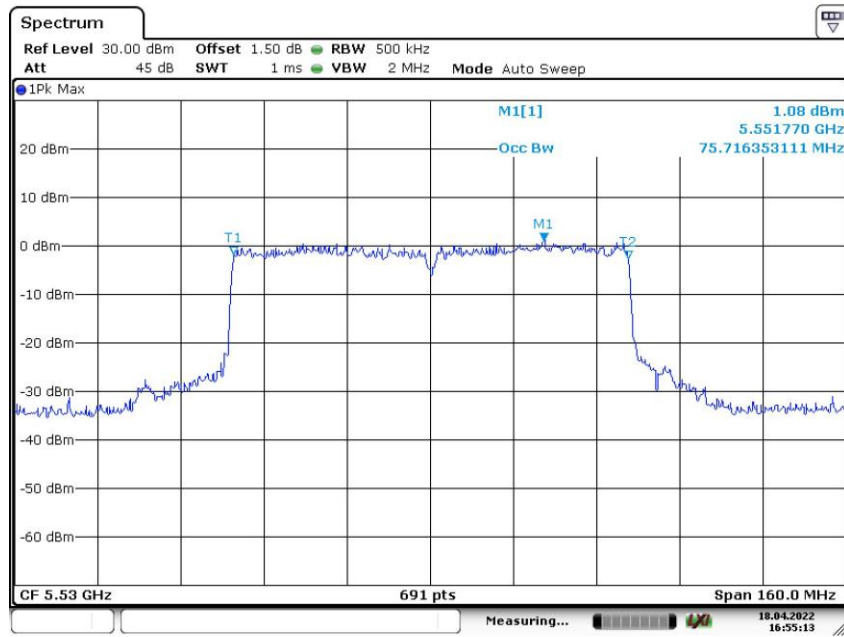

**Fig. 43 99% Occupied Bandwidth (802.11ac-VHT80, 5210MHz)**



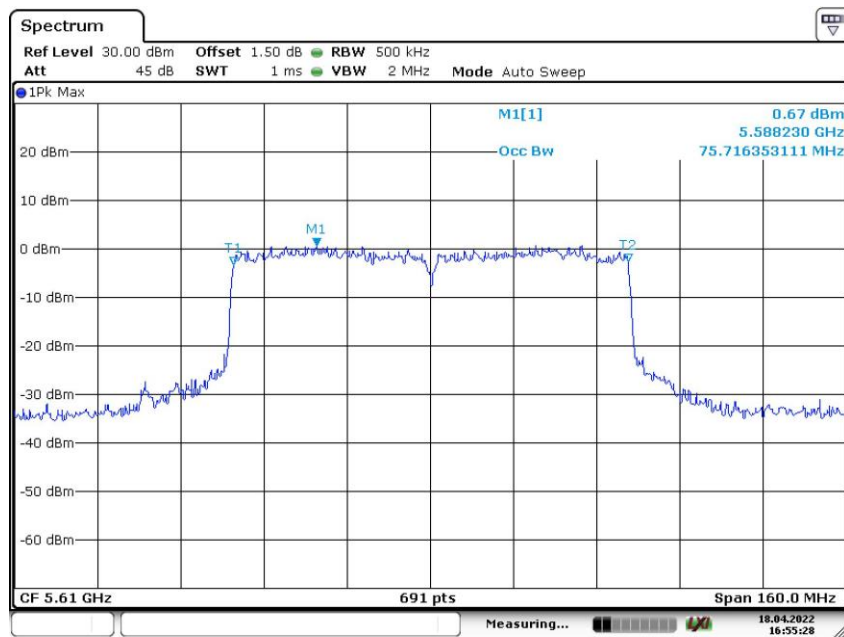

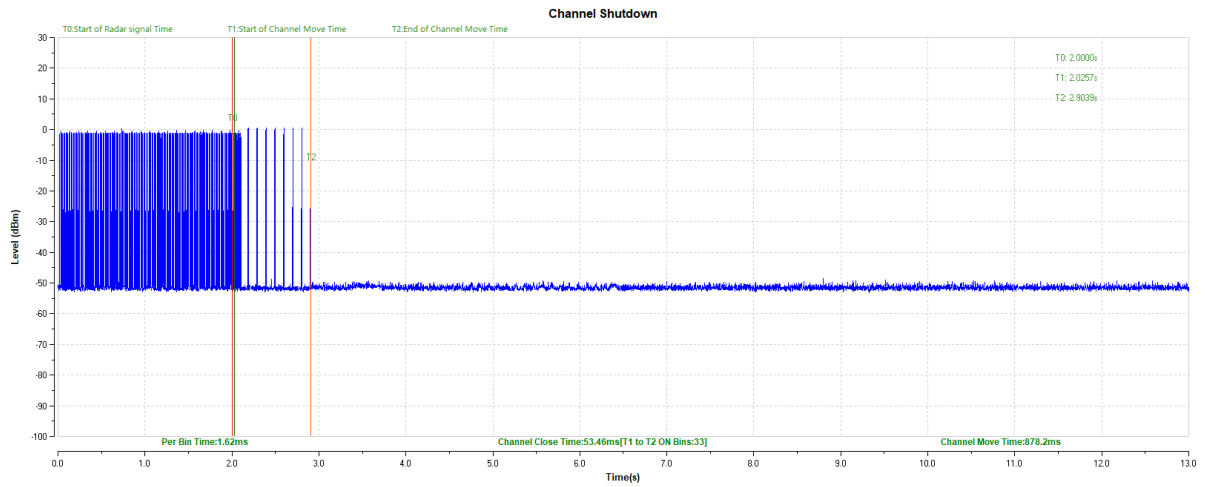

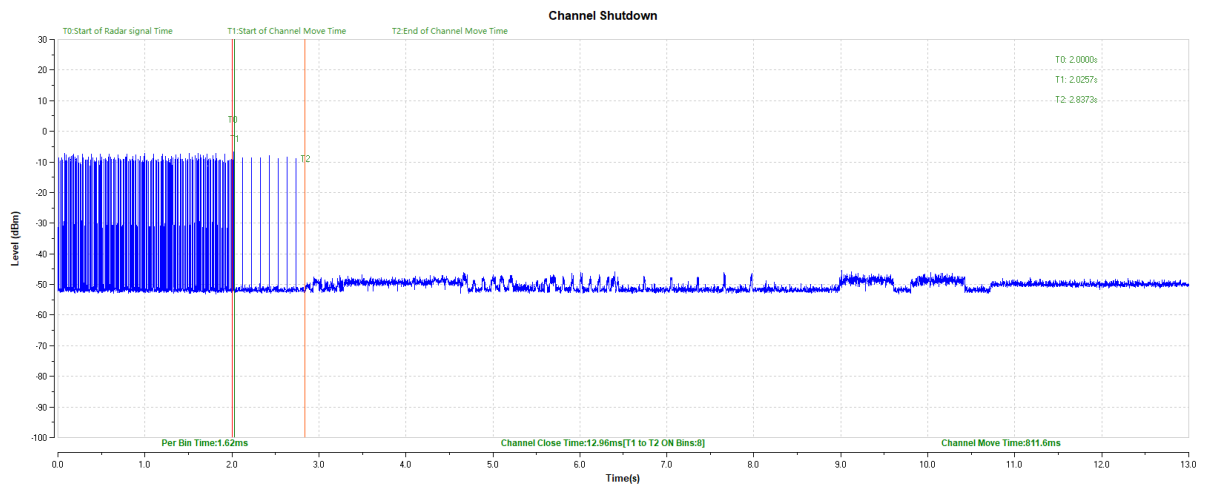

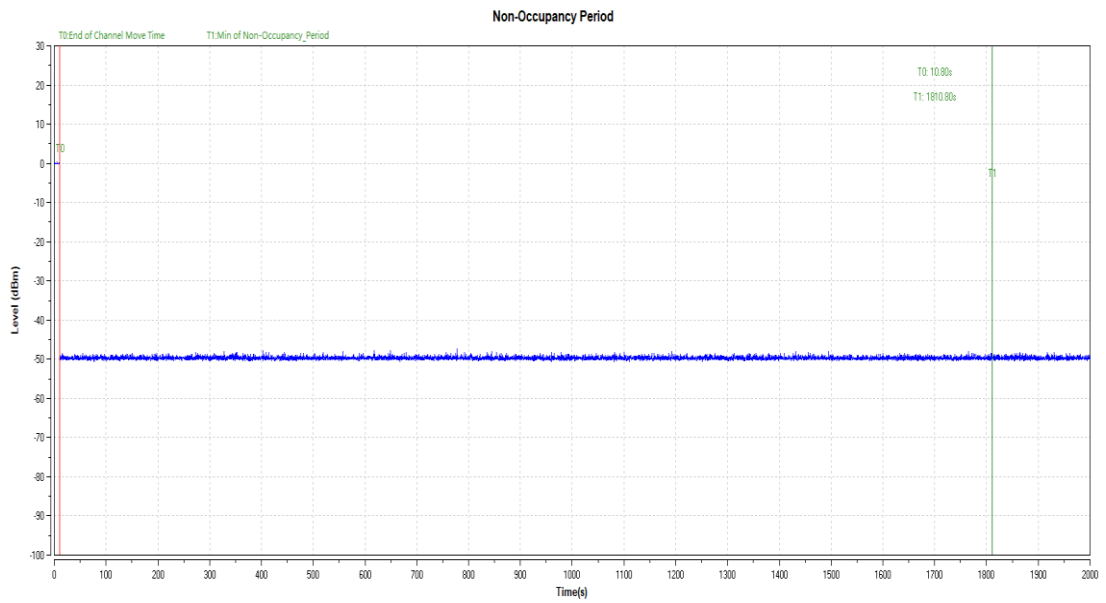

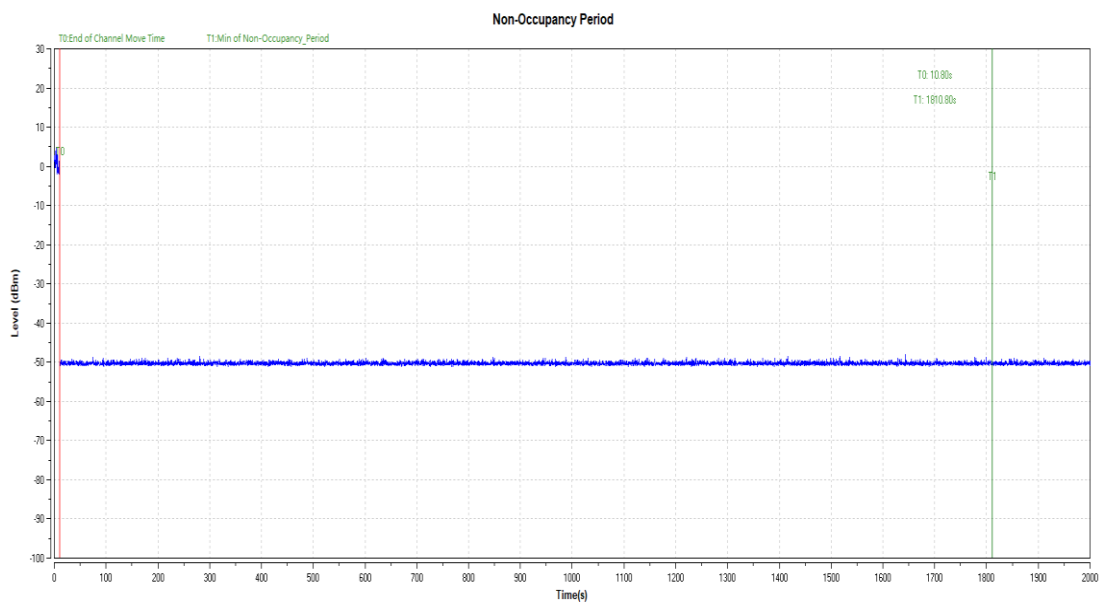
**Fig. 47 Channel Move Time & Channel Closing Transmission Time (802.11a Frequency Band: 5250MHz ~ 5350MHz)**
