

ANNEX A: MEASUREMENT RESULTS

A.1 OUTPUT POWER

Reference

FCC: CFR Part 2.1046, 22.913, 24.232, 27.50(d)

A.1.1 Summary

During the process of testing, the EUT was controlled via Rhode & Schwarz Digital Radio Communication tester (CMU-200) to ensure max power transmission and proper modulation.

This result contains max output power and EIRP measurements for the EUT. In all cases, output power is within the specified limits.

A.1.2 Conducted

A.1.2.1 Method of Measurements

The EUT was set up for the max output power with pseudo random data modulation.

These measurements were done at 3 frequencies, 1852.4 MHz, 1880.0MHz and 1907.6MHz for WCDMA Band II;826.4MHz, 836.6MHz and 846.6MHz for WCDMA Band V and 1712.4MHz, 1740.0MHz and 1752.6MHz for WCDMA Band IV (bottom, middle and top of operational frequency range).


A.1.3.1 Description

This is the test for the maximum radiated power from the EUT.


Rule Part 24.232(b) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(c) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage."Rule Part 22.913(a) specifies "The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts."

A.1.3.2 Method of Measurement

1. For radiated emissions measurements performed at frequencies less than or equal to 1 GHz, EUT was placed on a 80 cm high non-conductive stand at a 3 meter test distance from the receive antenna. For radiated measurements performed at frequencies above 1 GHz, EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. Receiving antenna was placed on the antenna mast 3 meters from the EUT. For emission measurements. The receiving antenna shall be varied from 1 m to 4 m in height above the reference ground in a search for the relative positioning that produces the maximum radiated signal level. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.



- 2. The EUT is then put into continuously transmitting mode at its maximum power level during the test. And the maximum value of the receiver should be recorded as (Pr).
- 3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.



In the chamber, an substitution antenna for the frequency band of interest is placed at the



reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjusts the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.

- 4. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna.
 - The cable loss (P_{cl}) , the Substitution Antenna Gain(dBi) (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test.
 - The measurement results are obtained as described below:
 - Power(EIRP)= $P_{Mea} P_{Ag} P_{cl} + G_a$
- 5. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dB.



A.2.1 Measurement Method

The spectrum was scanned from 30 MHz to the 10th harmonic of the highest frequency generated within the equipment. The resolution bandwidth is set 1MHz as outlined in Part 24.238, Part 22.917 and Part 27.53. The spectrum was scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of WCDMA Band II, WCDMA Band V and WCDMA Band IV.


The procedure of radiated spurious emissions is as follows:

1. For radiated emissions measurements performed at frequencies less than or equal to 1 GHz, EUT was placed on a 80 cm high non-conductive stand at a 3 meter test distance from the receive antenna. For radiated measurements performed at frequencies above 1 GHz, EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. Receiving antenna was placed on the antenna mast 3 meters from the EUT. For emission measurements. The receiving antenna shall be varied from 1 m to 4 m in height above the reference ground in a search for the relative positioning that produces the maximum radiated signal level. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.





A power (P_{Mea}) is applied to the input of the substitution antenna, and adjusts the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.

- 4. The Path loss (P_{pl}) between the Signal Source with the Substitution Antenna and the Substitution Antenna Gain(dBi) (G_a) should be recorded after test.
 - A amplifier should be connected in for the test.
 - The Path loss (P_{pl}) is the summation of the cable loss and the gain of the amplifier.
 - The measurement results are obtained as described below:
 - Power(EIRP)= $P_{Mea} P_{pl} + G_a$
- 5. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dB.





A.2.2 Measurement Limit

Part 24.238, Part 22.917 and Part 27.50 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB.

The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 + 10 log (P) dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm. At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.

A.2.3 Measurement Results

Radiated emissions measurements were made only at the upper, middle, and lower carrier frequencies of WCDMA Band II (1852.4 MHz, 1880.0MHz and 1907.6MHz), WCDMA Band V(826.4MHz, 836.6MHz and 846.6MHz) and WCDMA Band IV (1712.4MHz, 1740.0MHz and 1752.6MHz). It was decided that measurements at these three carrier frequencies would be sufficient to demonstrate compliance with emissions limits because it was seen that all the significant spurs occur well outside the band and no radiation was seen from a carrier in one block of the WCDMA Band II,WCDMA Band V and WCDMA Band IV into any of the other blocks. The equipment must still, however, meet emissions requirements with the carrier at all frequencies over which it is capable of operating and it is the manufacturer's responsibility to verify this.

A.3 FREQUENCY STABILITY

A.3.1 Method of Measurement

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMU200 DIGITAL RADIO COMMUNICATION TESTER.

- 1. Measure the carrier frequency at room temperature.
- 2. Subject the EUT to overnight soak at -30°C.
- 3. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on mid channel of WCDMA Band II, WCDMA Band V and WCDMA Band IV, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 5. Remeasure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments remeasuring carrier frequency at each voltage. Pause at nominal voltage for 1 1/2 hours unpowered, to allow any self-heating to stabilize, before continuing.
- 6. Subject the EUT to overnight soak at $+50^{\circ}$ C.
- 7. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 8. Repeat the above measurements at 10℃ increments from -30℃ to +50℃. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 9. At all temperature levels hold the temperature to $\pm 0.5^{\circ}$ during the measurement procedure.

A.3.2 Measurement Limit

A.3.2.1 For Hand carried battery powered equipment

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of between 3.60V and 4.35V, with a nominal voltage of 3.80V. Operation above or below these voltage limits is prohibited by transceiver software in order to prevent improper operation as well as to protect components from overstress. These voltages represent a tolerance of -5.5 % and +12.6 %. For the purposes of measuring frequency stability these voltage limits are to be used.

A.3.2.2 For equipment powered by primary supply voltage

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec.



24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. For this EUT section 2.1055(d)(1) applies. This requires varying primary supply voltage from 95 to 114 percent of the nominal value for other than hand carried battery equipment.

A.4.1 Occupied Bandwidth Results

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be set wide enough to capture all modulation products including the emission skirts (i.e., two to five times the OBW).
- b) The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1 to 5 % of the anticipated OBW, and the VBW shall be at least 3 times the RBW.
- c) Set the reference level of the instrument as required to keep the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope must be at least 10log (OBW / RBW) below the reference level.
- d) Set the detection mode to peak, and the trace mode to max hold.
- e) Use the 99 % power bandwidth function of the spectrum analyzer and report the measured bandwidth.

A.4.2 Occupied Bandwidth Results

Occupied bandwidth measurements are only provided for selected frequencies in order to reduce the amount of submitted data. Data were taken at the extreme and mid frequencies of the US Cellular/PCS frequency bands. The table below lists the measured 99% BW. Spectrum analyzer plots are included on the following pages.









A.5.1Emission Bandwidth Results

A.5.1 Measurement Procedure

The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26 dB below the transmitter power.

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The frequency span for the spectrum analyzer shall be set wide enough to capture all modulation products including the emission skirts (i.e., two to five times the OBW).
- b) The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1 to 5 % of the anticipated OBW, and the VBW shall be at least 3 times the RBW.
- c) Set the reference level of the instrument as required to keep the signal from exceeding the maximum input mixer level for linear operation. In general, the peak of the spectral envelope must be at least 10log (OBW / RBW) below the reference level.
- d) Set the detection mode to peak, and the trace mode to max hold.
- e) Use the 26dB bandwidth function of the spectrum analyzer and report the measured bandwidth.

A.5.2Emission Bandwidth Results

Similar to conducted emissions; Emission bandwidth measurements are only provided for selected frequencies in order to reduce the amount of submitted data. Data were taken at the extreme and mid frequencies of WCDMA Band II WCDMA Band V and WCDMA Band IV. Table below lists the measured -26dBc BW. Spectrum analyzer plots are included on the following pages.






Channel 1312-Emission Bandwidth (-26dBc BW)-16QAM

A.6 BAND EDGE COMPLIANCE

A.6.1 Measurement limit

On any frequency outside frequency band of the US Cellular/PCS spectrum, the power of any emission shall be attenuated below the transmitter power (P, in Watts) by at least 43+10Log (P) dB. For all power levels +30 dBm to 0 dBm, this becomes a constant specification limit of -13 dBm. A relaxation of the reference bandwidth is often provided for measurements within a specified frequency range at the edge of the authorized frequency block/band. This is often implemented by permitting the use of a narrower RBW (typically limited to a minimum RBW of 1% of the OBW) for measuring the out-of-band emissions without a requirement to integrate the result over the full reference bandwidth.

A.6.2Measurement Procedure


The testing follows ANSI C63.26

- a) The EUT was connected to spectrum analyzer and system simulator via a power divider.
- b) The band edges of low and high channels for the highest RF powers were measured.
- c) Set RBW >= 1% EBW in the 1MHz band immediately outside and adjacent to the band edge.
- d) Set spectrum analyzer with RMS detector.
- e) The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
- f) Checked that all the results comply with the emission limit line.



LOW BAND EDGE BLOCK-A-Channel 9262






HIGH BAND EDGE BLOCK-C-Channel 9538






WCDMA Band $\,\mathrm{V}\,$ LOW BAND EDGE BLOCK-A-Channel 4132




HIGH BAND EDGE BLOCK-C (WCDMA Band V) - Channel 4233






WCDMA Band IV LOW BAND EDGE BLOCK-A -Channel 1312

A.7.1 Measurement Method

The following steps outline the procedure used to measure the conducted emissions from the EUT.

- Determine frequency range for measurements: From CFR 2.1051 the spectrum should be investigated from the lowest radio frequency generated in the equipment up to at least the 10th harmonic of the carrier frequency. For the mobile station equipment tested, this equates to a frequency range of 13 MHz to 9 GHz, data taken from 10 MHz to 25 GHz.
- 2. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.



A.7.2 Measurement Limit

Part 24.238, Part 22.917 and Part 27.53(h) specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB.


The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 + 10 log (P) dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm. At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.











Channel 9400: 30MHz –19.1GHz Spurious emission limit –13dBm.



Channel 4132: 30MHz –8.49GHzSpurious emission limit –13dBm.








Channel 4183: 30MHz –8.49GHz Spurious emission limit –13dBm.








Channel 4233: 30MHz –8.49GHz Spurious emission limit –13dBm.










Channel 1450: 30MHz –17.55GHz Spurious emission limit –13dBm.

A.8 PEAK-TO-AVERAGE POWER RATIO

The peak-to-average power ratio (PAPR) of the transmitter output power must not exceed 13 dB. The PAPR measurements should be made using either an instrument with complementary cumulative distribution function (CCDF) capabilities to determine that PAPR will not exceed 13 dB for more than 0.1 percent of the time or other Commission approved procedure. The measurement must be performed using a signal corresponding to the highest PAPR expected during periods of continuous transmission.

- a)Refer to instrument's analyzer instruction manual for details on how to use the power statistics/CCDF function;
- b) Set resolution/measurement bandwidth ≥ signal's occupied bandwidth;
- c) Set the number of counts to a value that stabilizes the measured CCDF curve;
- d) Set the measurement interval to 1 ms
- e)Record the maximum PAPR level associated with a probability of 0.1%




Channel 1450- Peak-To-Average Power Ratio(PAPR)-16QAM
