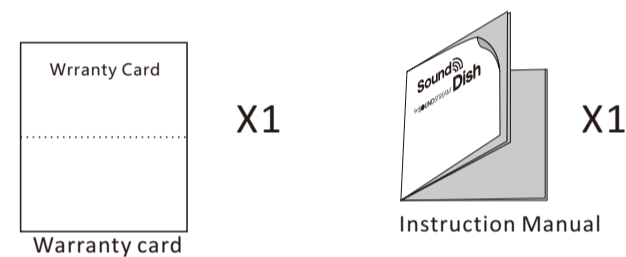
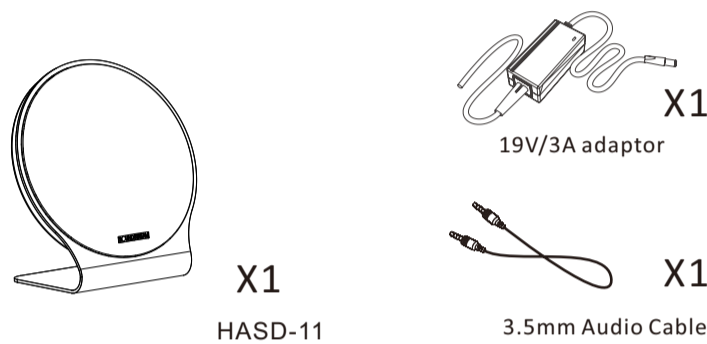

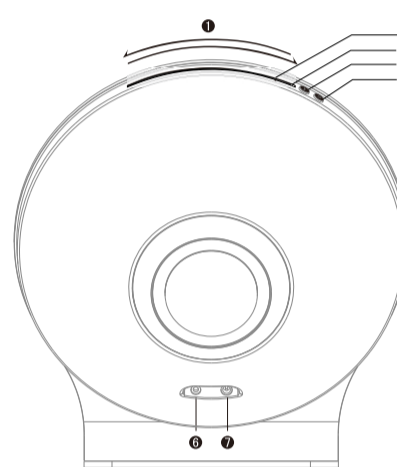

DEAR SIR / MADAM

Thank you for purchasing HASD-11 Bluetooth speaker. For the best performance of the HASD-11, please read this manual carefully before using. The HASD-11 features a fashionable design, multiple functions and high acoustic quality. In addition, it adopts the latest electro-acoustic technology and it is compatible with most of Bluetooth devices, including table computers, cell phones and music players, allowing you to enjoy excellent sounds.

NOTES

Please use or keep this device at the places with normal temperature. When listen to the music, please adjust the volume properly to avoid high-pitched sound impairing your hearing. Please disconnect the power supply immediately while the device break down to avoid loudspeaker and other components damaged.

FUNCTION SPECIFICATION

After charged through the equipped 19V/3A adapter, short press the power button to turn on or turn off the speaker. The blue LED light blinks when turn on the speaker. Search for "Sound Dish" with your Bluetooth device for wireless connection, enter PIN code "0000" if needed. Once connected, blue LED light shines consistently. While in Bluetooth mode, short press "MFB" button to pause, press again to play. Long press the "MFB" button to disconnect the Bluetooth connection. Slide on the volume adjustment area to increase or decrease volume: slide from left to right to increase the volume, slide from right to left to decrease the volume.

WORKING STATUS INSTURCTION FOR INDICATOR LIGHT

- Blue indicator light:
- A. The light blinks in Bluetooth pairing mode
 - B. The light shines consistently when connected
 - C. The light blinks twice quickly when the volume reaches the maximum or reaches the minimum in Aux-in mode
 - D. The light shines when slide on the volume adjustment area

COMMUNICATION

When playing music in Bluetooth speaker and a call comes, short press "MFB" button to pick up the call and press again to hangup. Long press to reject the call and press twice to redial the last call.

AUDIO INPUT

Aux-in mode: the blue indicator light shines consistently when playing music. The "MFB" button is ineffective in Aux-in mode. Slide on the volume adjustment area to increase or decrease volume: slide from left to right to increase the volume, slide from right to left to decrease the volume.

LIMITED ONE-YEAR CONSUMER WARRANTY WITH PROOF OF PURCHASE

Soundstream promises to the original purchaser, to repair or replace this product with a new or refurbished unit (at Soundstream's sole and absolute discretion) should it prove to be defective in workmanship or material under normal use, for a period of one-year from the date of purchase from the Soundstream authorized retailer, PROVIDED the product was purchased from a Soundstream authorized retailer. During this one-year period, there will be no charge for product repair or replacement, PROVIDED the unit is returned to Soundstream, return shipping pre-paid, along with the required bill of sale or other dated proof of purchase, and the consumer's contact information.

If the unit is sold by anyone other than a Soundstream authorized retailer, the warranty period will be 90-days from the date of purchase. This warranty is nontransferable and does not apply to any unit that has been modified or used in a manner contrary to its intended purpose, and does not cover damage to the unit caused by installation or removal of the unit. During this 90-day period, there will be no charge for the repair or replacement PROVIDED the unit is returned to Soundstream, return shipping prepaid, along with the bill of sale or other dated proof of purchase and the consumer's contact information.

This warranty is void if the product has been damaged by accident or unreasonable use, neglect, improper service or other causes not arising out of defects in materials or construction. This warranty does not cover the elimination of externally generated static or noise, or the correction of antenna problems or weak reception, damage to speakers, accessories, electrical systems, cosmetic damage or damage due to negligence, misuse, failure to follow operating instructions, accidental spills or customer applied cleaners, damage due to environmental causes such as floods,airborne fallout, chemicals, salt, hail, lightning or extreme temperatures, damage due to accidents, road hazards, fire, theft, loss or vandalism, damage due to improper connection to equipment of another manufacturer, modification of existing equipment, or Product which has been opened ortampered for any reason.
