



Installation Guide



①

Use the supplied hex key to screw the lugs onto the back of your new EO2 display.



②

Draw a mark on the wall where you'd like the center of your EO2 to go. We recommend 57" from the floor or about eye level.




③

Center the Wall Mount over the mark, using the built-in bubble level to straighten it, then trace the locations of the two holes in the Wall Mount onto the wall.



④

Using a 3/16" drill bit, drill two holes in the center of the marked locations. Screw the wall anchors into the holes. Secure the Wall Mount using the included screws and washers.



⑤

Plug the DC plug into EO2, then carefully slide EO2 down into the Wall Mount, ensuring that it's securely attached to the wall before letting go. Press the power button on the back of the display.



⑥

Download the Electric Objects app from the App Store, Google Play or visit electricobjects.com/apps.

Create an Electric Objects account (or log in to an existing account)

Follow the instructions in the app to connect your EO2 to the Internet.

Troubleshooting

Why Won't EO2 Turn On?

1. Make sure the power cord is connected securely, and that it's plugged into the wall.
2. Press the power button on the back of the frame at the top of the display.

Why Won't my Phone Connect to EO2?

1. Make sure Bluetooth is enabled on your phone.
2. Make sure that you are within 5 feet of EO2, and that there are no obstructions.

Why Won't EO2 Connect to my WiFi Network?

1. Double-check the basics: your network name and password must match (including things like capitalization and punctuation).
2. EO2 cannot connect to networks that require secondary browser-based authentication (such as many corporate portals). Please contact your network administrator to whitelist your EO2's MAC network address (you can find this on the back of your unit).

What is Covered?

This limited warranty covers defects in materials and workmanship in this Product.

What is Not Covered?

This limited warranty does not cover any damage, failure, deterioration or malfunction resulting from any alteration, modification, improper, inadequate or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, improper packing and shipping (such claims must be presented to the carrier), lighting, power surges, or other acts of nature. This limited warranty does not cover any damage, deterioration or malfunction resulting from the installation or removal of this Product, any unauthorized tampering with this Product, any repairs attempted by anyone not authorized by the Company to make such repairs, or any other cause which does not relate directly to a defect in materials and/or workmanship of this Product. This limited warranty does not cover cables or accessories used in conjunction with this Product. How Long Does this Limited Warranty Last?

This limited warranty continues for twelve (12) months from the date of original purchase of this Product by the original purchaser.

Who is Covered?

Only the original purchaser of this Product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this Product.

What the Company Will Do Under this Limited Warranty.

The Company will, at its sole option, provide one of the following two (2) remedies to whatever extent it shall deem necessary to satisfy a proper claim (as determined by the Company) under this limited warranty.

1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this Product to its proper operating condition. The Company will also pay the shipping costs necessary to return this Product once the repair is complete.
2. Replace this Product with a direct replacement or with a similar product deemed by the Company to perform substantially the same function as the original Product.

What the Company Will Not Do Under this Limited Warranty.

The Company will not be responsible for any costs related to the removal or re-installation of this Product. The Company will not be

responsible for any costs related to any setting up of this Product, any adjustment of user controls or any programming required for a specific installation of this Product.

How to Obtain a Remedy Under this Limited Warranty.
