2DH5_Ant1_Hop

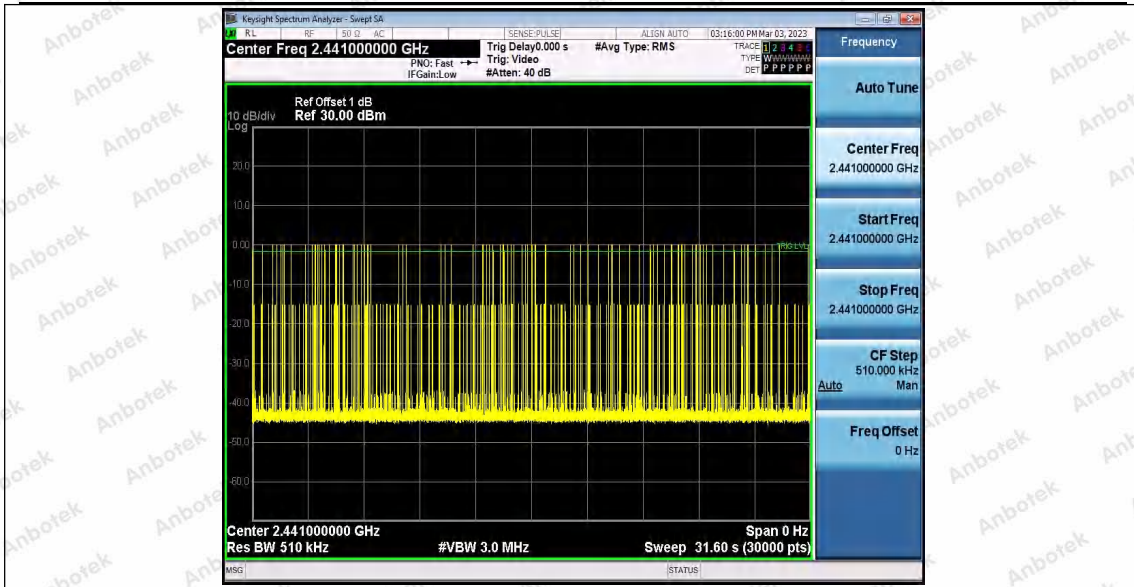

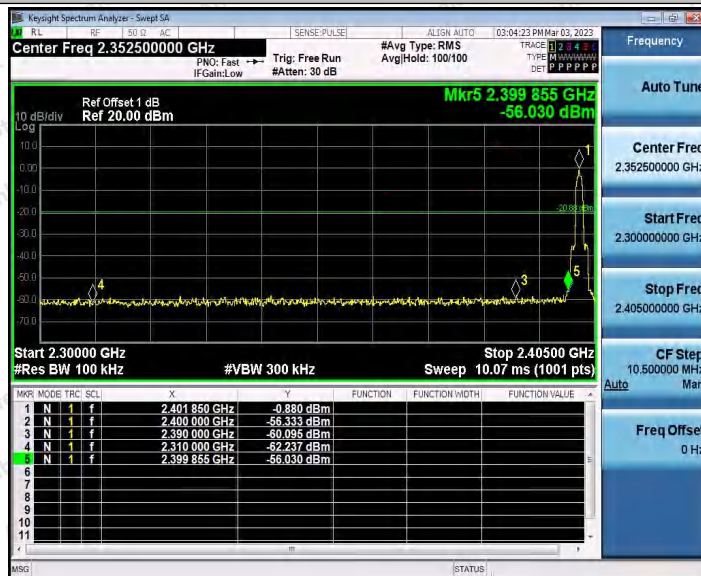




DH5_Ant1_High_Hop_2480

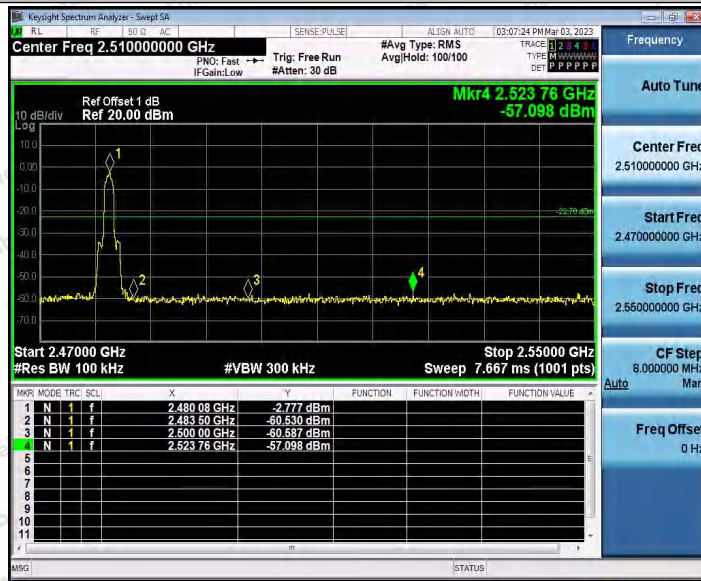

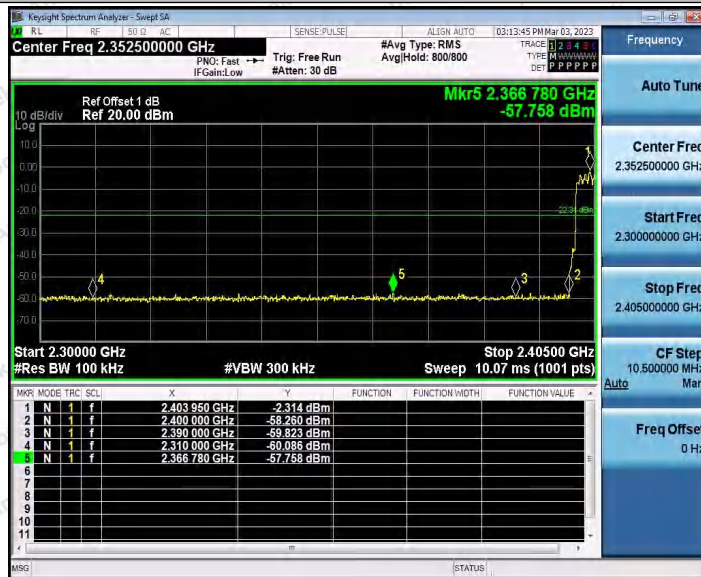

2DH5_Ant1_Low_Hop_2402



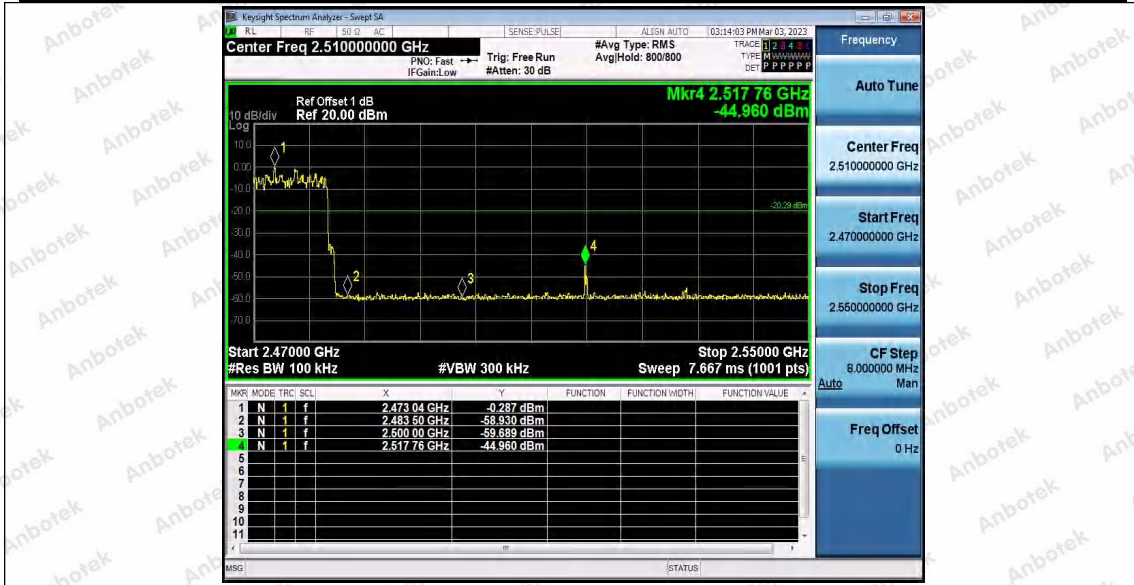
