#### **GENERAL INFORMATION**

#### Product Description for Equipment under Test (EUT)

The **Foto Electric Supply Co., INC.** 's product, model number: **FL3002 (FCC ID: 2AJVKFL3002 )** (the "EUT") in this report was a **Mobile phone**, which was measured approximately: 9.6 cm (L) × 4.7 cm (W) × 1.8 cm (H), rated input voltage: DC3.7V rechargeable Li-ion battery or DC5V from adapter.

Adapter Information: INPUT: 100-240VAC 50/60Hz OUTPUT: DC 5.0V, 500mA±50mA

Note: The series product, model FL3002, CBF2003 are electrically identical, the difference between them just is the model name, we selected FL3002 for fully testing, the details was explained in the declaration letter.

\*All measurement and test data in this report was gathered from final production sample, serial number: 161010003 (assigned by the BACL, Chengdu). It may have deviation from any other sample. The EUT supplied by the applicant was received on 2016-10-10, and EUT conformed to test requirement.

#### Objective

This report is prepared on behalf of *Foto Electric Supply Co., INC.* in accordance with: Part 2-Subpart J, Part 22-Subpart H, and Part 24-Subpart E of the Federal Communications Commission's rules.

The objective is to determine compliance with FCC rules for output power, modulation characteristic, occupied bandwidth, spurious emissions at antenna terminal, spurious radiated emission, frequency stability and band edge.

#### **Test Methodology**

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2, Sub-part J, Part 22 Subpart H, Part 24 Subpart E.

Applicable Standards: TIA/EIA 603-D-2010.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Chengdu).

#### **Test Facility**

The test site used by BACL to collect test data is located in the 5040, HuiLongWan Plaza, No. 1, ShaWan Road, JinNiu District, ChengDu, China.

Test site at BACL has been fully described in reports submitted to the Federal Communication Commission (FCC). 






# GSM850\_Middle Channel

# FCC §2.1053, §22.917 & §24.238 - SPURIOUS RADIATED EMISSIONS

#### **Applicable Standard**

FCC § 2.1053, §22.917 and § 24.238.

#### **Test Procedure**

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB = 10 Ig (TXpwr in Watts/0.001) - the absolute level

Spurious attenuation limit in  $dB = 43 + 10 \text{ Log}_{10}$  (power out in Watts)


According to §24.235, the frequency stability shall be sufficient to ensure that the fundamental emissions stays within the authorized frequency block.

#### **Test Procedure**

Frequency Stability vs. Temperature: The equipment under test was connected to an external DC power supply and the RF output was connected to communication test set via feed-through attenuators. The EUT was placed inside the temperature chamber. The DC leads and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the communication test set.

Frequency Stability vs. Voltage: An external variable DC power supply was connected to the battery terminals of the equipment under test. The voltage was set from 85% to 115% of the nominal value and was then decreased until the transmitter light no longer illuminated; i.e., the battery end point. The output frequency was recorded for each battery voltage.
