

2.2 Assessment Results

Power density (S) is calculated according to the formula:

 $S = PG / (4\pi R^2)$

Where S = power density in mW/cm^2

- P = Radiated transmit power in mW
- G = numeric gain of transmit antenna
- R = distance (cm)

As we can see from the test report 200401694SHA-001, 200401694SHA-002 and 200401694SHA-003:

The calculations in the table below use the highest gain of antenna for client EUT. These calculations represent worst case in terms of the exposure levels.

For the device can support simultaneous transmission, according to 447498 D01 General RF Exposure Guidance v06,

For the device consider simultaneous transmission of WiFi and Bluetooth:

The worst MPE = $0.0144/1 + 0.0016/1 = 0.0160 \text{ mW/cm}^2 < 1 \text{ mW/cm}^2$.



Appendix I

Definition below must be outlined in the User Manual:

To satisfy FCC RF exposure requirements, a separation distance of 20 cm or more should be maintained between the antenna of this device and persons during device operation. To ensure compliance, operations at closer than this distance is not recommended.
