IMPORTANT SAFETY AND HANDLING INFORMATION

Read the following instructions before using Phiro. Failure to do so may cause injury. **CAUTION:** To reduce the risk of damage or injury, do not attempt to remove Phiro's shell. Please refer all servicing questions to Robotix. No user-serviceable parts are contained inside.

General

- Read all safety and operating instructions before operating Phiro.
- Retain the safety and operating instructions for future reference.
- Follow all operating and use instructions.
- Do not attempt to service Phiro. Refer all servicing questions to Robotix.

Seizure, Blackouts and Eyestrain

If you have experienced seizures or blackouts when exposed to flashing lights or light patterns such as when playing games or watching video, or have a family history of such occurrences, you should consult a physician before using Phiro. If you experience headaches, blackouts, seizures, convulsion, eye or muscle twitching, loss of awareness, involuntary movement, or disorientation while using Phiro, discontinue use of Phiro and your smart device controller and consult a physician. To reduce the risk of headaches, blackouts, seizures, and eyestrain, avoid prolonged use of Phiro, hold your smart device controller some distance from your eyes, and use Phiro in a well-lit room.

Repetitive Injury

Avoid prolonged use of the smart device controller, particularly by children, which may cause occasional discomfort in the hands, arms, shoulders, neck, or other parts of the body. Those experiencing such discomfort during or after use of the smart device controller, should stop using it and consult a physician.

WARNING: Choking Hazards

Phiro has small parts, which may present a choking hazard to children under 4 years of age and pets. Keep Phiro and its accessories away from children under 4 years of age.

Keeping Phiro Within Acceptable Temperatures

Operate and store Phiro in a place where the temperature is between 0° and 40° C (32° to 104° F). Low or high-temperature conditions, such as in parked cars, might temporarily shorten battery life or cause Phiro to temporarily stop working properly. Avoid dramatic changes in temperature or humidity when using Phiro, as condensation may form on or within Phiro. However, when using Phiro or charging the battery, it is normal for Phiro to become warm.

Use and Maintenance

WARNING: Phiro is not suitable for use by children under 4 years of age.

Never:

- Throw, drop, puncture, kick, step on, or otherwise subject Phiro to physical abuse. This can damage Phiro and compromise its safe operation.
- Operate Phiro in dangerous, hazardous or public areas where use is not permitted, such as near high voltage power lines, in train stations or airports, or on trains or airplanes). Check whether use of Phiro is permitted before using it in public areas.

Always:

- Keep Phiro in sight at all times while operating it to avoid injuries or damage to people, animals, or property.
- Ensure that people, animals, and property are more than 1 yard (1 meter) away from Phiro while it is in operation.
- Periodically examine Phiro for potential hazards such as cracked, damaged or otherwise broken parts. In the event of such damage, do not use Phiro.
- Operate Phiro on smooth, flat and hard surfaces (such as carpet, tile wood floors, and concrete).

Battery Warning

- Lithium Polymer batteries are extremely hazardous and may cause serious injuries to persons or property. As the manufacturer, the distributor, and Robotix cannot ensure the battery is used correctly (such as when charging, discharging, or storing, etc.), the user accepts liability for any damages caused by the use of a Lithium Polymer battery.

- In the event of battery leakage, avoid the liquid coming into contact with skin and eyes. In case of contact with the skin, wash with soap and water. In case of contact with the eyes, rinse with cold water and consult a physician. If you notice a suspicious smell or noise or observe smoke around the charger, disconnect it immediately.
- Non-compliance with these instructions below may result in dangerous gas emissions, fire, electric shock, or an explosion.

Charging

- Use an approved charger to charge Phiro. (CE, FCC, ASTM, UL and/or any other applicable standards as per your country)
- Examine the charging cord regularly for damage. Never use a damaged charging cord. Use only the supplied charging cord. Misuse of the charger or the charging cord may cause electrical shock.
- Never charge a leaky battery or one that has been damaged. Do not use the Phiro charging cord to charge any battery other than the provided rechargeable battery.
- Do not charge the battery near inflammable materials, on an inflammable surface (such as carpet, wooden flooring, wooden furniture, etc.), or on a conducting surface (such as metallic surfaces, wet surfaces etc.). Do not leave Phiro unattended during charging.

- Never charge Phiro immediately after use or while it is still hot. Allow Phiro to cool down to room temperature before charging.
- Batteries should be charged by children only with adult supervision.
- Do not cover Phiro or its charger while the battery is charging. Recharge the battery only in a place where the temperature is between 0° and 40° C (32° to 104° F).

Use and storage

- Do not use Phiro if its cover has been broken and the battery's plastic cover has been cracked or broken in any way.
- Do not expose the battery to excessive physical shock.
- Do not expose Phiro or its battery to heat or put them in or near fire.
- Do not put Phiro or its battery in a microwave oven or in a pressurized container.
- Do not attempt to dismantle, pierce, distort, cut, or otherwise repair the battery.
- Do not place any heavy objects on Phiro, the battery, or the charging cord.
- Do not clean the charging cord with a solvent, denatured alcohol, or other inflammable solvent. When cleaning, be sure to unplug the charging cord and clean only with a dry cloth.

- Avoid direct contact with the electrolyte contained within the battery and with electrolysis vapor from the battery, which are harmful to health.
- Do not subject Phiro and its battery to large temperature variations. Do not place Phiro near a source of heat.
- Disconnect the charging cord when not charging the battery.

Limited Warranty to Original Purchaser

This Phiro product, as supplied and distributed by Robotix USA, LLC., and delivered new, in the original carton to the original customer purchaser, is warranted by Robotix USA, LLC. against manufacturing defects in materials and workmanship for a period of 1 year. Robotix USA will repair or replace this product, at our option and at no charge with new or reconditioned parts, if found to be defective during the limited warranty period specified above.

This limited warranty covers only the normal and intended use of Phiro and applies only to the hardware product "Phiro" manufactured by or for Robotix USA, LLC that can be identified by the "Phiro" trademark, trade name or logo affixed to it. This limited warranty does not apply to any non-Robotix hardware product or any software, even if packaged or sold with the Phiro hardware product. Refer to the software license agreement accompanying the software for details of your rights with respect to its use.
