

Result plot as follows: Normal mode (DH5 data packet with GFSK modulation type): Lowest Channel(2.402 GHz):










Middle Channel (2.441 GHz):




Middle Channel (2.441 GHz): 30MHz to 1GHz






Middle Channel (2.441 GHz): 5GHz to 25GHz


