## 2.2 Assessment methods

Calculation Formula from FCC OET 65:

$$S = \frac{P * G}{4 * \pi * R^2}$$

Where:

S = Power Density (mW/cm<sup>2</sup>)

P = Input Power of the Antenna (mW)

G = Antenna Gain Relative to an Isotropic Antenna

R = Distance from the Antenna to the Point of Investigation (cm)

### Note(s):

1. For 300 – 1,500MHz: Power Density limit is f/1500 mW/cm<sup>2</sup>
2. For 1,500 – 100,000MHz: Power Density limit is 1.0 mW/cm<sup>2</sup>
3. The device can not transmit with WIFI and BT simultaneously, so MPE is not evaluated in this configuration.

## 2.4 Conclusion

The Power Density at the position which is 20 cm far from the EUT is smaller than the General Population/Uncontrolled Exposure limit.

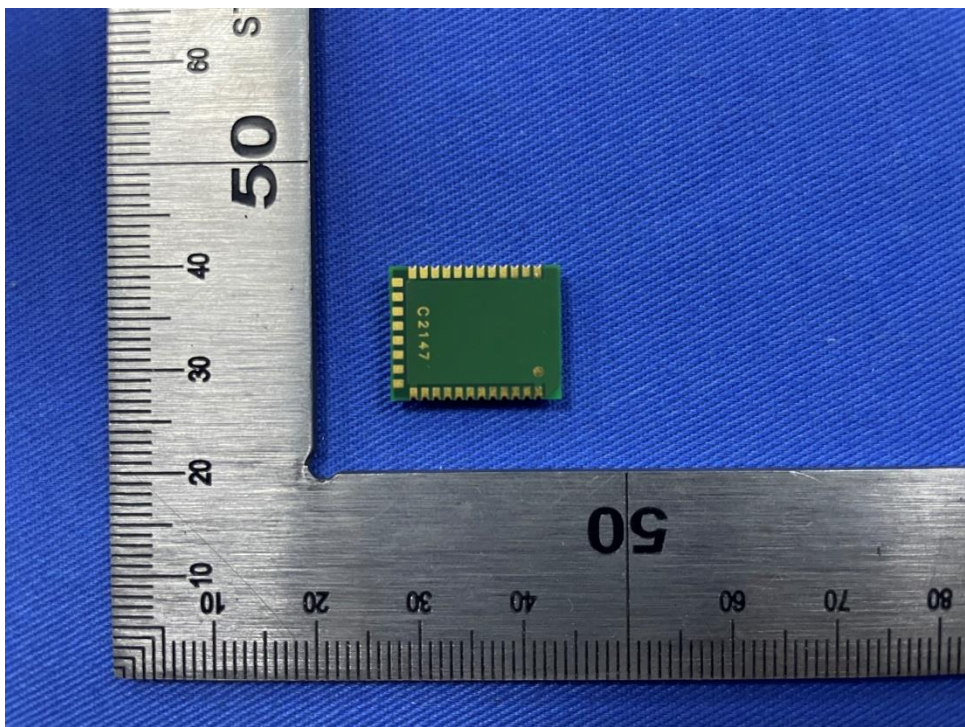

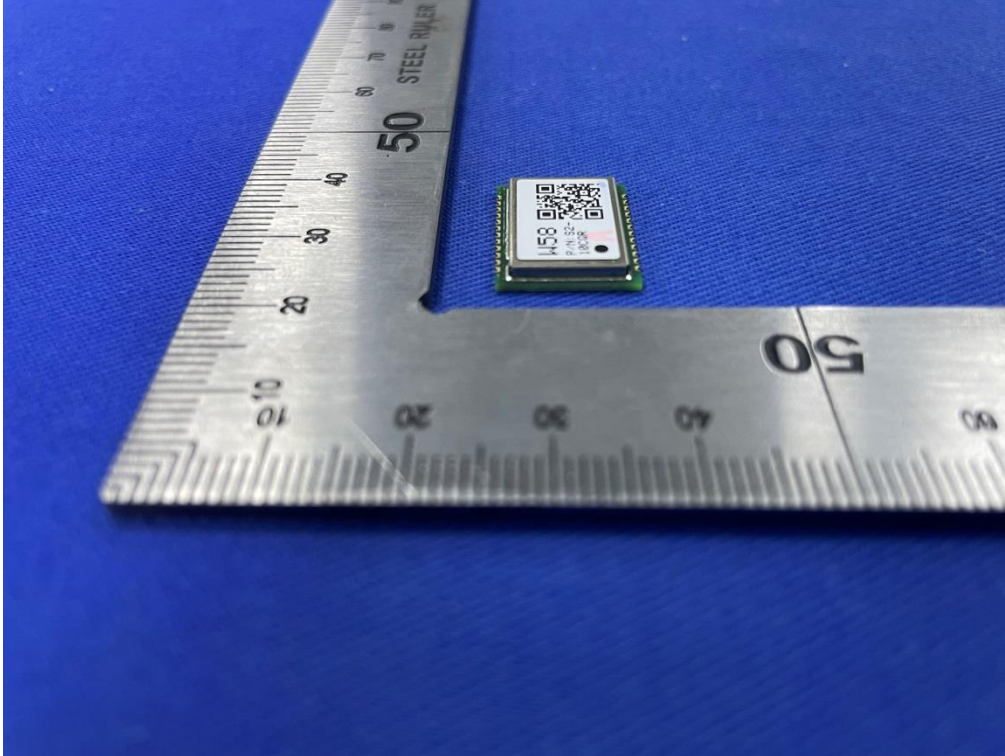

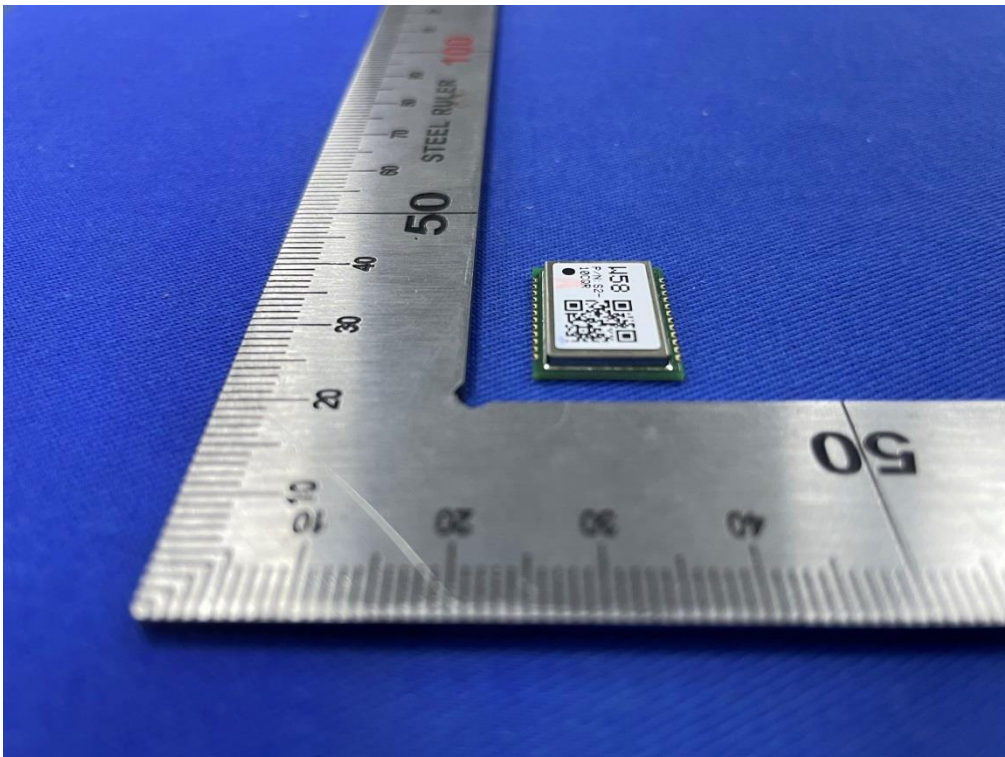

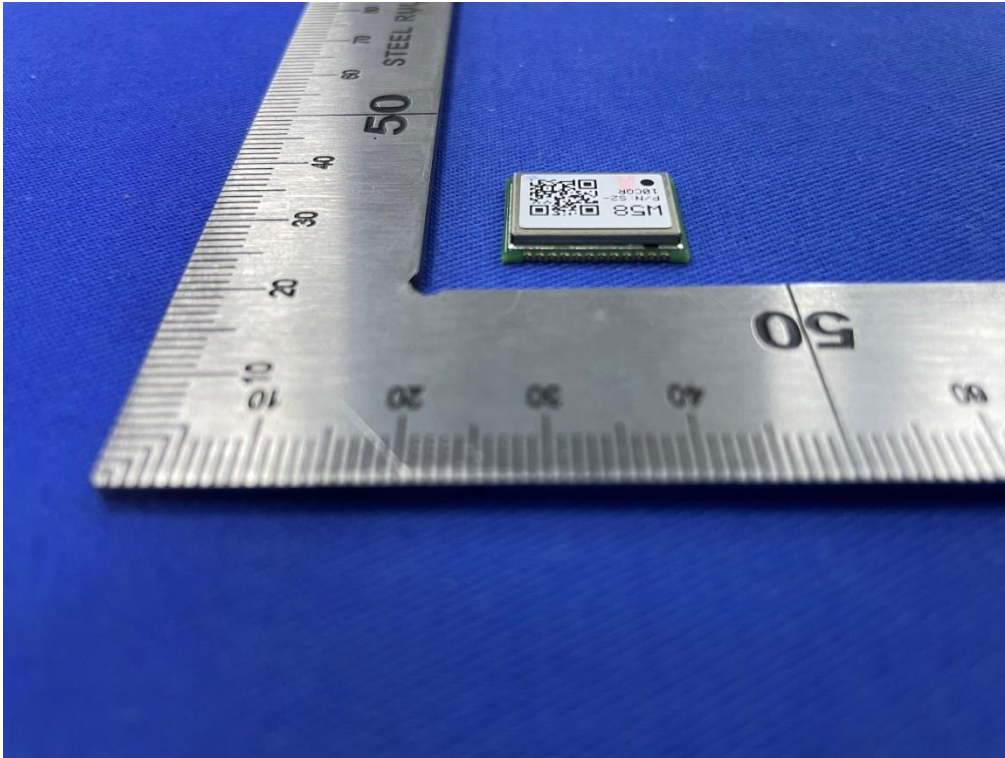
Right of the sample

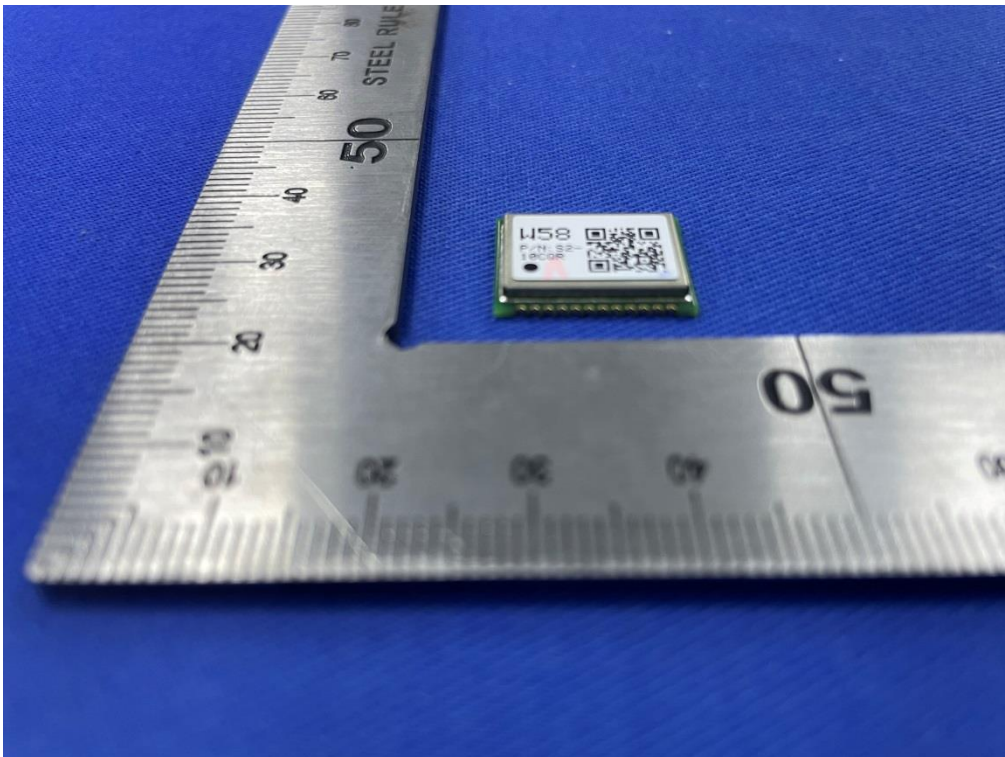

Bottom of the sample

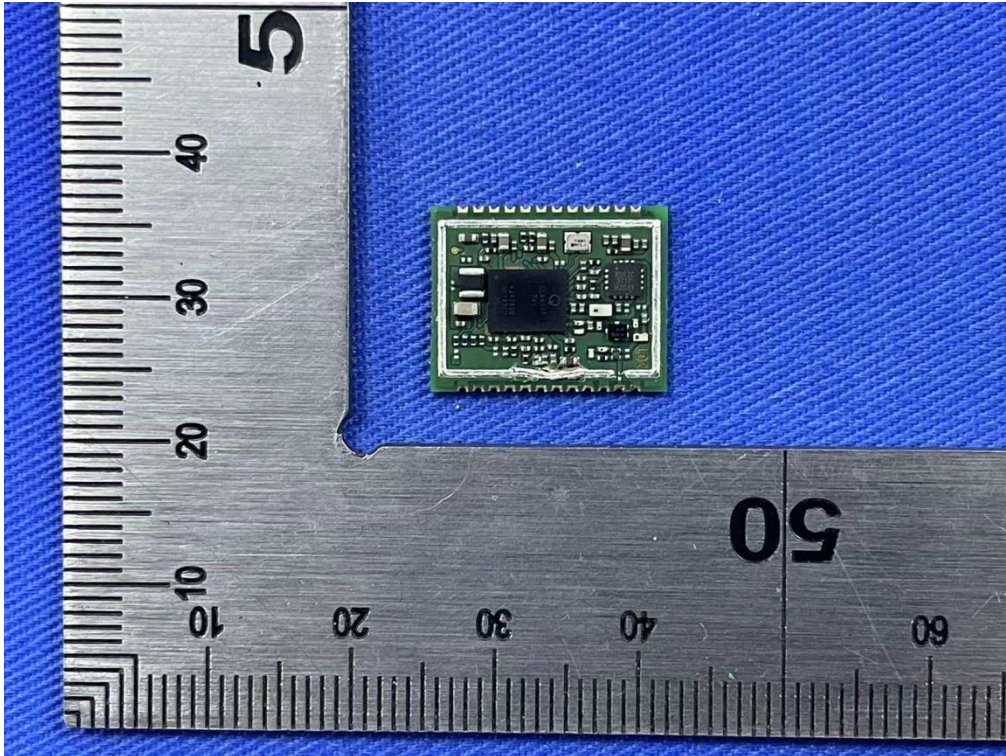

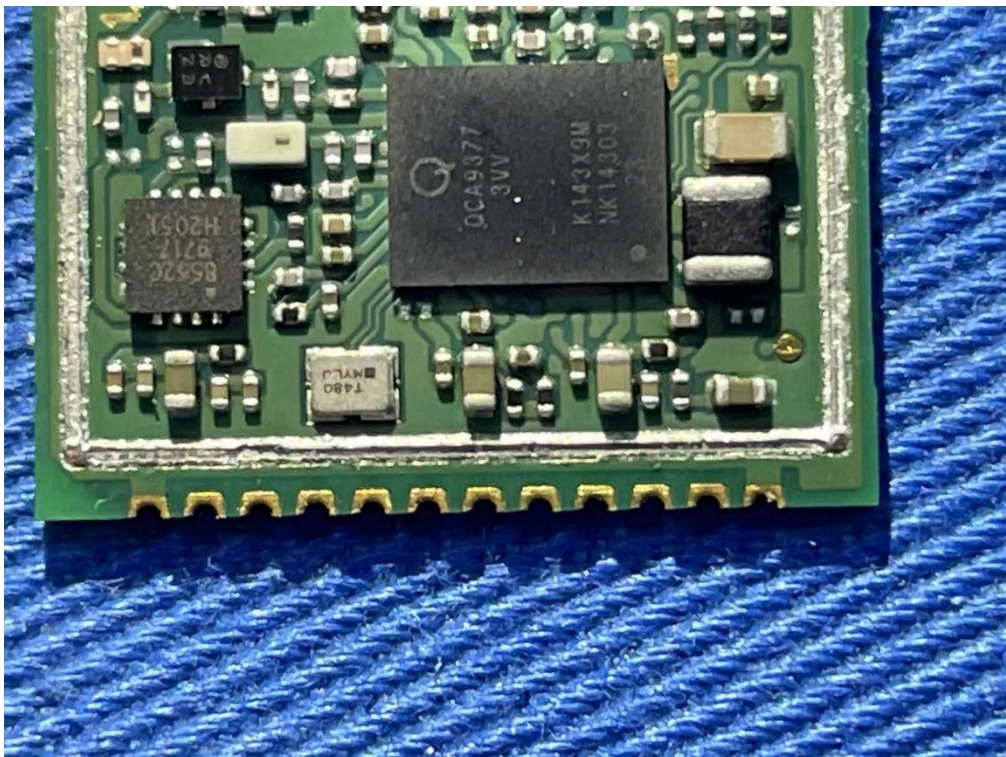
