

# **Item**

#### 1.1. Head Lift +

Press and maintain, head lift stretches out

#### 1.2. Head Lift -

Press and maintain, head lift retracts

#### 1.3. Foot Lift +

Press and maintain, foot lift stretches out

#### 1.4. Foot Lift -

Press and maintain, foot lift retracts

# 1.5. Massage head test

Click massage head button, the head massage motor switches the massage intensity, and the massage intensity cycles between 0-1-3-6;

# 1.6. Massage foot test

Click massage foot button, the foot massage motor switches the massage intensity, and the massage intensity cycles between 0-1-3-6;

#### 1.7. Massage timer test

Click the massage timer button to switch the massage motor massage time, and the massage time will cycle between 0-10min-20min-30min;

# 1.16. EXTM1 test


Click EXTM1 butoon, actuator will move in to EXTM1 position;
