1.5. Measurement results explanation example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 2.25 + 10 = 12.25 (dB)

- 7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

ANSI C63.10-2013 - Section 11.8.2

The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described above (i.e., RBW = 100 kHz, VBW \geq 3 \times RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be \geq 6 dB.

Limit

According to §15.247(a)(2), systems using digital modulation techniques may operate 902 ~ 928 MHz, 2 400 ~ 2 483.5 MHz, and 5 725 ~ 5 850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.





3.2. Output power

Test procedure

ANSI C63.10 -section 11.9.1.3 and 11.9.2.3.2



ANSI C63.10 - section 11.9.1.3

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector.

ANSI C63.10 - section 11.9.2.3.2

Alternatively, measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since this measurement is made only during the ON time of the transmitter, no duty cycle correction is required.

Limit

According to §15.247(b)(3), For systems using digital modulation in the 902~928 Mb, 2 400~2 483.5 Mb, and 5 725~5 850 Mb bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted out-put power. Maximum Conducted Out-put Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4), The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmit-ting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

- 1. Set analyzer center frequency to DTS channel center frequency.
- 2. Set the span to 1.5 times the DTS channel bandwidth.
- 3. Set the RBW : 3 kHz \leq RBW \leq 100 kHz
- 4. Set the VBW \geq 3 \times RBW.
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum amplitude level.
- 10. If measured value exceeds limit, reduce RBW(no less than 3 klb) and repeat.

Limit

According to §15.247(e), For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.





The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 Mz Emissions.




The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mz to 1 Gz emissions.

Test procedure below 30 Mbz

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- 3. We have done x, y, z planes in EUT and horizontal and vertical polarization and Parallel to the ground plane in detecting antenna.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum hold mode.

Test procedure above 30 Mbz

- 1. Spectrum analyzer settings for f < 1 GHz:
 - ① Span = wide enough to fully capture the emission being measured
 - \bigcirc RBW = 100 kHz
 - \bigcirc VBW \geq RBW
 - 4 Detector = quasi peak
 - ⑤ Sweep time = auto
 - \bigcirc Trace = max hold
- 2. Spectrum analyzer settings for $f \ge 1$ GHz: Peak
 - ① Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
 - ② RBW = 1 Mbz
 - $3 \text{ VBW} \geq 3 \text{ Mz}$
 - 4 Detector = peak
 - ⑤ Sweep time = auto
 - \bigcirc Trace = max hold
 - 7 Trace was allowed to stabilize

- 3. Spectrum analyzer settings for $f \ge 1$ GHz: Average
 - ① Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
 - \bigcirc RBW = 1 Mbz
 - 3 VBW $\geq 3 \times RBW$
 - ① Detector = RMS, if span/(# of points in sweep) \leq (RBW/2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied, then the detector mode shall be set to peak.
 - (5) Averaging type = power(i.e., RMS)
 - 1) As an alternative, the detector and averaging type may be set for linear voltage averaging.
 - 2) Some instruments require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used.
 - \bigcirc Sweep = auto
 - \bigcirc Trace = max hold
 - 8 Perform a trace average of at least 100 traces.
 - A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:
 - 1) If power averaging (RMS) mode was used in step \bigcirc 5, then the applicable correction factor is $10 \log(1/x)$, where x is the duty cycle.
 - 2) If linear voltage averaging mode was used in step \bigcirc 5, then the applicable correction factor is $20 \log(1/x)$, where x is the duty cycle.
 - 3) If a specific emission is demonstrated to be continuous (≥ 98 percent duty cycle) rather than turning on and off with the transmit cycle, then no duty cycle correction is required for that emission.

- 7. The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z, it was determined that **X orientation** was worst-case orientation; therefore, all final radiated testing was performed with the EUT in **X orientation**.
- 8. The worst-case emissions are reported however emissions whose levels were not within 20 dB of respective limits were not reported.
- 9. All channels, modes (e.g. 802.11b/g/n (20, 40 Mb BW)), and modulations/data rates were investigated among DTS band. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

10. According to exploratory test no any obvious emission were detected from 9 kHz to 30 MHz. Although these tests were performed other than open field test site, adequate comparison measurements were confirmed against 30 m open field test site. Therefore sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 414788.

According to 15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section 15.209(a) is not required. In addition, radiated emission which in the restricted band, as define in section 15.205(a), must also comply the radiated emission limits specified in section 15.209(a) (see section 15.205(c))









According to 15.207(a), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50uH/50 ohm line impedance stabilization network (LISN). Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequencies ranges.


