



































<p><b>SETUP</b></p> <ol style="list-style-type: none"> <li>Download the Petcube App and register your account </li> <li>Power up the camera and wait for yellow light to flash </li> <li>Press the Setup button on the side speaker above the USB port until you hear a sound </li> <li>Follow instructions in the app to finish the setup</li> </ol>	<p><b>PLACEMENT</b></p> <p>It's best to point Bites 2 Lite in the direction where your pets spend most of their time so their activities are captured with the wide-angle lens.</p>  <p>If placing on a table or a shelf, put Bites 2 Lite at least 3 feet above the floor. A rubber foot at the bottom provides a firm grip on the surface.</p> 	<p>If you want to hang the camera on a drywall, anchor screws are included in the packaging for easy and secure setup.</p>  <p>Wall mounted position gives extra protection from eager pets and allows for the best room coverage.</p> 	<p><b>DISPENSER SETUP</b></p> <p><b>Detachable Treat Container</b></p> <p>Detach the treat container by pushing the release buttons on both sides and pulling it up away from the base.</p>  <p><b>Control Treat Portions</b></p> <p>3 orange inserts help control how many treats you fling at once. Usually it flings 1-3 treats at a time. The insert for medium-size treats is preset by default. For small and large size treats, use the other included inserts.</p> 	<p><b>TREAT COMPATIBILITY</b></p>  <p>Petcube Bites 2 Lite is compatible with a variety of treat brands. We recommend dry crunchy treats with dimensions of 1" or less.</p> <p>Use your pet's favorite compatible treats.
