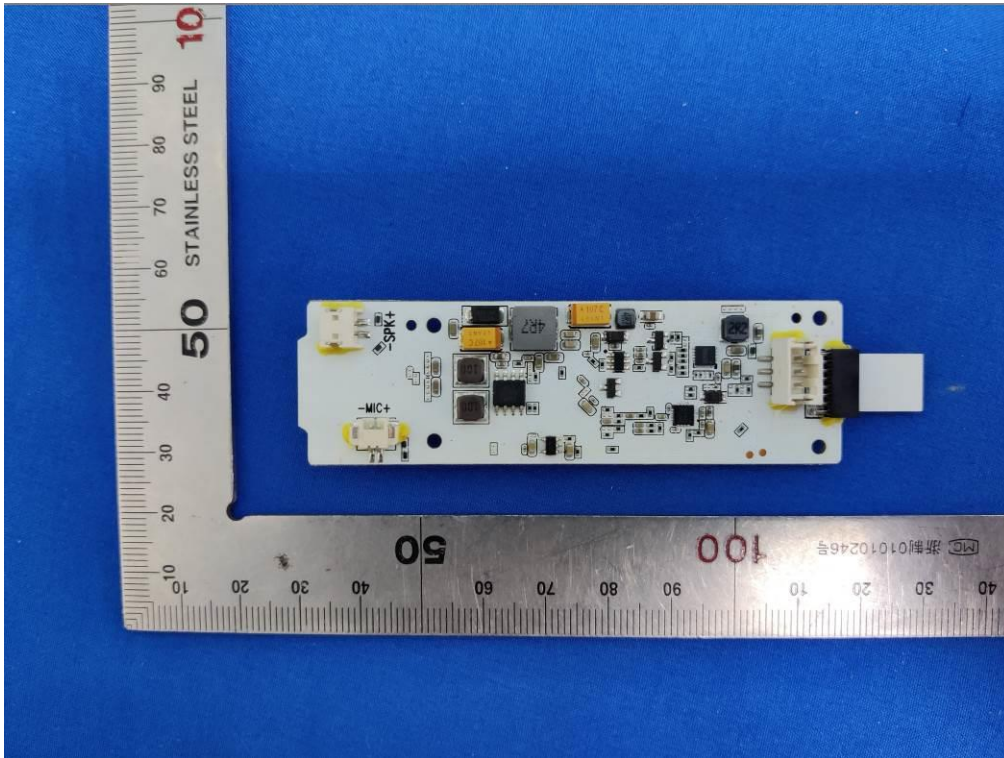

INTERNAL VIEW OF EUT-2

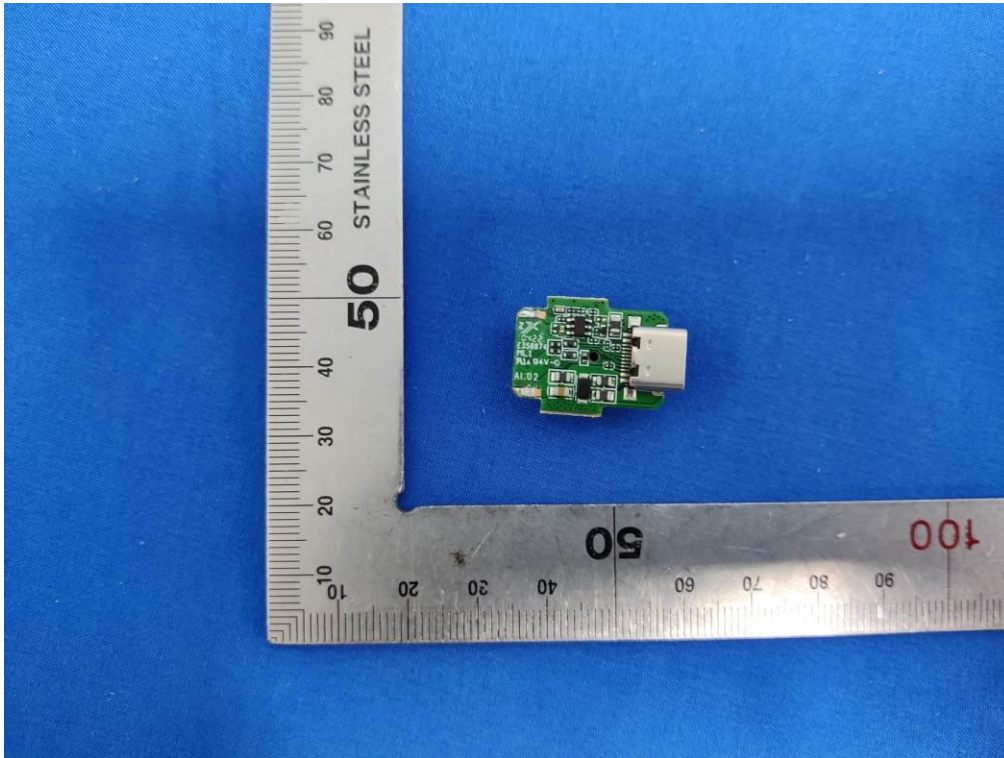


INTERNAL VIEW OF EUT-3

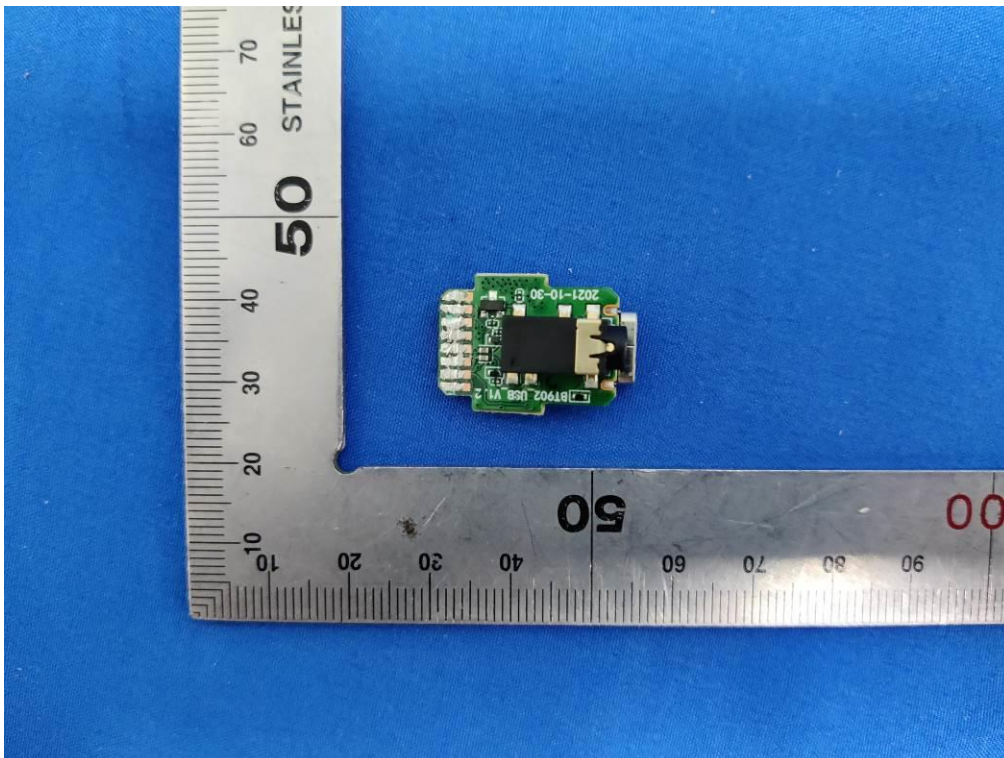

INTERNAL VIEW OF EUT-4

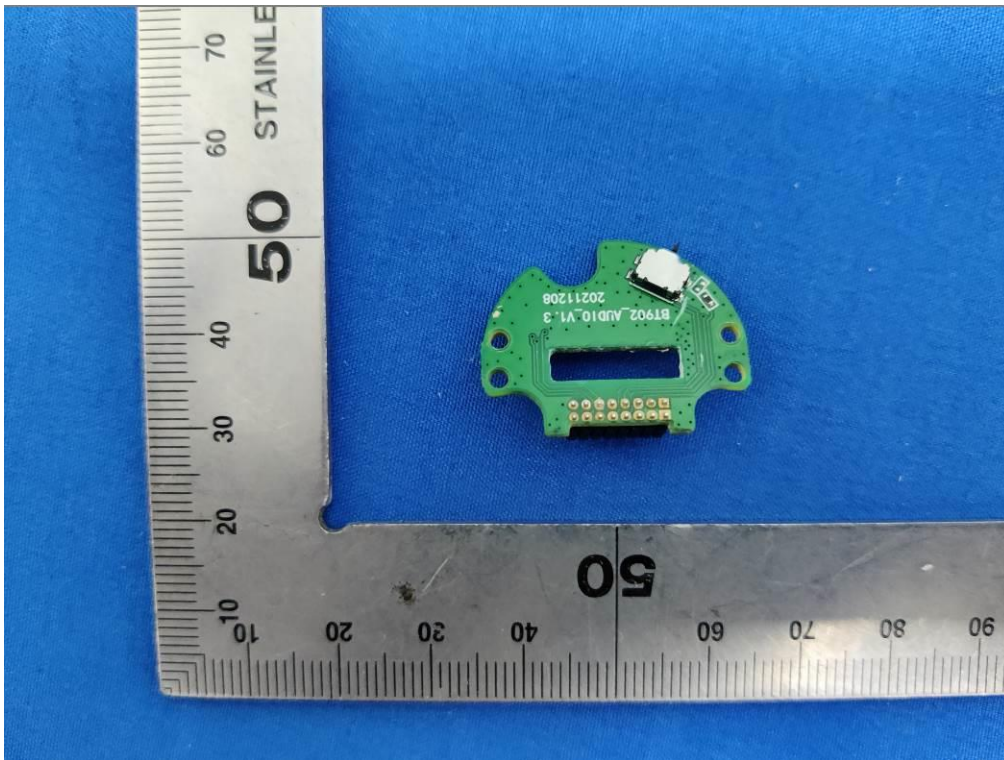


INTERNAL VIEW OF EUT-5

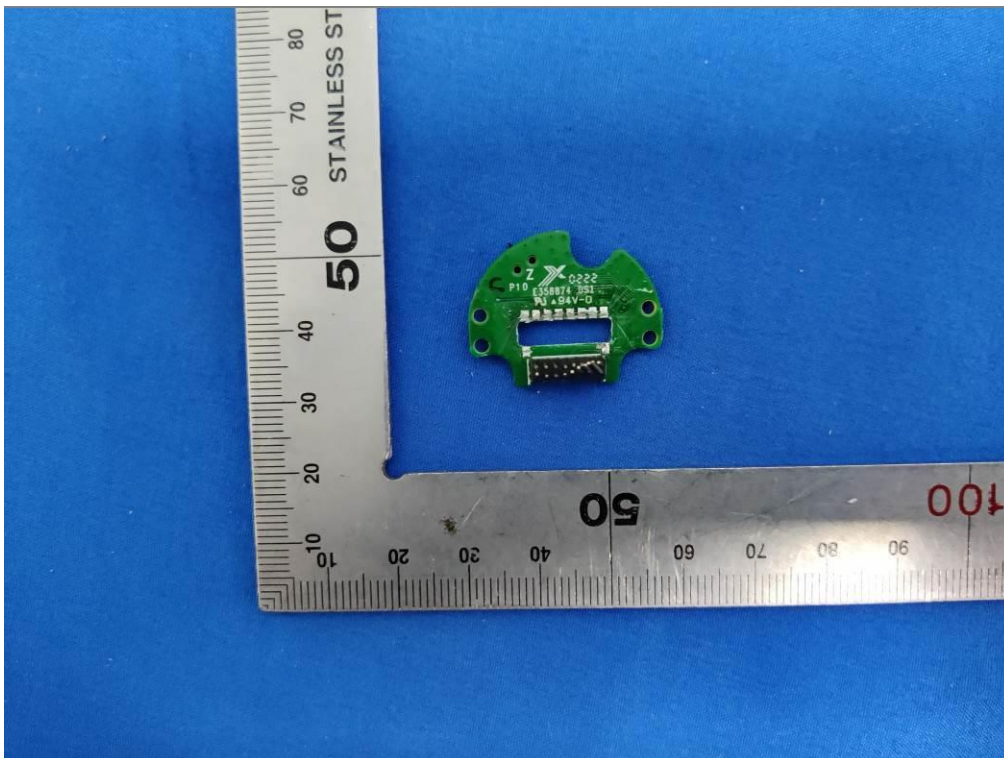
