Setting Up Your SF Rush

- Once the app is downloaded, open it and follow the on-screen instructions to complete the pairing of your SF Rush with your phone. Please ensure that all permissions asked for are approved so that the app can function properly.

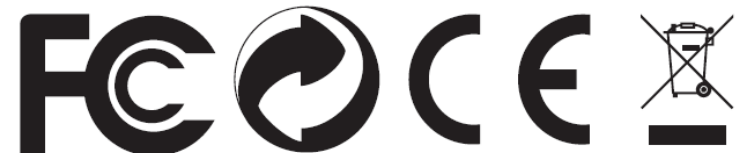

Precautions
