

1. MAXIMUM PERMISSIBLE EXPOSURE (MPE)

1.1 Standard Applicable

According to § 1.1307(b)(1), system operating under the provisions of this section shall be operating in a manner that the public is not exposed to radio frequency energy level in excess limit for maximum permissible exposure.

(a) Limits for Occupational / Controlled Exposure

Note: f = frequency in MHz; * = Plane-wave equivalent power density

1.2 MPE Calculation Method

$$S = (30 * P * G) / (377 * R^2)$$

S = power density (in appropriate units, e.g., mw/cm²)

P = power input to the antenna (in appropriate units, e.g., mw)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor is normally numeric gain.

R = distance to the center of radiation of the antenna (in appropriate units, e.g., cm)

1.3 MPE Calculation Result

Device category: Mobile device

For Wi-Fi:

Maximum peak output power: 17.82 (dBm)

Maximum peak output power at antenna input terminal: 60.5341(mW)

Prediction distance: >20(cm)

Prediction frequency: 2462 (MHz)

Antenna gain: 0.5 (dBi)

Directional gain: 1.12 (numeric)

The worst case is power density at prediction frequency at 20cm: 0.014(mw/cm²)

MPE limit for general population exposure at prediction frequency: 1 (mw/cm²)

For Bluetooth:

Maximum peak output power: -0.13 (dBm)

Maximum peak output power at antenna input terminal: 0.97(mW)

Prediction distance: >20(cm)

Prediction frequency: 2480 (MHz)

Antenna gain: 0.5 (dBi)

Directional gain: 1.12 (numeric)

The worst case is power density at prediction frequency at 20cm: 0.002(mw/cm²)

MPE limit for general population exposure at prediction frequency: 1 (mw/cm²)

For simultaneous:

Wi-Fi + Bluetooth: 0.016(mW/cm²)

$0.016(\text{mw}/\text{cm}^2) < 1 (\text{mw}/\text{cm}^2)$

So the transmitter complies with the RF exposure requirements and the SAR is not required.
