CONNECT THE YELLOW USB CABLE TO THE USB PORT WITH THE YELLOW RING AROUND THE IT. CONNECT THE REMAINING 2 USB CABLES AND MICRO USB CABLE INTO THE PORTS. AFTER CONNECTING THE USB CABLES INTO THE PORTS, CLOSE THE USB HOLDER AROUND THE BASE OF THE POWER BANK AND PLACE IN SMART BATTERY POCKET THE ZIP POCKET CLOSED. ONCE THE USB CABLES ARE CONNECTED THE BREATHING LIGHTS IN THE NAMEPLATE WILL FLASH.

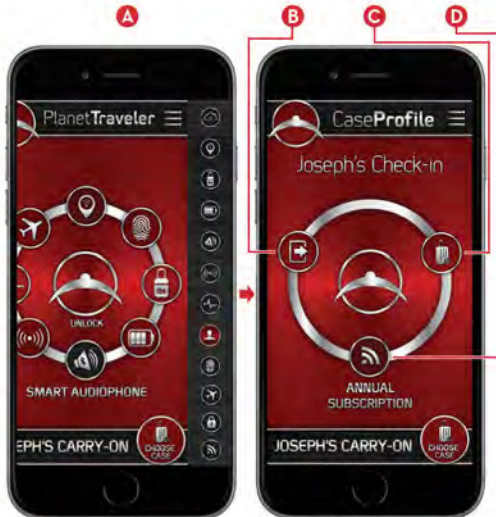

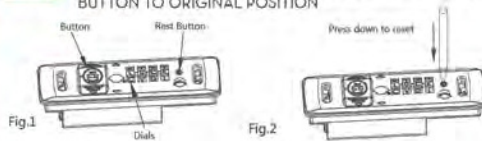

TSA ROBOTIC LOCK RESETTING COMBINATION ON LOCK

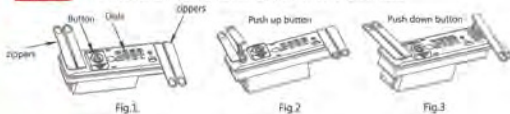
THE OPENING COMBINATION IS PRESET AT L-U-C-K FROM FACTORY.

- STEP 1** TURN THE DIALS TO THE OPENING COMBINATION
- STEP 2** PRESS DOWN THE RESET BUTTON WITH A PEN (OR OTHER TOOL) ALL THE WAY UNTIL YOU HEAR A "CLICK" SOUND.
