

1 Installation

- 1. Insert the arm into the receiver and secure with the pin.
- 2. Move the flexible arm and angle the projector to the desired distance and angle.
- 3. Connect the 4-Way connectors of the Hitch Demon and the Vehicle. (The running lights must be on for the Hitch Demon to receive power. This can be done by turning on the headlights.)





Turn Hitch Demon On

The eyes of the Hitch Demon logo on the back of the device will glow when it is receiving power from the vehicle (the headlights of the vehicle may need to be turned on). Press the left eye to turn the Hitch Demon on.

2 Using the App

2.1 Installation

Download App

- 1. Open Google Play or App Store on your mobile device.
- 2. Search for and select the Hitch Demon App.
- 3. Press Install or Get depending on your device.
- 4. Follow any prompts to finalize the installation.

2.2 Connecting to Hitch Demon

Connect to the Network

- 1. Turn the Hitch Demon on.
- 2. Navigate to the WiFi settings on your mobile device.
- 3. Select the Hitch Demon's network (Default is HitchDemon-*serial number*).

Launch App

Find the Hitch Demon icon on your mobile device and select it to launch the app.
