What's in the box

In your Targetize kit you will find:

Targetize sensor Targetize sensor mounting rail USB cable

Android & iOS Requirements

Android 5 or newer.

iPhone 5 or newer, iOS 8 or newer.

Older phone versions may still work with the system, but with limited compatibility.

Charging your sensor

Initial charging

We recommend fully charging the sensor prior to first time use. A full charge is indicated by all 5 LED lights staying on and may take up to 3 hours.

How to charge your sensor

Step 1:

To charge, connect the sensor with the provided charger.

Step 2:

Connect the micro-USB cable to the charger and a power supply; the LEDs will light up to indicate battery level.

Note: Using other power supply adaptors will void the product warranty.

Targetize sensor installation

Step 1 -

Unscrew the nut of the provided mounting rail to spread it open. While open, insert the Targetize sensor into the space reviled, the Targetize logo should be visible through the gap.

Step 2 - Attaching the sensor mount:

While holding the sensor & mount together, position the mount onto the picatinny rail and turn the nut so that the mount clamp onto the rail.

Sensor button functionality

To turn the sensor on:

Press the sensor button once.

The LEDs will light up one by one to show battery charge level.

To turn the sensor off:

Press the sensor button for 3 seconds, all three LEDs will flash once The sensor will also turn off automatically after a period of no activity.

To check battery status:

Press the sensor button once.

The LEDs will light up one by one to show battery charge level.



Sensor LED indications

All LEDs flashing – sensor is ready to pair Middle LED flashing – Sensor is paired and ready for use All LEDs flashing sequentially – Sensor is charging 1 LED flashing quickly – Sensor battery is low

Using your smartphone with Targetize:

Step 1 – Download the Targetize app

Download the Targetize app from the

and follow the steps as instructed to set up your account.

Step 2 – Connect the sensor with your smartphone:
Start the Targetize app. Turn the sensor on by pressing the sensor button once. Open the sync devices drawer via the icon at the top right corner of the app, select the sensor from the list of possible devices and press connect. When connected successfully, the sensor's level of charge will be presented next to its name.
You are now ready for your first session! Press start, and enjoy!

Targetize sensor is a motion sensor with a transceiver Module which operates in the 2.4GHz frequency spectrum. The transceiver module is based on a BLE 4.1.
