

## **Using Your Mindkoo BH09**

#### 1.Turn on/off



Mindkoo BH09 will automatically turn off after 5 minutes if no device is connected.

### 2.Pair with your device






With the Mindkoo BH09 off, hold the Multifunction Button for 3s to power on Mindkoo BH09 and Mindkoo BH09 will automatically connect to the last connected device.

With the Mindkoo BH09 off, hold the Multifunction Button for 5s to enter Pairing mode.

To pair a different device, first disable Bluetooth on the connected device to re-enter pairing mode. Then repeat the pairing steps.


Having connection problems? Remove Mindkoo BH09 from your device's Bluetooth history, ensure it's less than 1 meter away then try pairing again.

#### 3. Connect via AUX



When using AUX mode, control audio playback via the connected device.

#### 4. Charge your Mindkoo BH09



Mindkoo BH09 will beep every 10 s when the battery is low.
