Plug your Mini Plug into an available outlet and power on the plug, the small LED light at the top will blink steadily, waiting to be associated with your mobile device. **Step 2:**

association process. You can also name your device after you clicked on it.



The small LED light at the top will blink blue rapidly when associating. The light becomes solid blue when the device associated successfully. The notice would be popped out to indicate that the association process is finished. The plug will be shown on the 'Associated Devices' list if associated successfully. Tap the 'return' icon in the top left corner



#### Step 3:

In the home page you will see the name of the associated plug. It means you have successfully associated the plug. Now you can tap the plug to enter the control panel.
