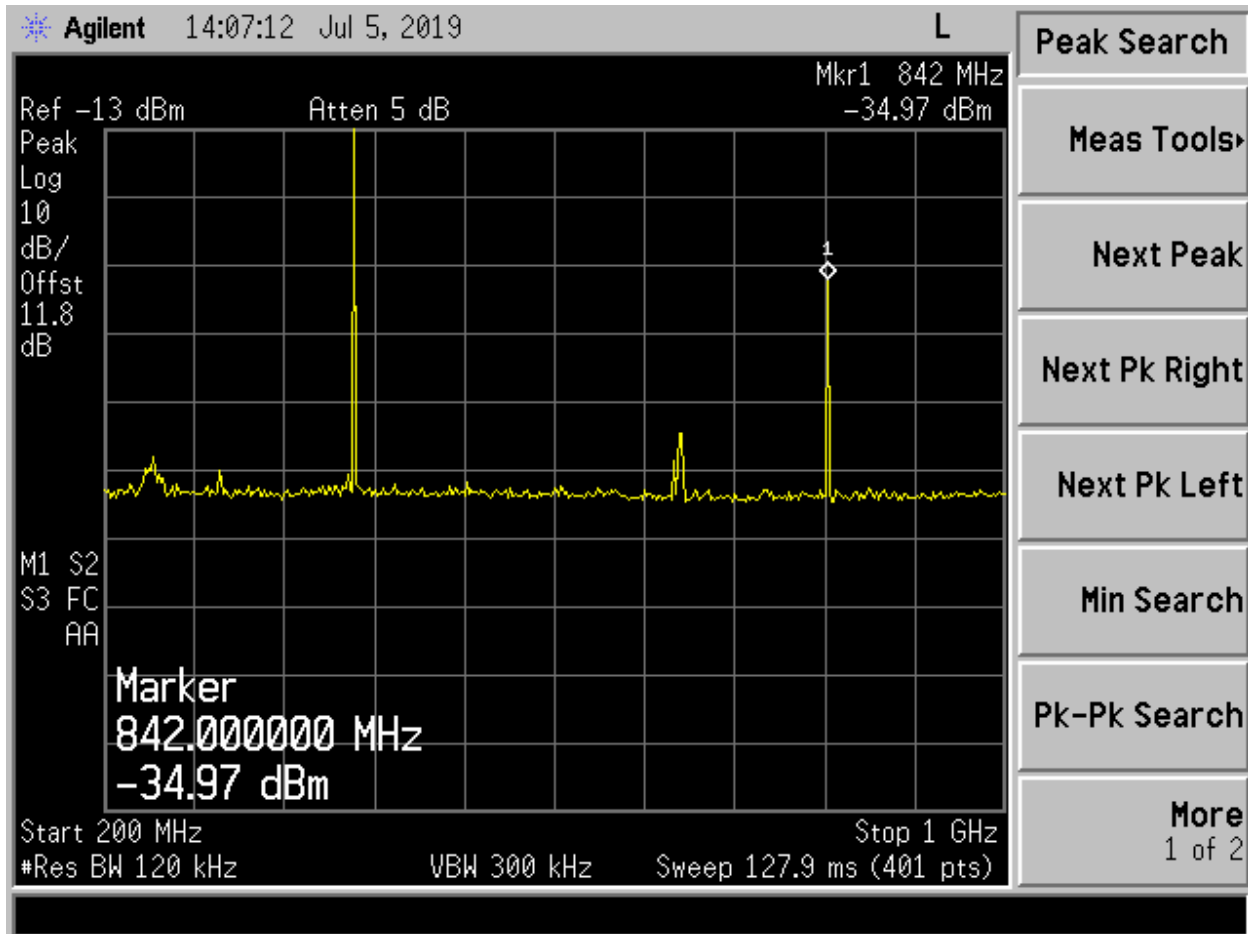


Figure 187. 421 MHz Horizontal, 200 MHz - 1 GHz

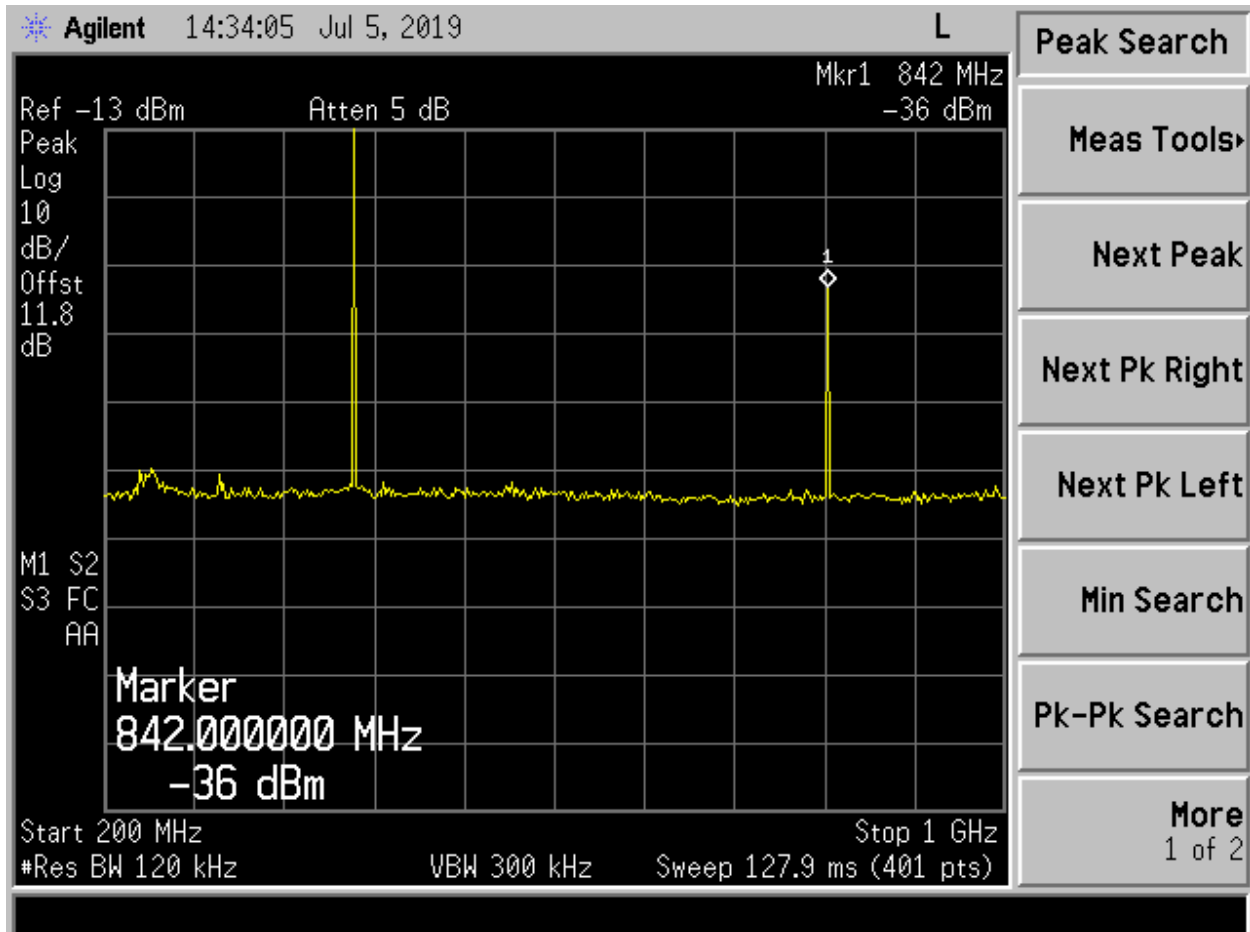


Figure 188. 421 MHz Vertical, 200 MHz - 1 GHz

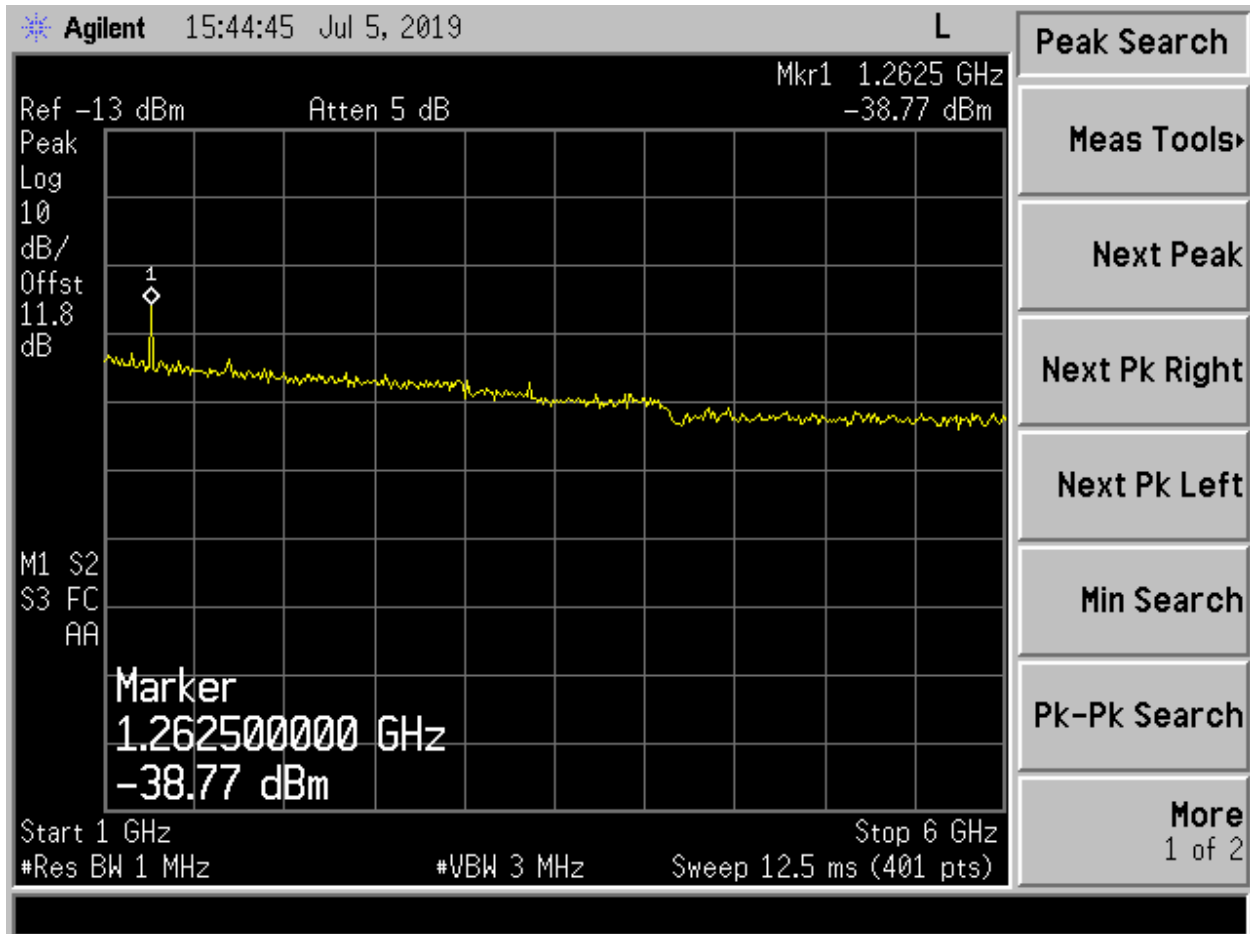


Figure 189. 421 MHz Horizontal, 1 – 6 GHz

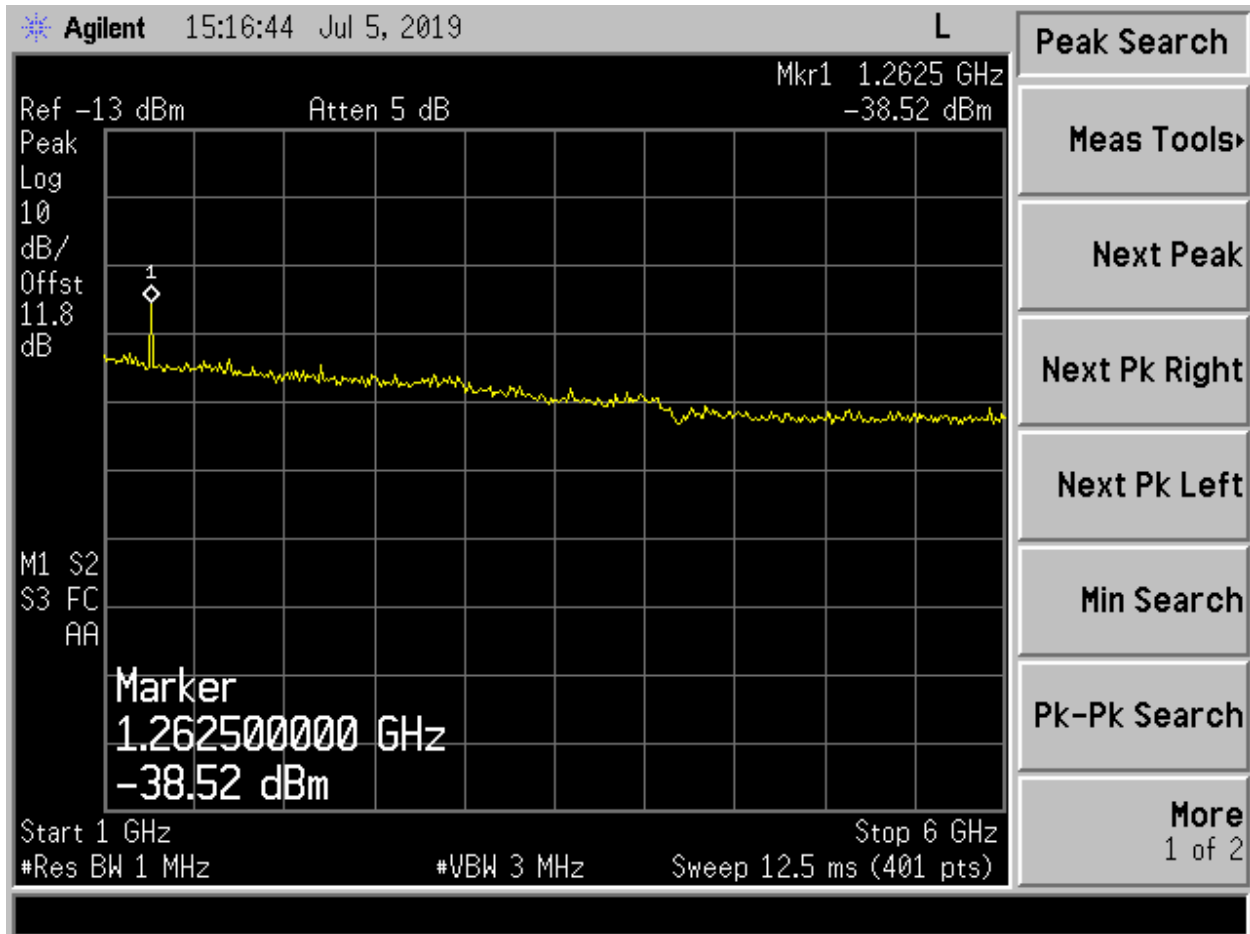


Figure 190. 421 MHz Vertical, 1 – 6 GHz

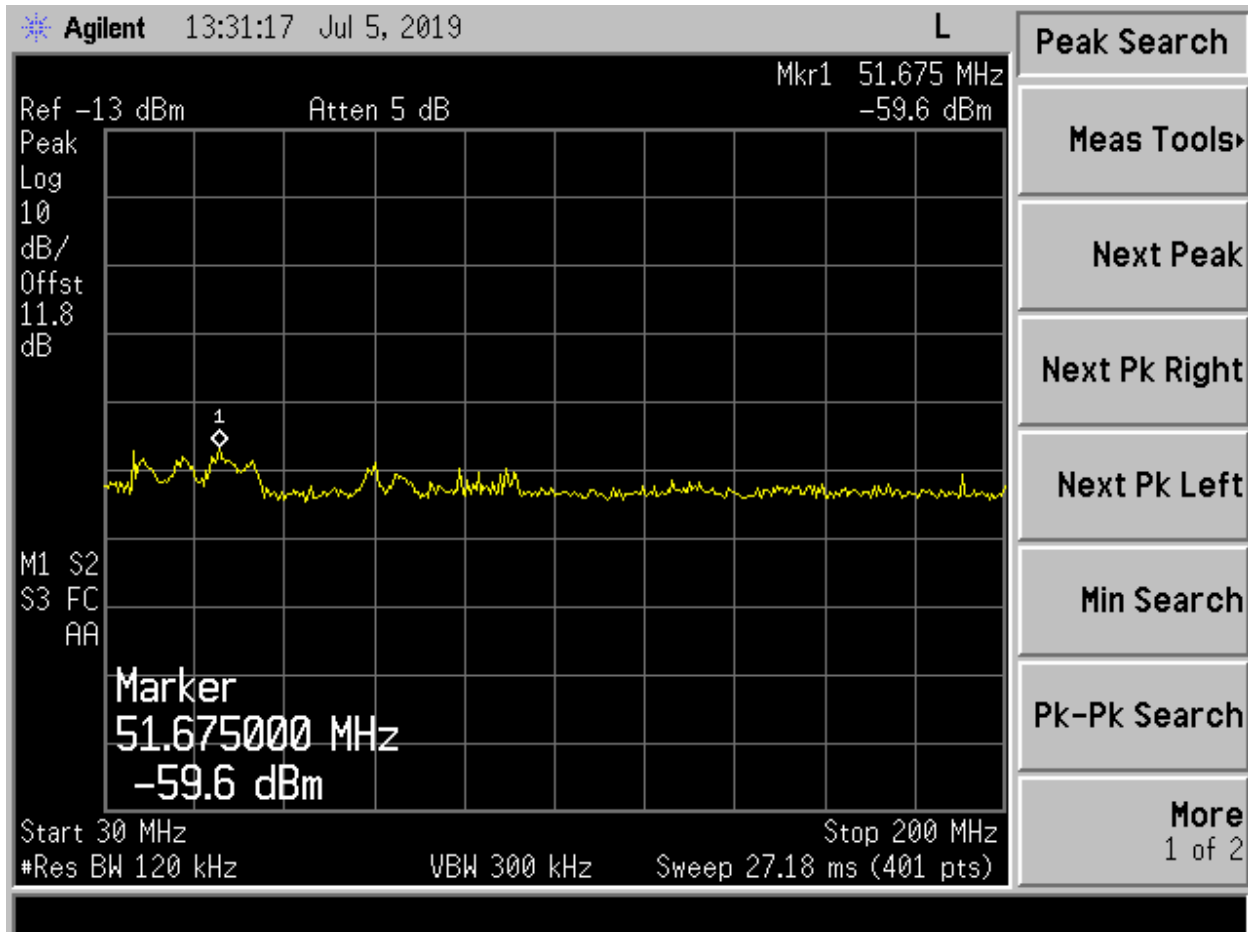


Figure 191. 480 MHz Horizontal, 30 – 200 MHz

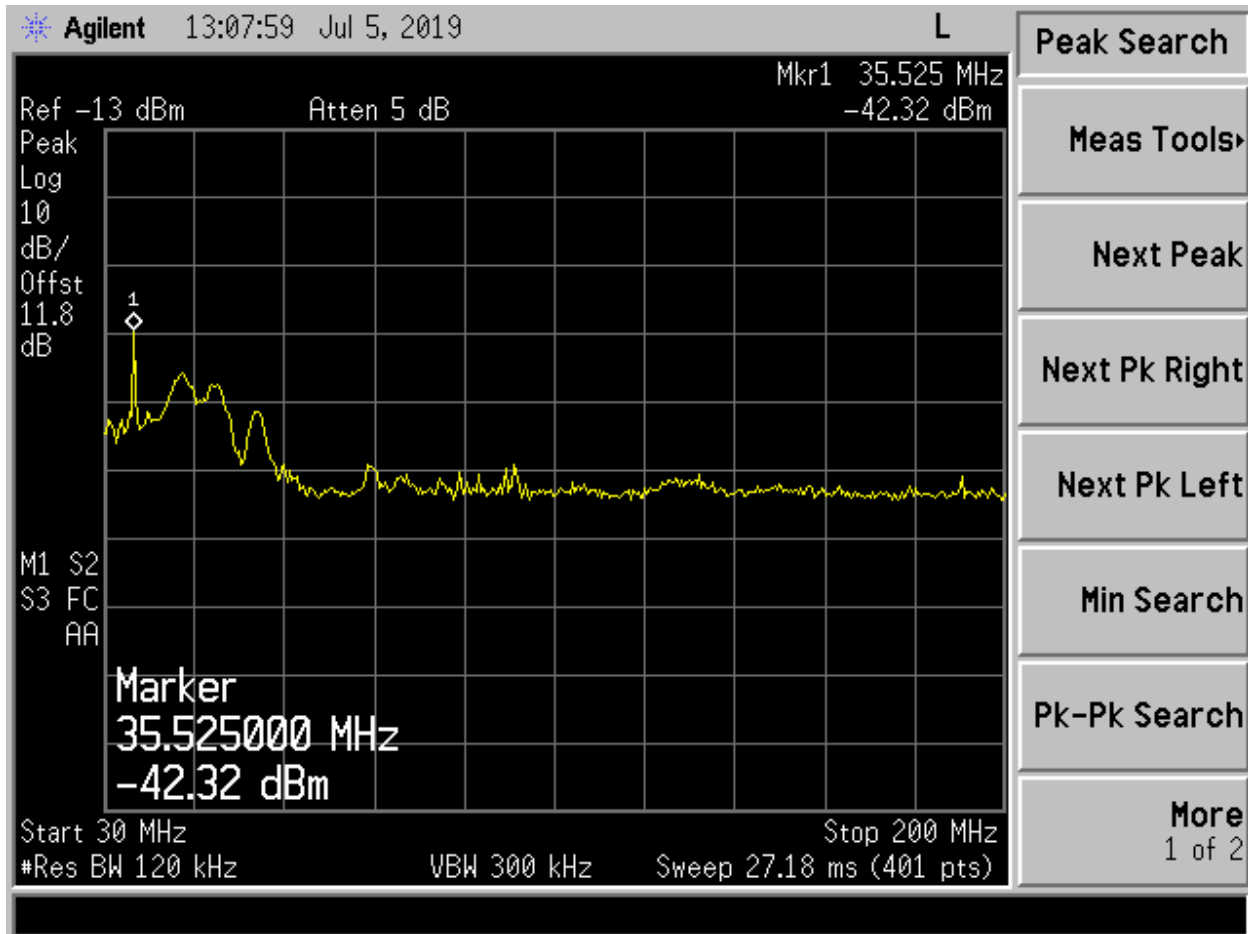


Figure 192. 480 MHz Vertical, 30 – 200 MHz

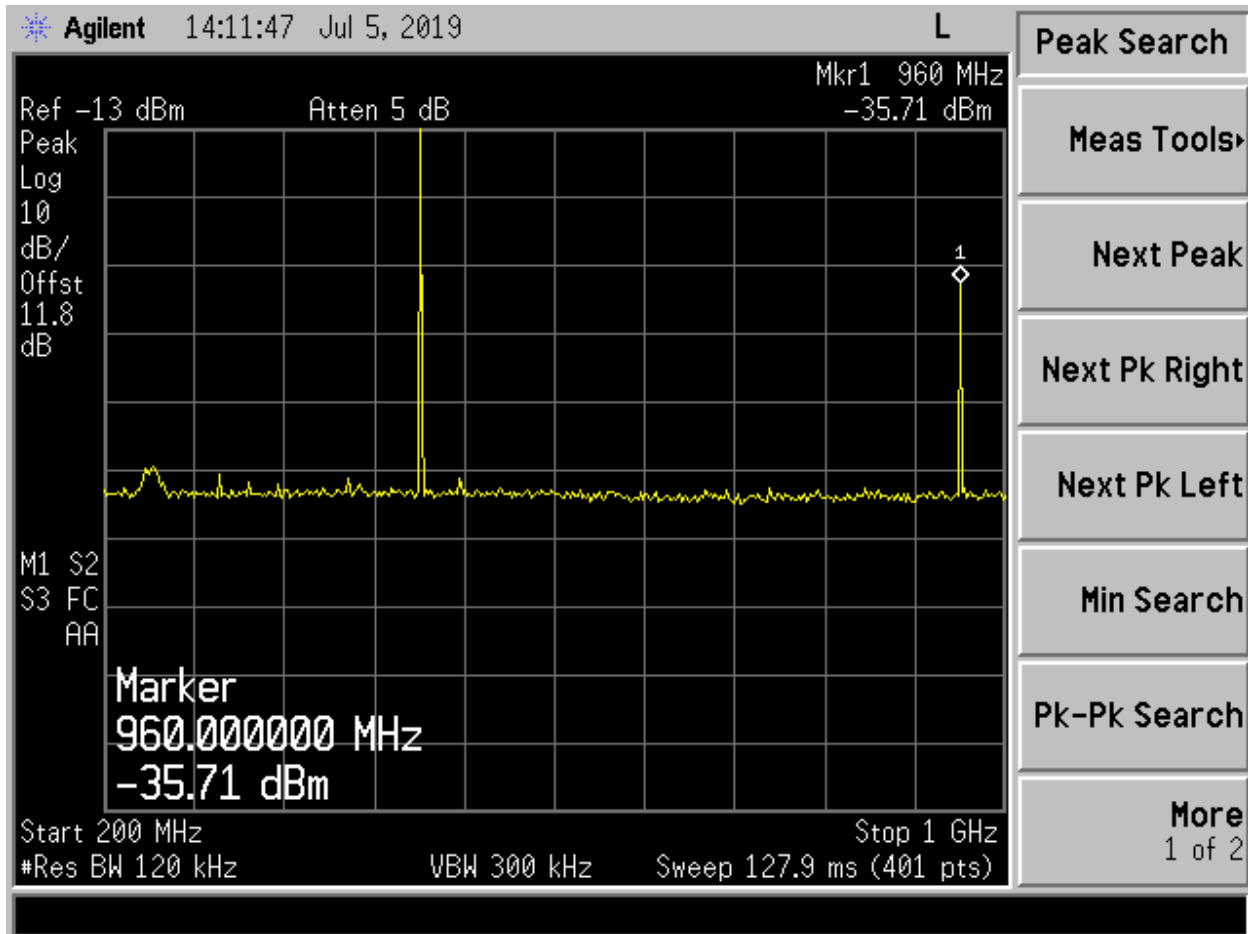


Figure 193. 480 MHz Horizontal, 200 MHz – 1 GHz



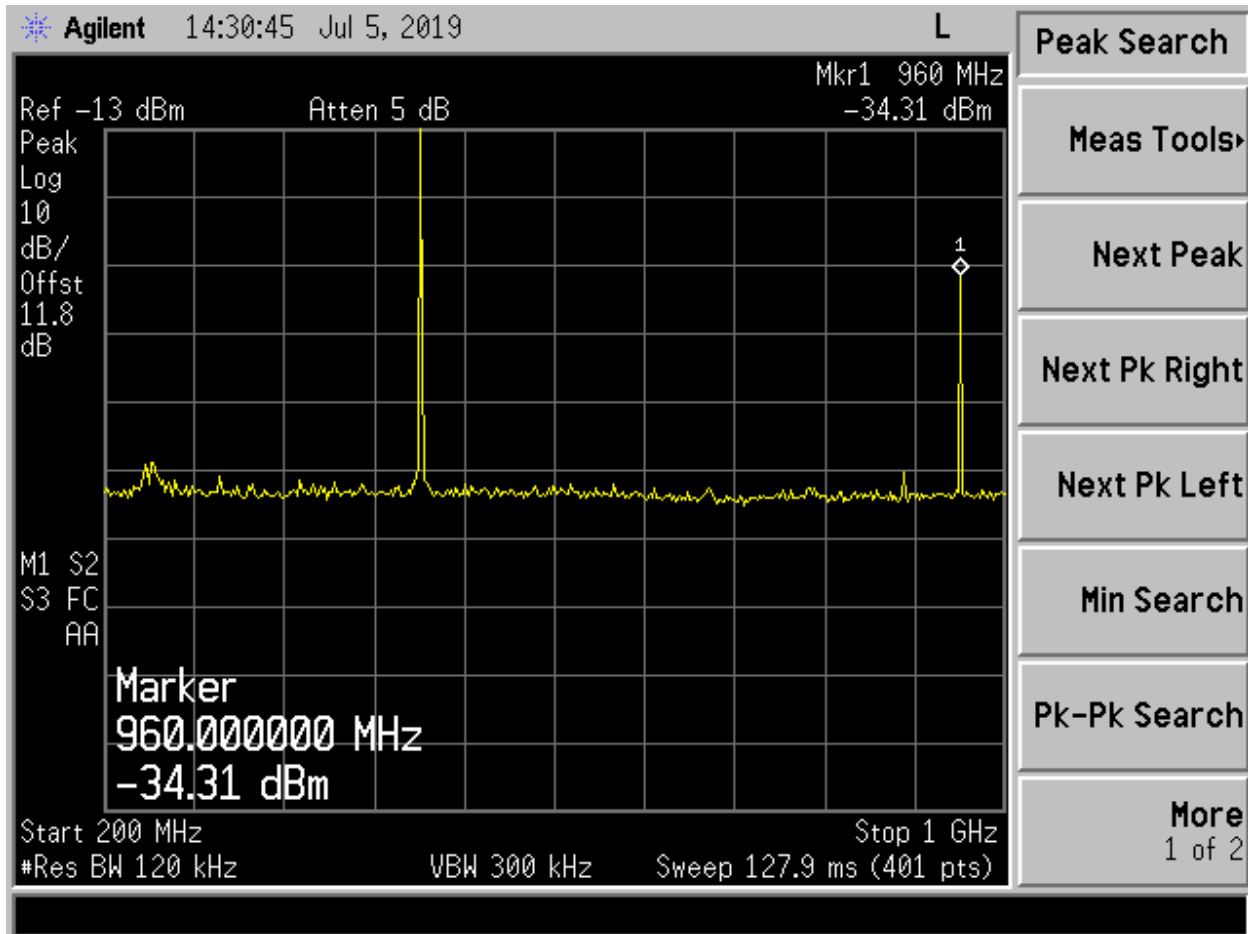


Figure 194. 480 MHz Vertical, 200 MHz – 1 GHz

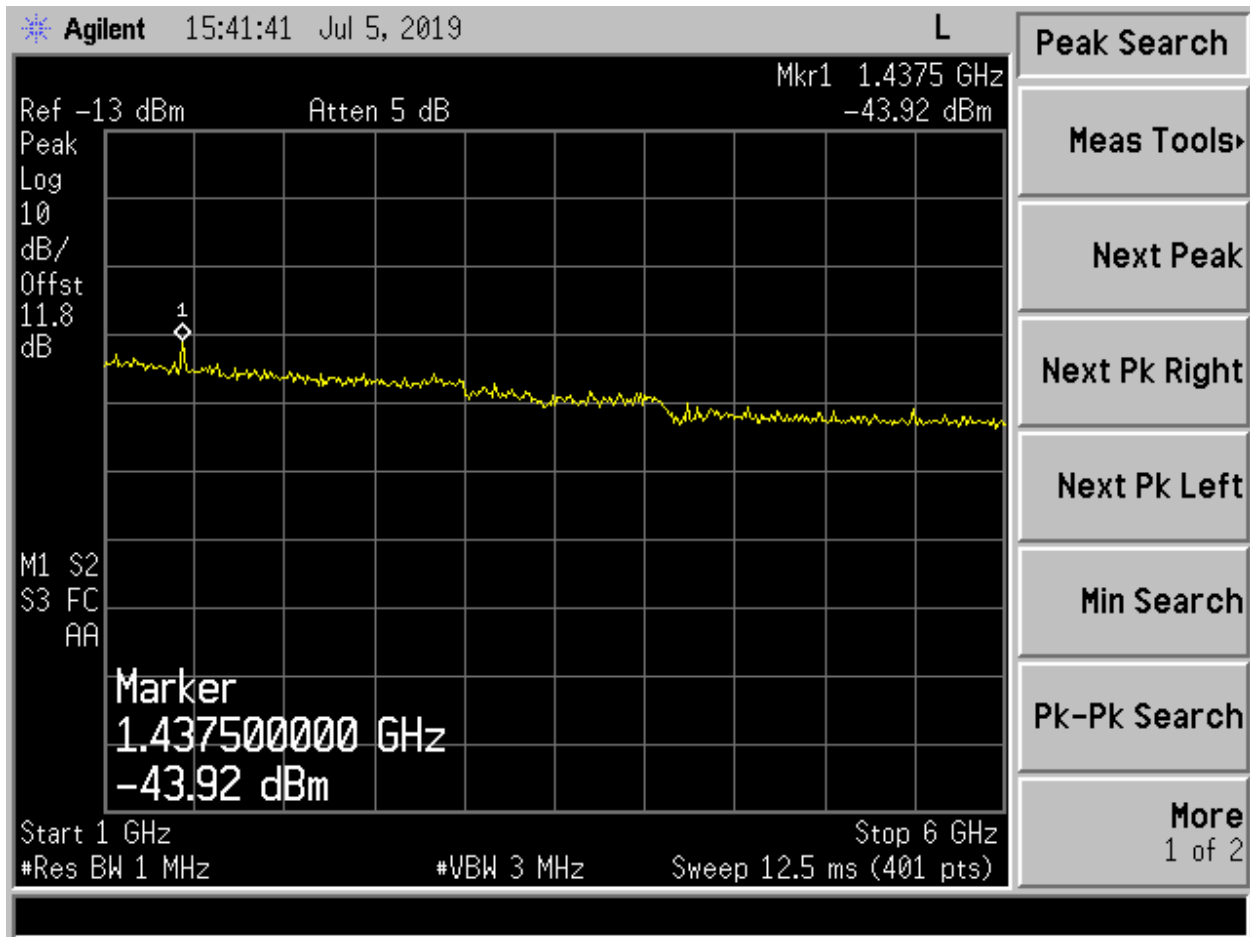


Figure 195. 480 MHz Horizontal, 1 – 6 GHz

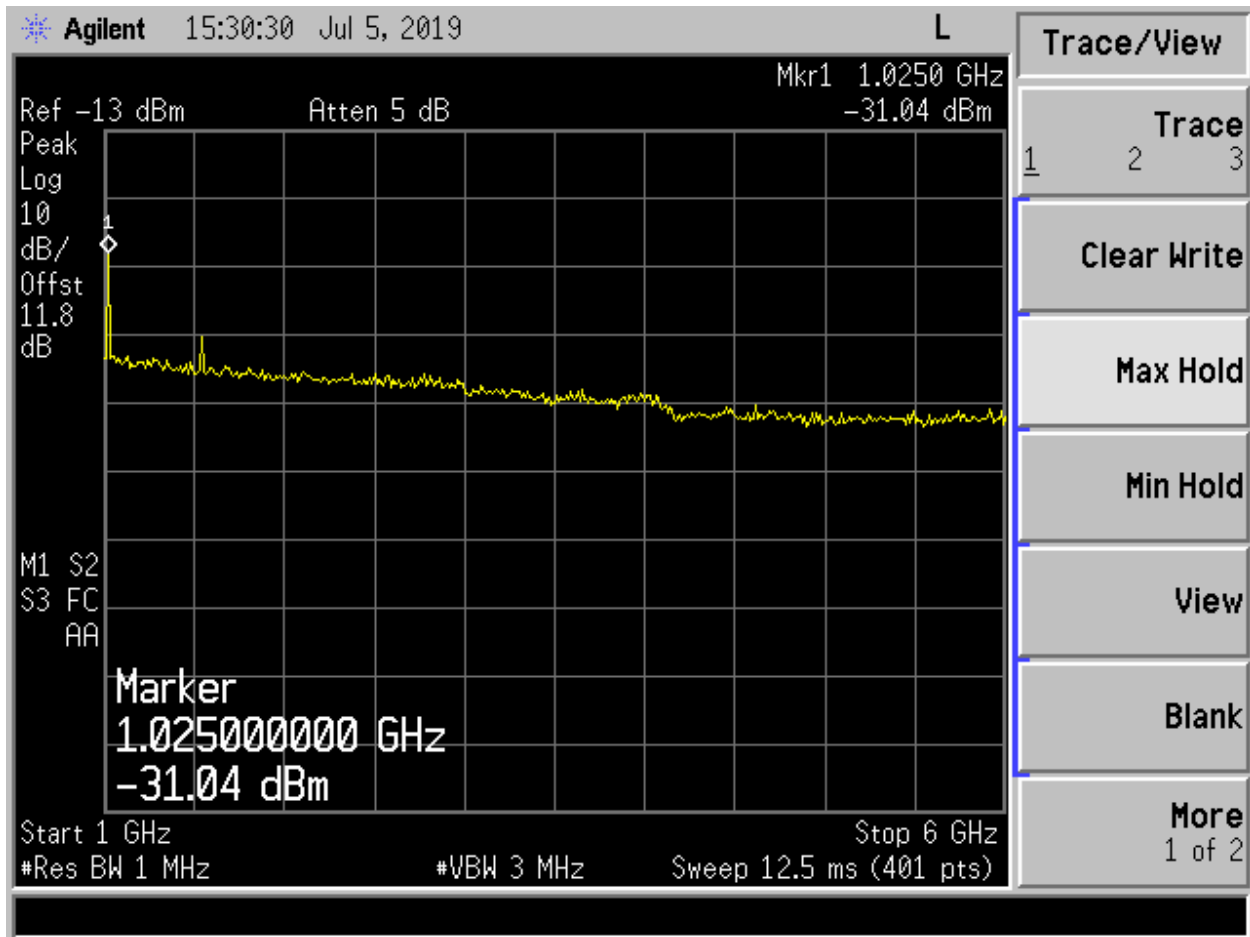


Figure 196. 480 MHz Vertical, 1 – 6 GHz

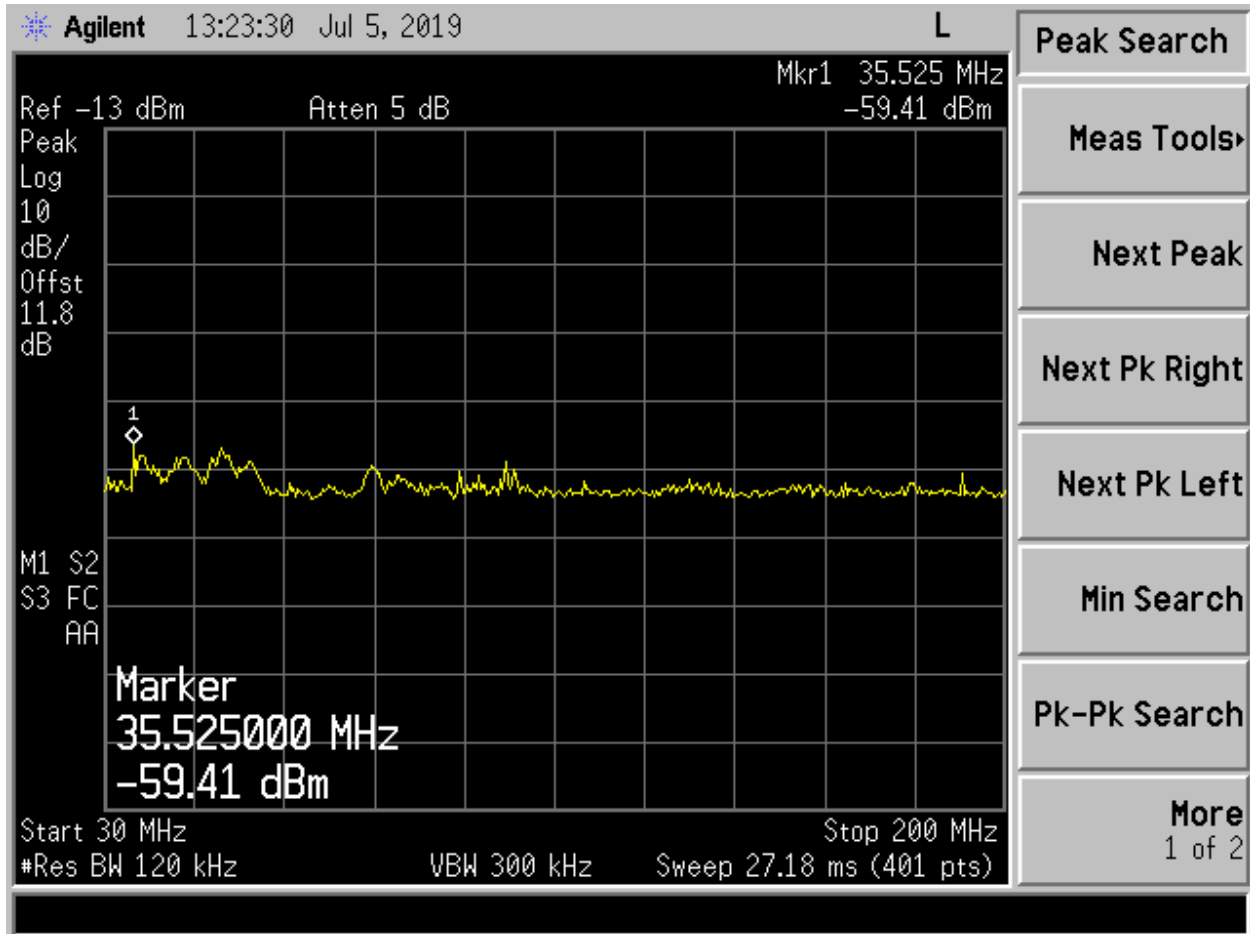


Figure 197. 512 MHz Horizontal, 30 - 200 MHz

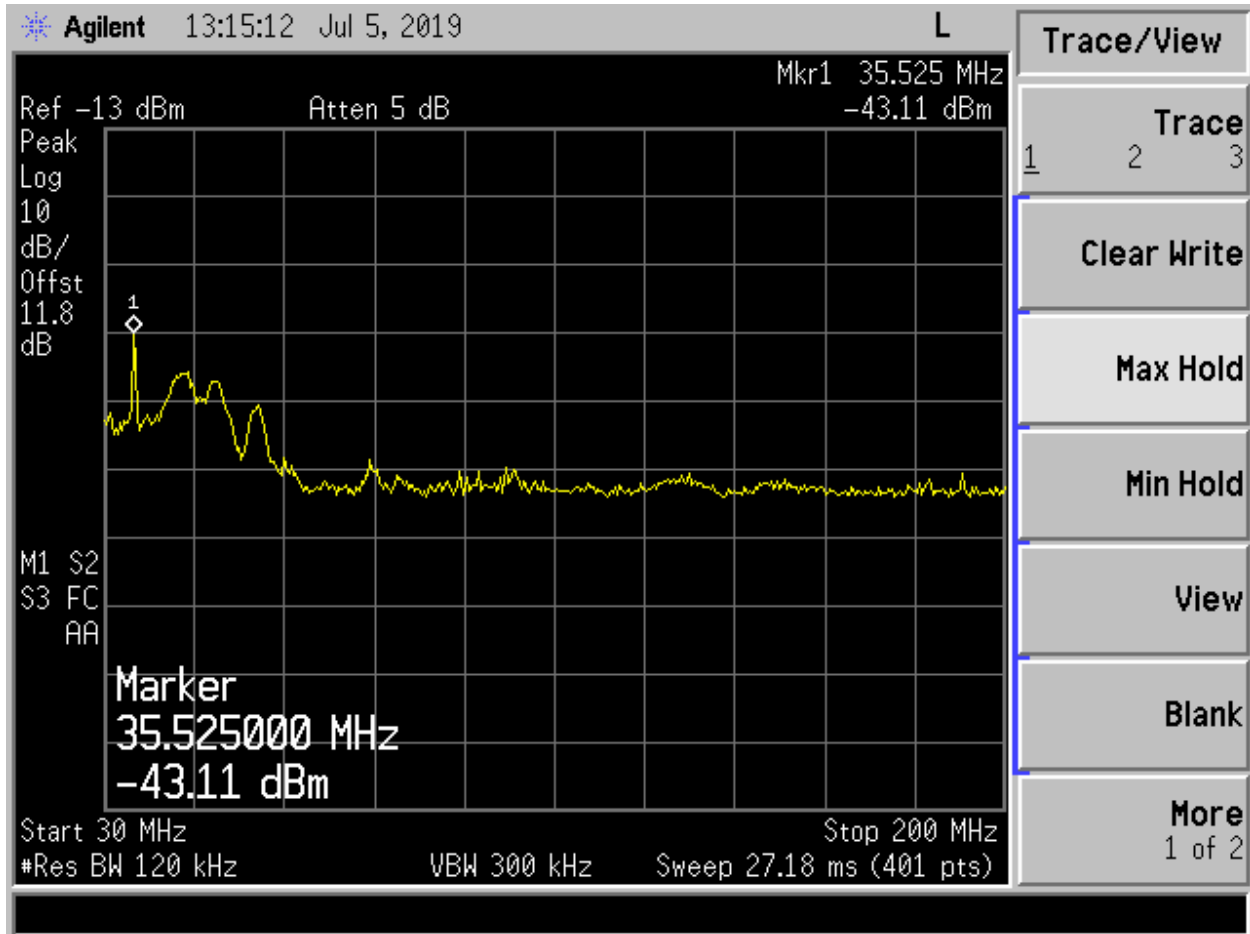


Figure 198. 512 MHz Vertical, 30 - 200 MHz

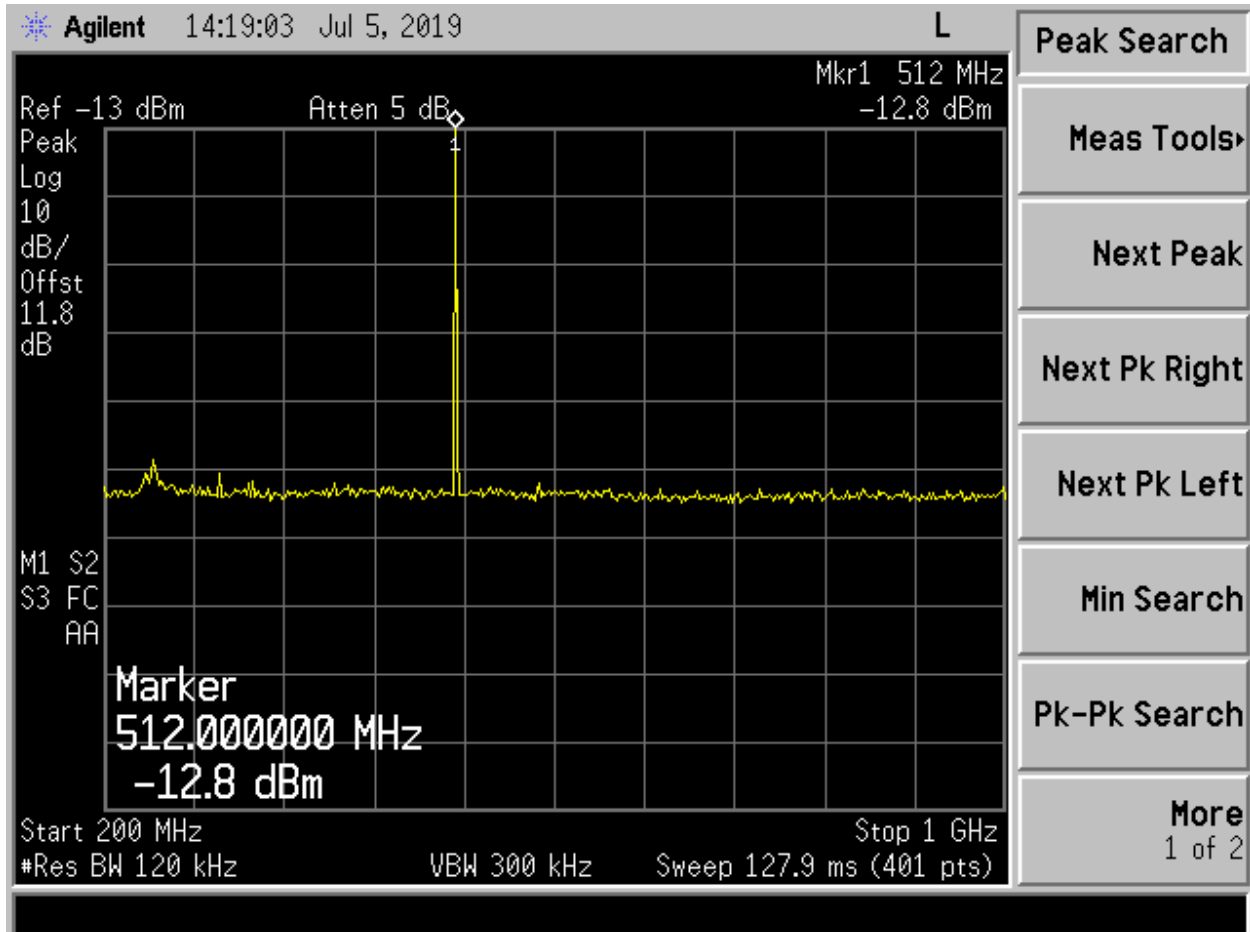


Figure 199. 512 MHz Horizontal, 200 MHz – 1 GHz

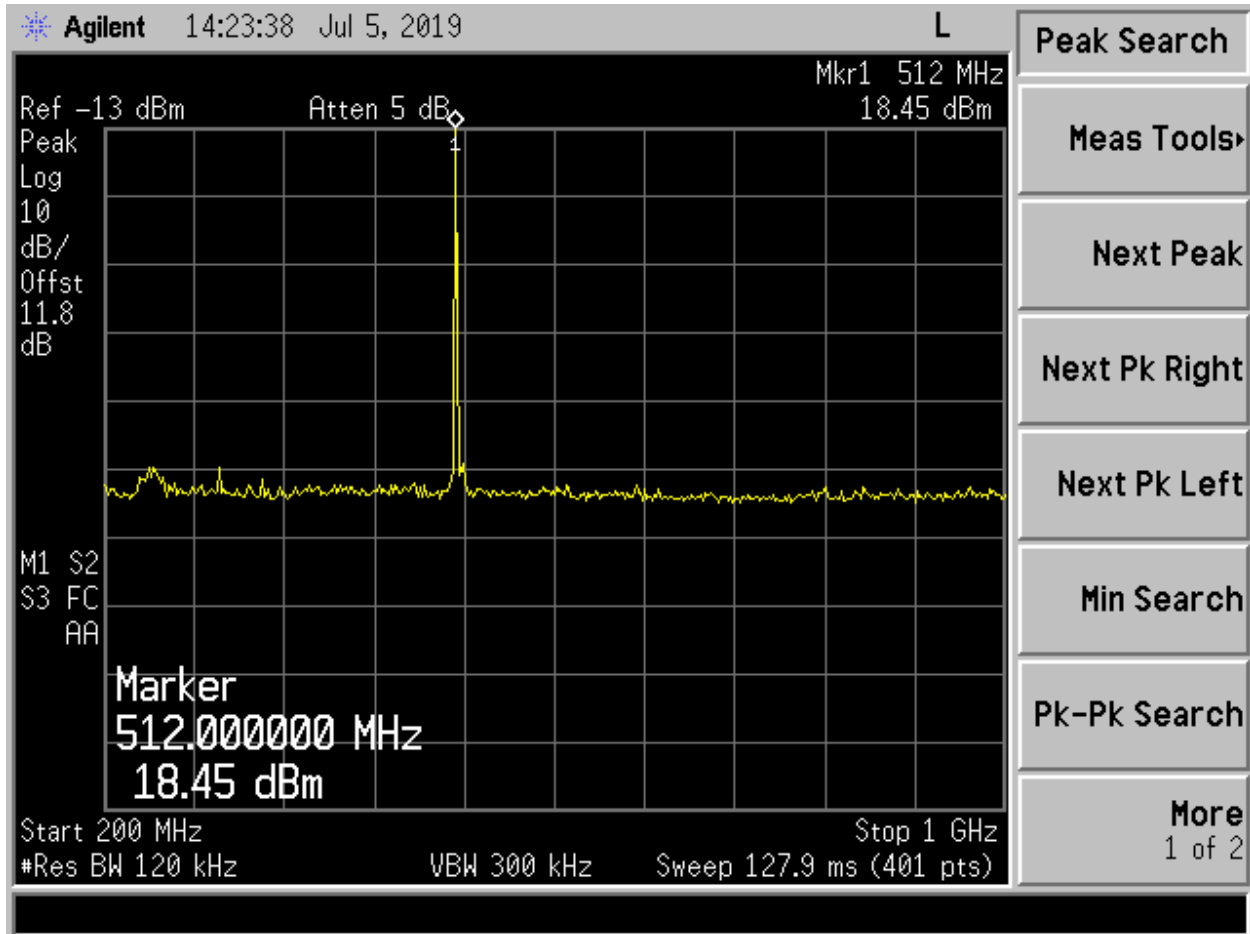


Figure 200. 512 MHz Vertical, 200 MHz – 1 GHz

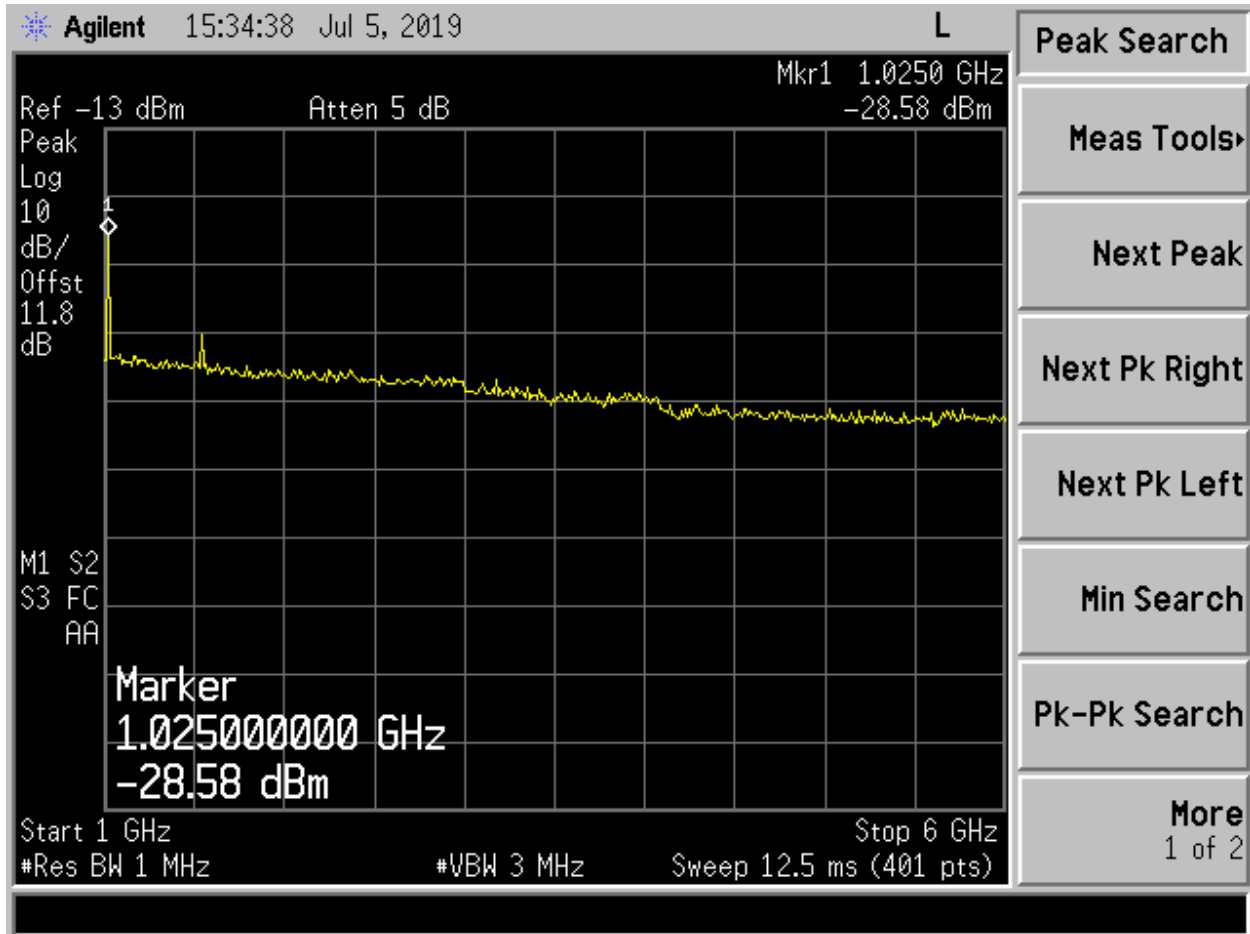


Figure 201. 512 MHz Horizontal, 1 – 6 GHz



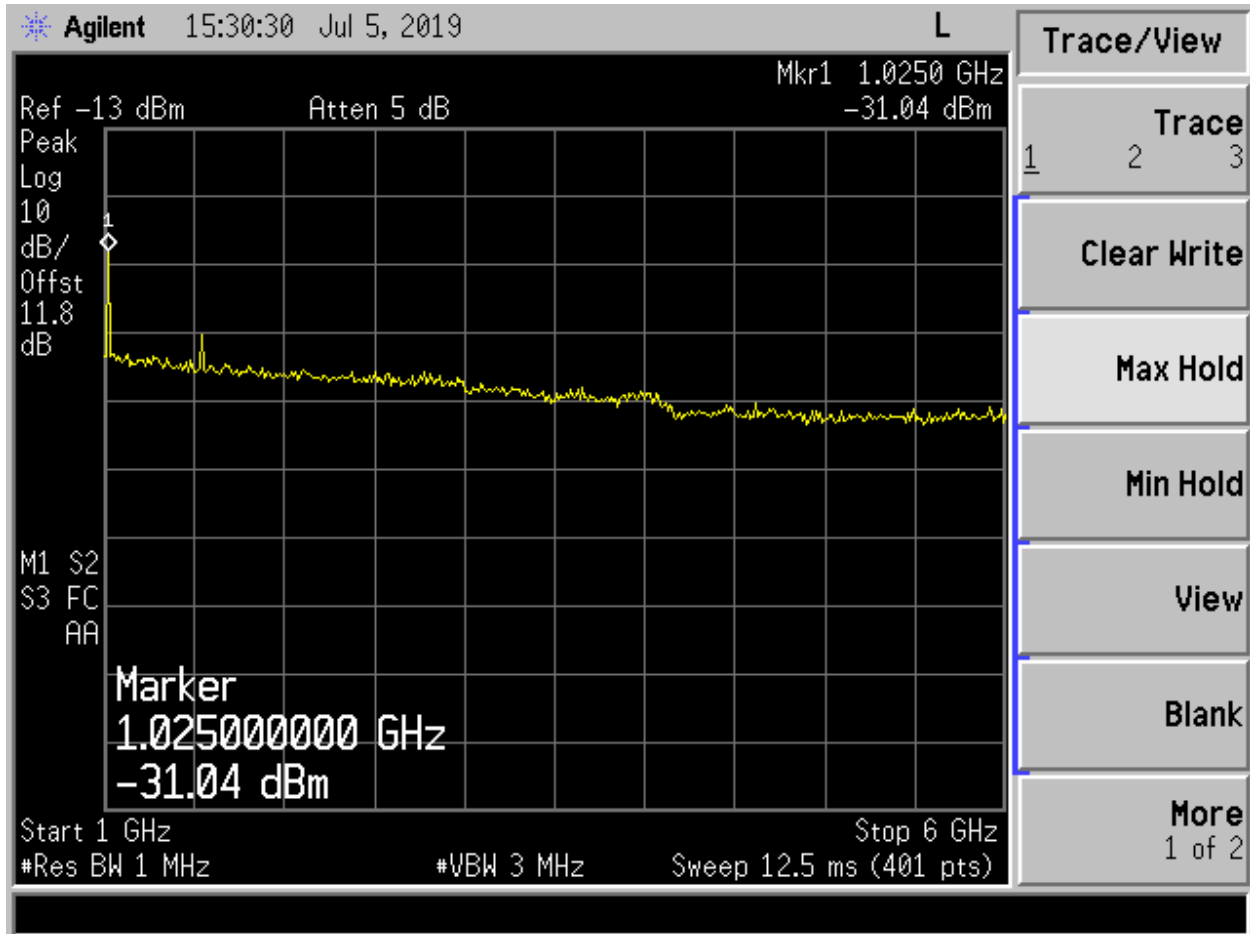


Figure 202. 512 MHz Vertical, 1 – 6 GHz

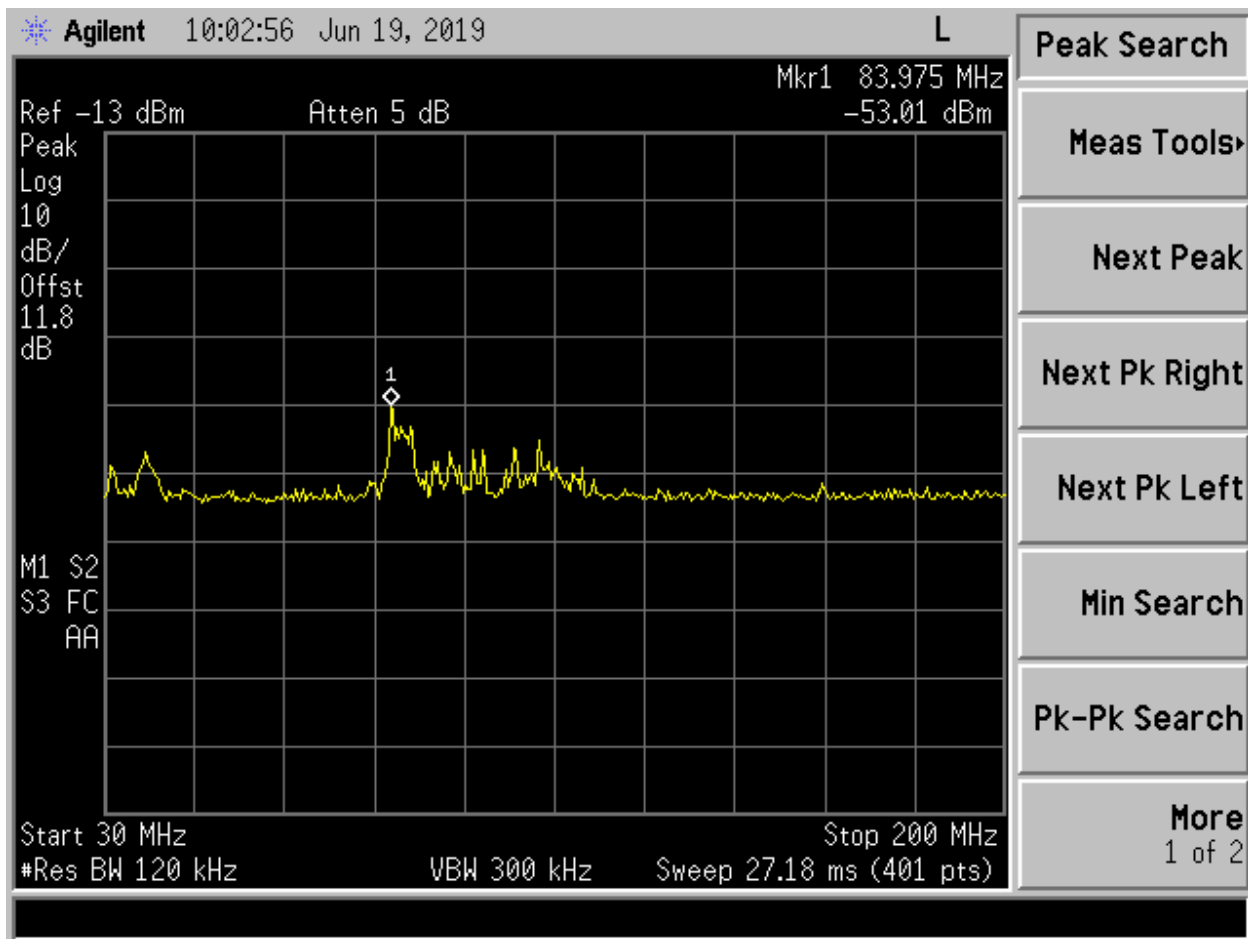


Figure 203. 788 MHz Horizontal, 30 – 200 MHz

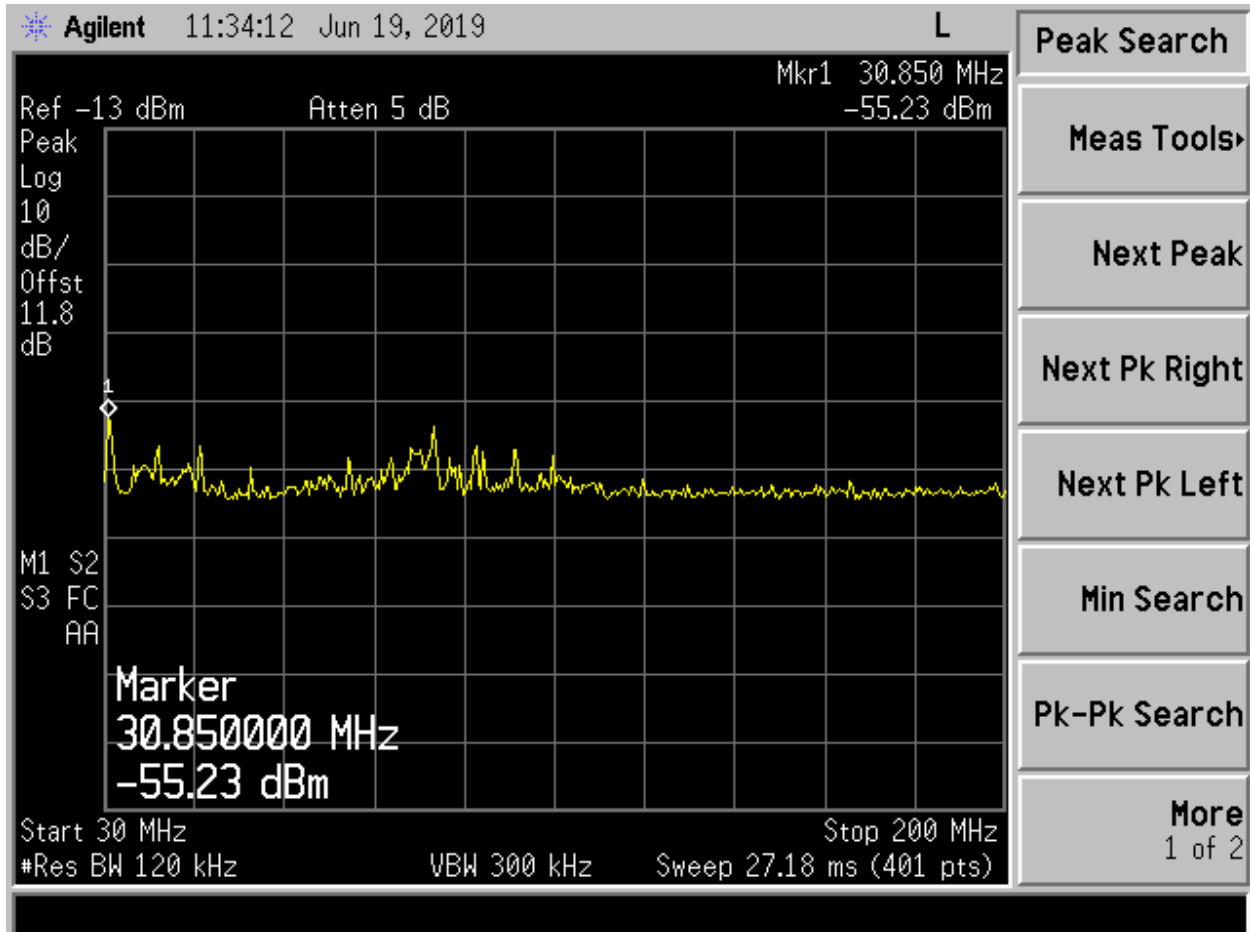


Figure 204. 788 MHz Vertical, 30 - 200 MHz

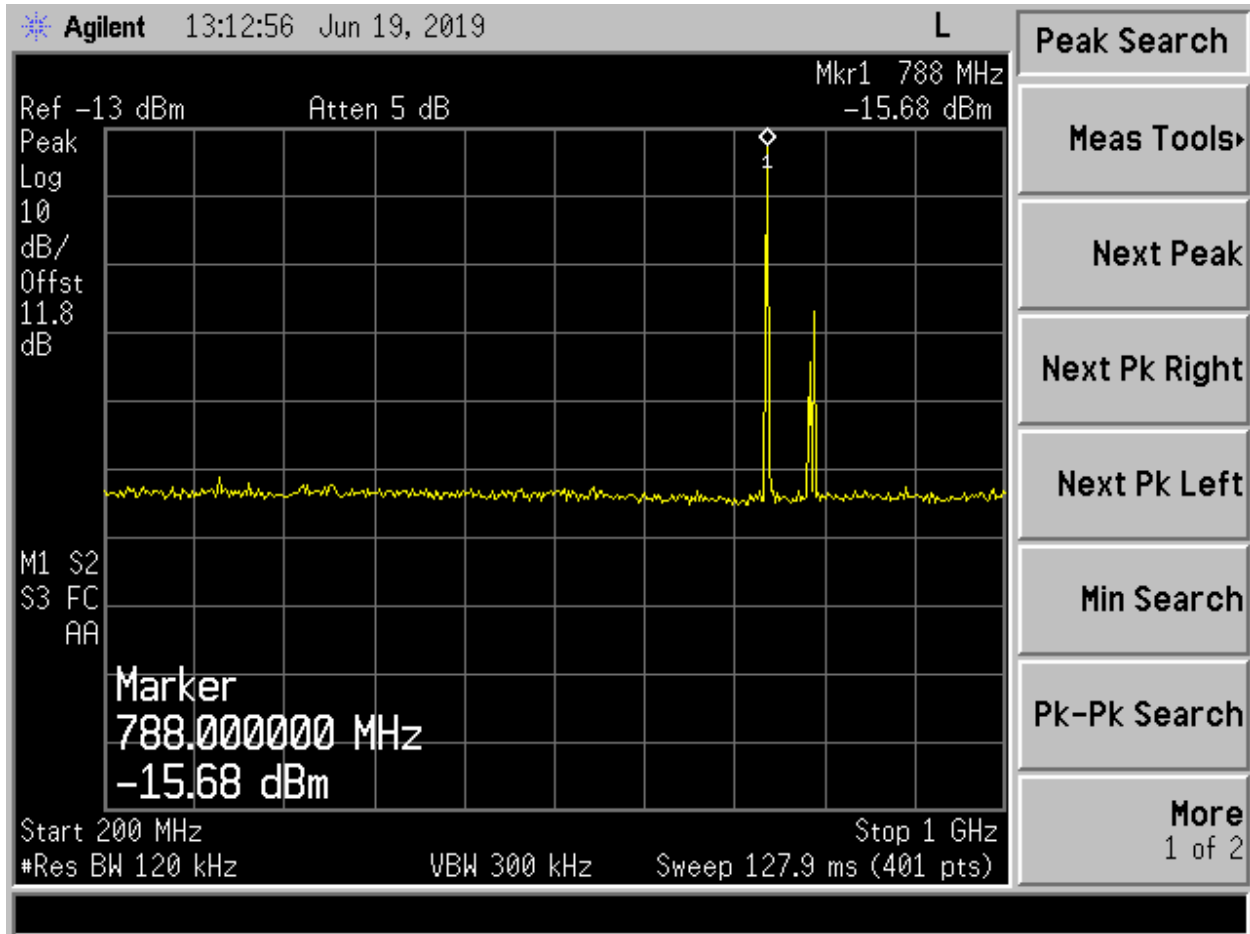


Figure 205. 788 MHz Horizontal, 200 MHz - 1 GHz

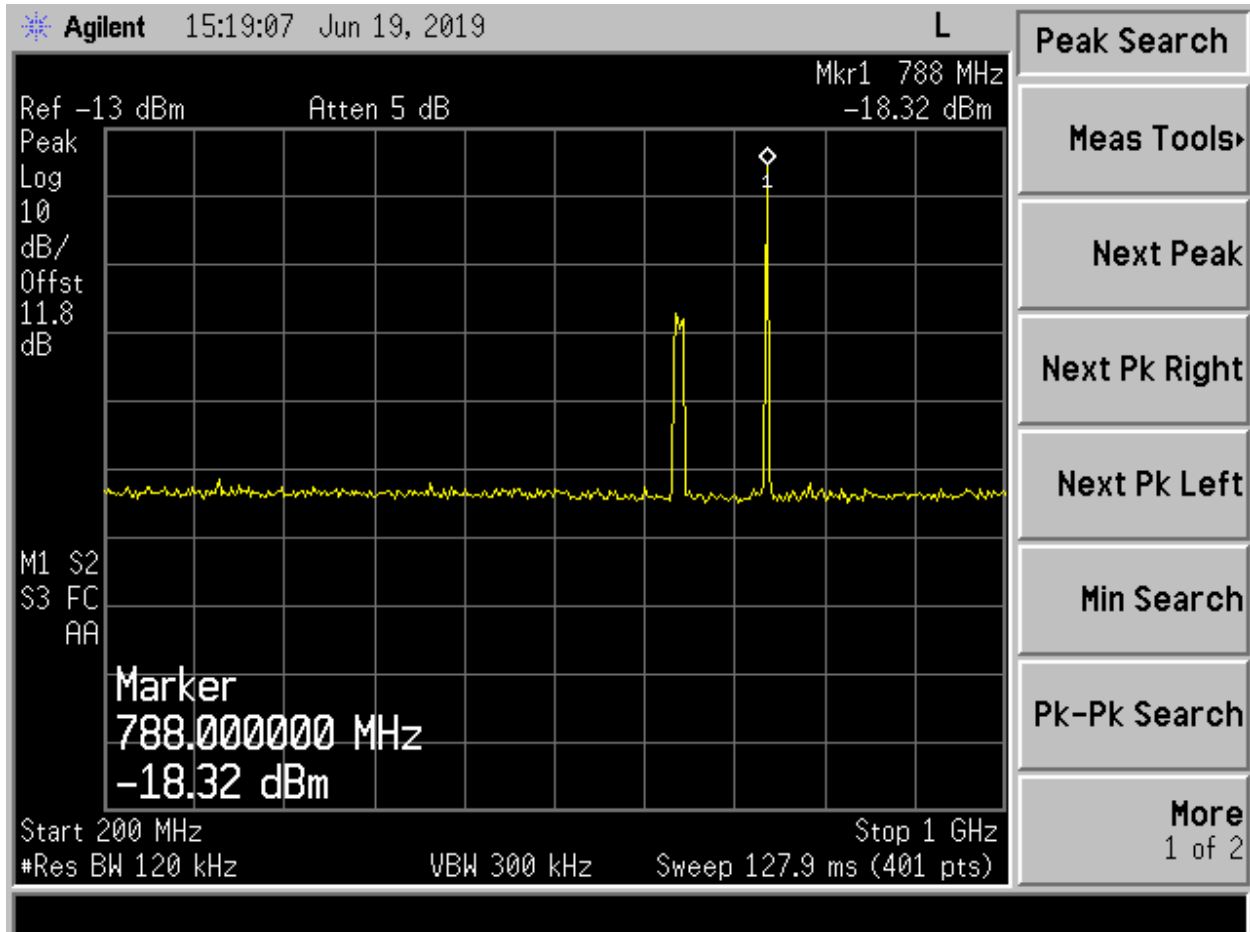


Figure 206. 788 MHz Vertical, 200 MHz - 1 GHz

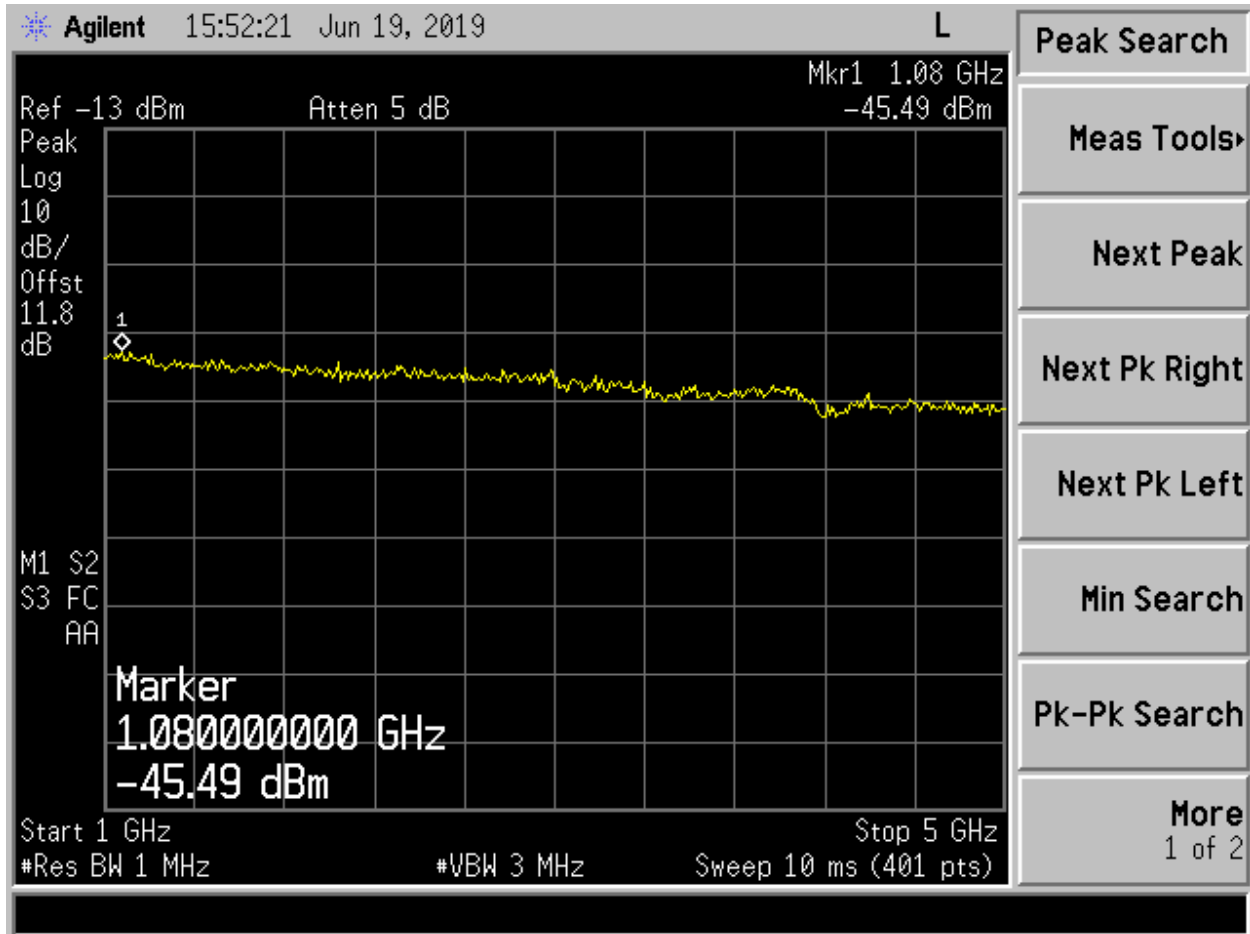


Figure 207. 788 MHz Horizontal, 1 – 5 GHz

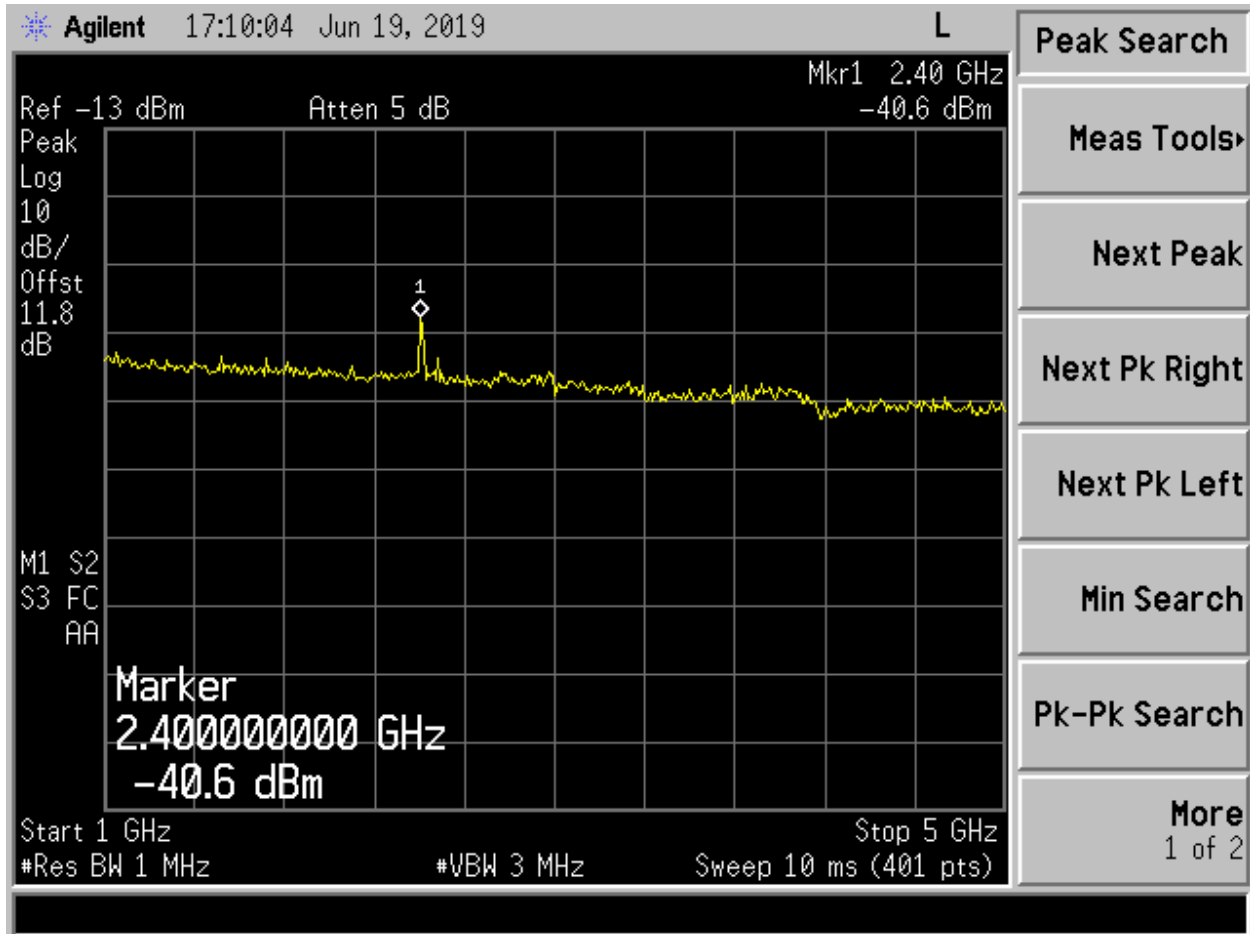


Figure 208. 788 MHz Vertical, 1 – 5 GHz

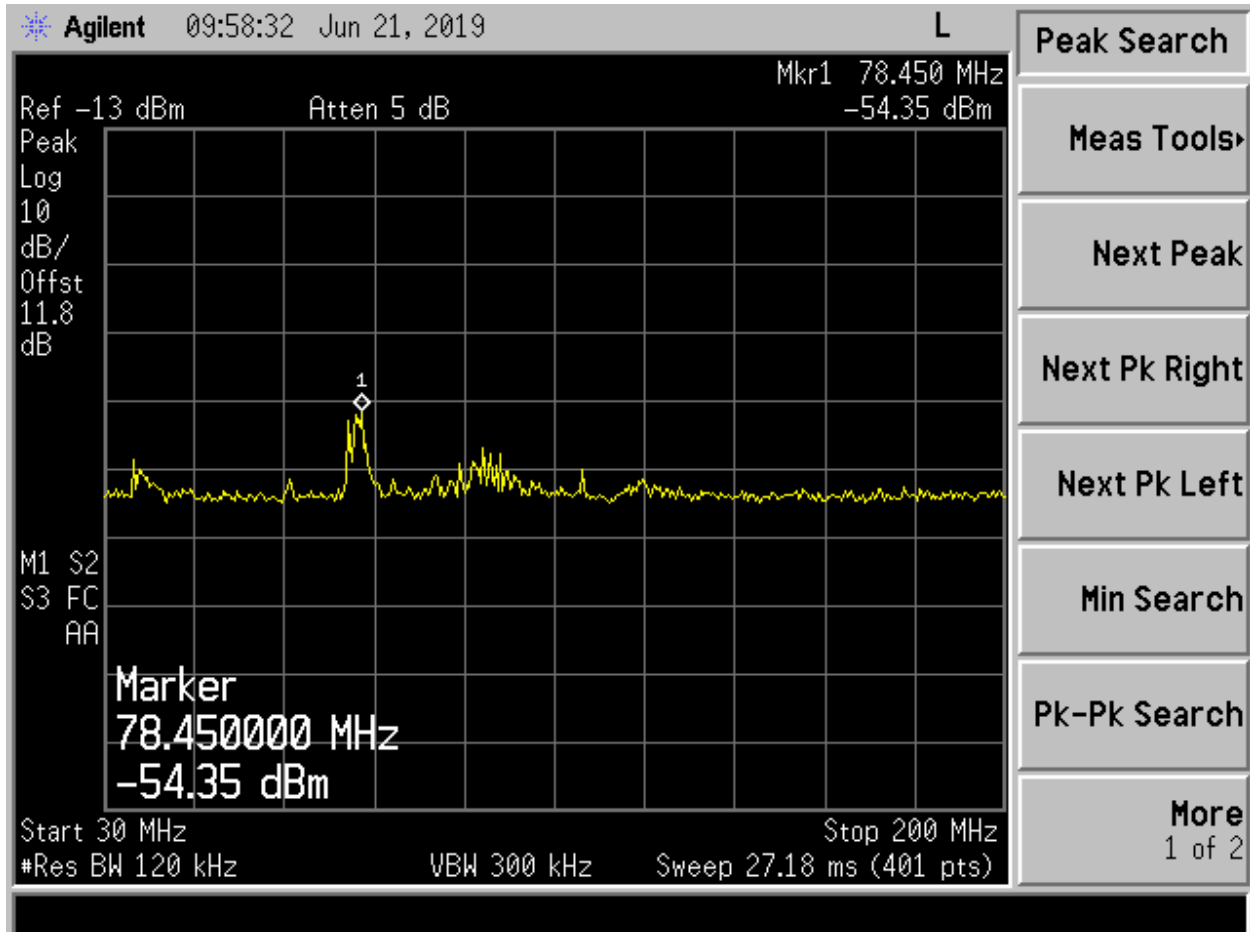


Figure 209. 798 MHz Horizontal, 30 – 200 MHz



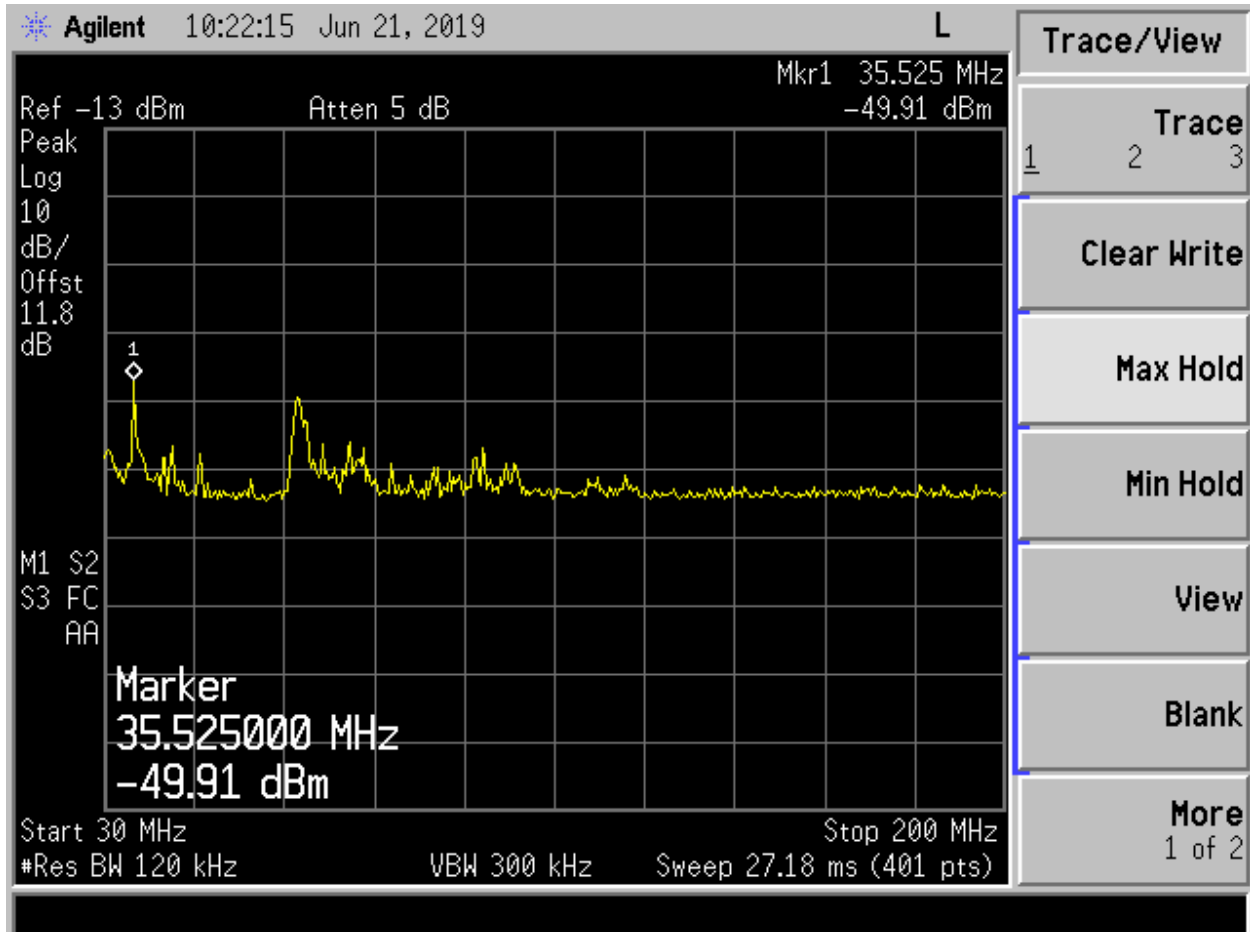


Figure 210. 798 MHz Vertical, 30 – 200 MHz

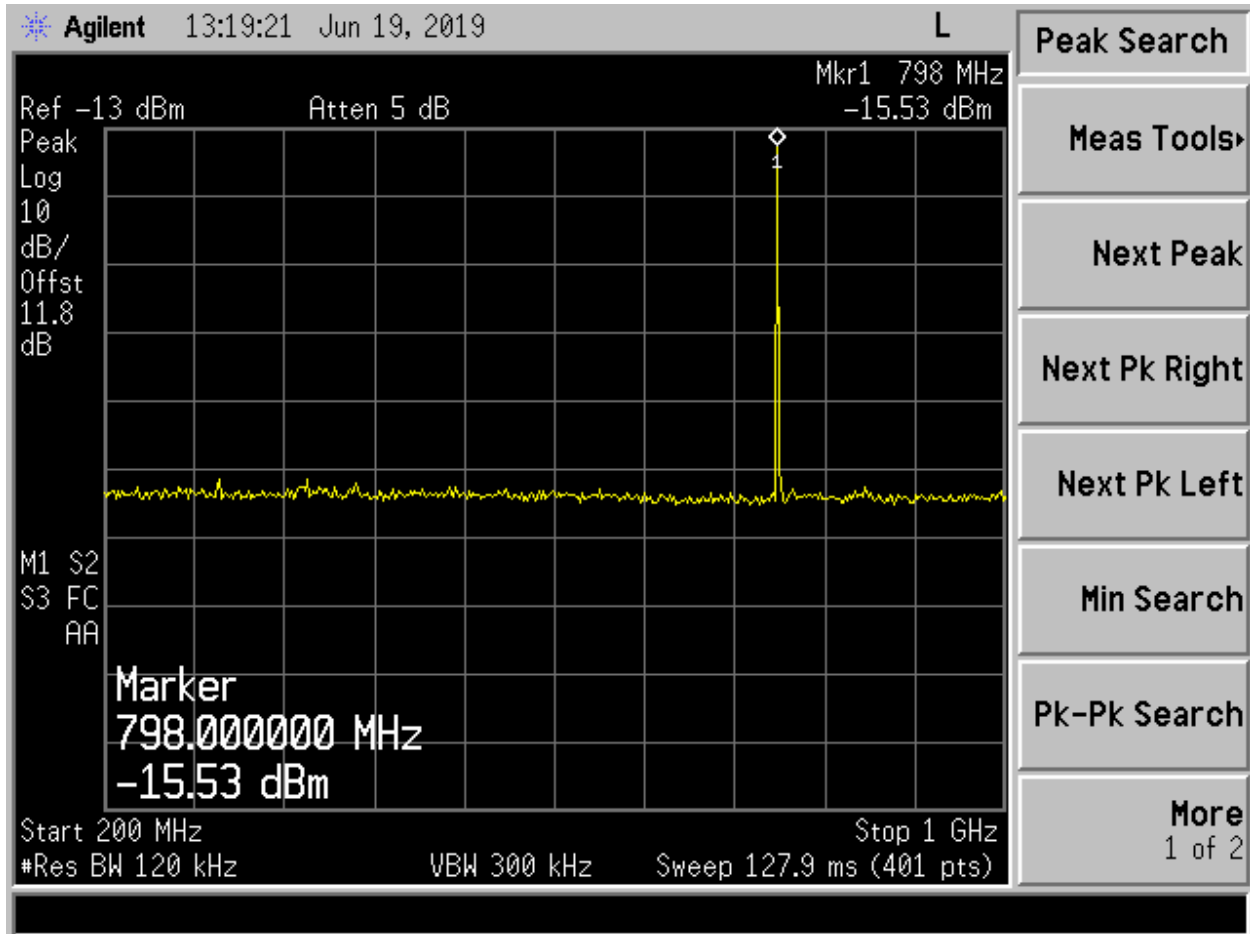


Figure 211. 798 MHz Horizontal, 200 MHz – 1 GHz

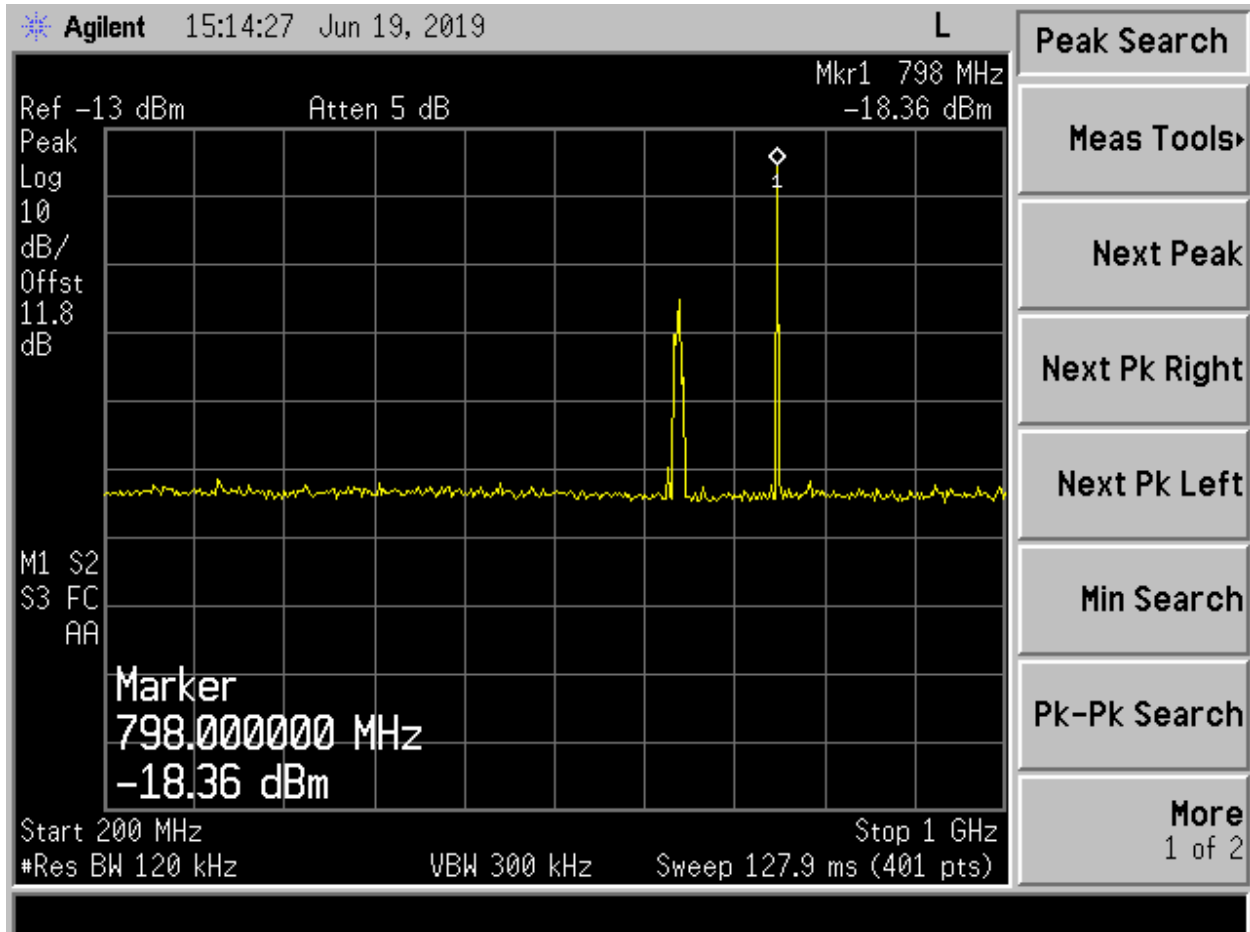


Figure 212. 798 MHz Vertical, 200 MHz – 1 GHz

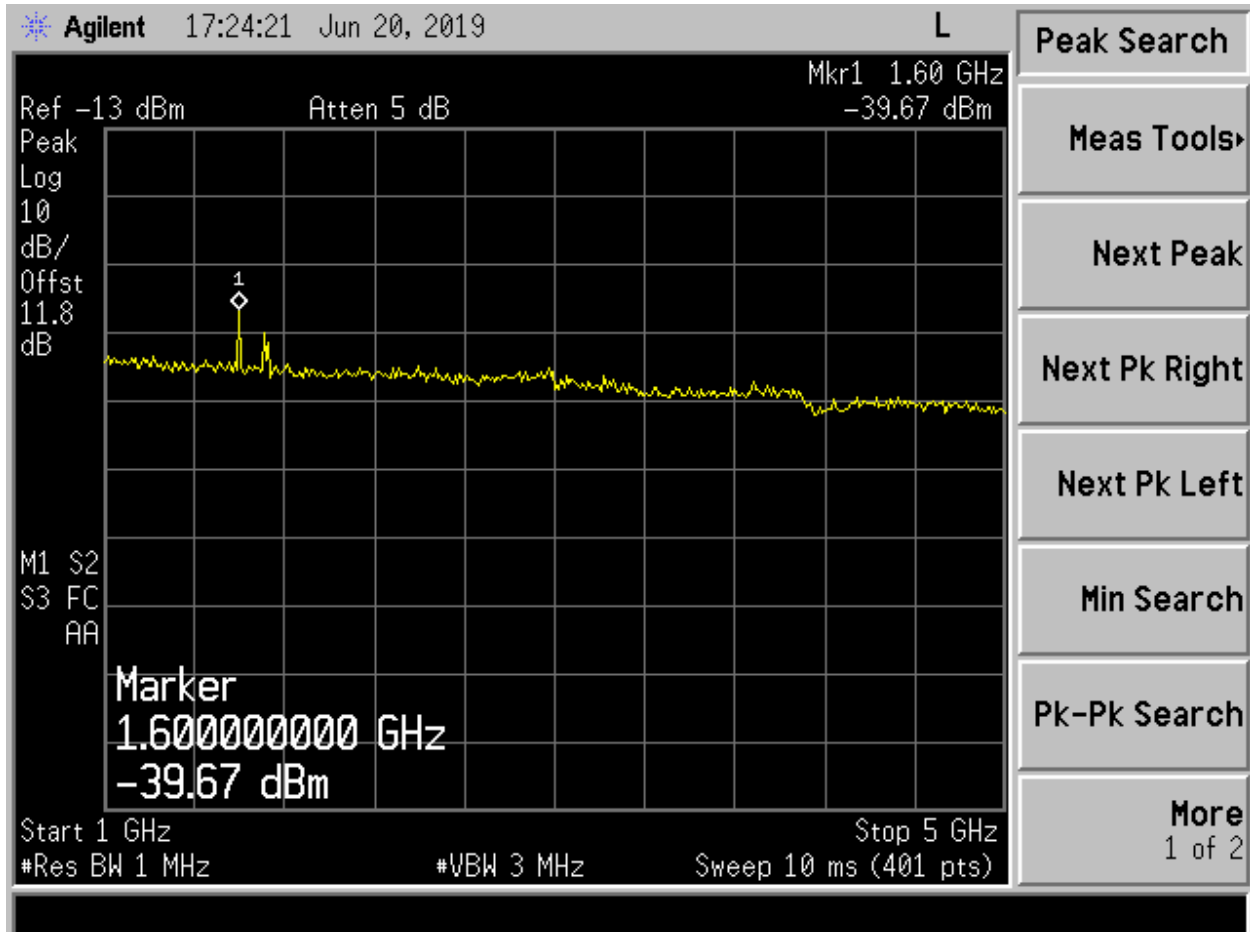


Figure 213. 798 MHz Horizontal, 1 – 5 GHz

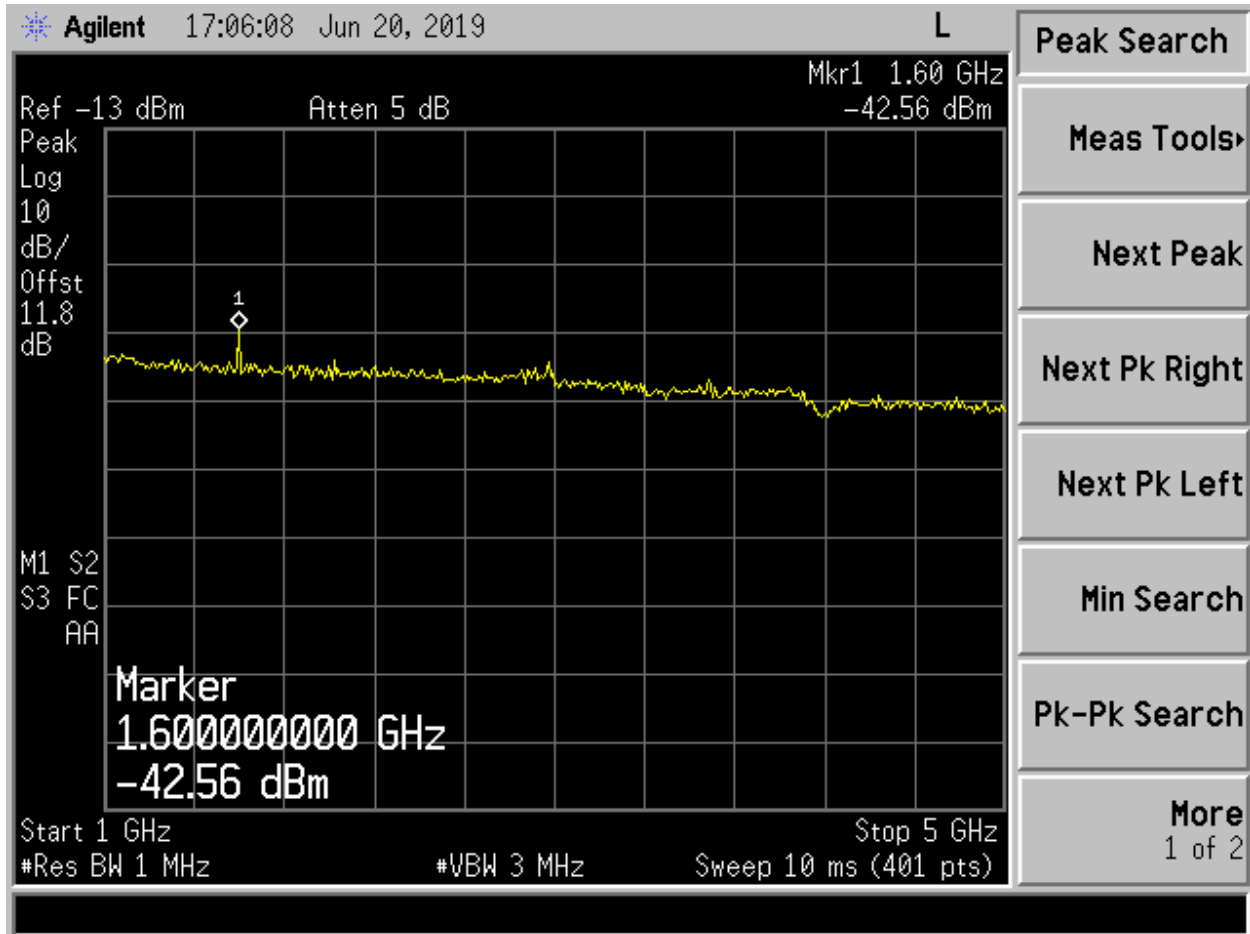


Figure 214. 798 MHz Vertical, 1 – 5 GHz

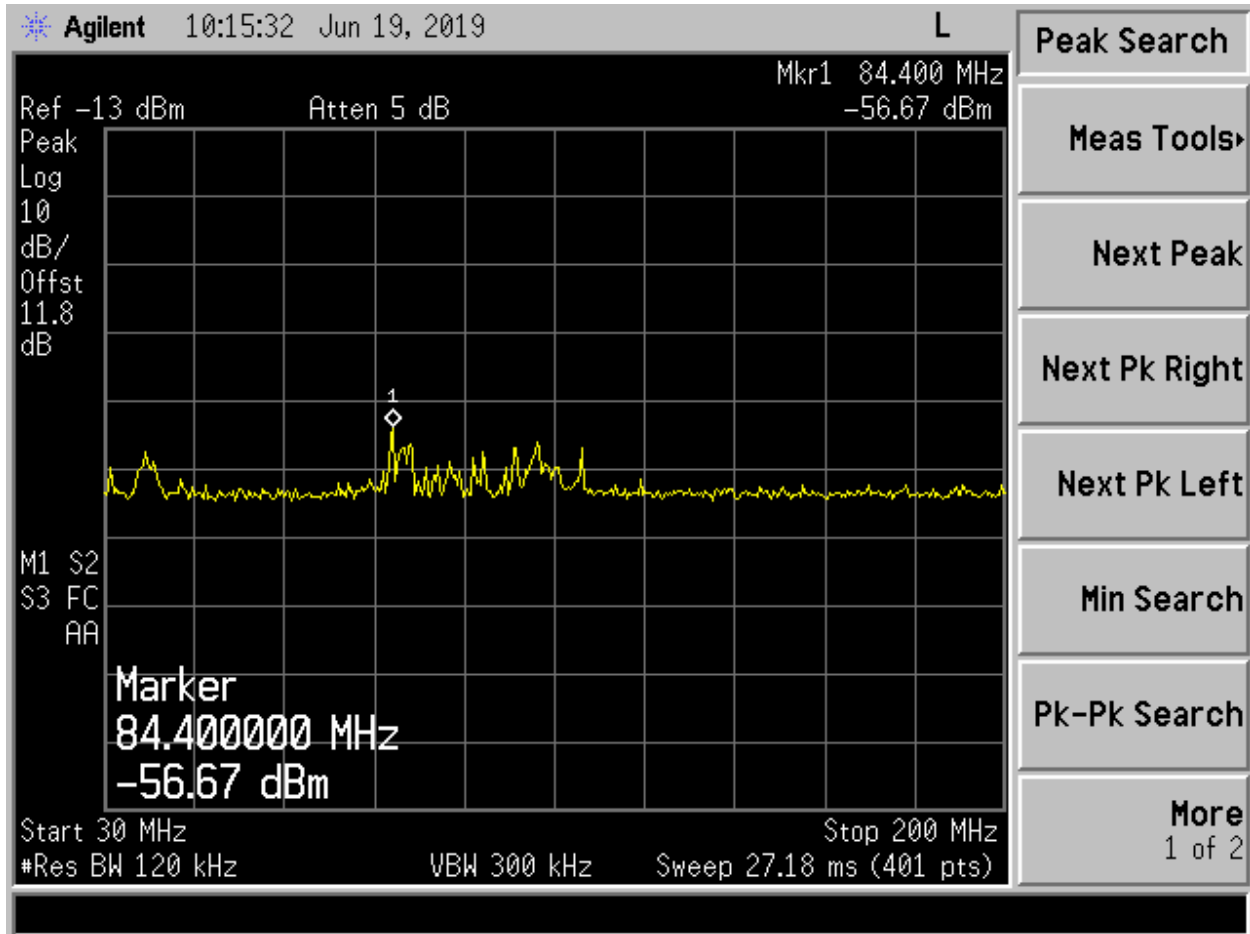


Figure 215. 799 MHz Horizontal, 30 – 200 MHz

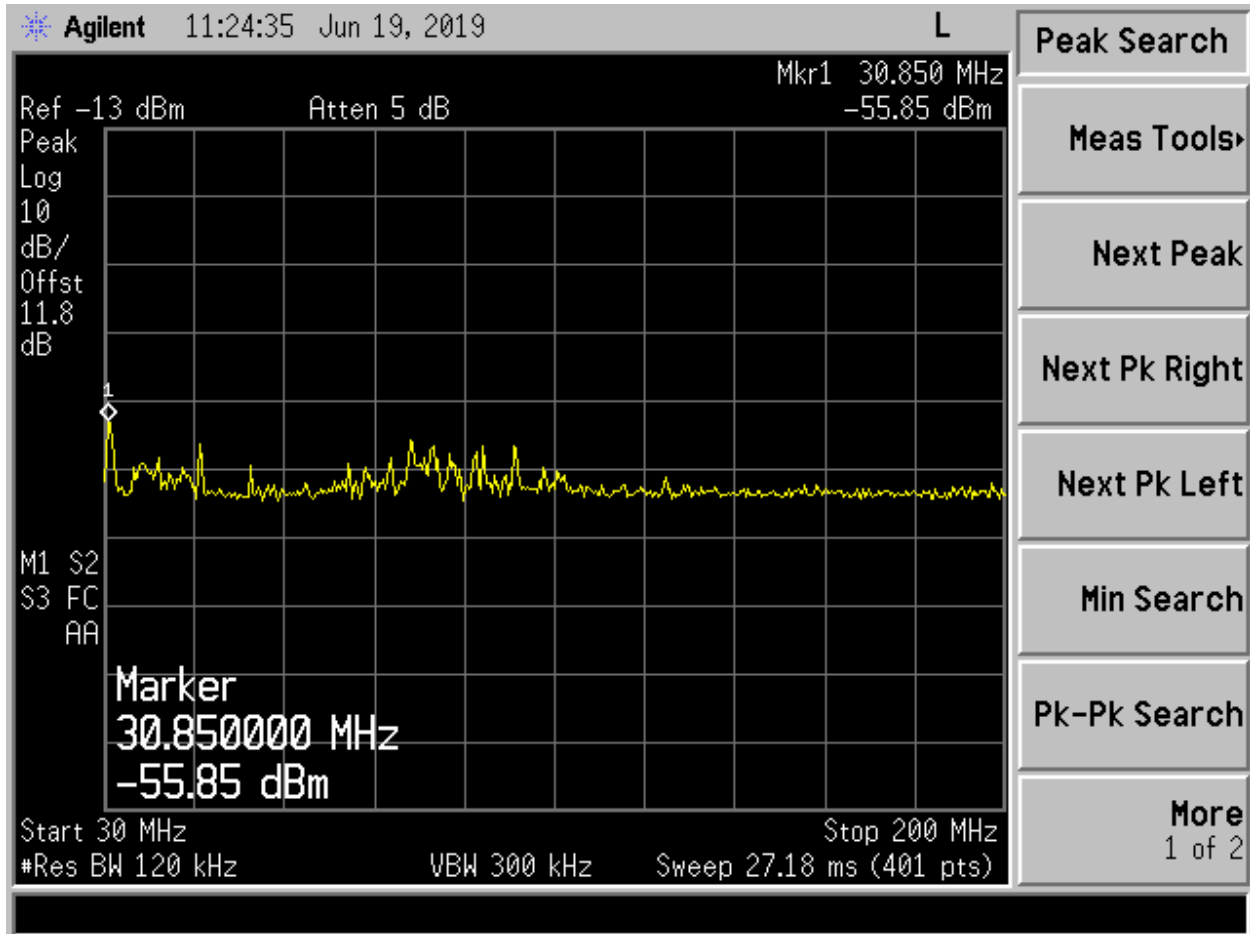


Figure 216. 799 MHz Vertical, 30 – 200 MHz

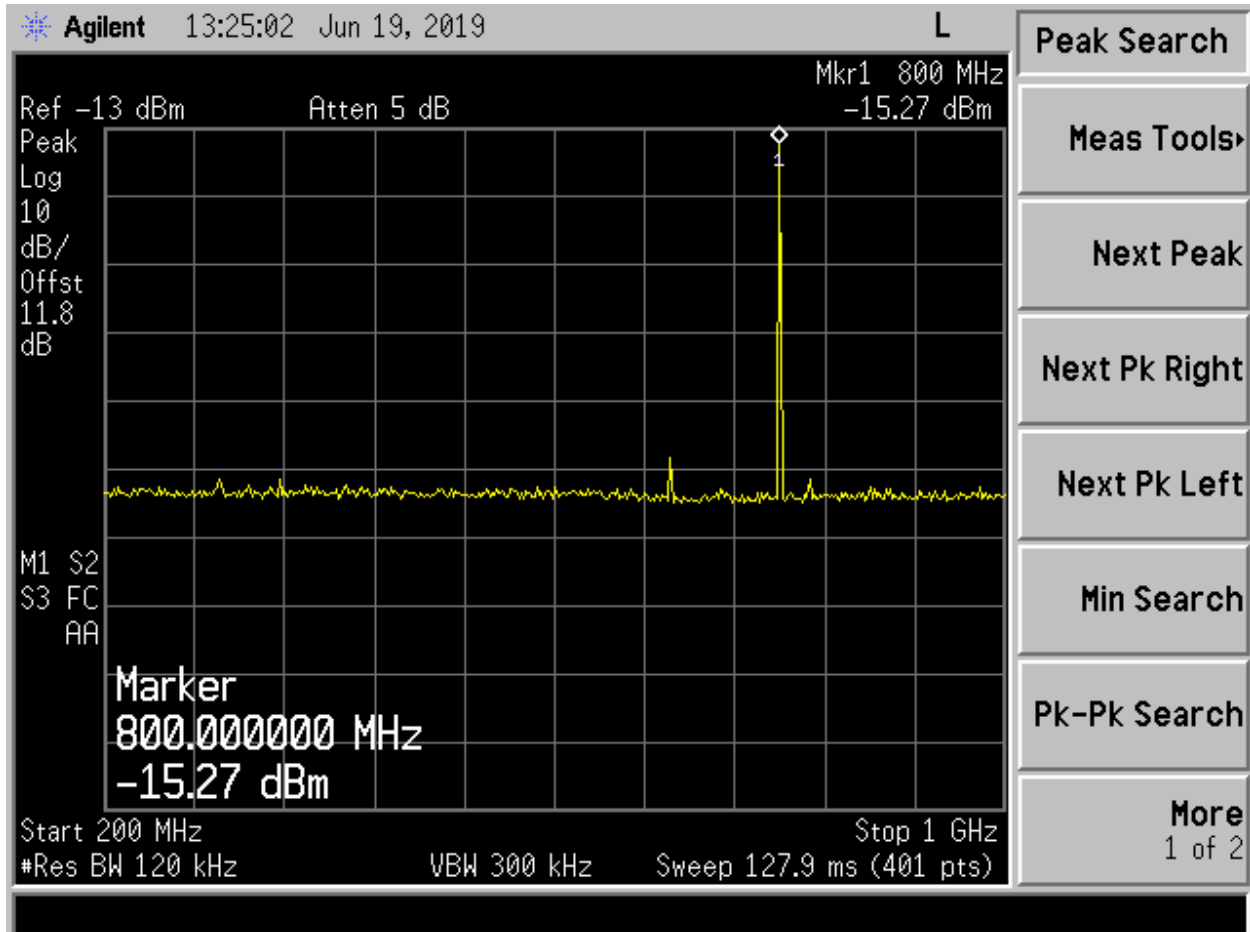


Figure 217. 799 MHz Horizontal, 200 MHz – 1 GHz



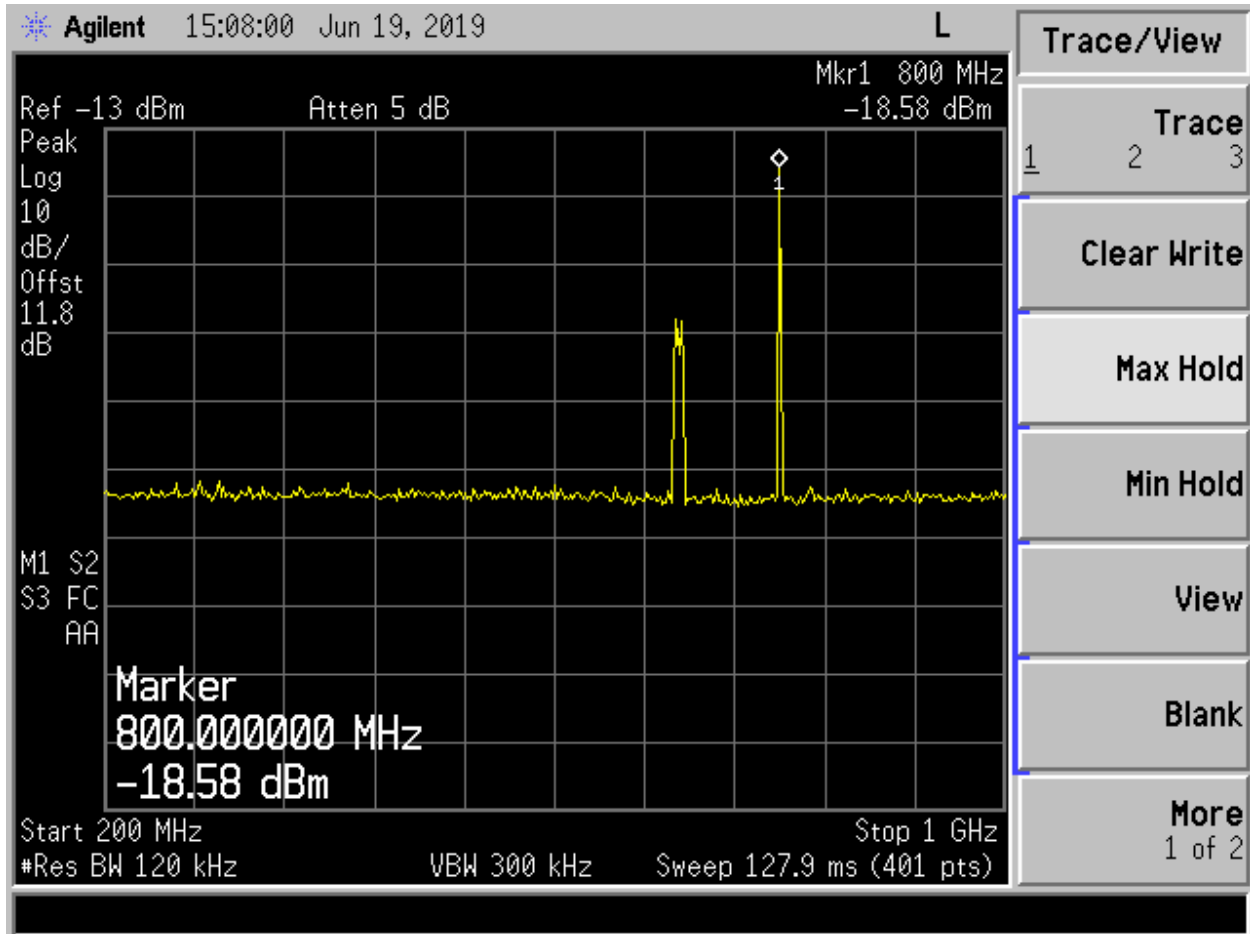


Figure 218. 799 MHz Vertical, 200 MHz – 1 GHz

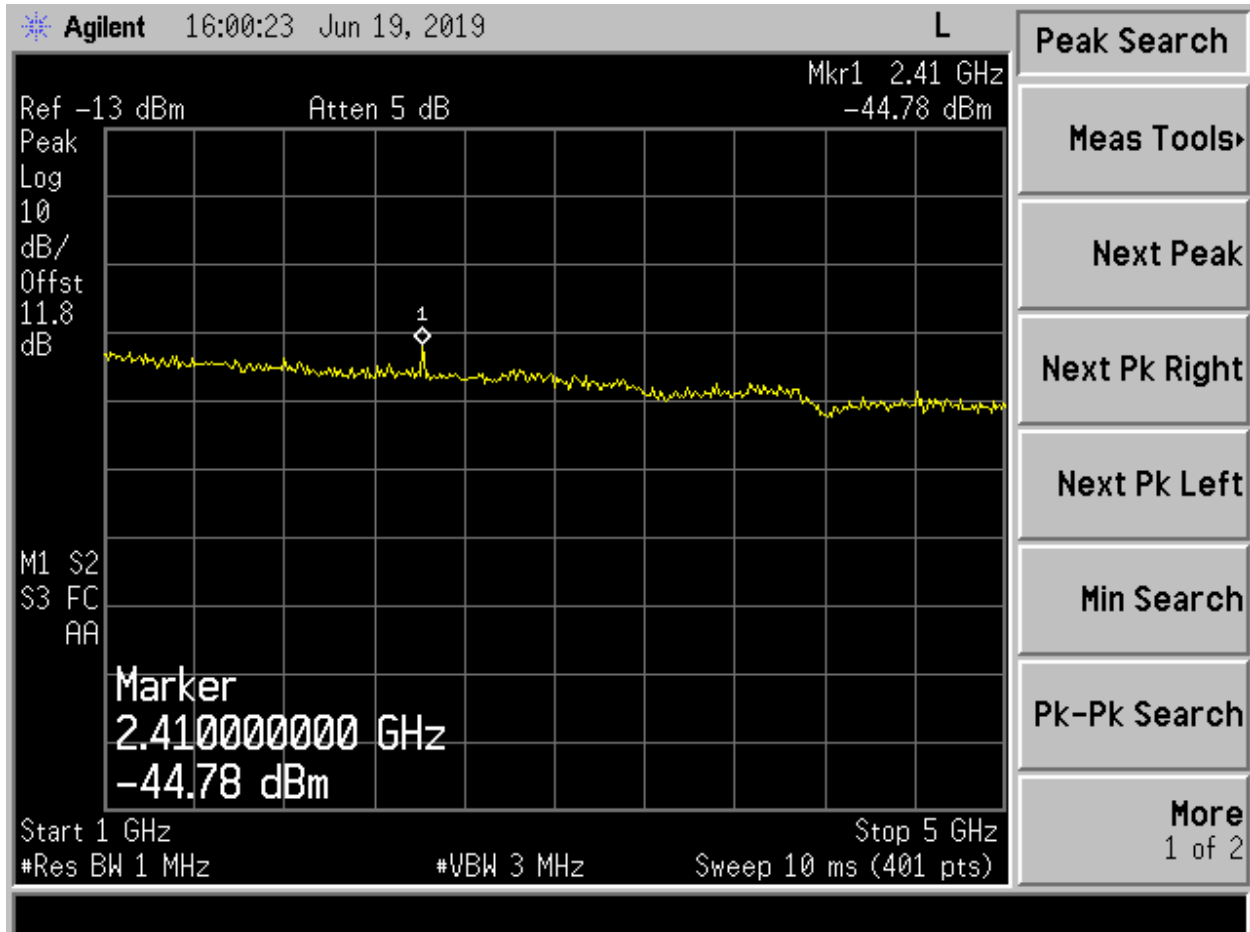


Figure 219. 799 MHz Horizontal, 1 – 5 GHz

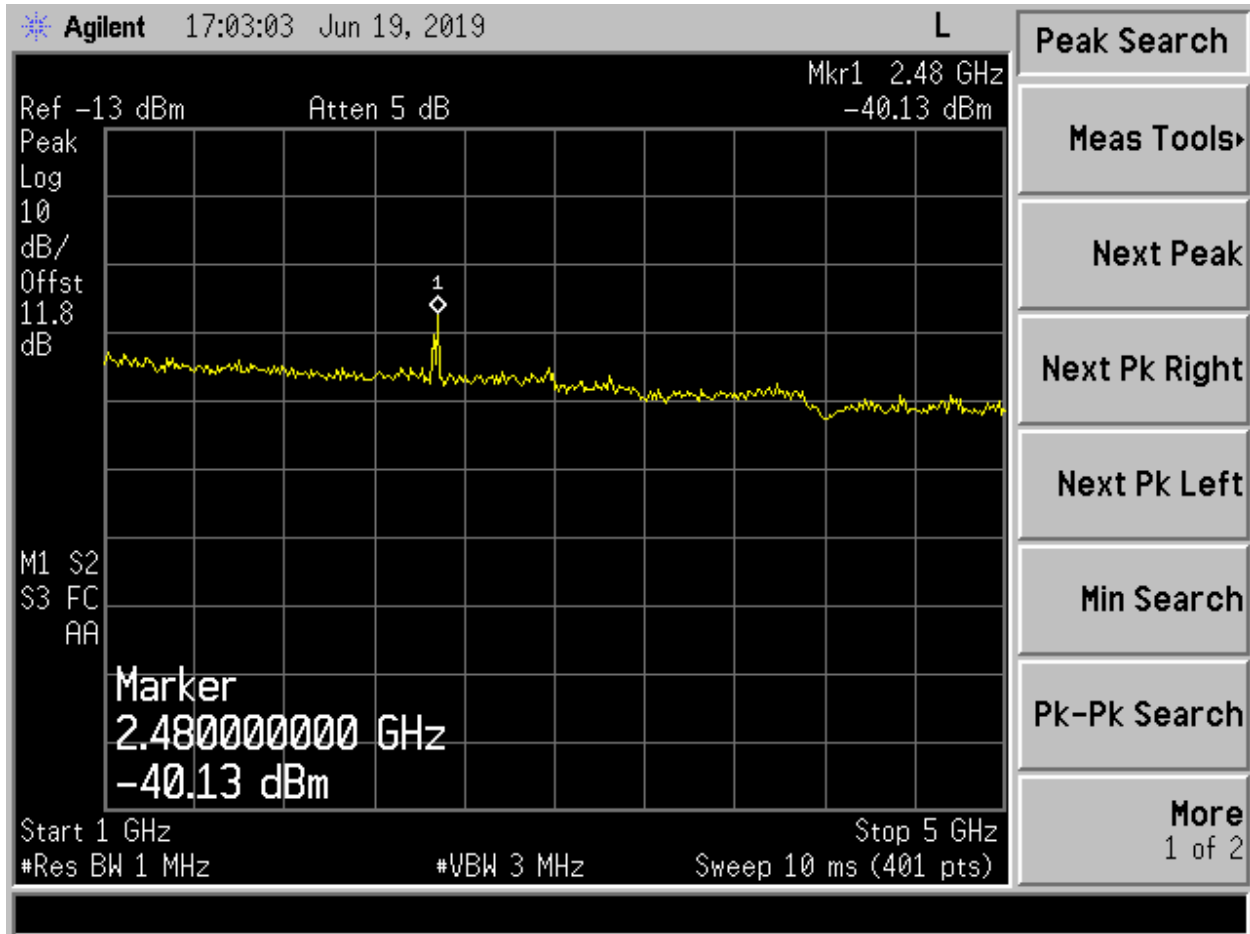


Figure 220. 799 MHz Vertical, 1 – 5 GHz

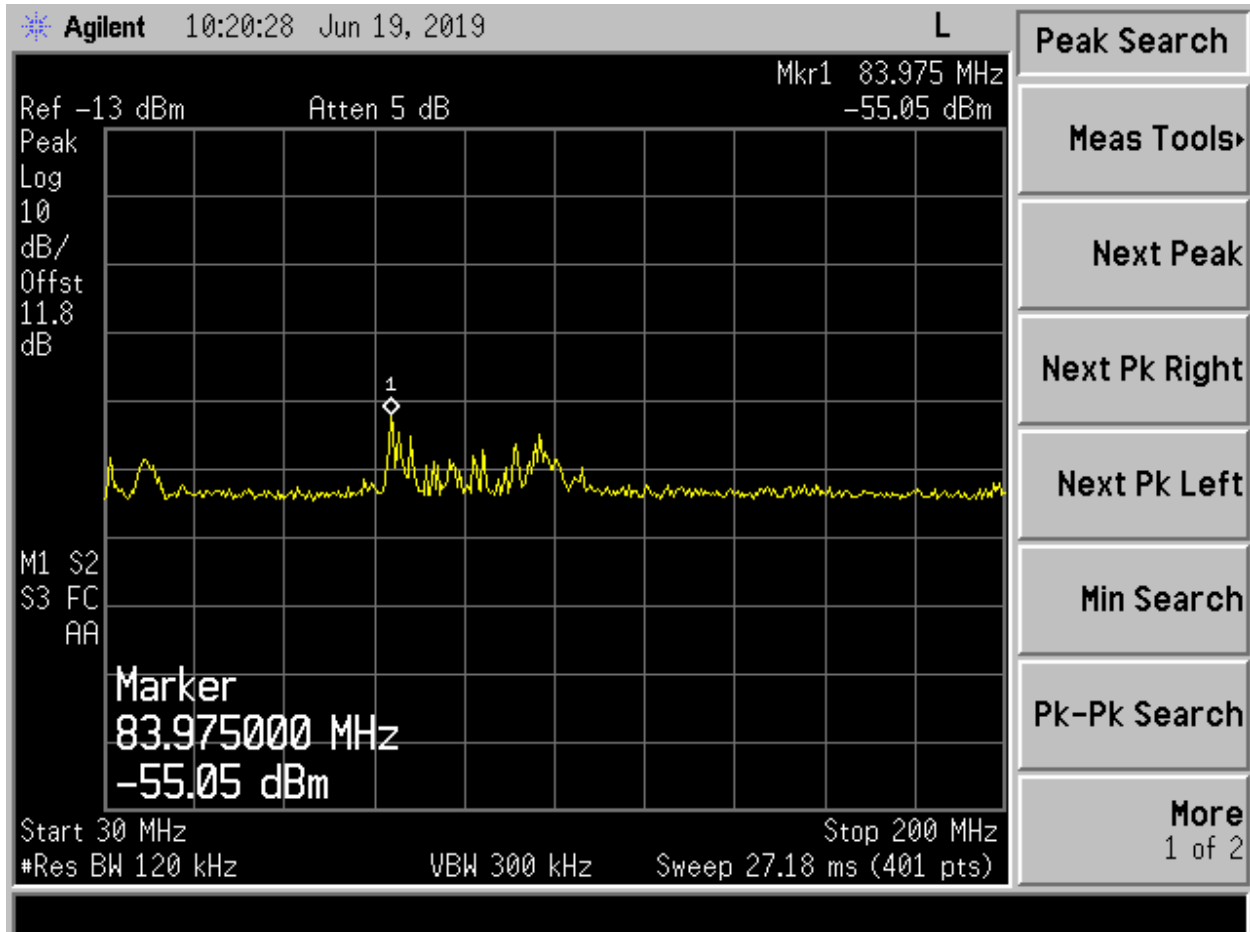


Figure 221. 805 MHz, Horizontal, 30 – 200 MHz

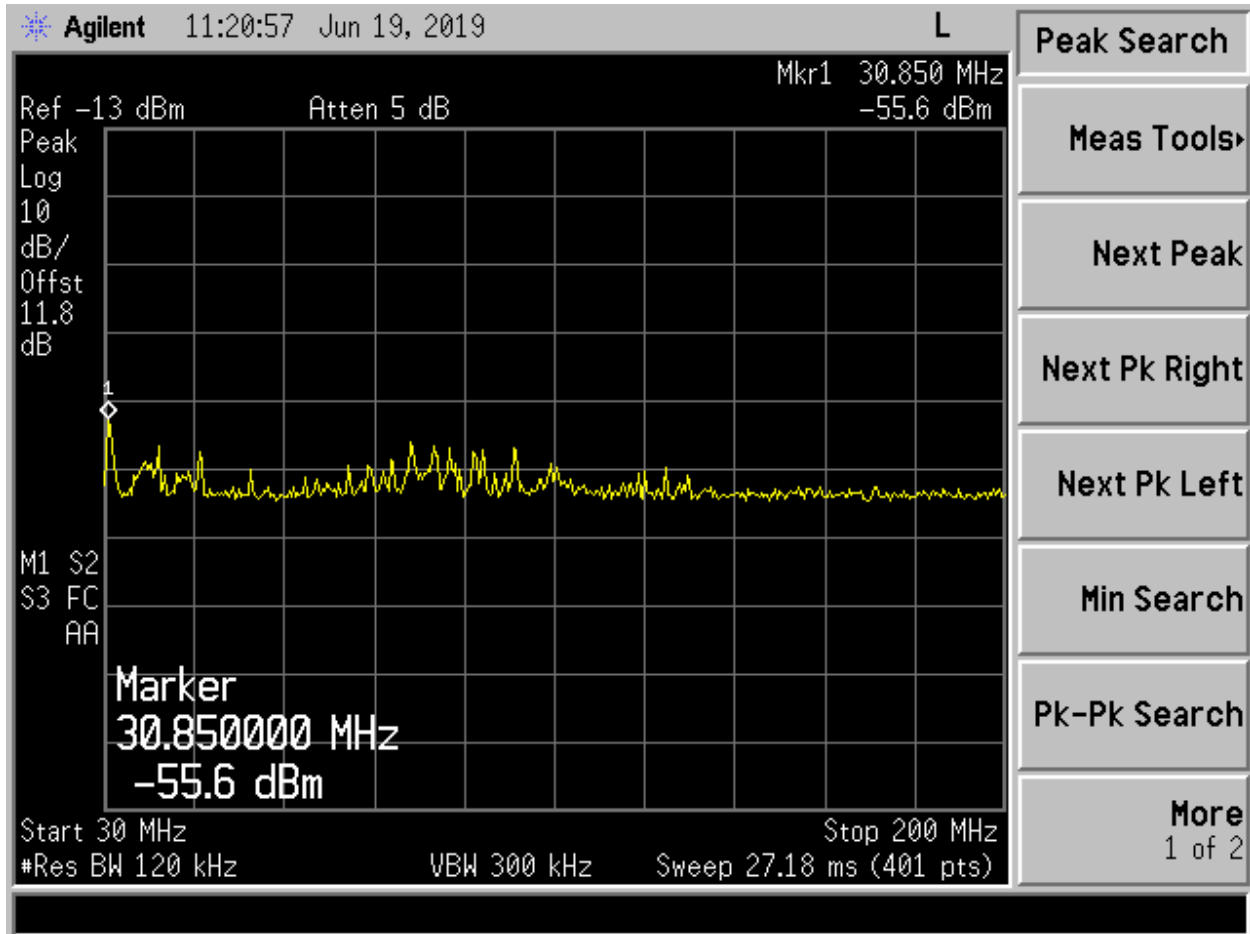


Figure 222. 805 MHz, Vertical, 30 – 200 MHz

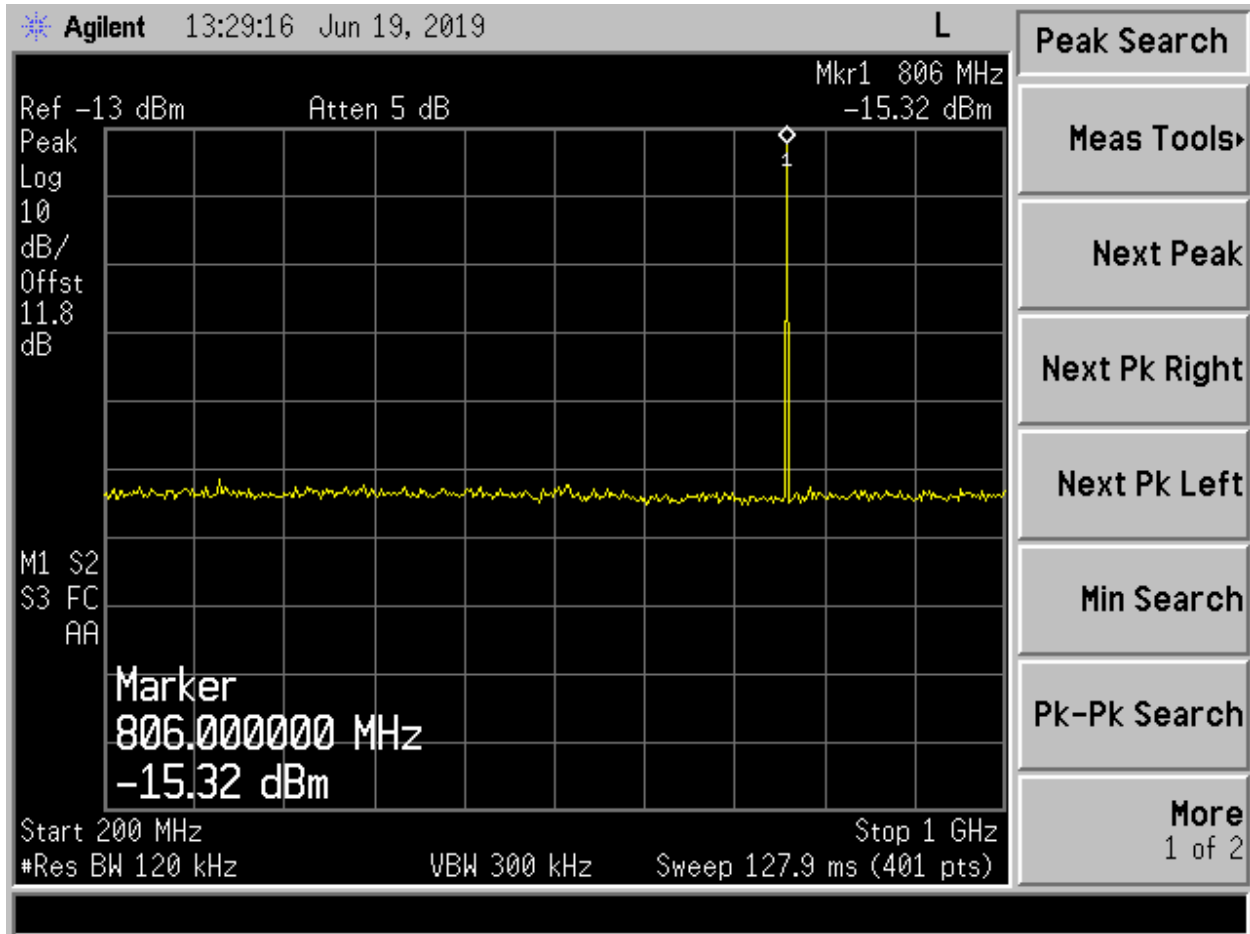


Figure 223. 805 MHz, Horizontal, 200 MHz – 1 GHz

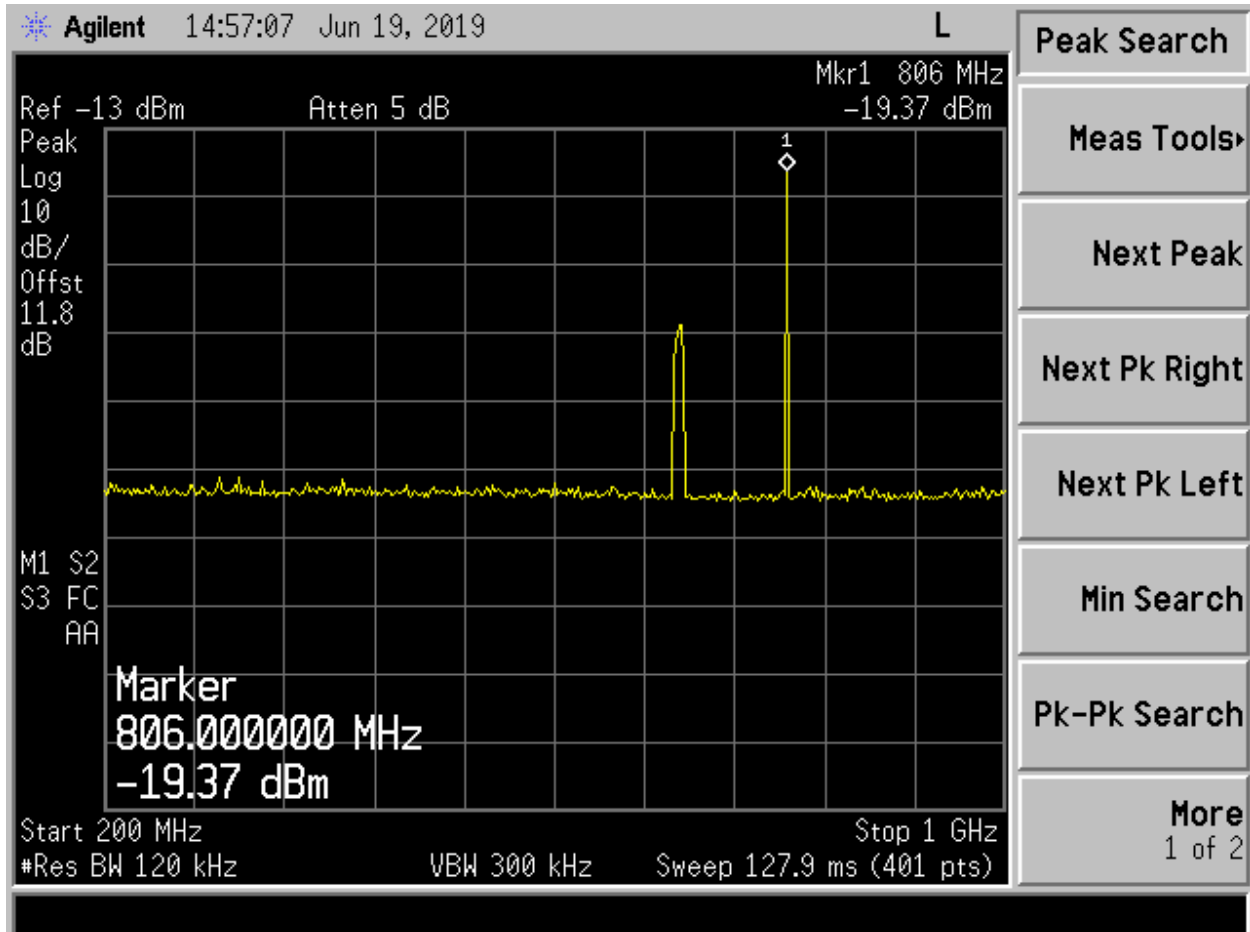


Figure 224. 805 MHz, Vertical, 200 MHz – 1 GHz

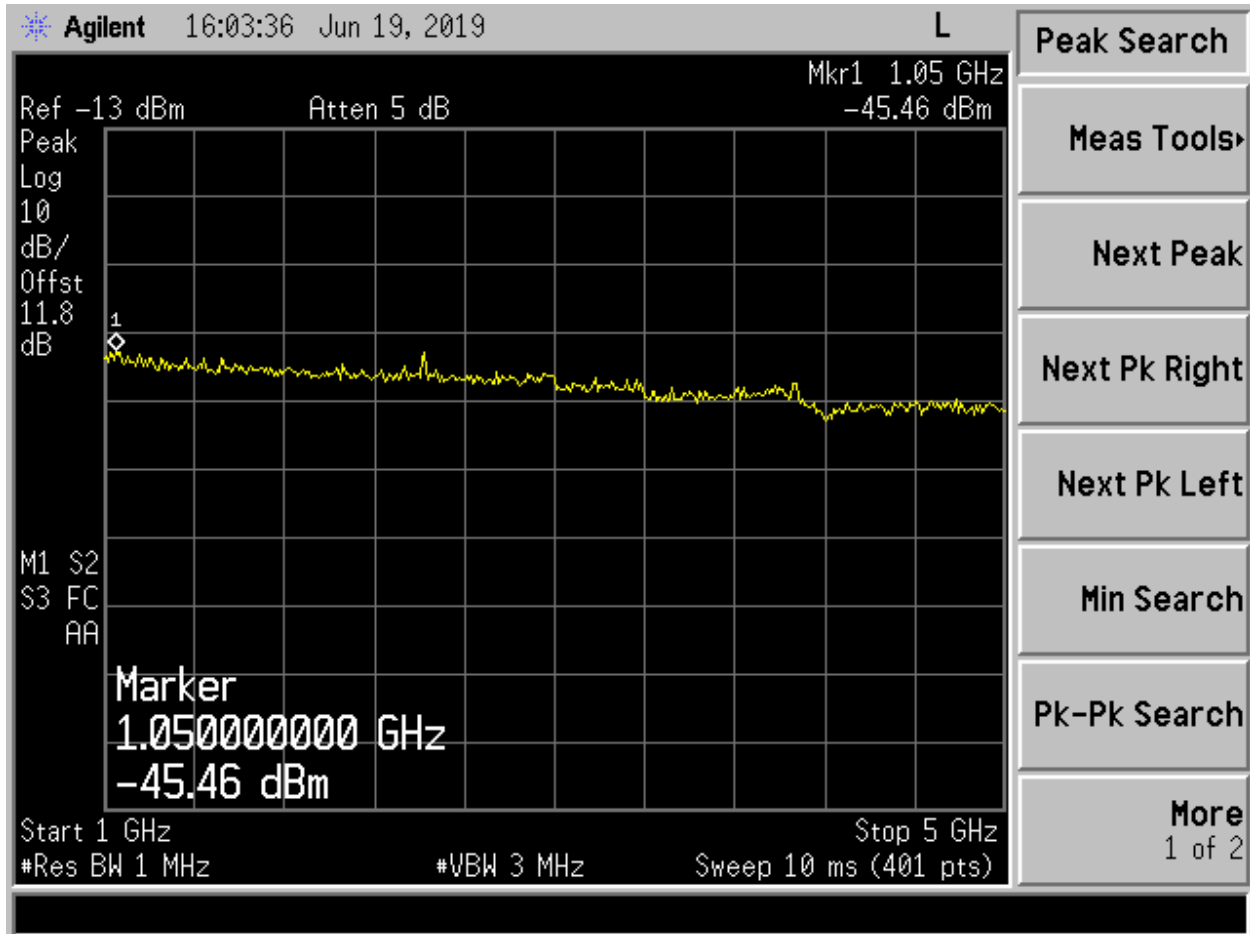


Figure 225. 805 MHz, Horizontal, 1 – 5 GHz



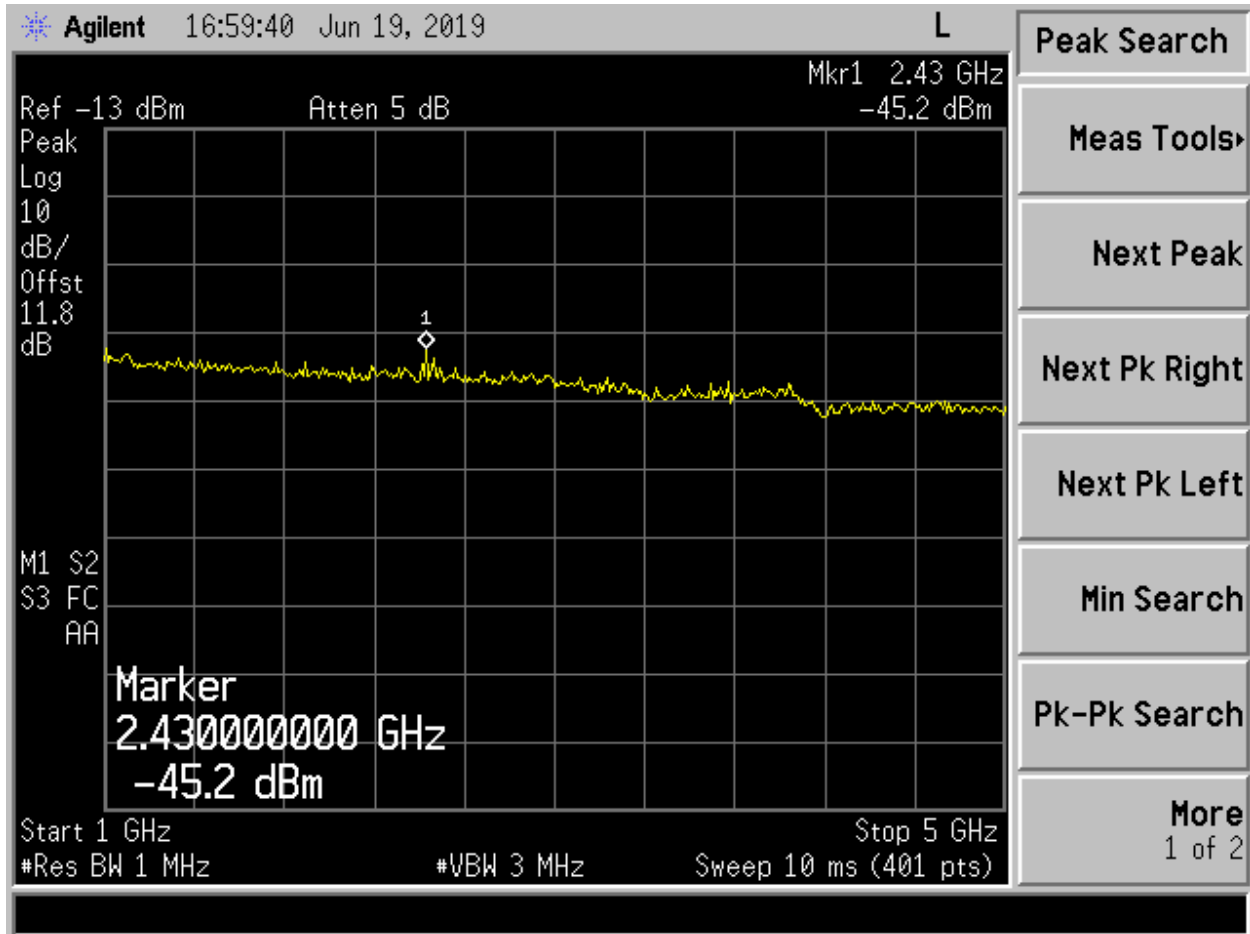


Figure 226. 805 MHz, Vertical, 1 – 5 GHz

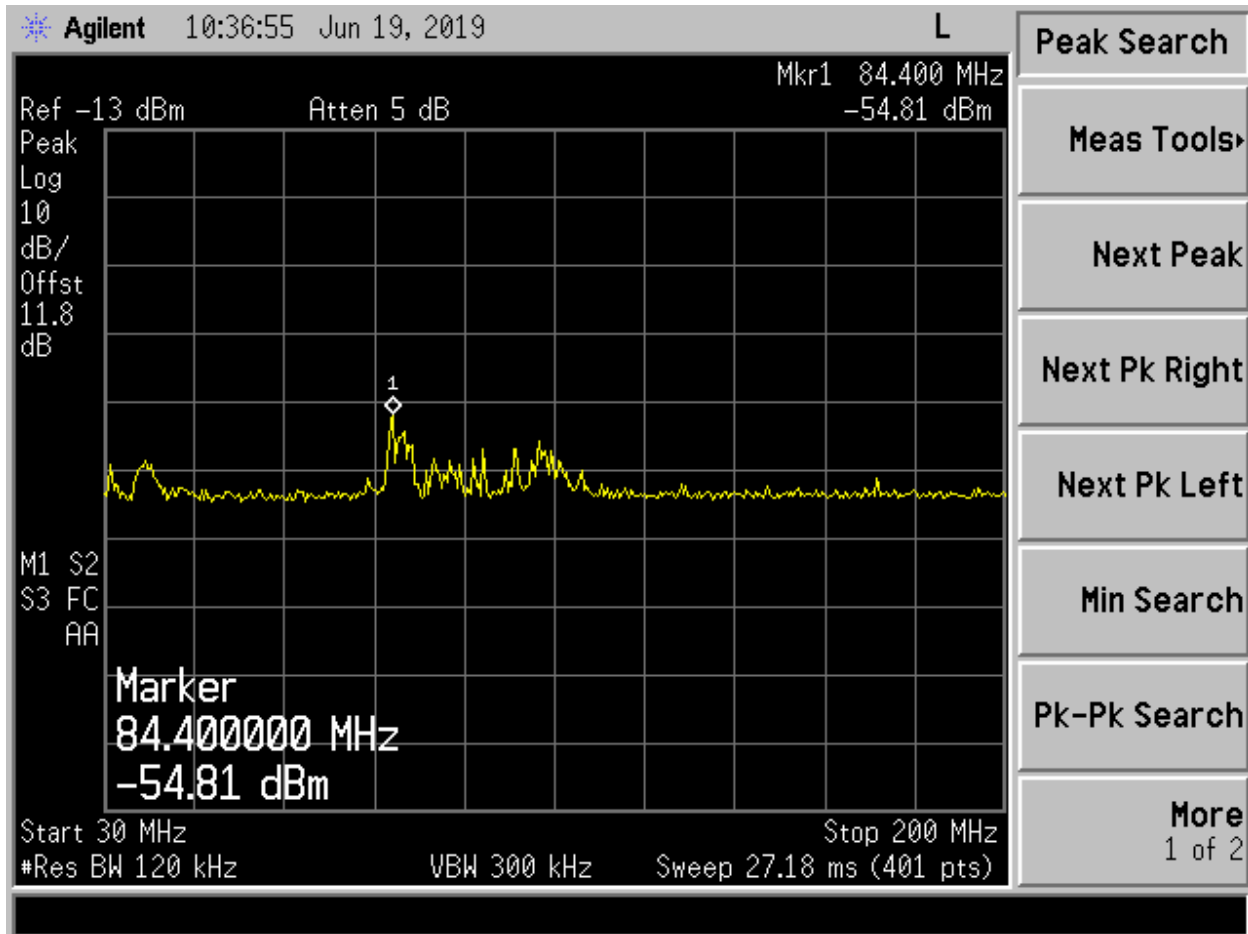


Figure 227. 824 MHz Horizontal, 30 – 200 MHz

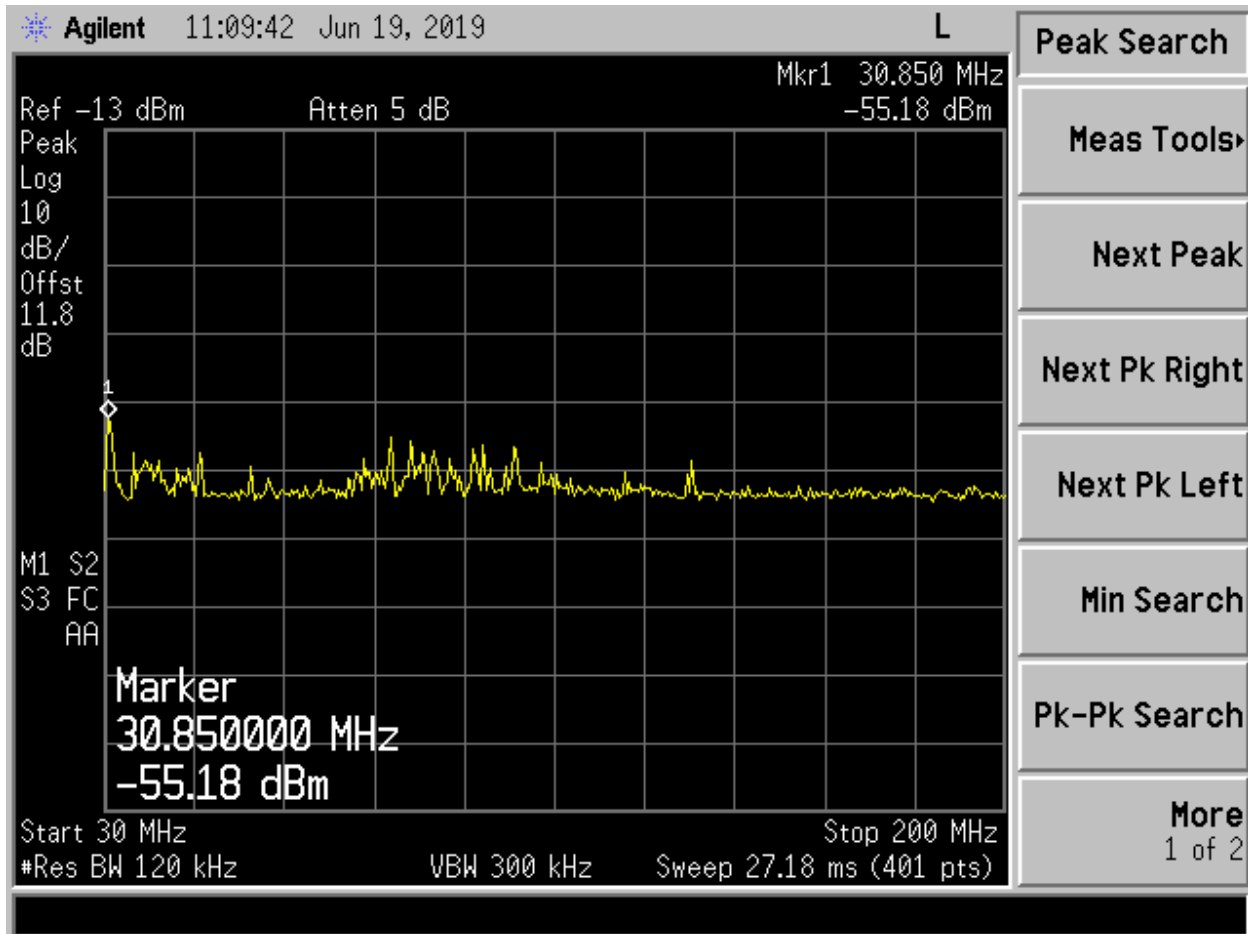


Figure 228. 824 MHz Vertical, 30 - 200 MHz

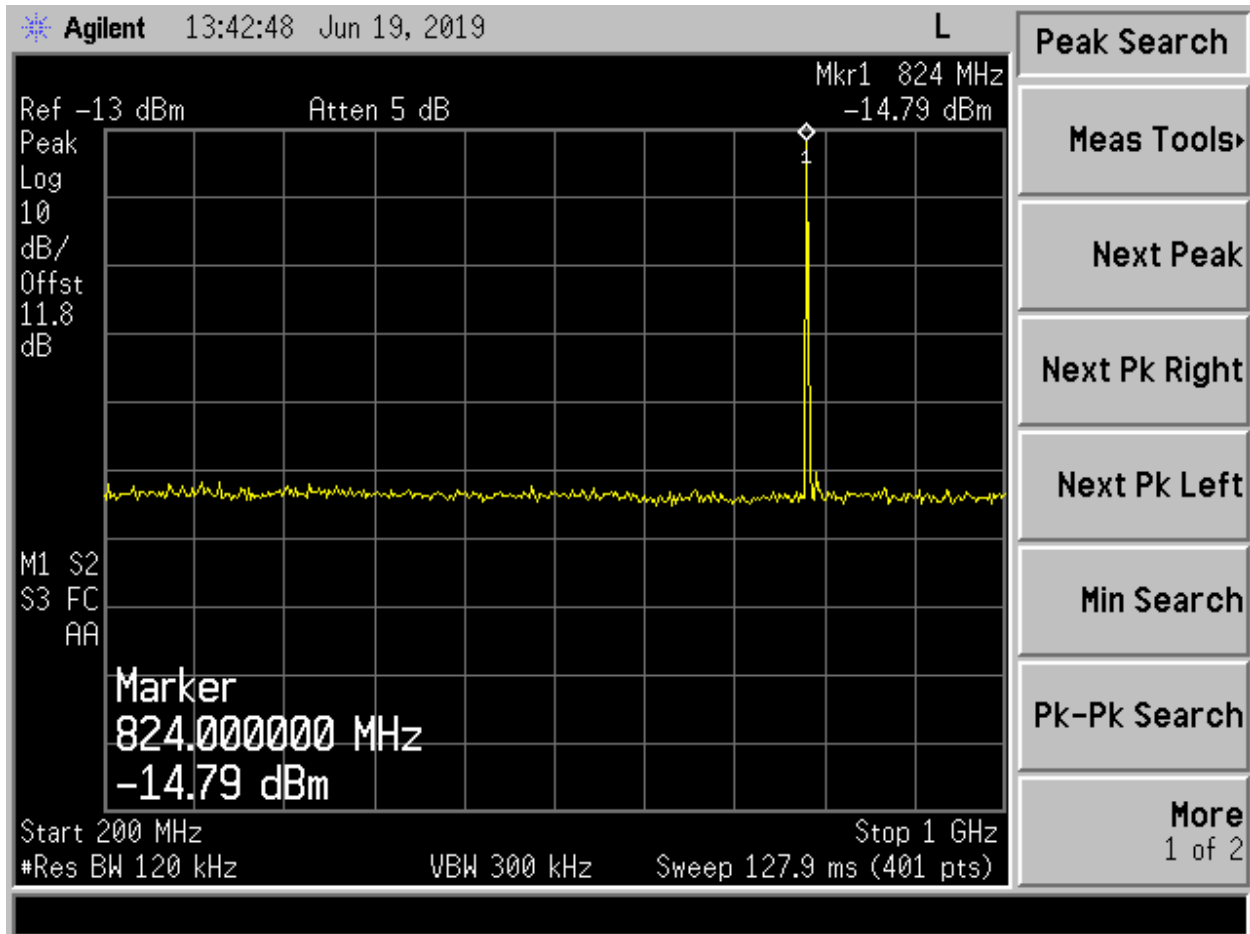


Figure 229. 824 MHz Horizontal 200 MHz - 1 GHz

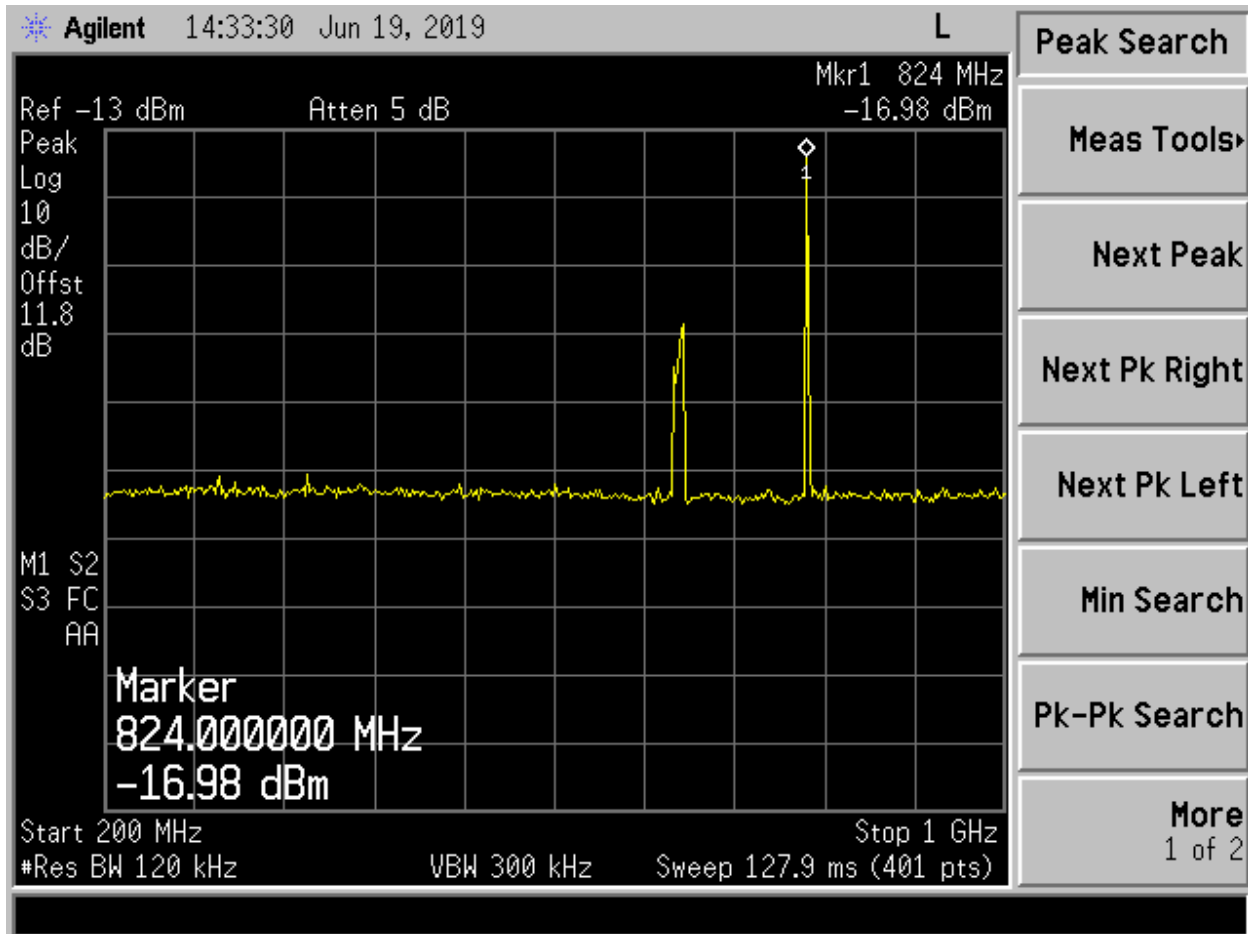


Figure 230. 824 MHz Vertical, 200 MHz – 1 GHz

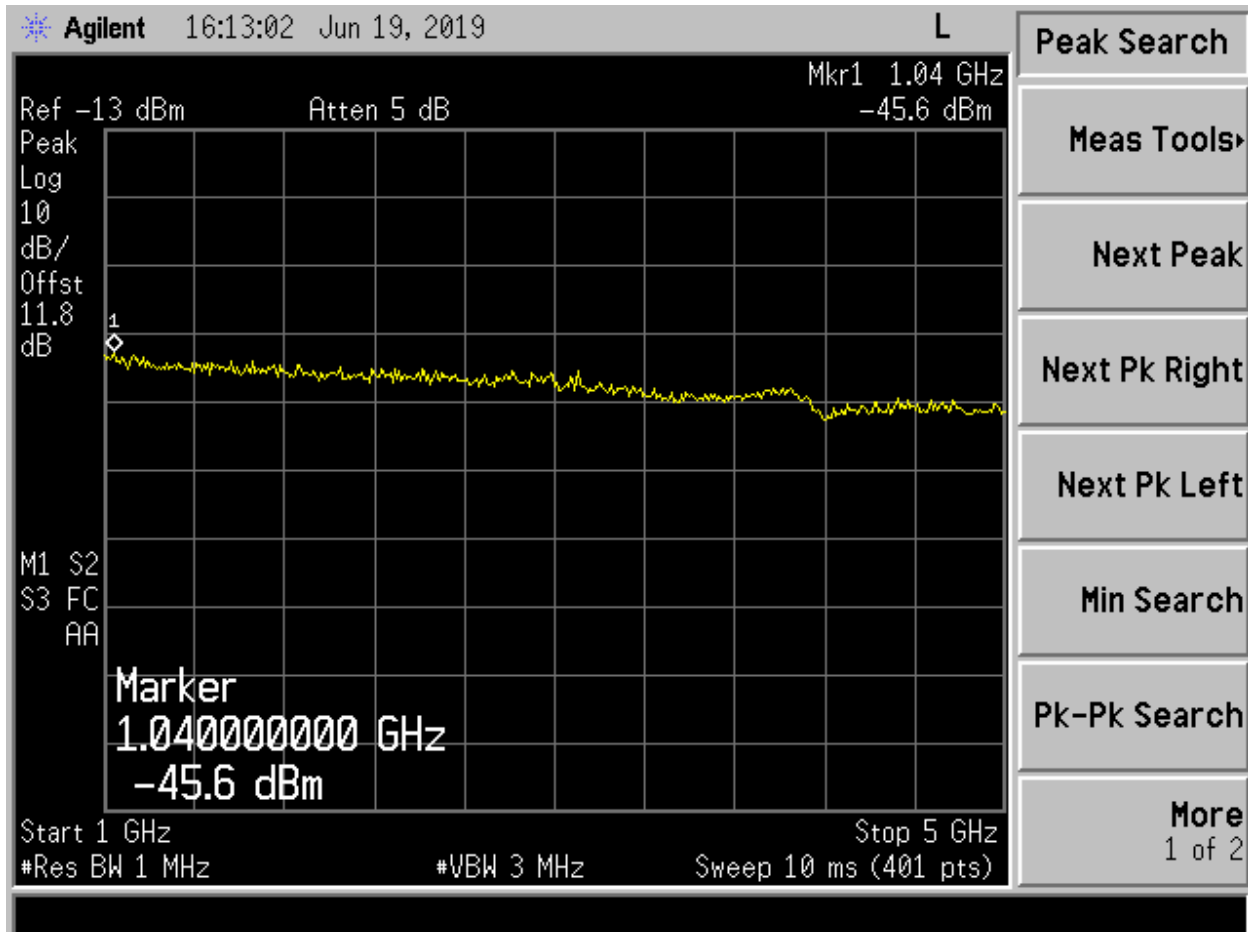


Figure 231. 824 MHz Horizontal, 1 – 5 GHz

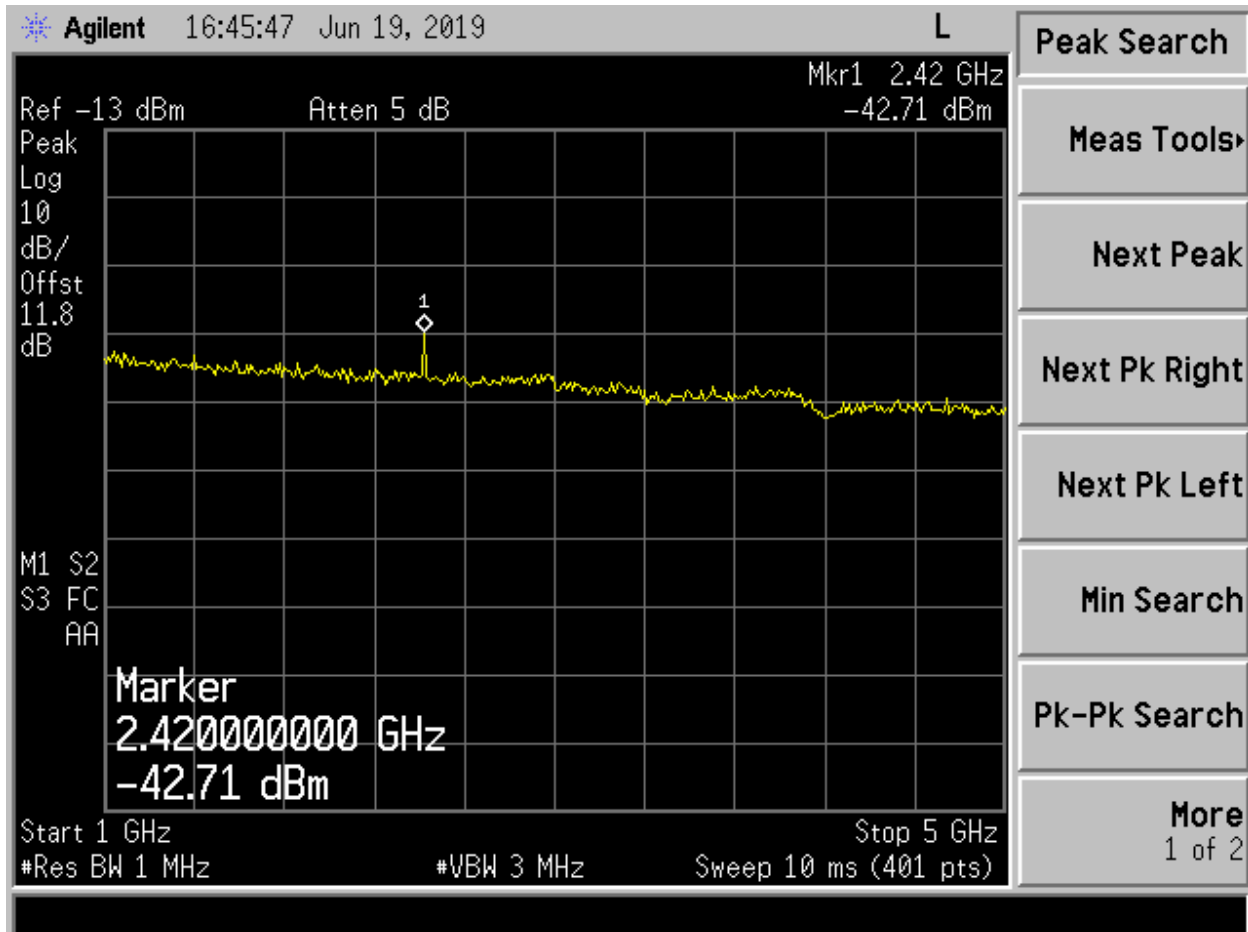


Figure 232. 824 MHz Vertical, 1 – 5 GHz

## 2.12.2 Conducted Spurious Emissions Measurement (90.219(e)(4), RSS-131, 6.5)

The EUT was connected to a spectrum analyzer through a 20 dB attenuator. All cable and attenuator losses were input into the spectrum analyzer as a combination of reference level offset and correction factors as needed to ensure the accuracy of the readings obtained.

A CW signal was used to set the center frequency of the transmitter. The RF input signal level was set to at least 0.2 dB below the ACG threshold. The RBW was set to 100 KHz for measurements below 1 GHz and 1 MHz for measurements above 1 GHz. The VBW was 3 times the RBW.

Limit = -13 dBm (Display line set to represent the limit)

Emissions were investigated from 30 MHz to the 10<sup>th</sup> harmonic of the applicable frequency band of concern. The following plots show the worst-case measurements.

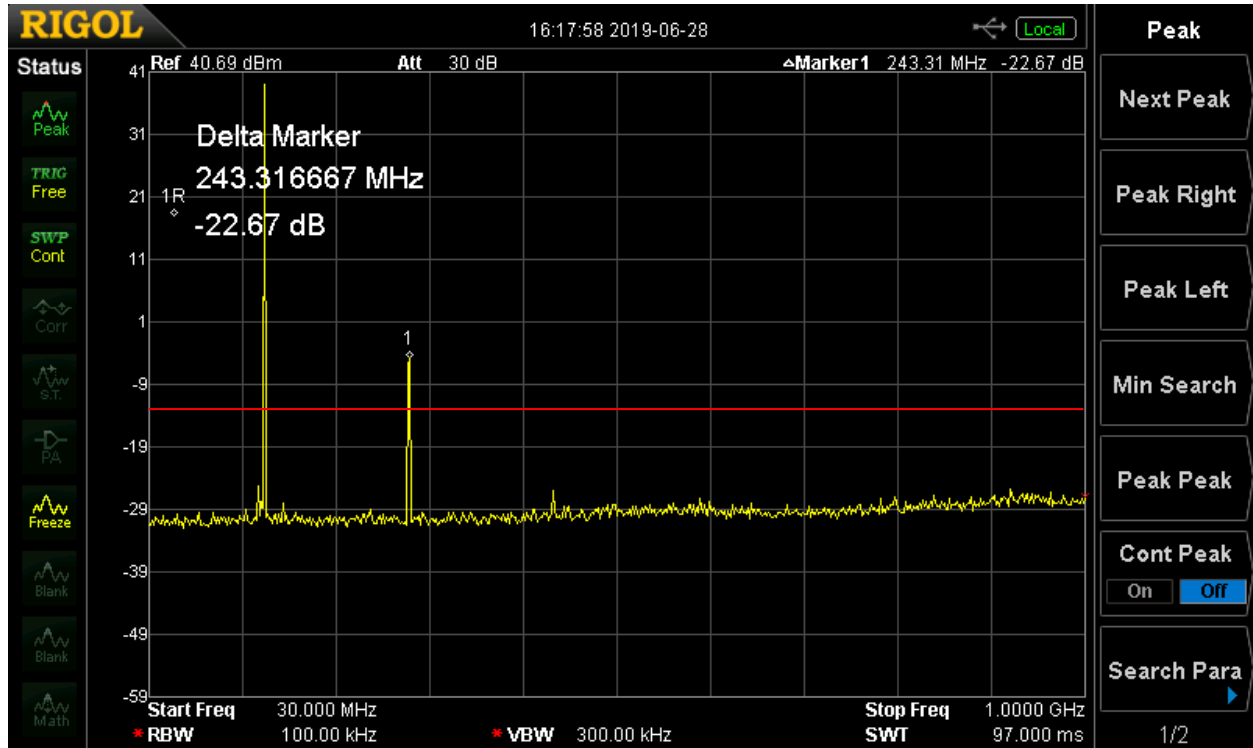


Figure 233. 150 MHz below 1 GHz

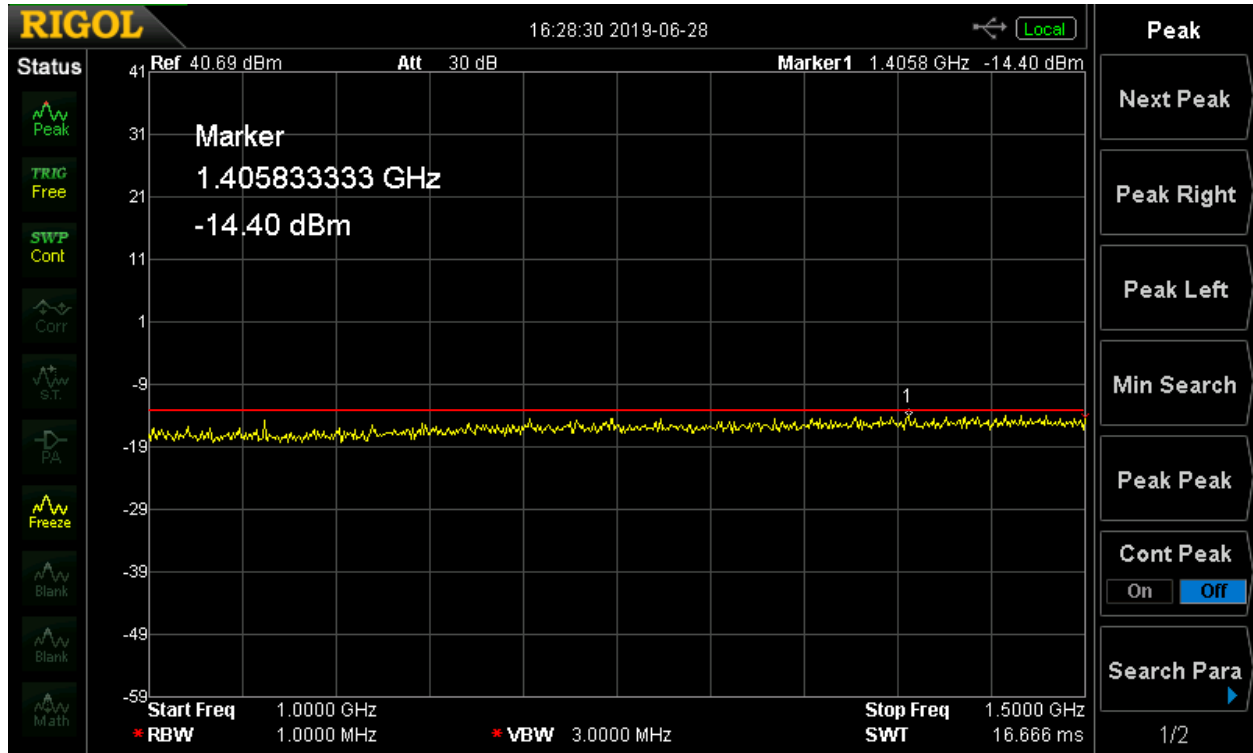


Figure 234. 150 MHz, above 1 GHz

Note: All emissions other than fundamental and harmonics are below the limit.

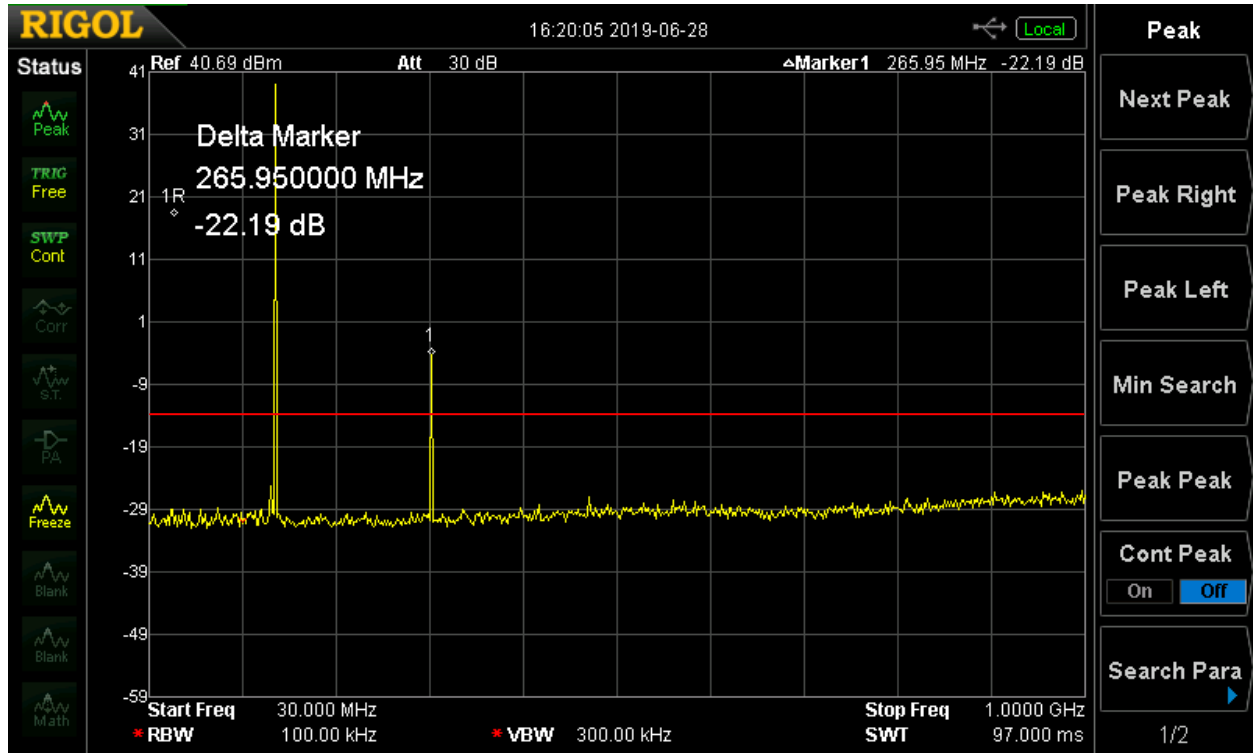


Figure 235. 162 MHz below 1 GHz

Note: All emissions other than fundamental and harmonics are below the limit.

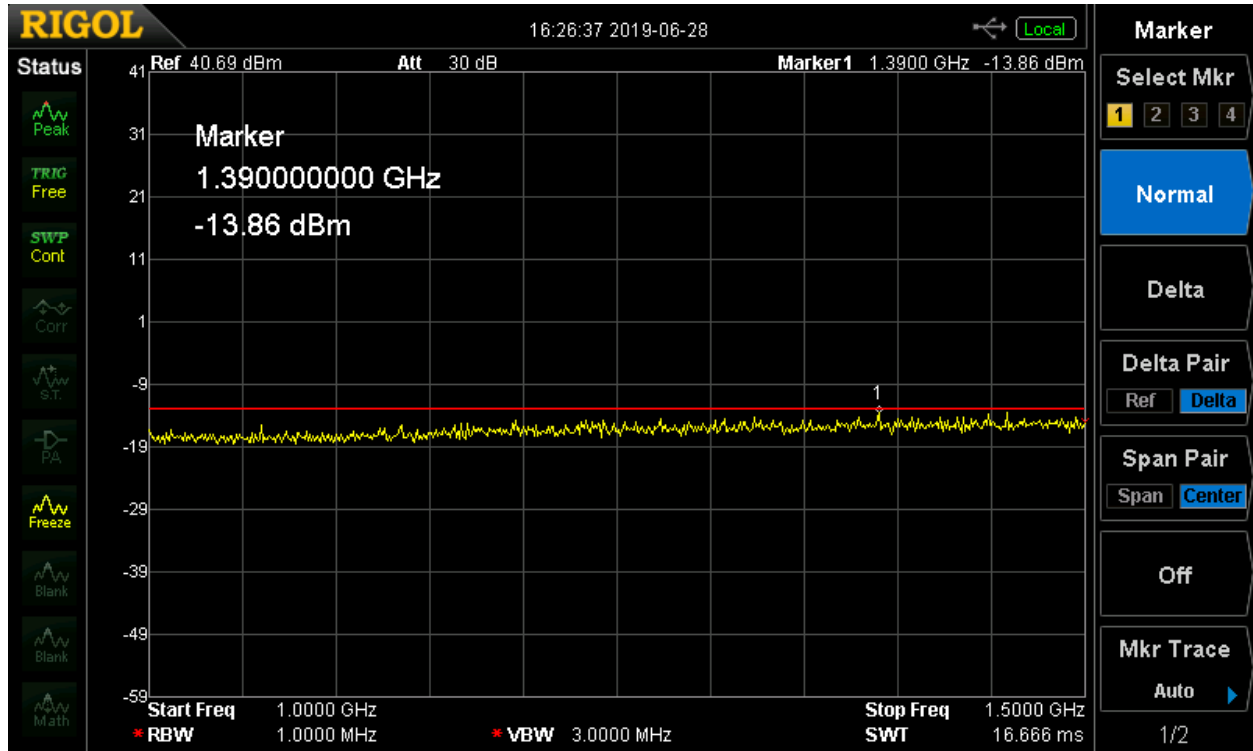


Figure 236. 162 MHz, above 1 GHz

Note: All emissions other than fundamental and harmonics are below the limit.

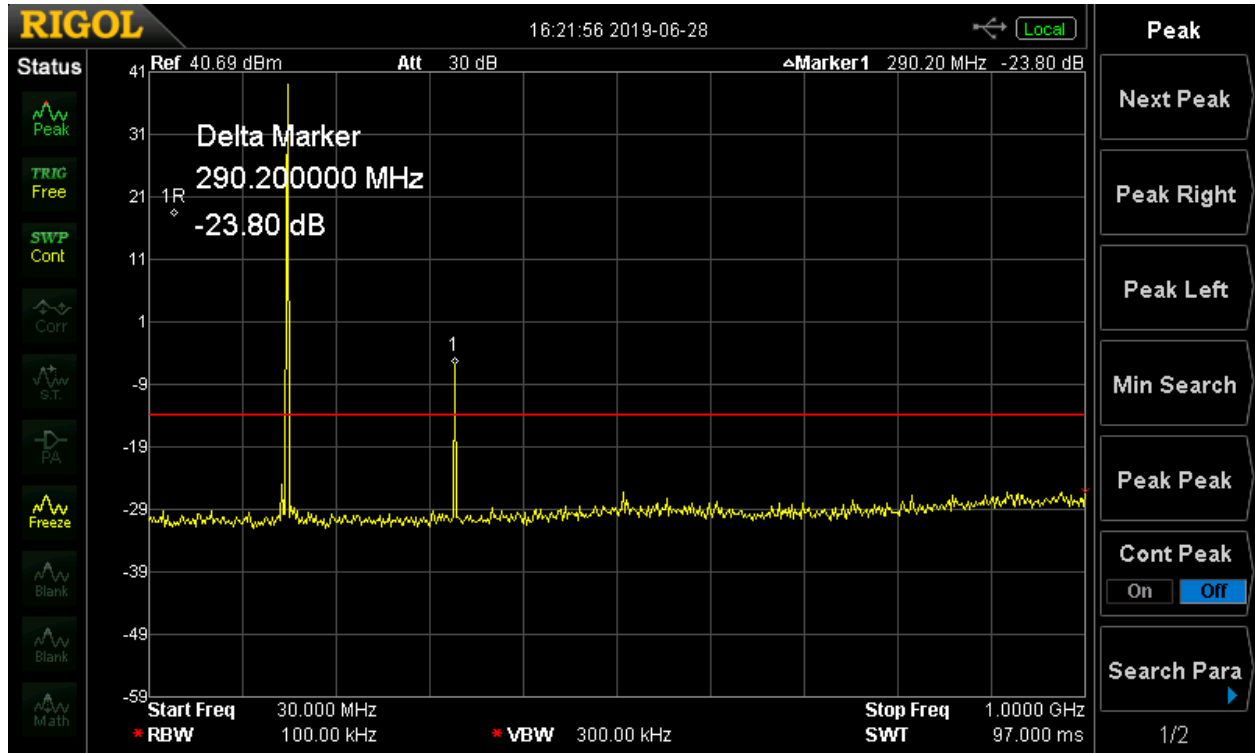


Figure 237. 174 MHz below 1 GHz

Note: All emissions other than fundamental and harmonics are below the limit.

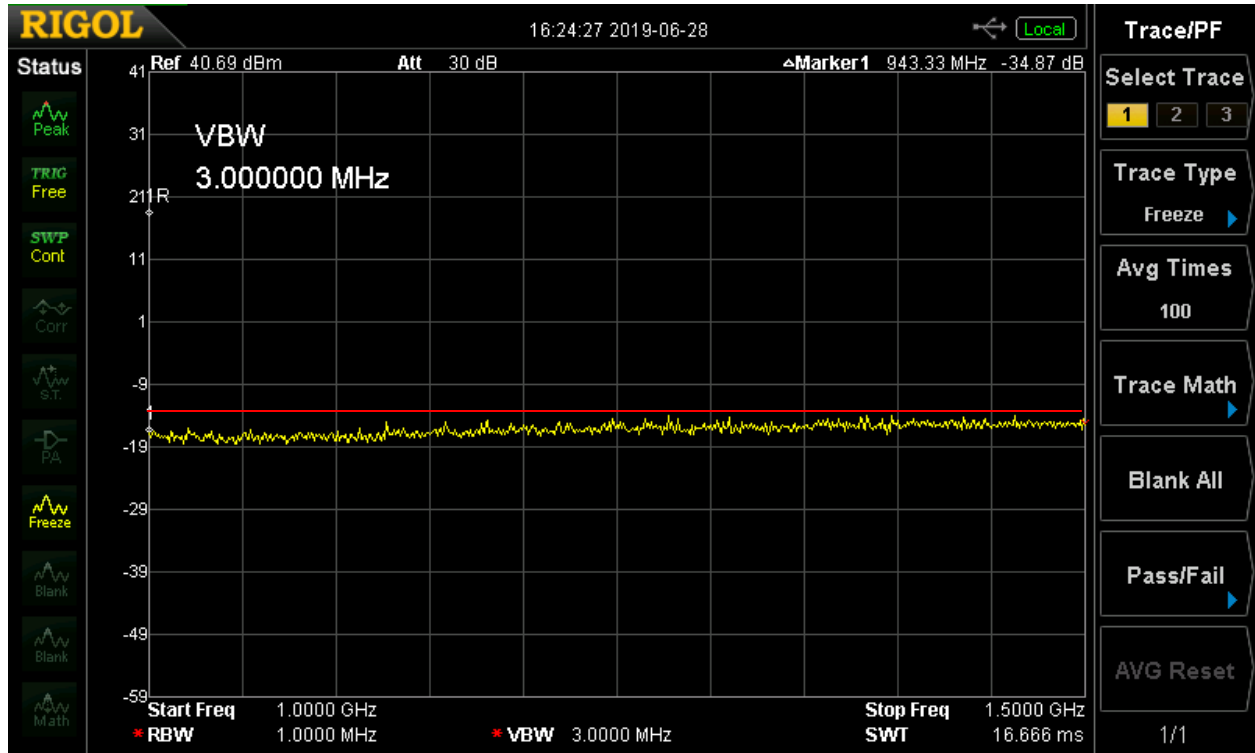
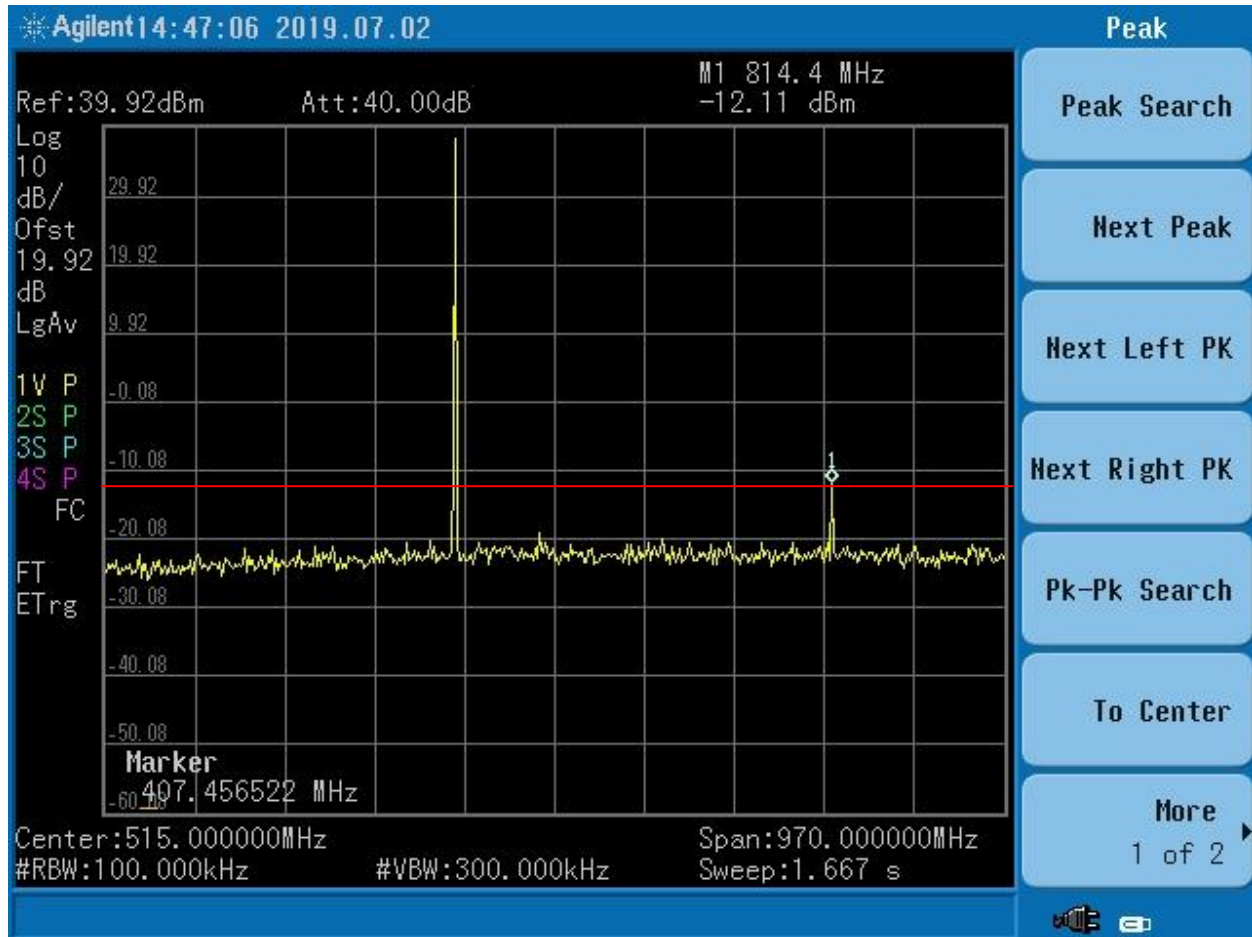


Figure 238. 174 MHz, above 1 GHz

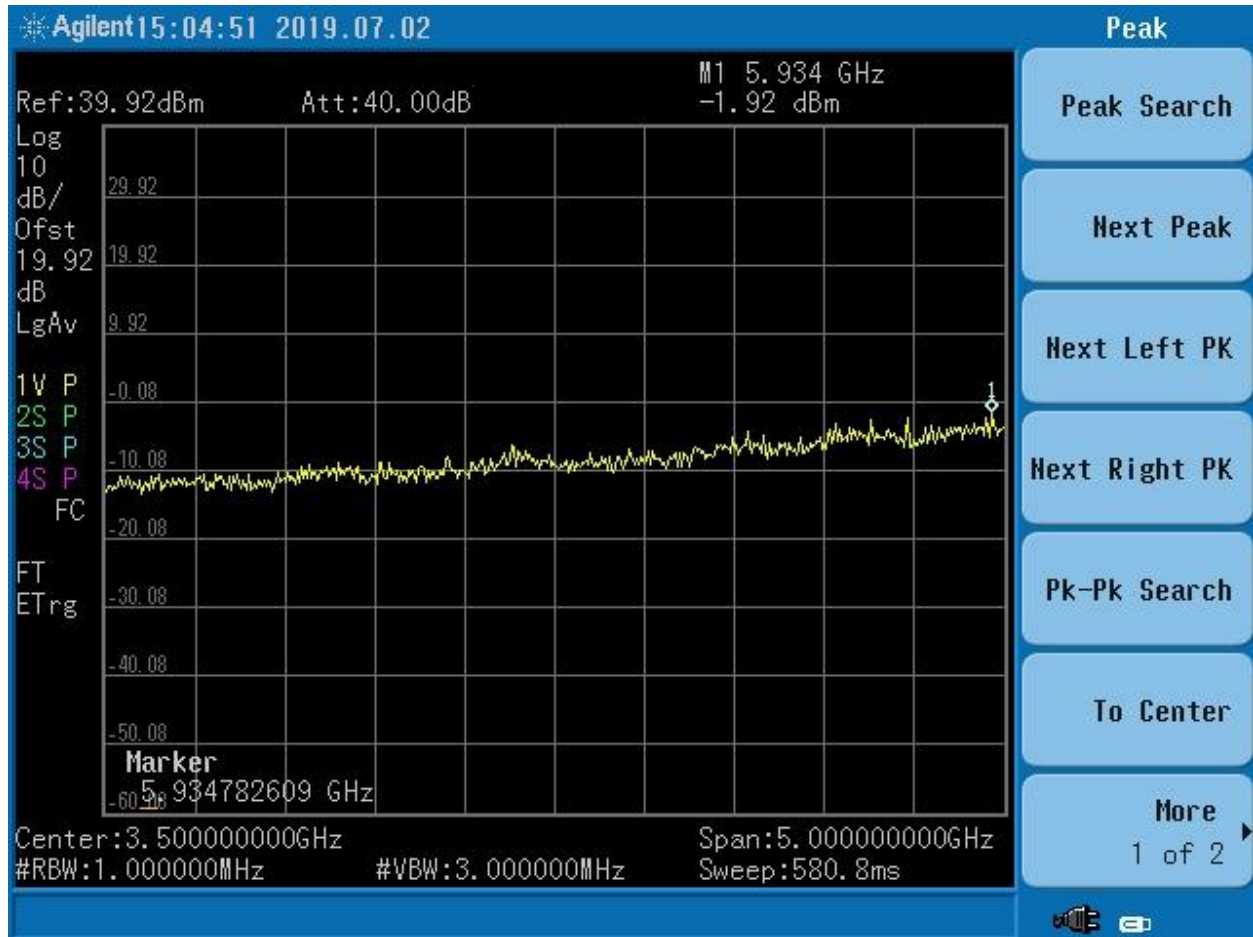

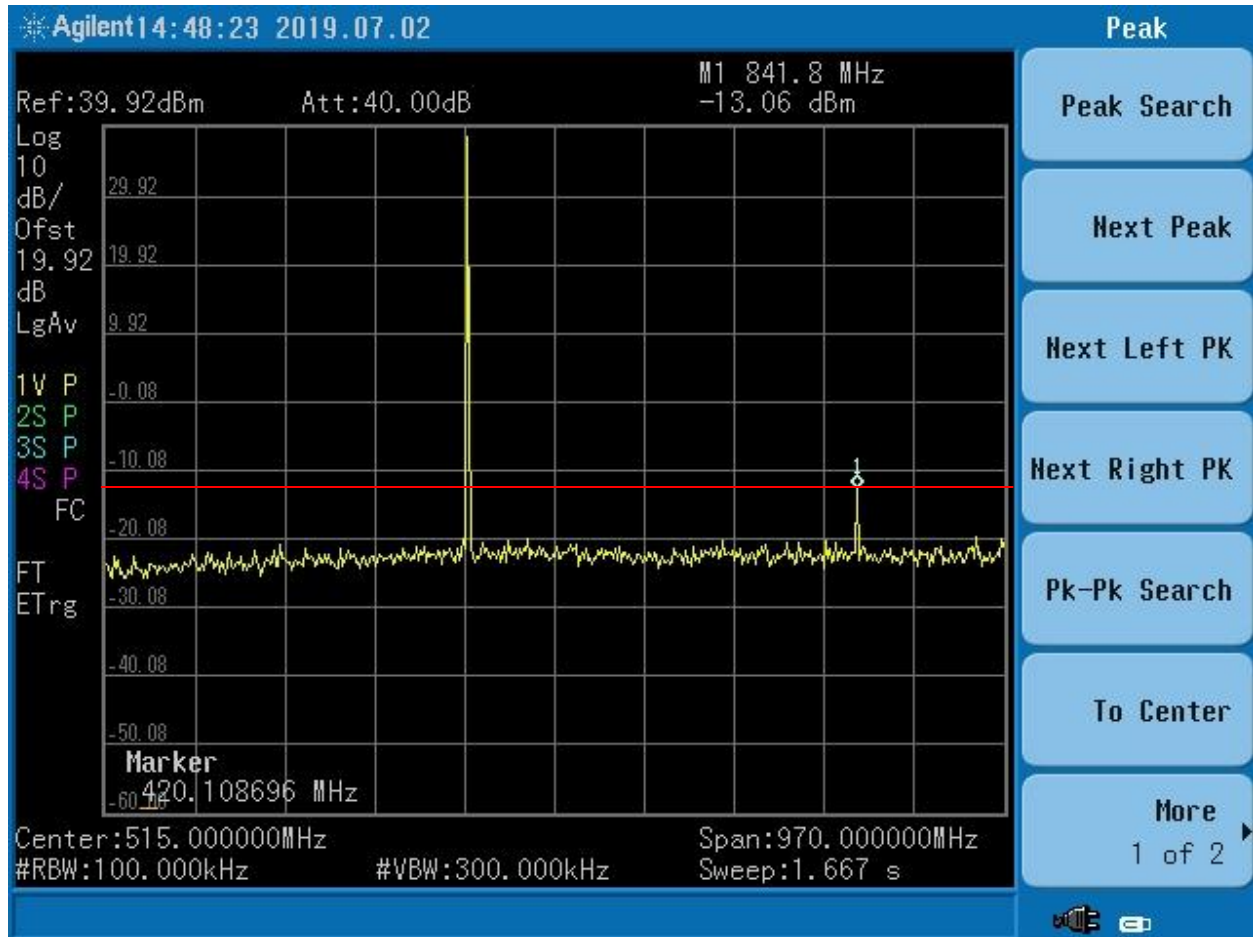
**Figure 239. 407 MHz, below 1 GHz**

**Figure 240. 407 MHz, 1 – 6 GHz**

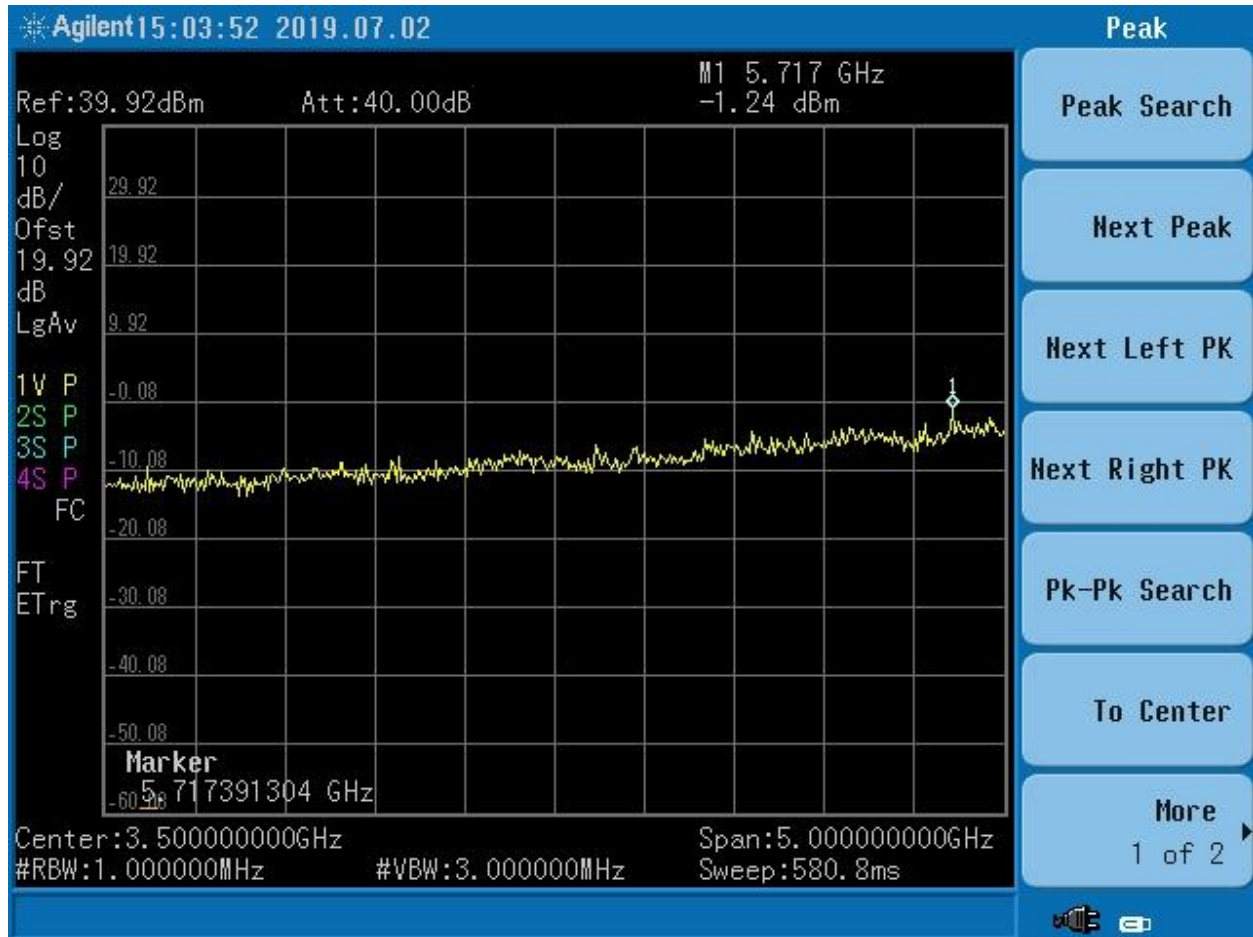

**Figure 241. 421 MHz, below 1 GHz**

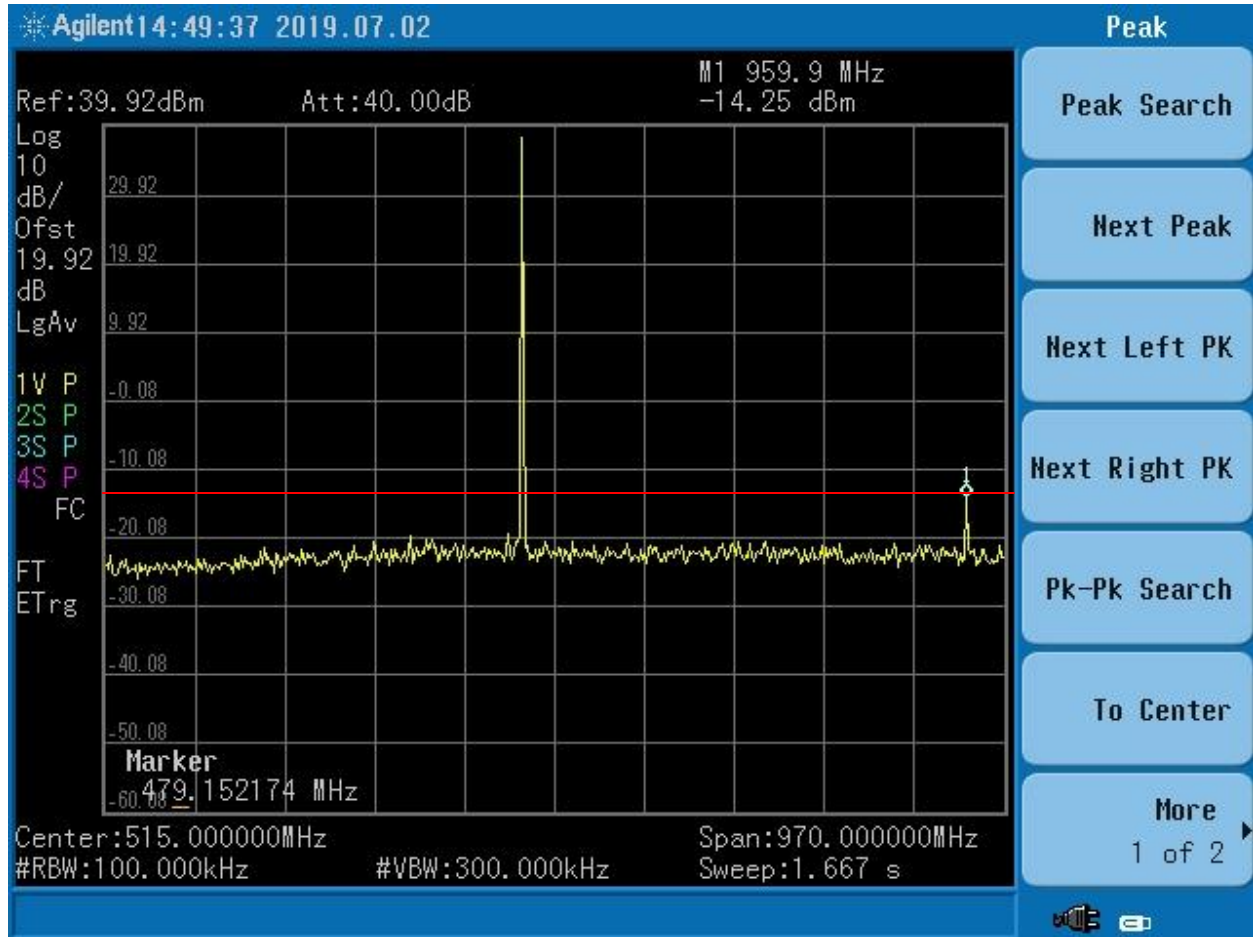

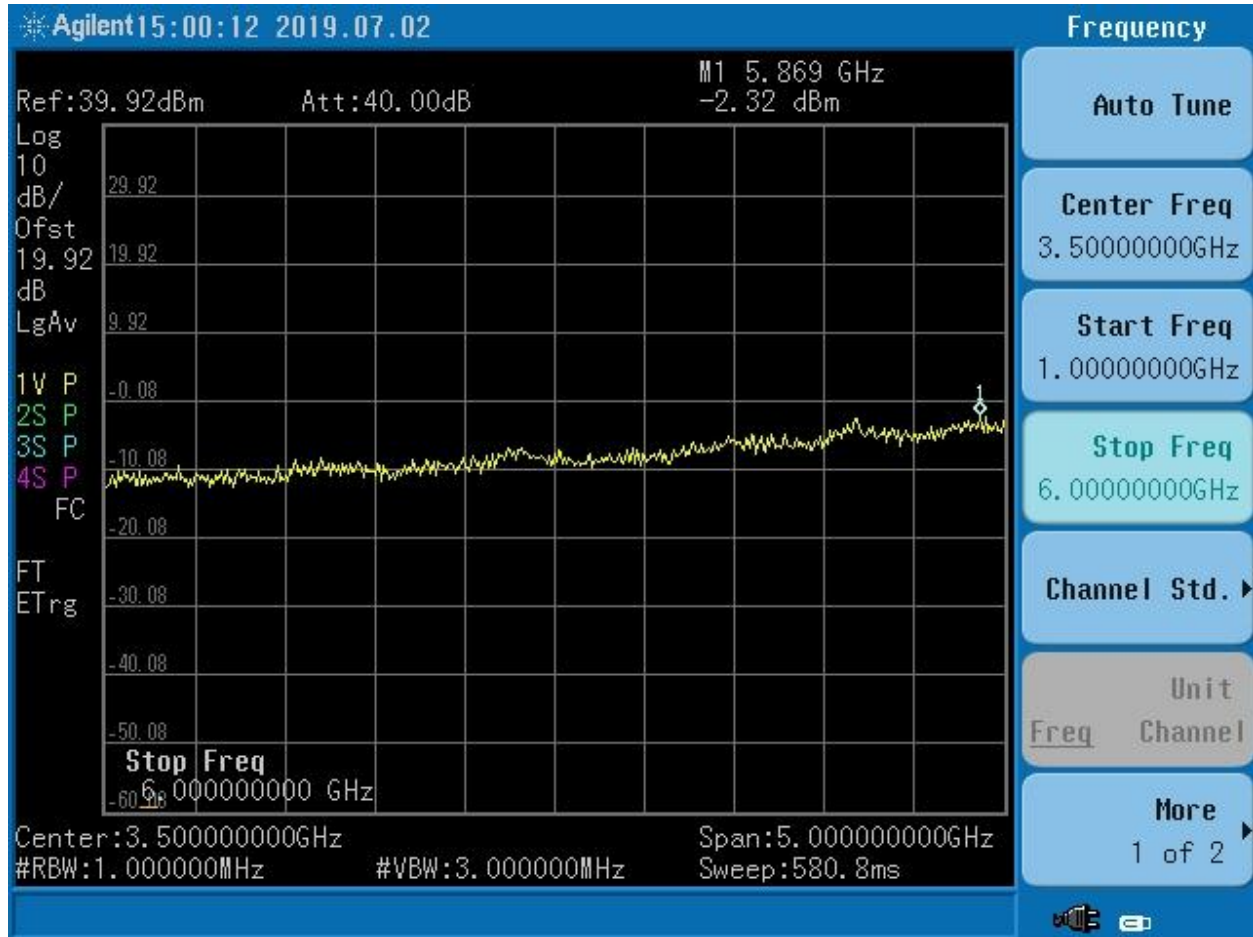
**Figure 242. 421 MHz, 1 – 6 GHz**

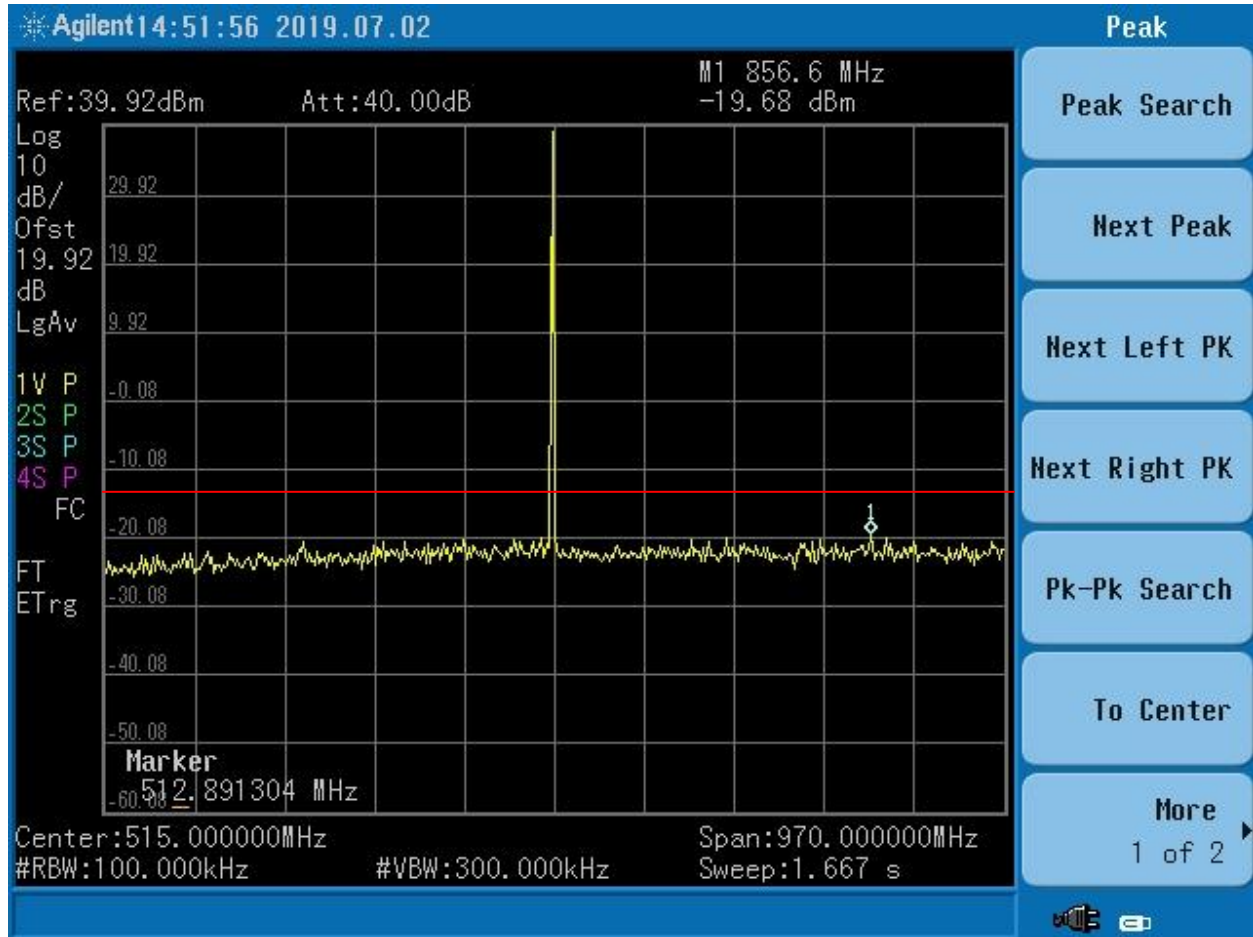
**Figure 243. 480 MHz below 1 GHz**

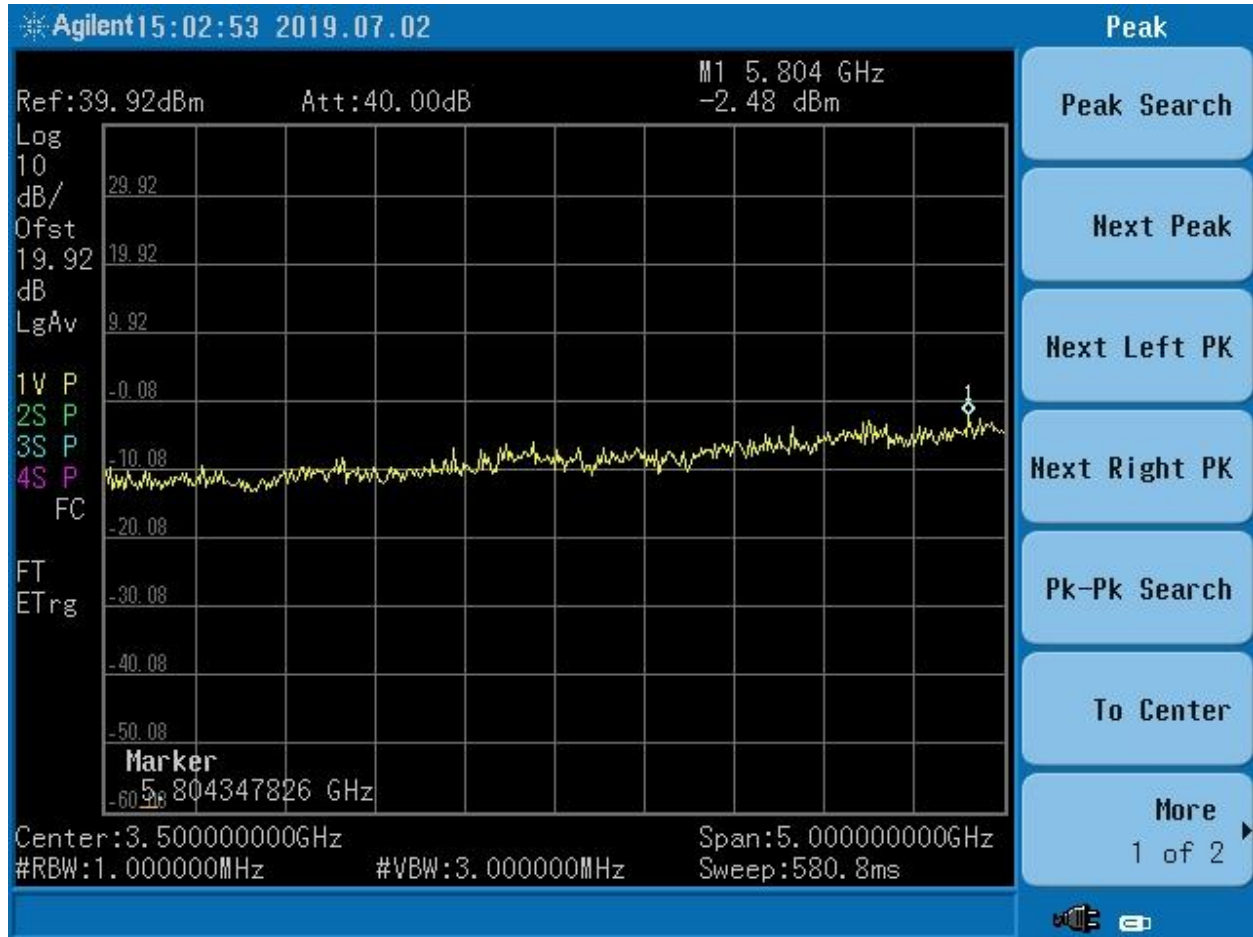
**Figure 244. 480 MHz, 1 – 6 GHz**

**Figure 245. 512 MHz, below 1 GHz**

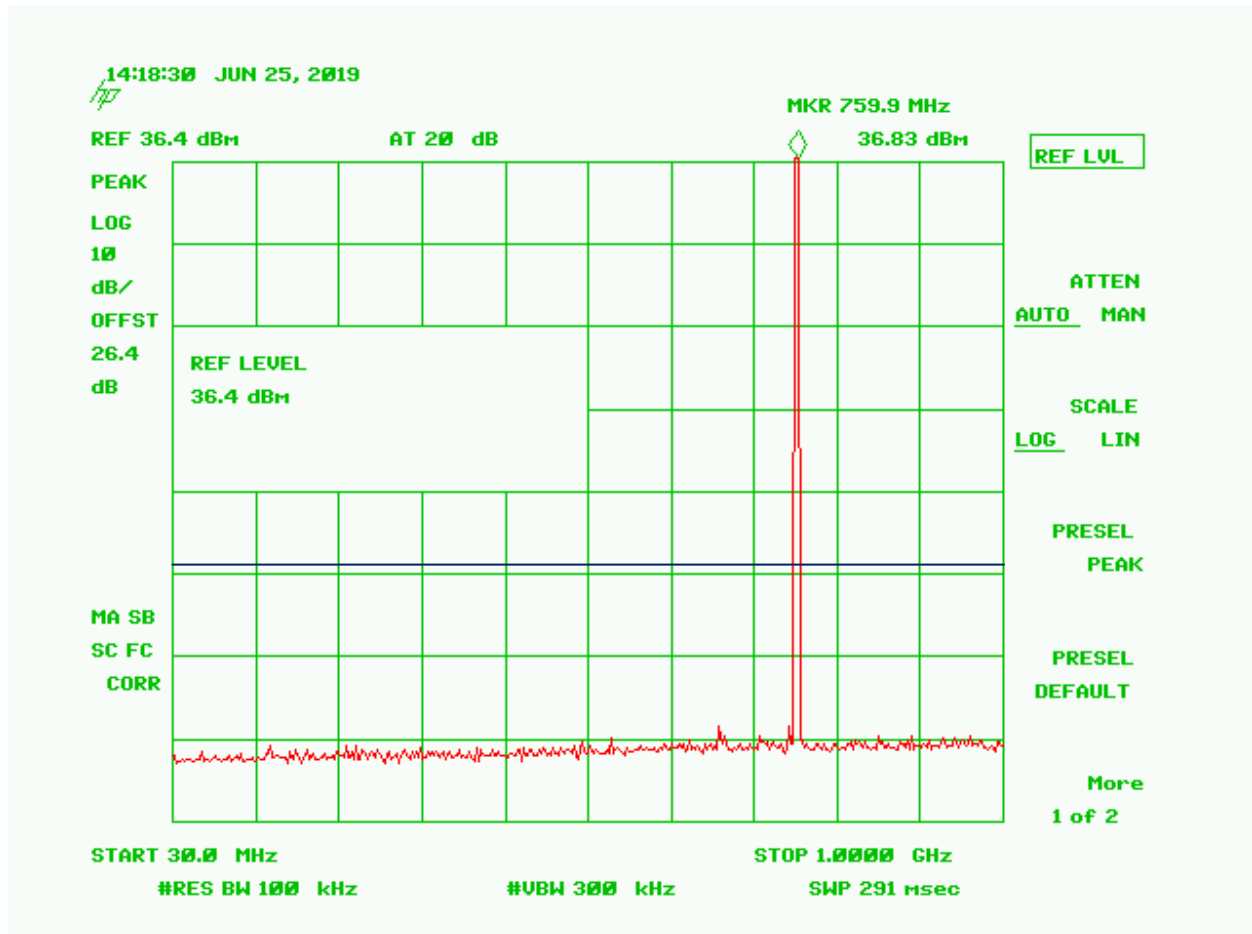

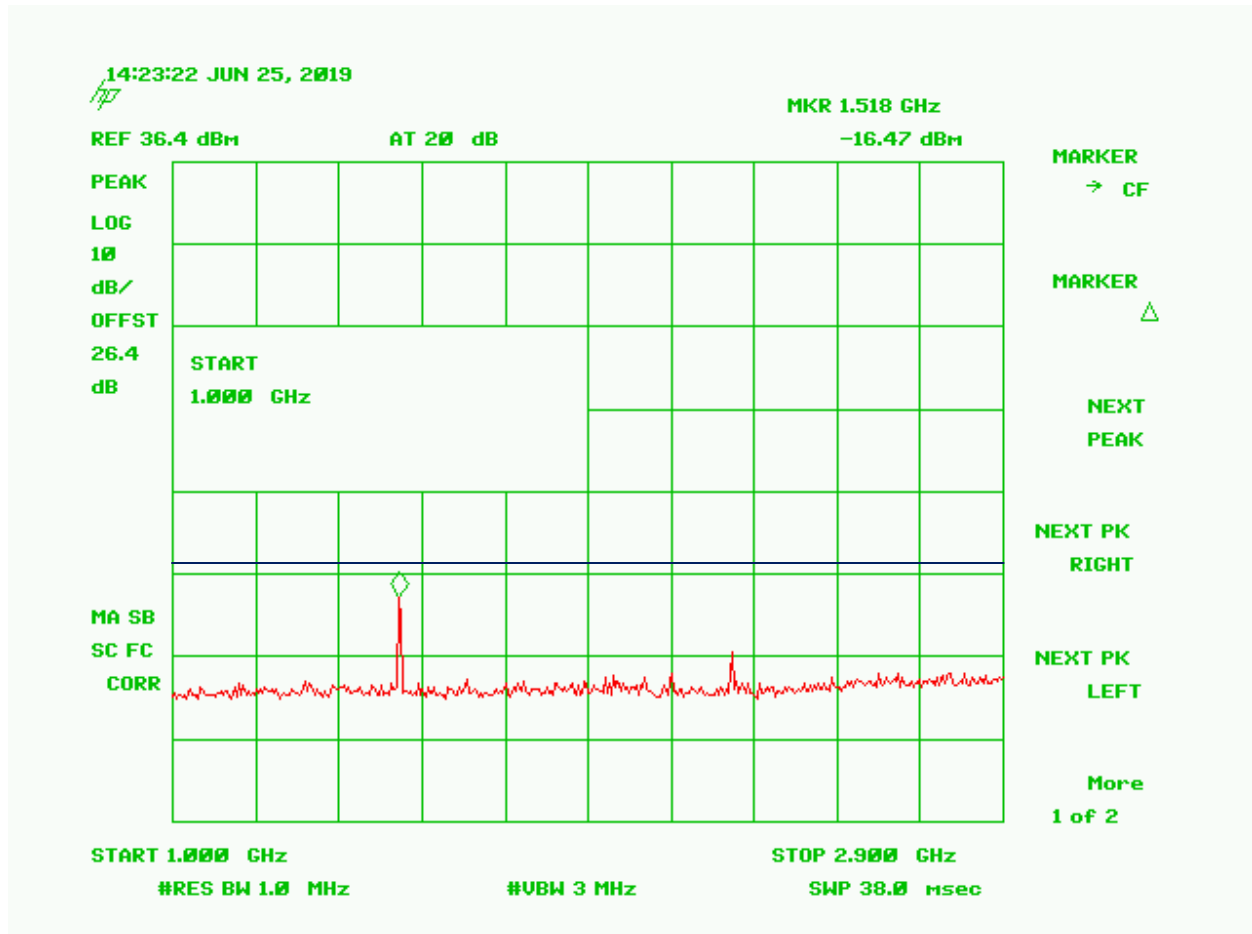


Figure 248. 758 MHz, 1 – 2.9 GHz

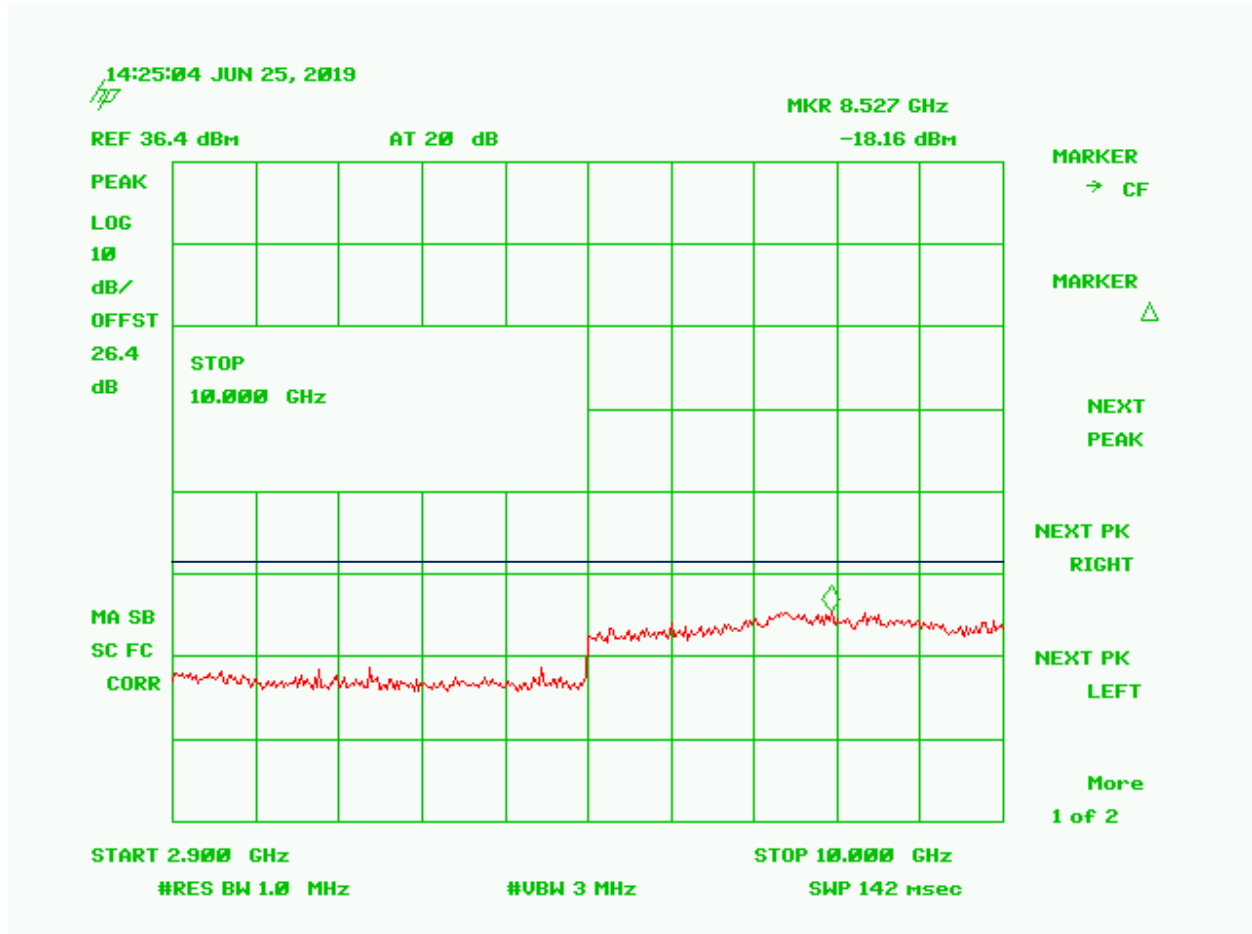
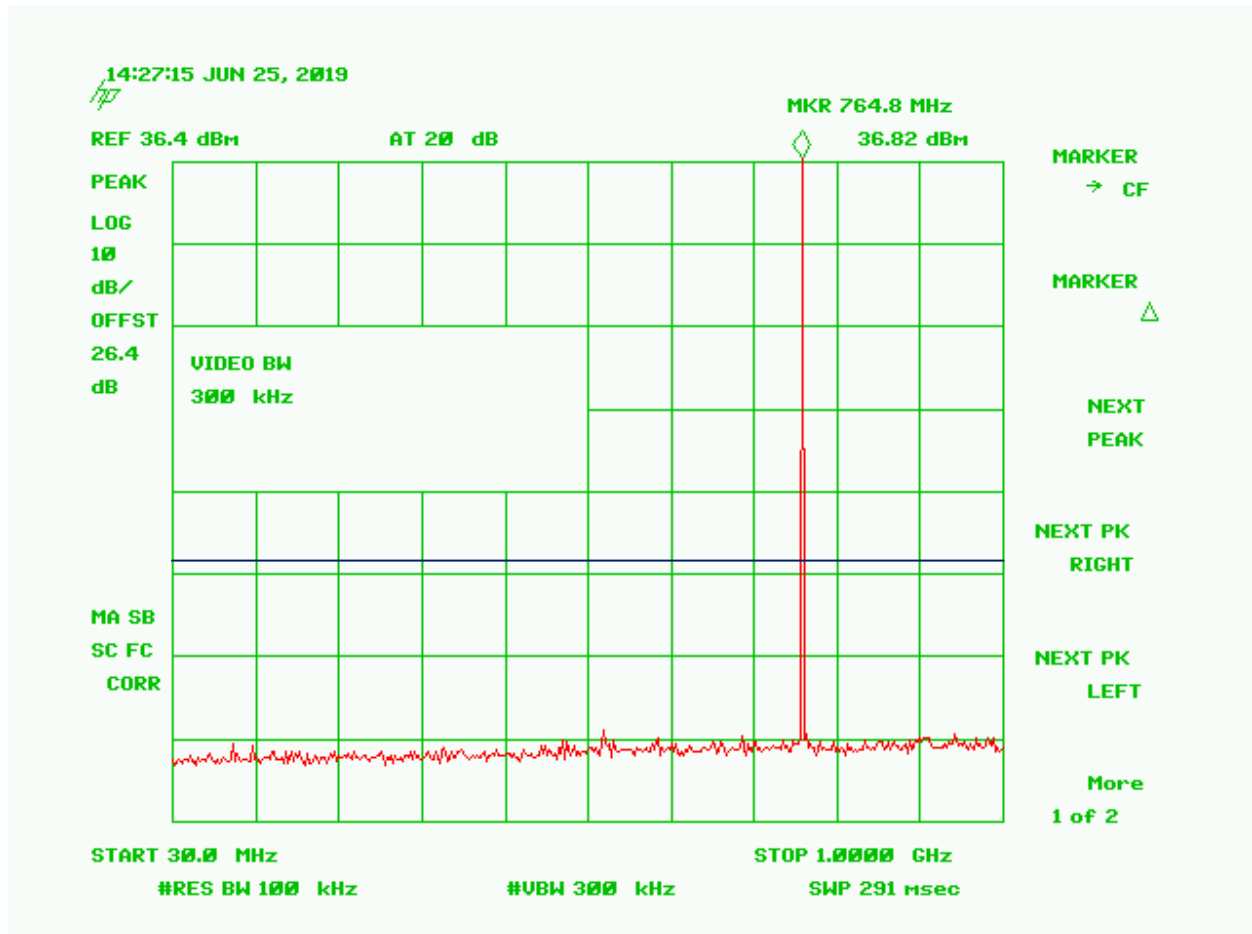


Figure 249. 758 MHz, 2.9 - 10 GHz

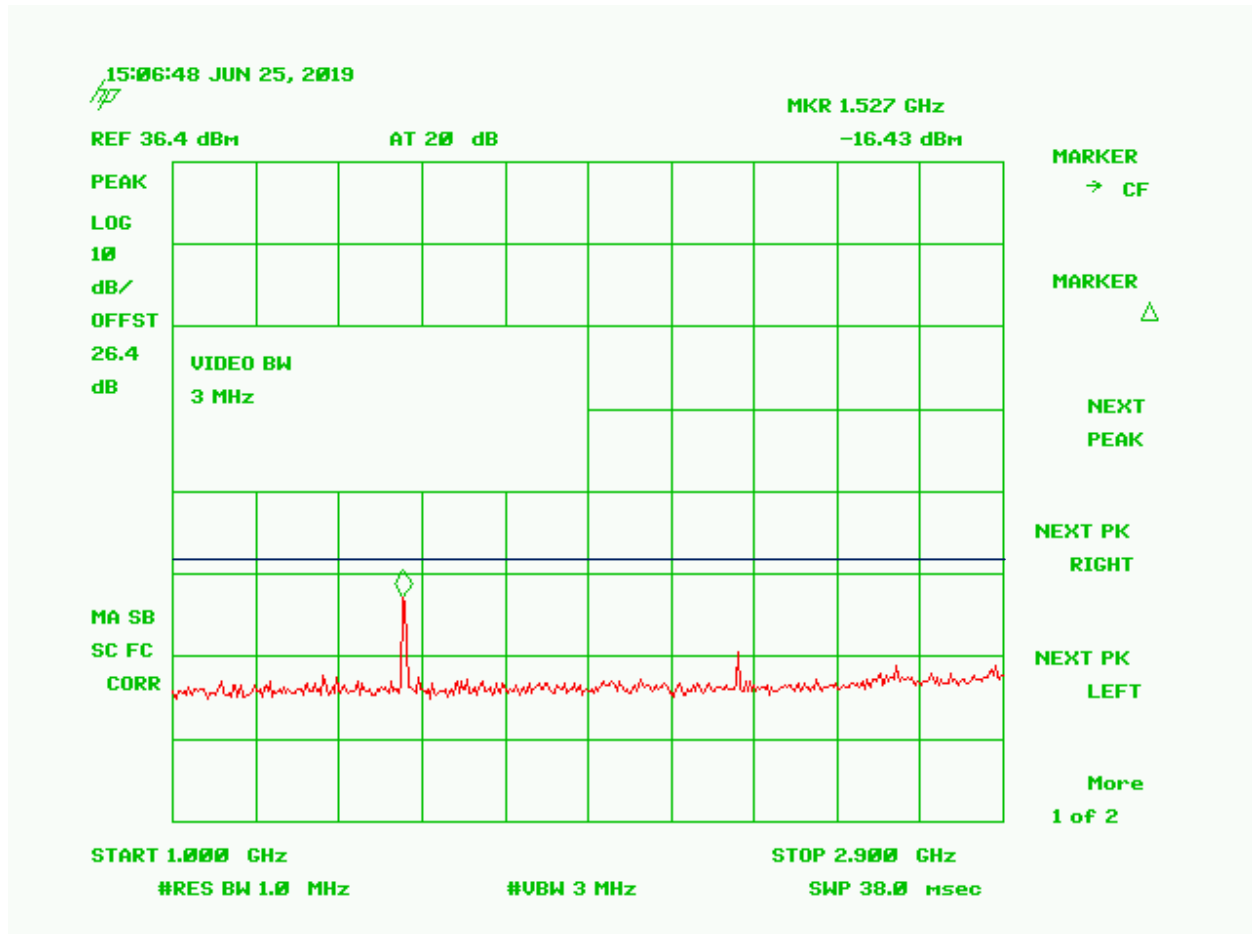


Figure 251. 763 MHz, 1 – 2.9 GHz

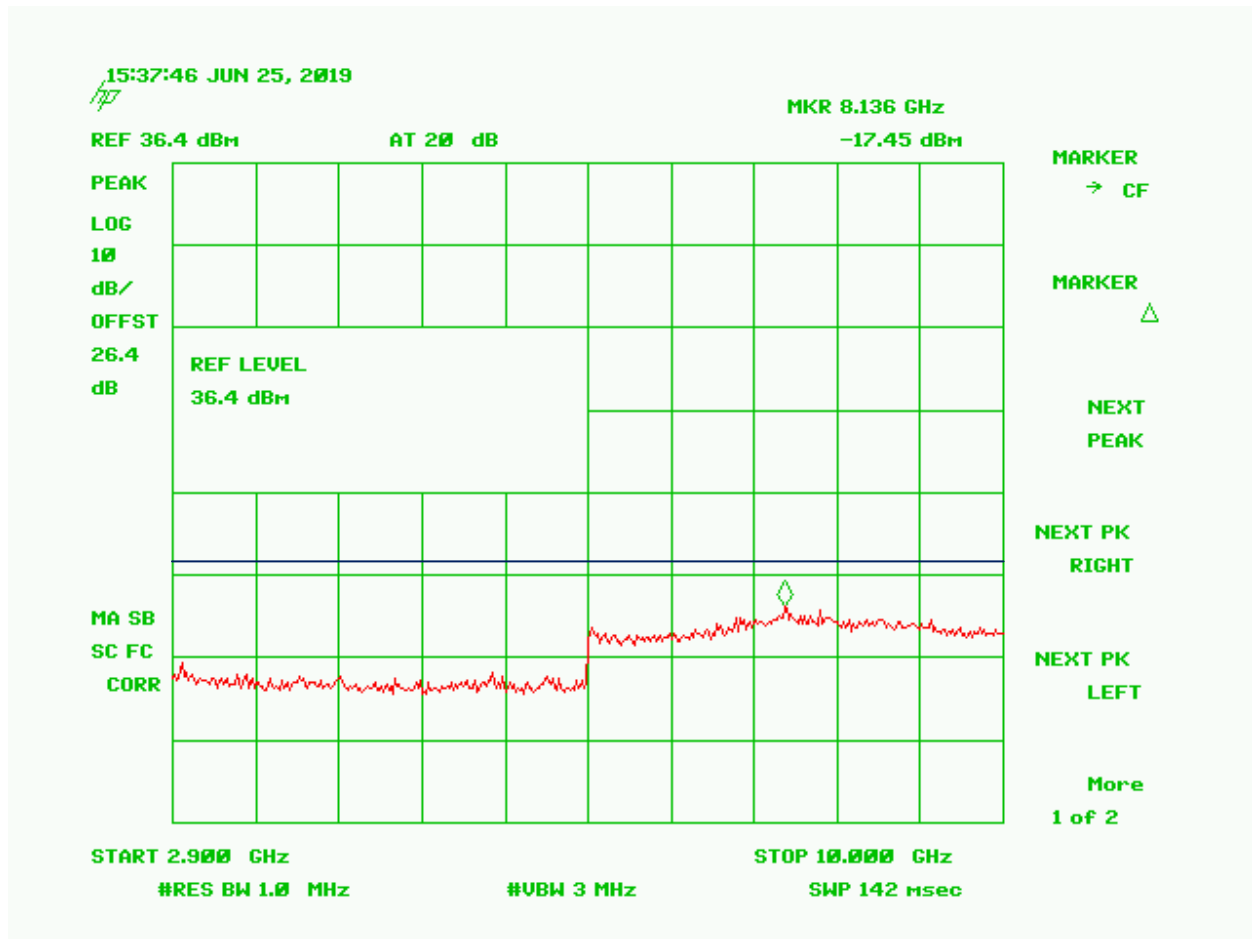
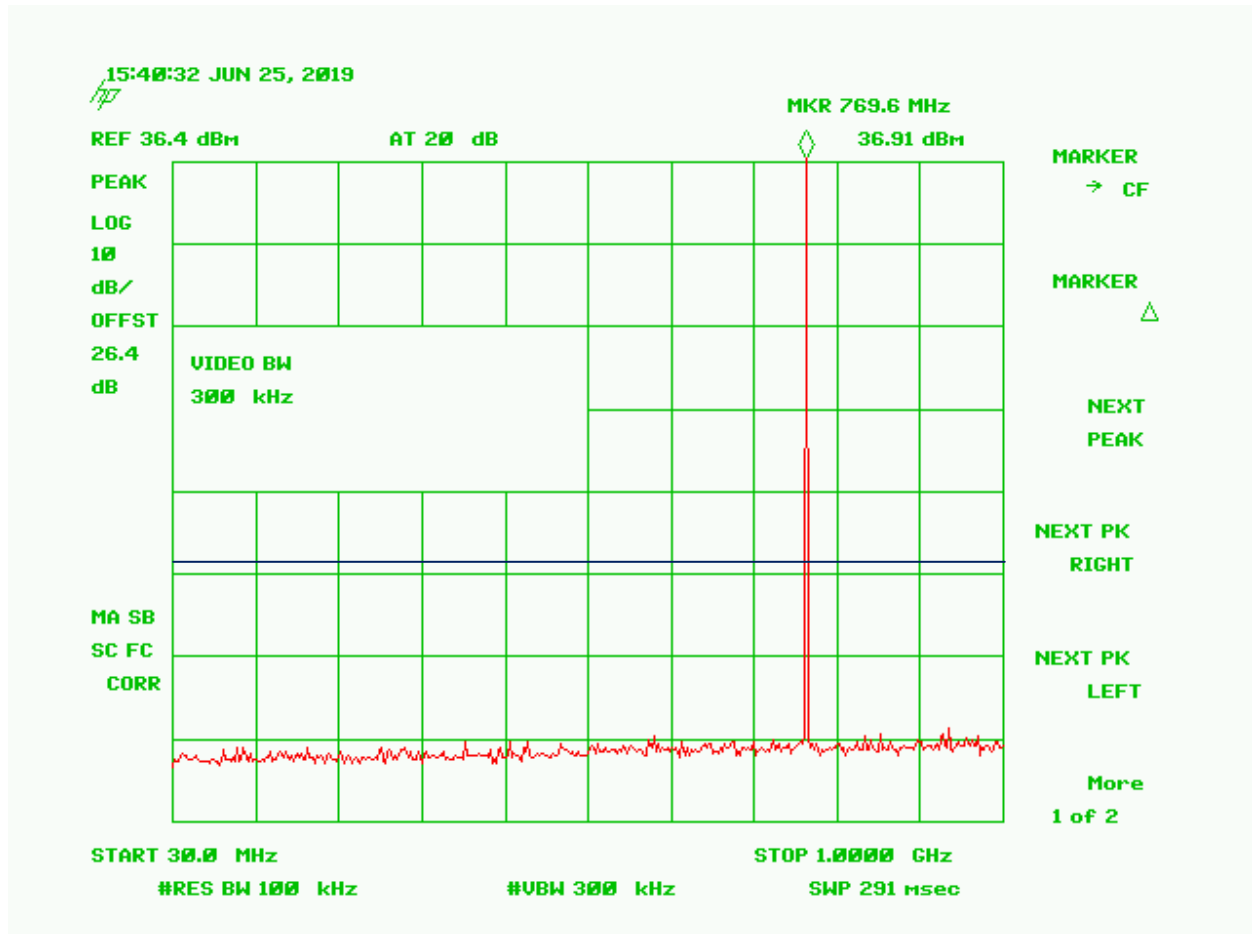


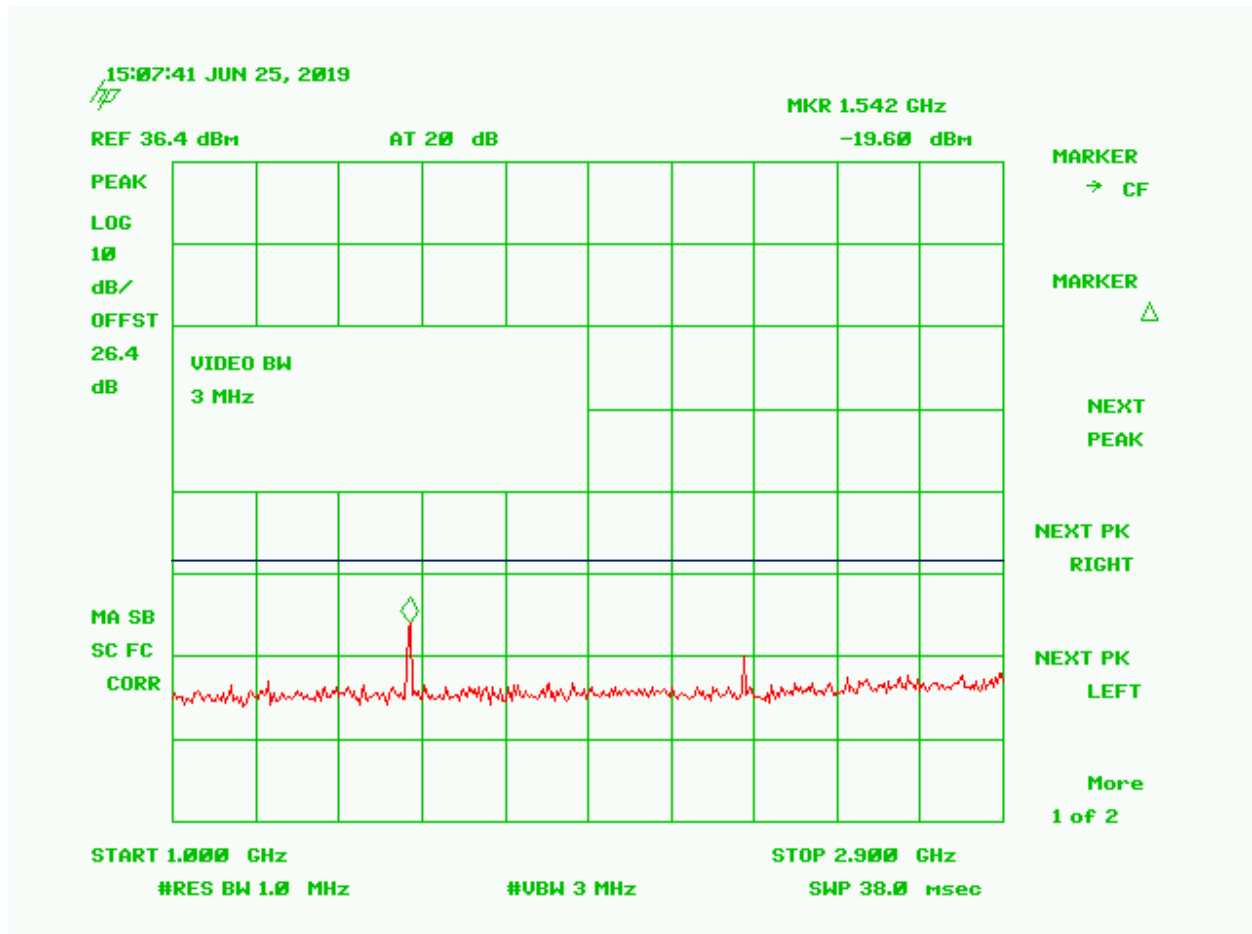
Figure 252. 763 MHz, 2.9 - 10 GHz

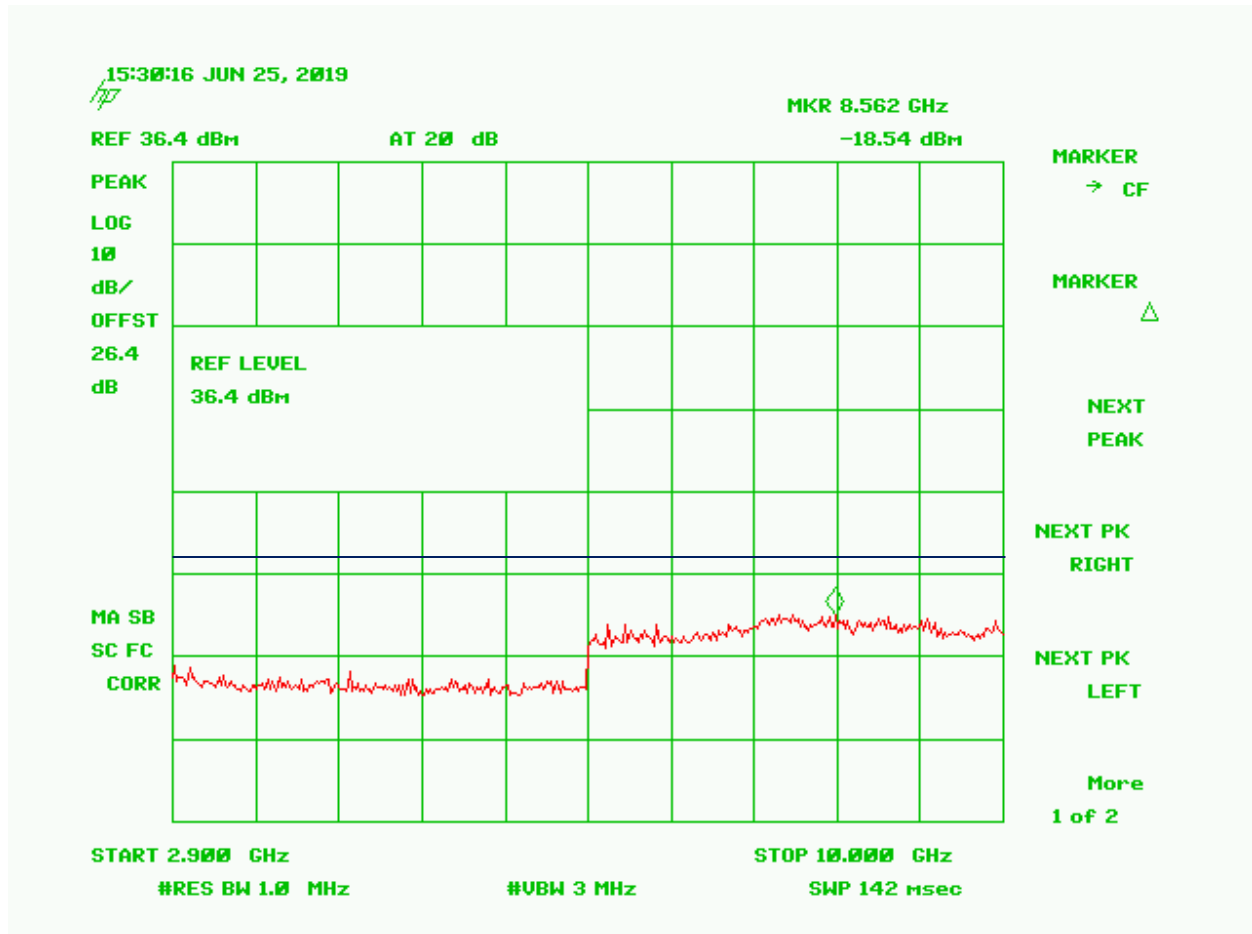
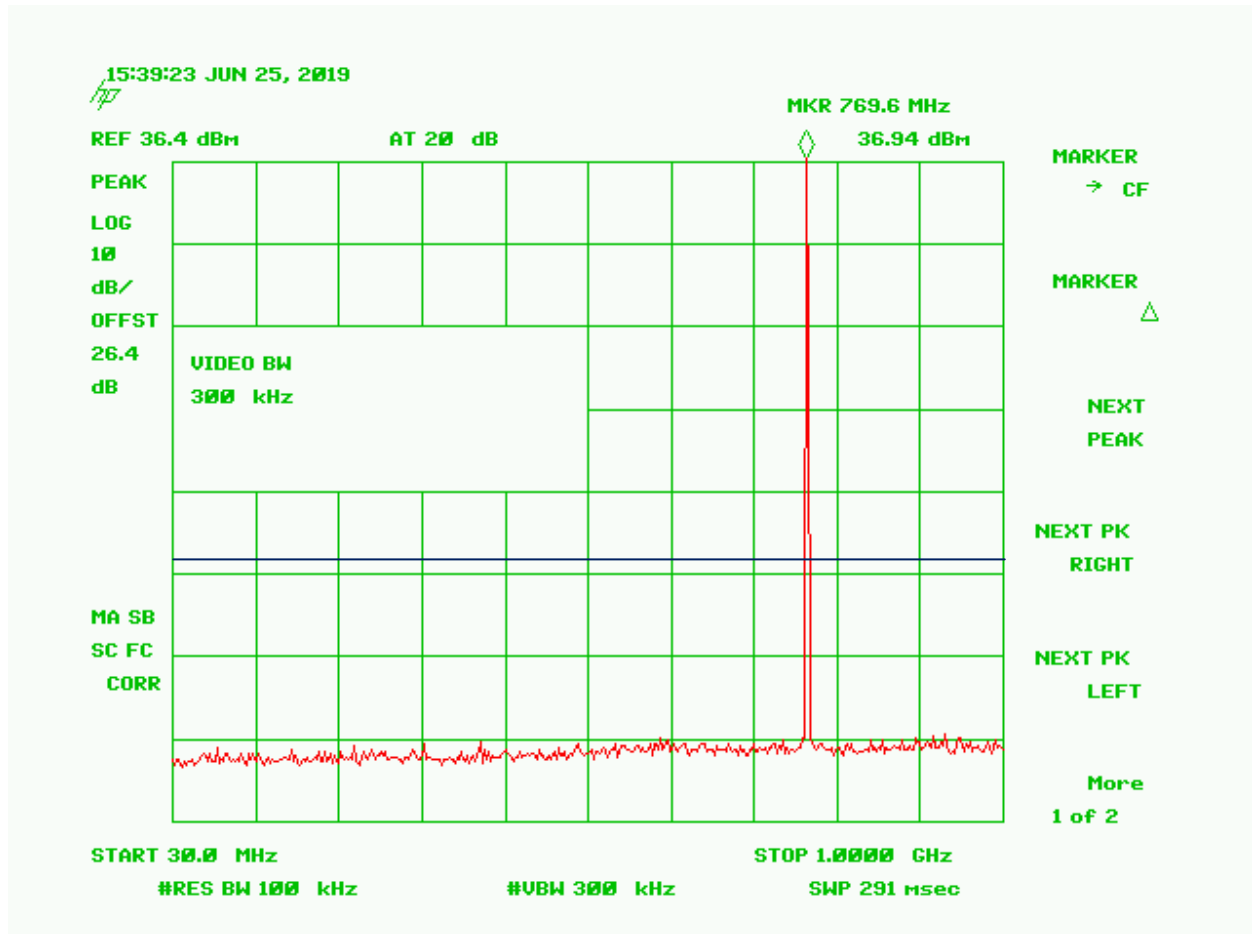


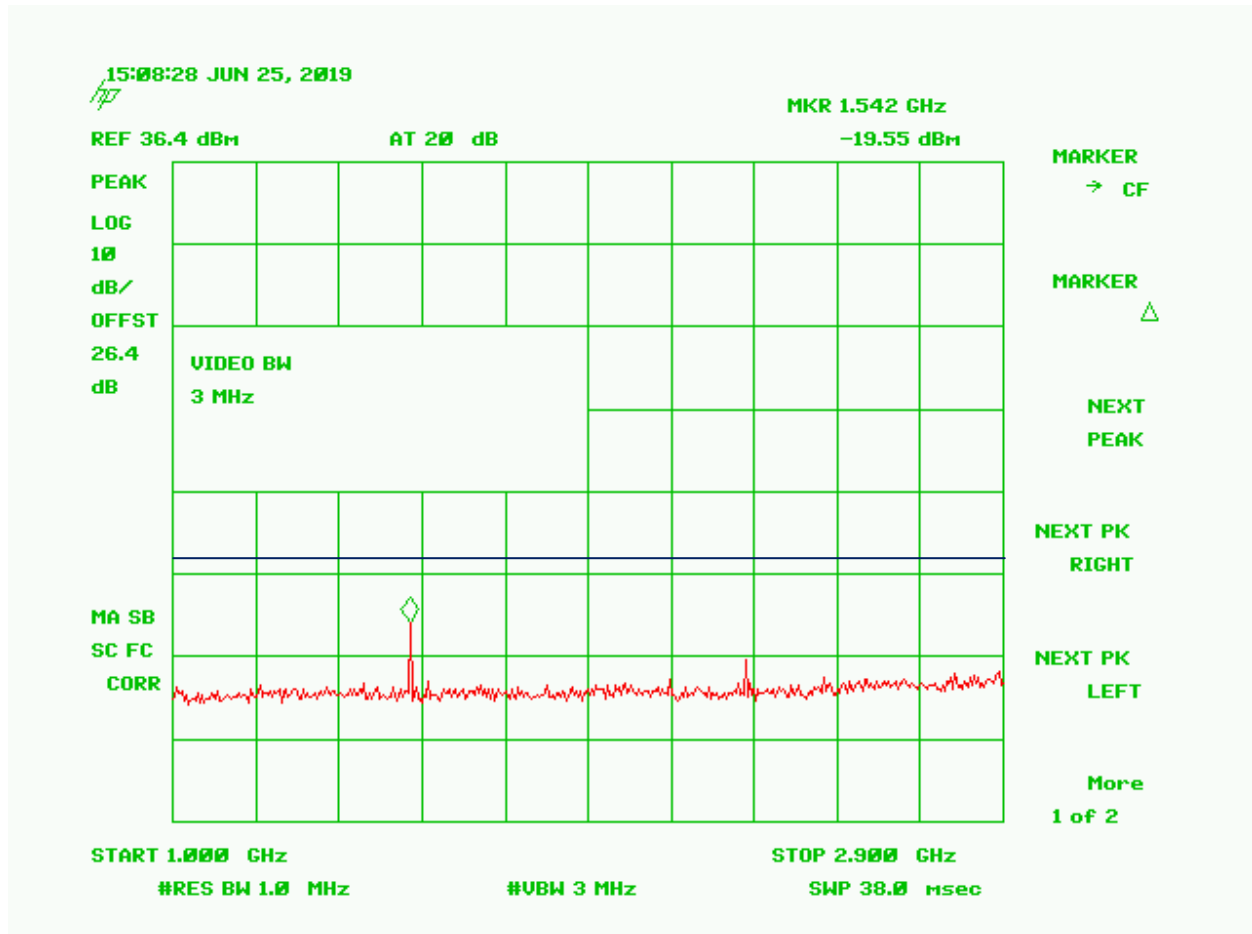
Figure 255. 768 MHz, 2.9 GHZ – 10 GHZ

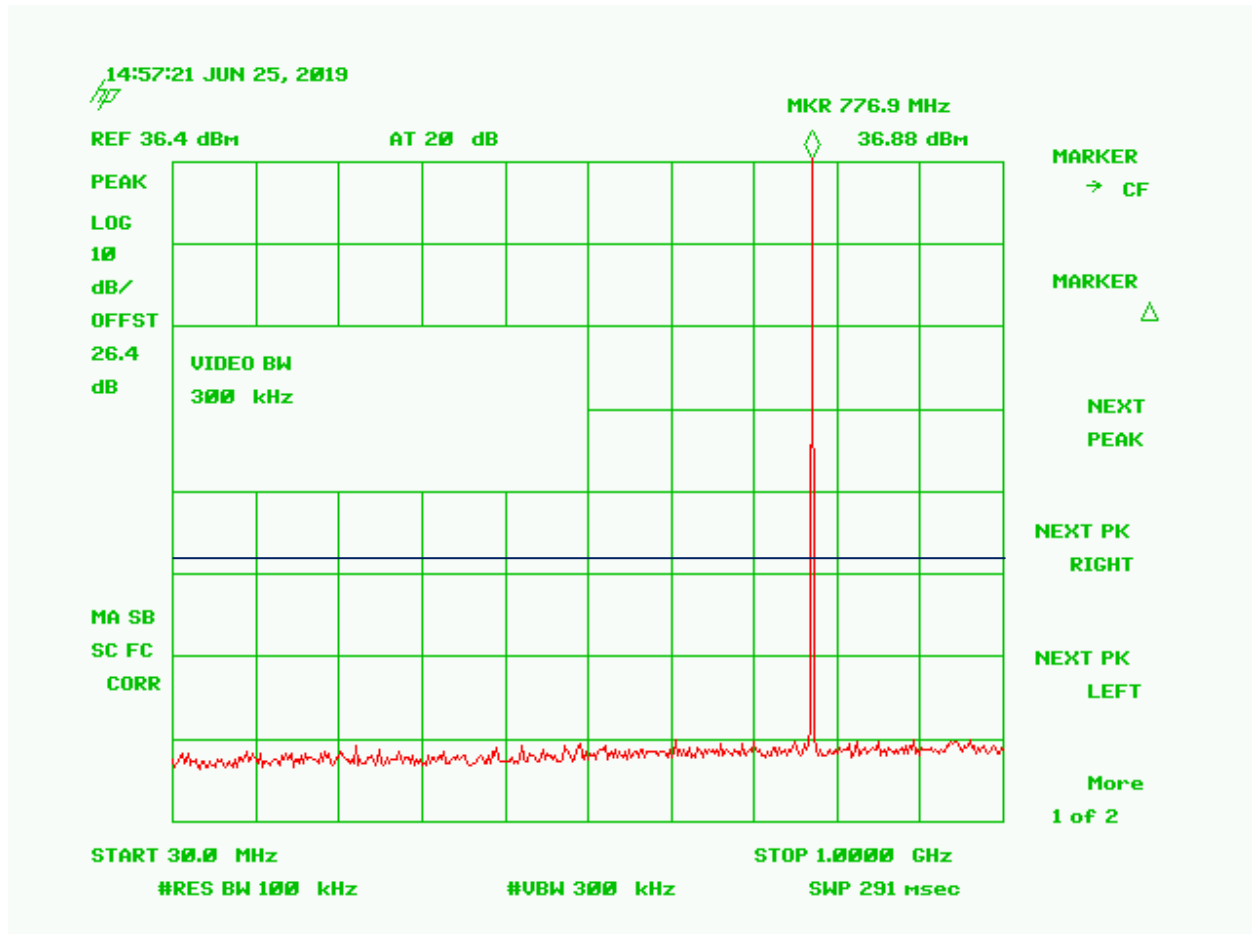


**Figure 257. 769 MHz, 1 GHz – 2.9 GHz**

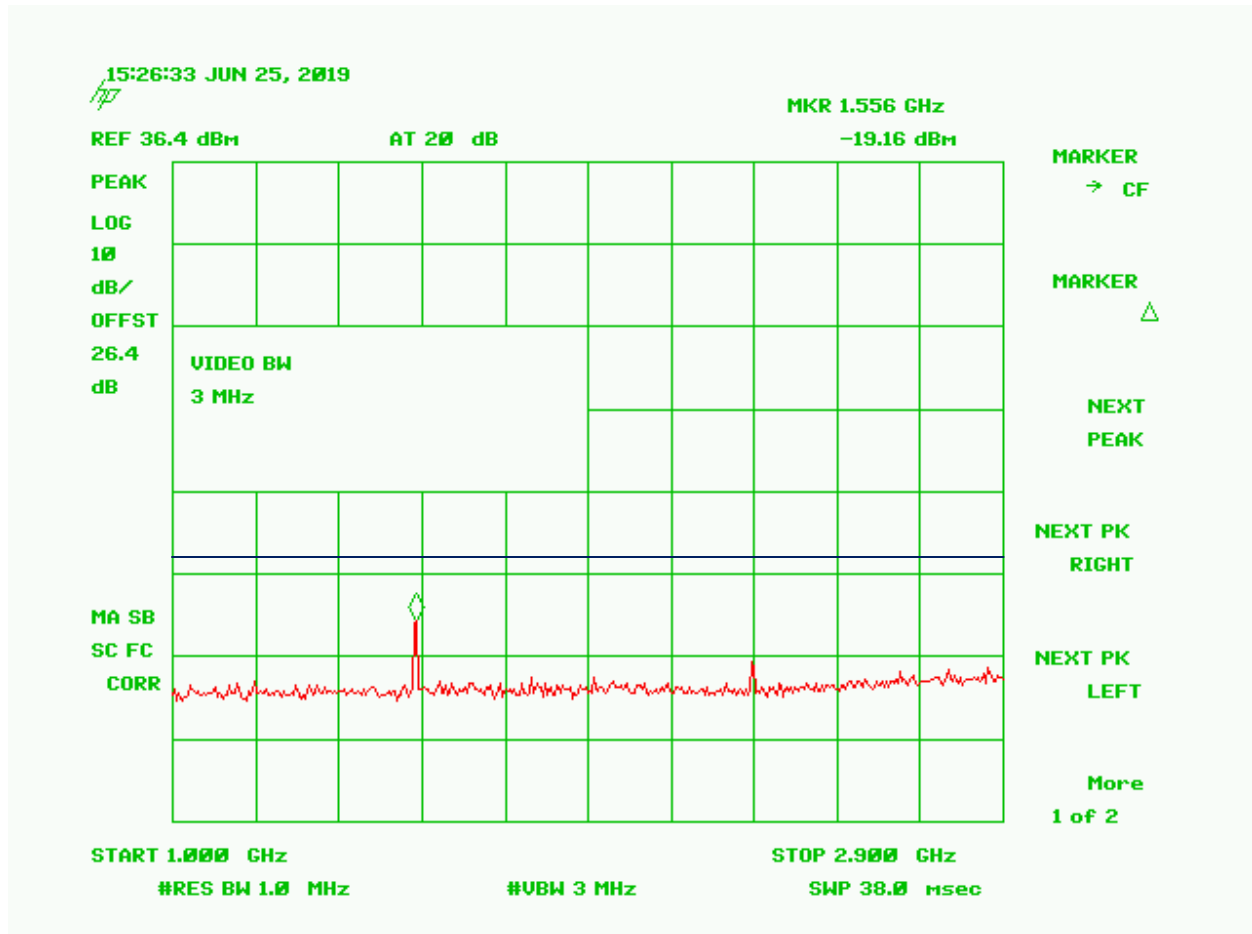






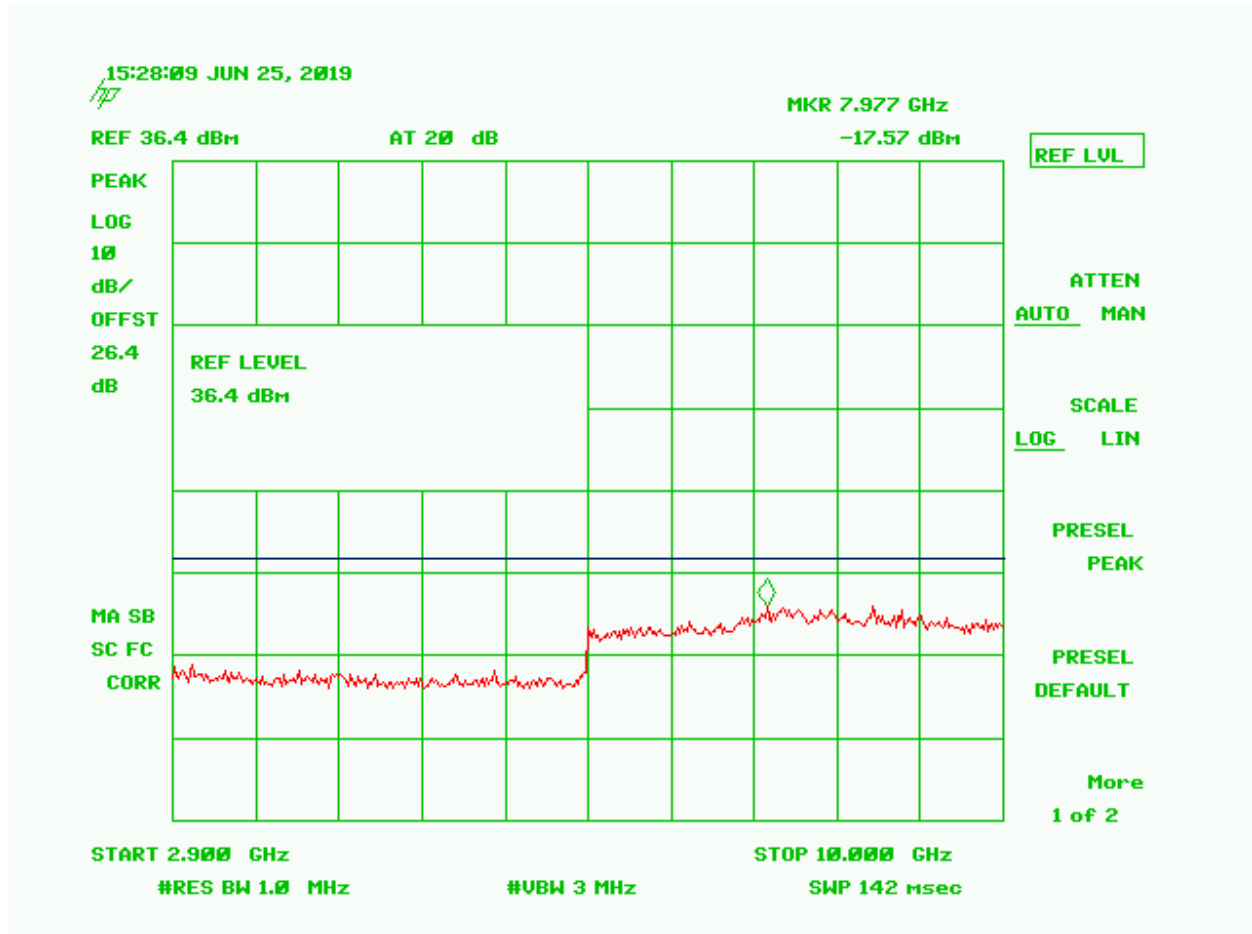
**Figure 259. 775 MHz, below 1 GHz**

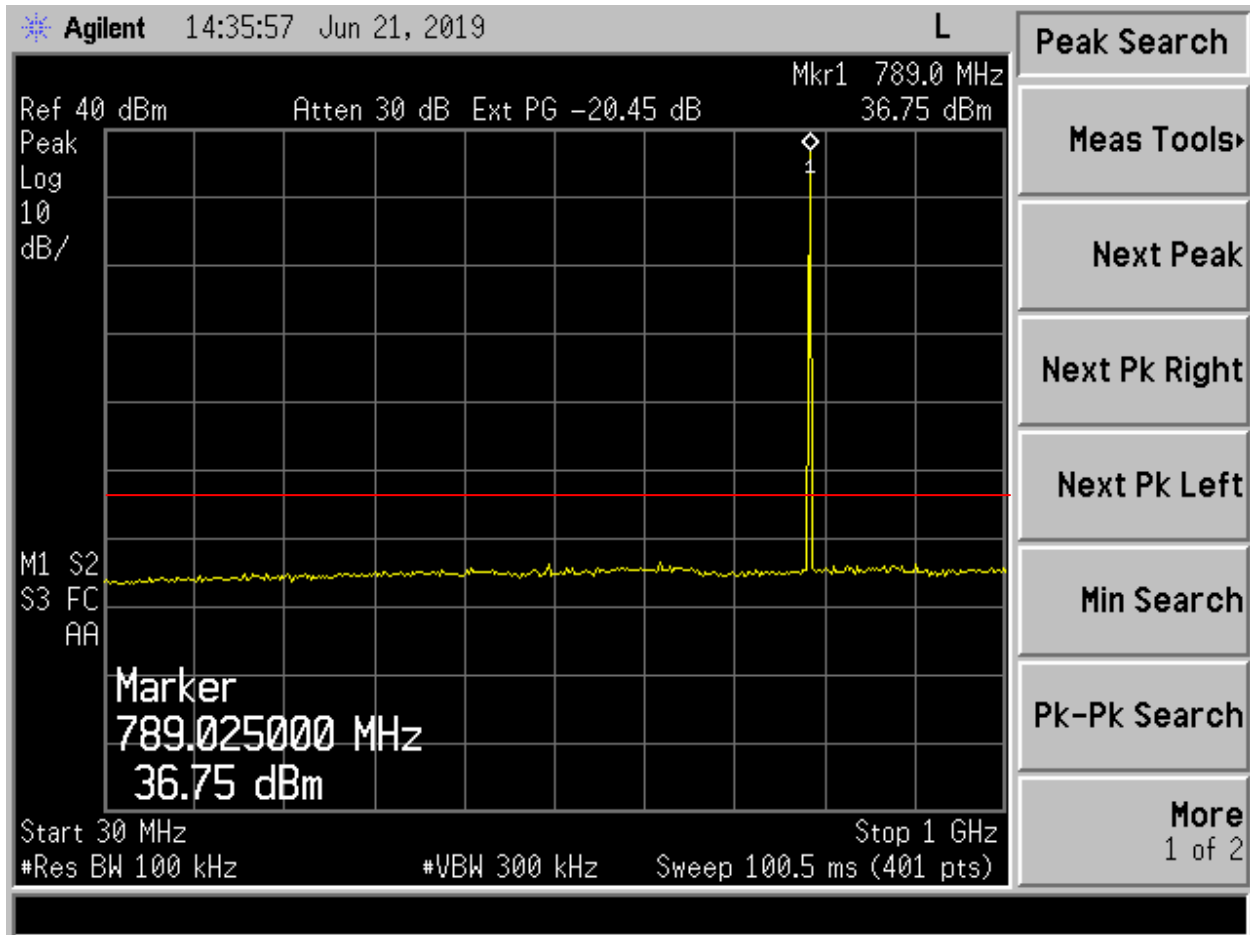
**Figure 260. 775 MHz, 1 GHz – 2.9 GHz**

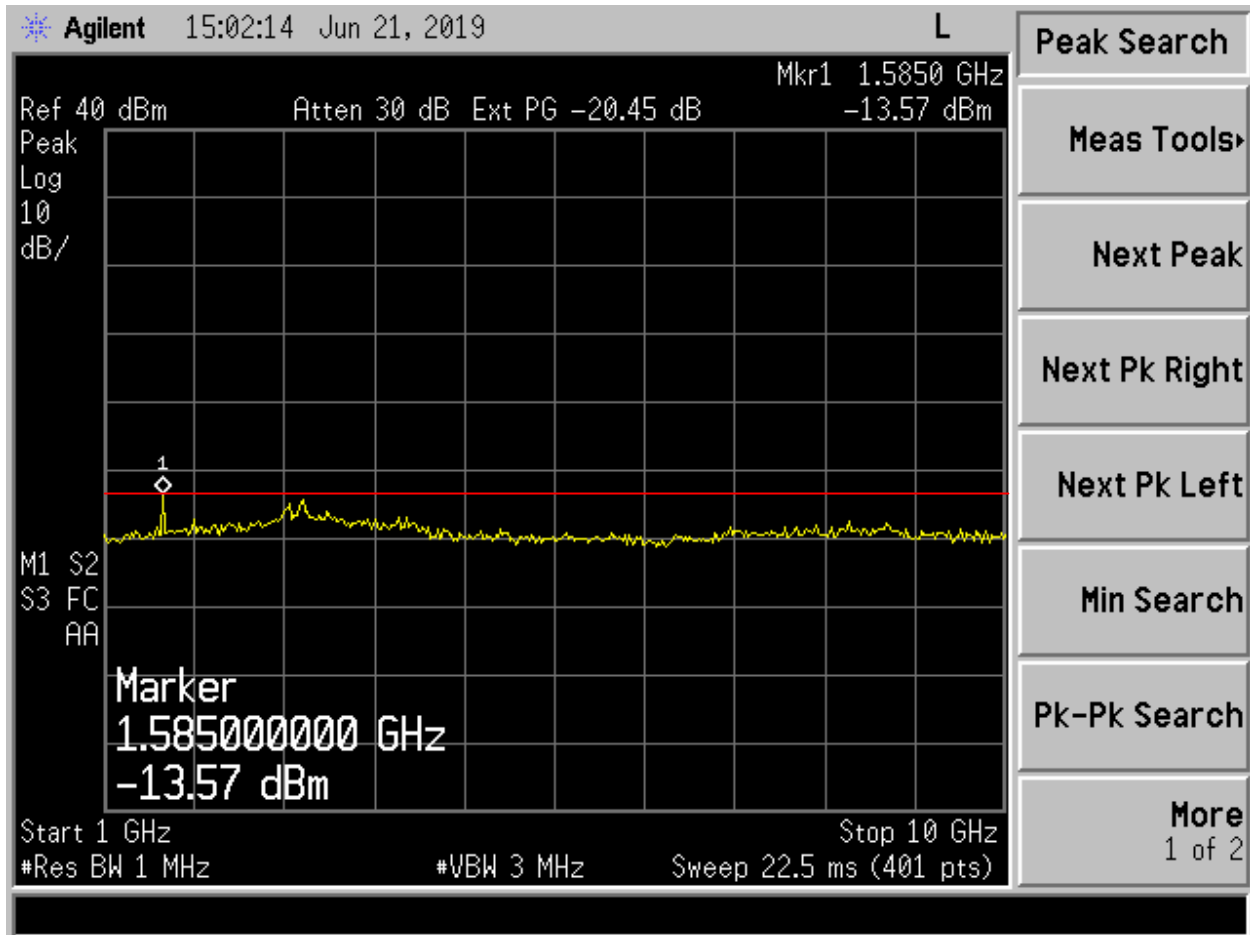
**Figure 261. 775 MHz, 2.9 GHz – 10 GHz**

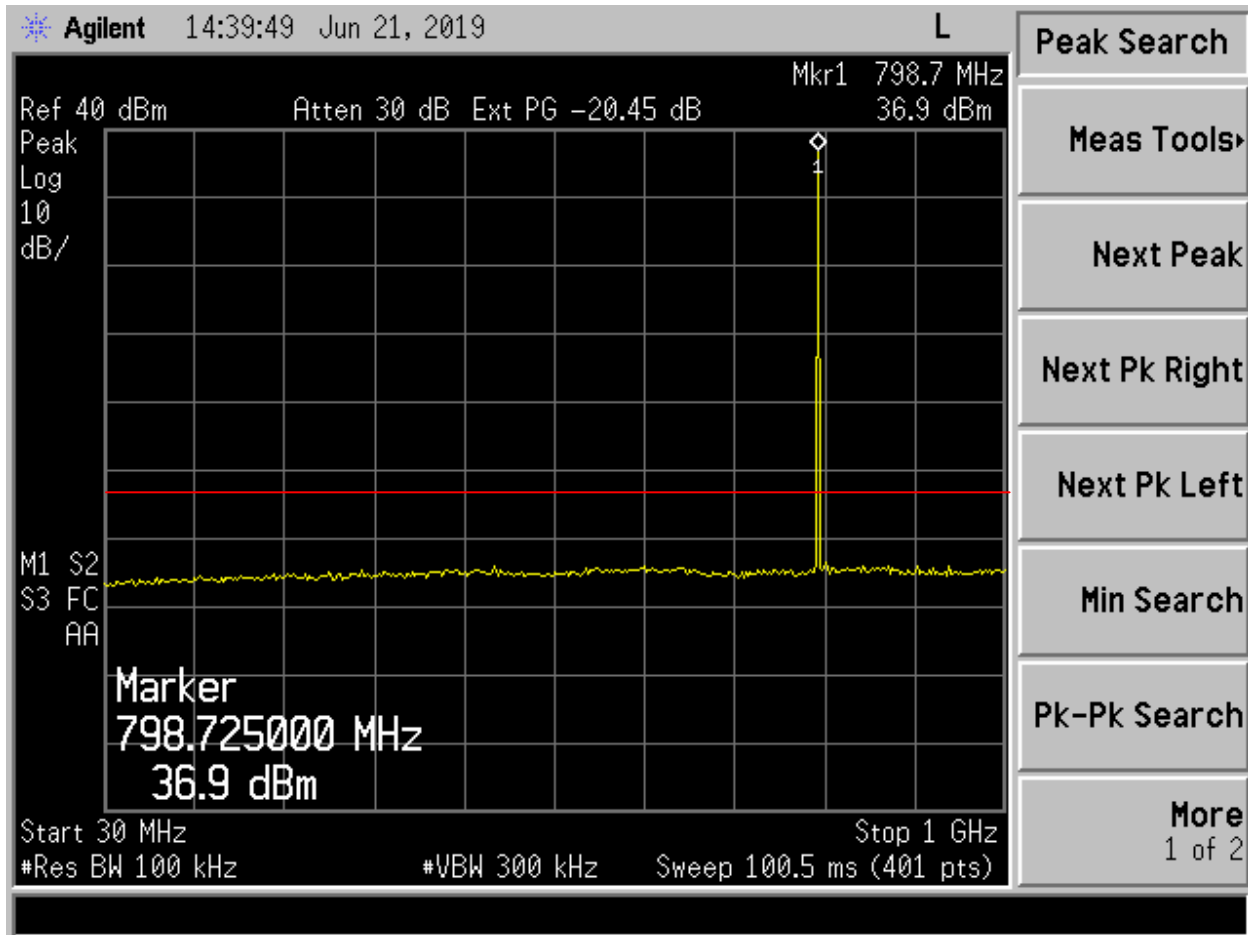
**Figure 262. 788 MHz below 1 GHz**

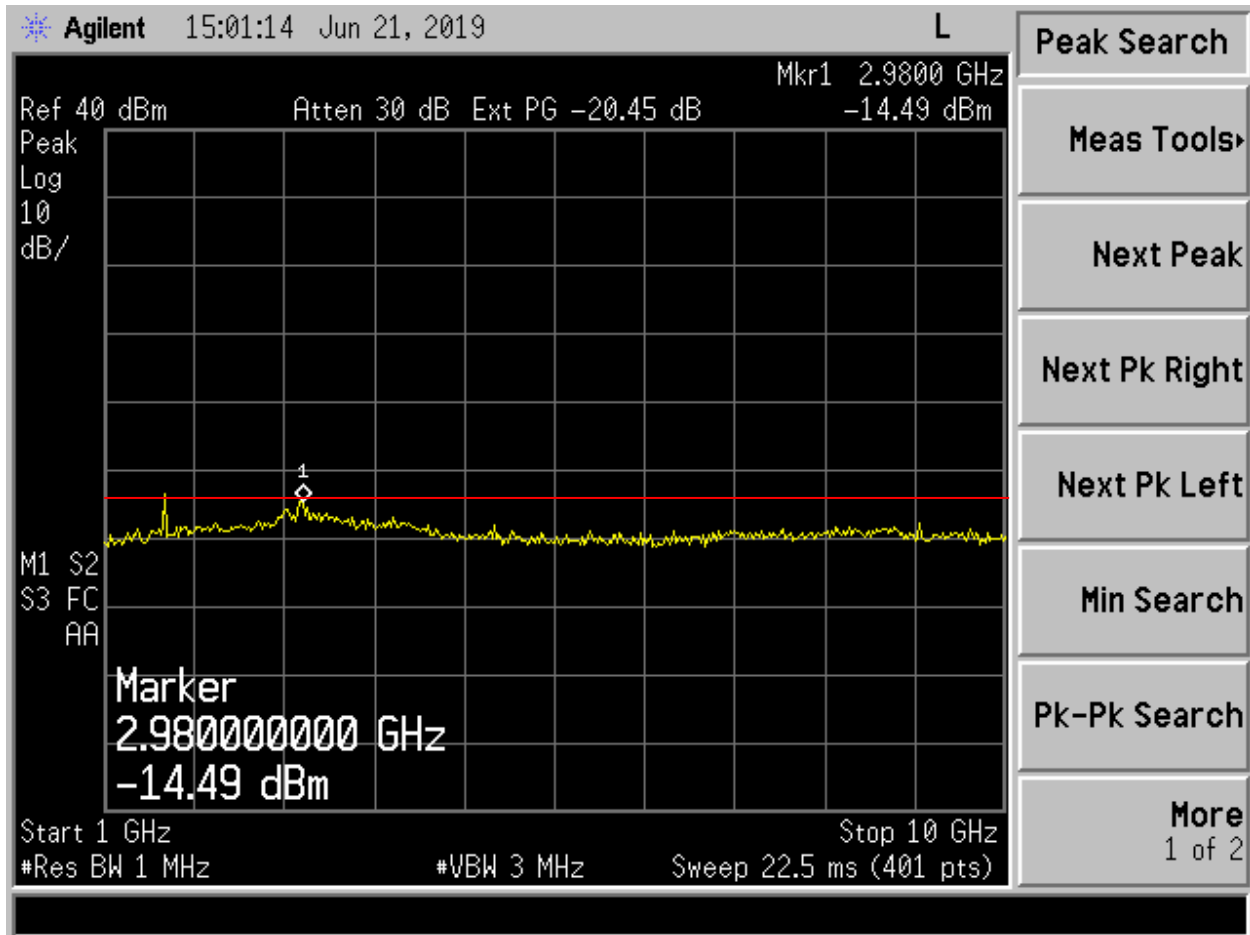
**Figure 263. 788 MHz, 1 – 10 GHz**

**Figure 264. 798 MHz below 1 GHz**

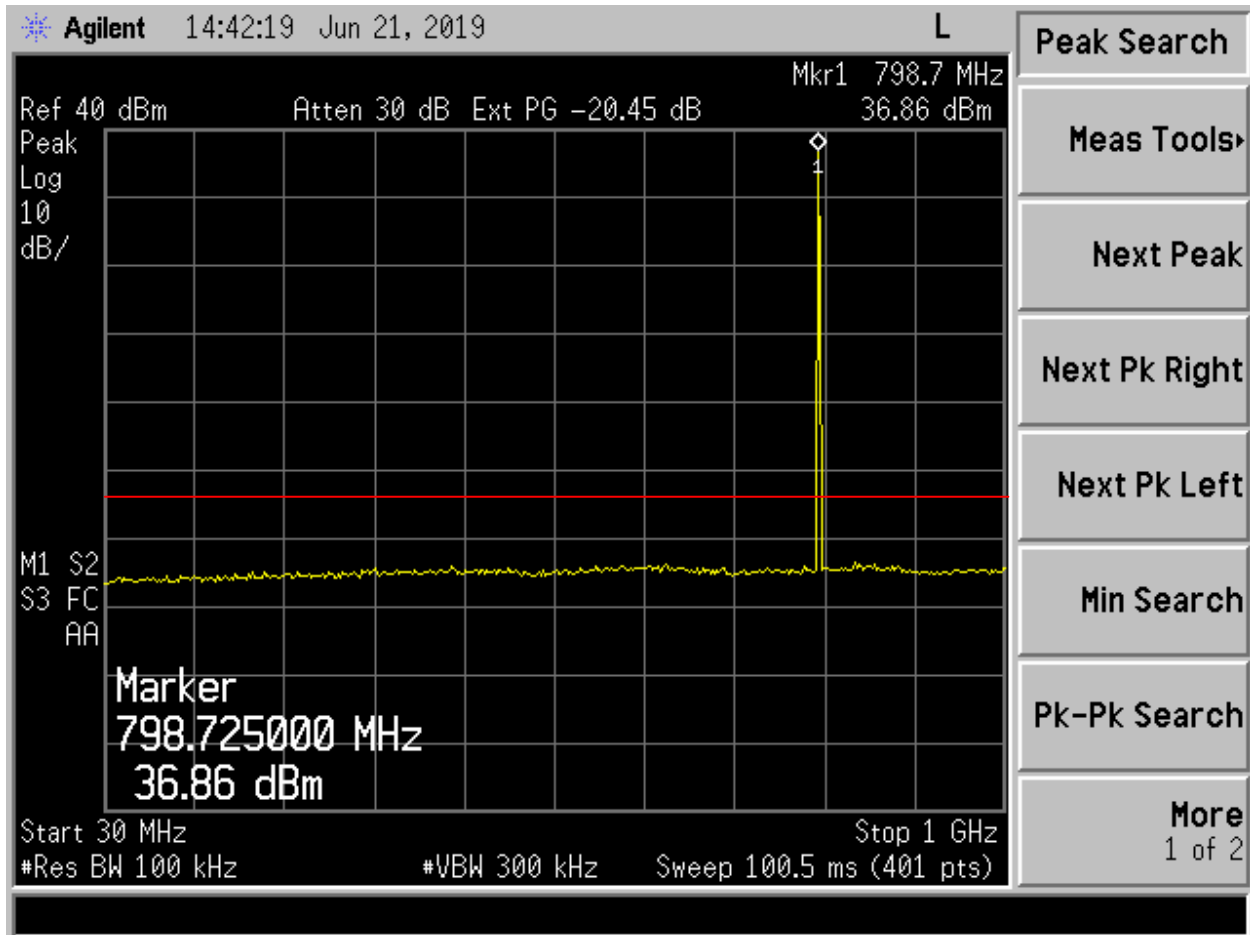

**Figure 265. 798 MHz, 1 – 10 GHz**

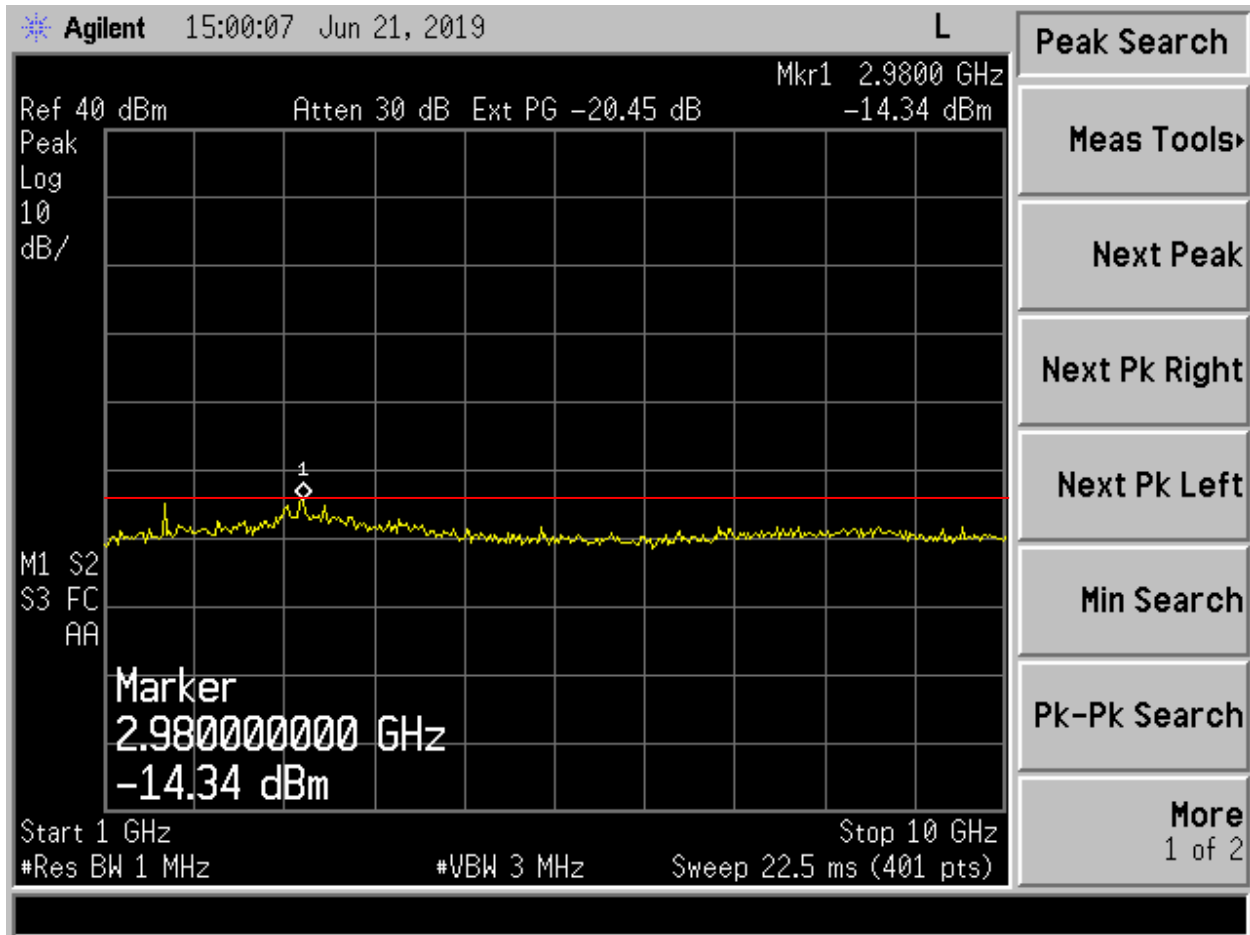

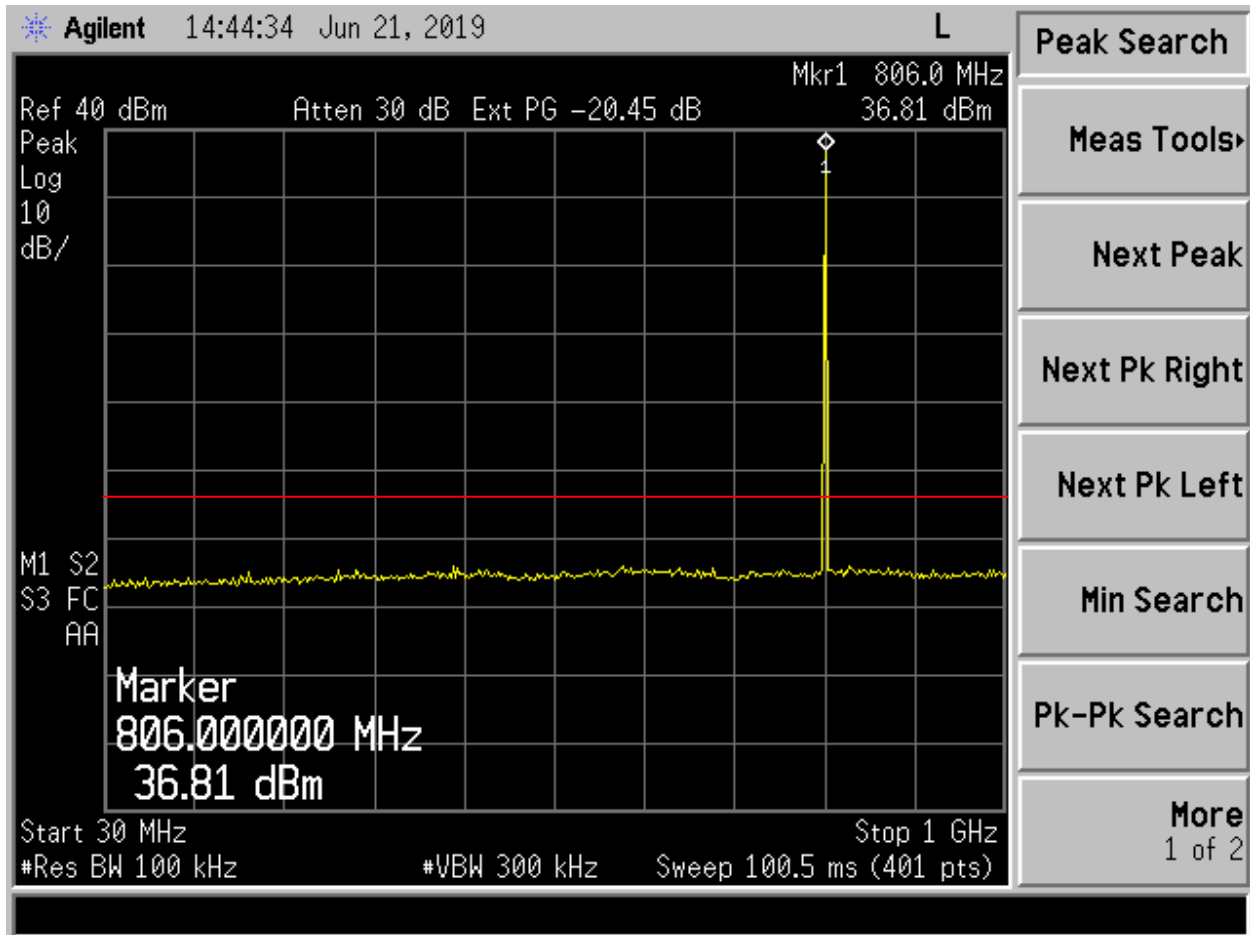
**Figure 266. 799 MHz below 1 GHz**

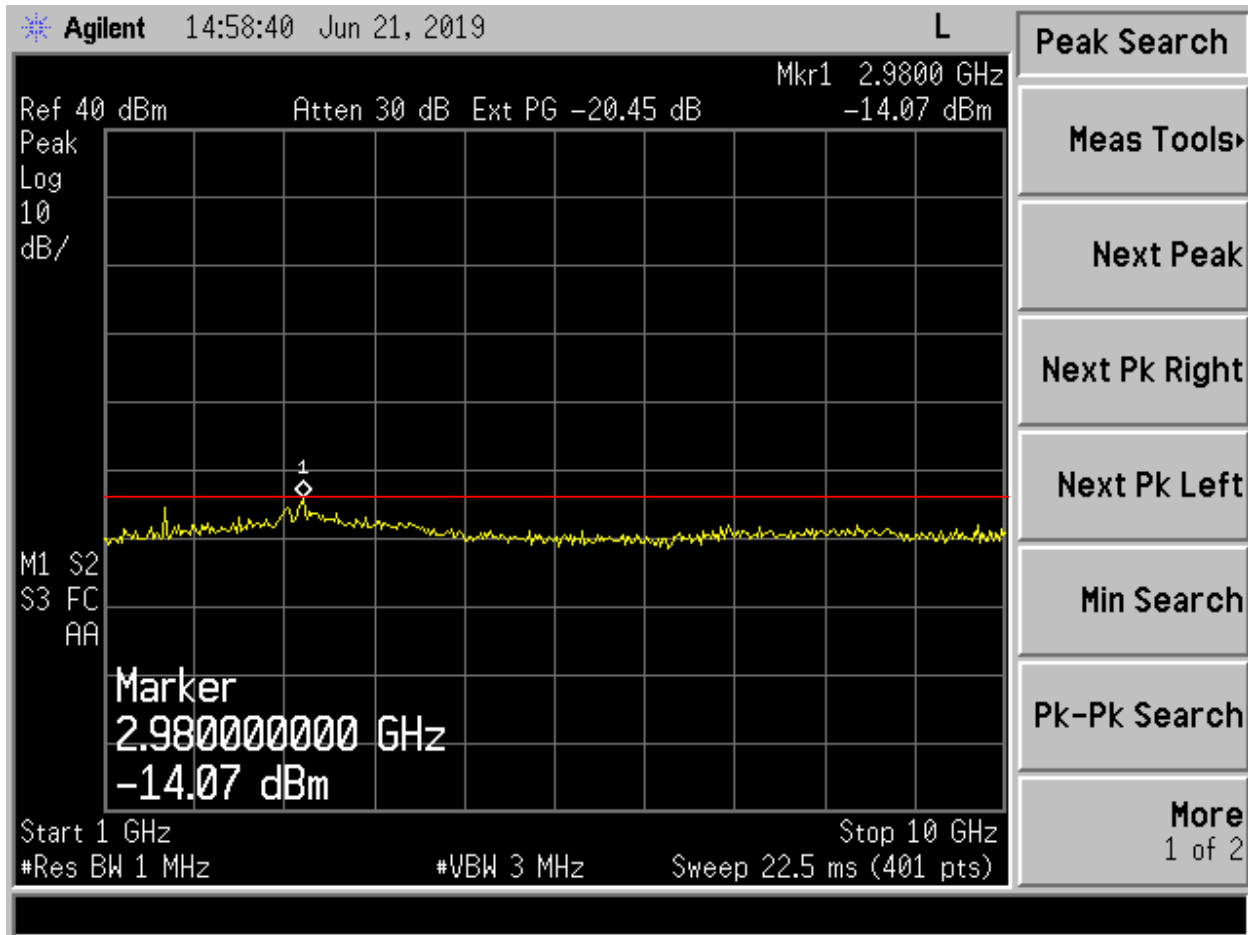
**Figure 267. 799 MHz, 1 – 10 GHz**

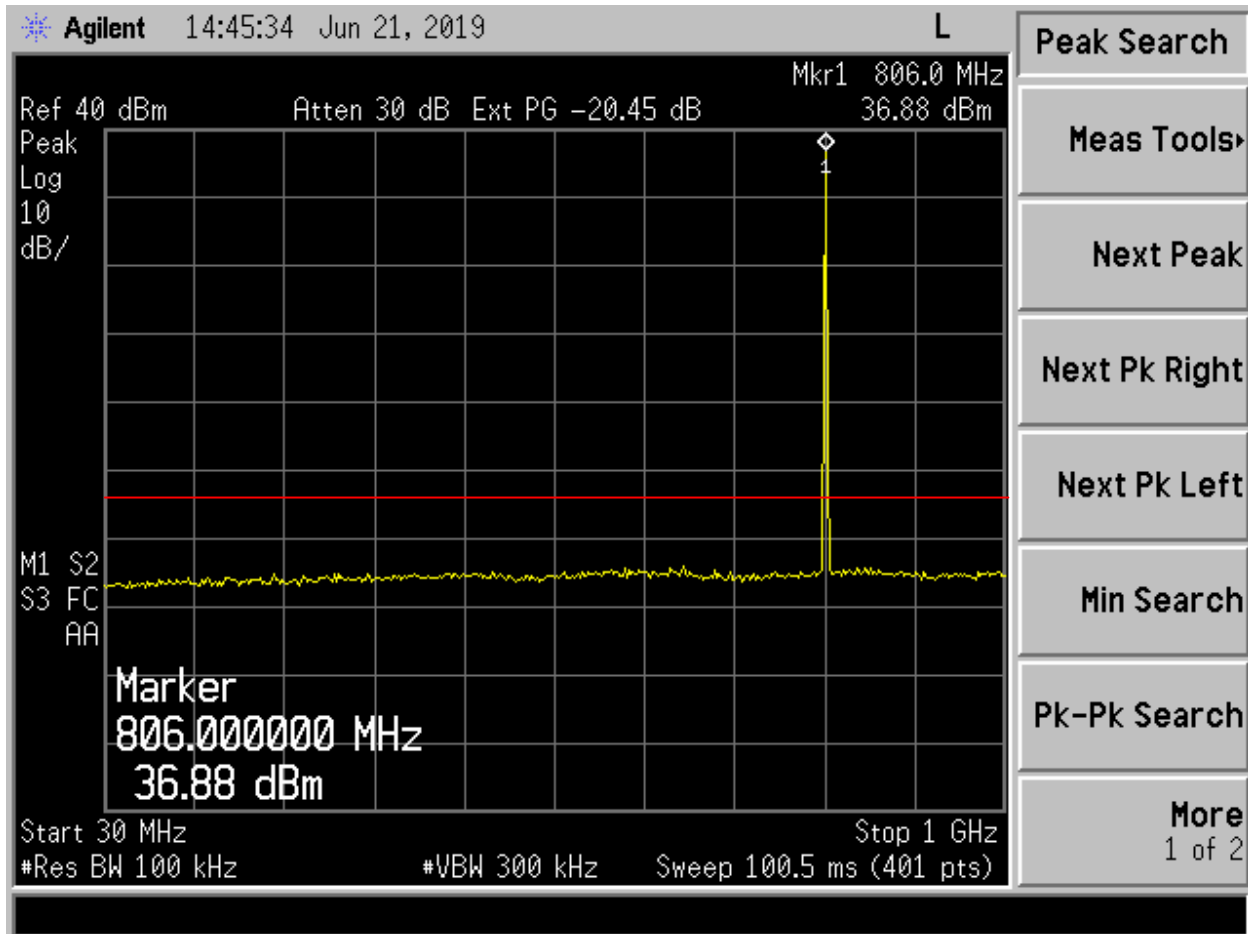
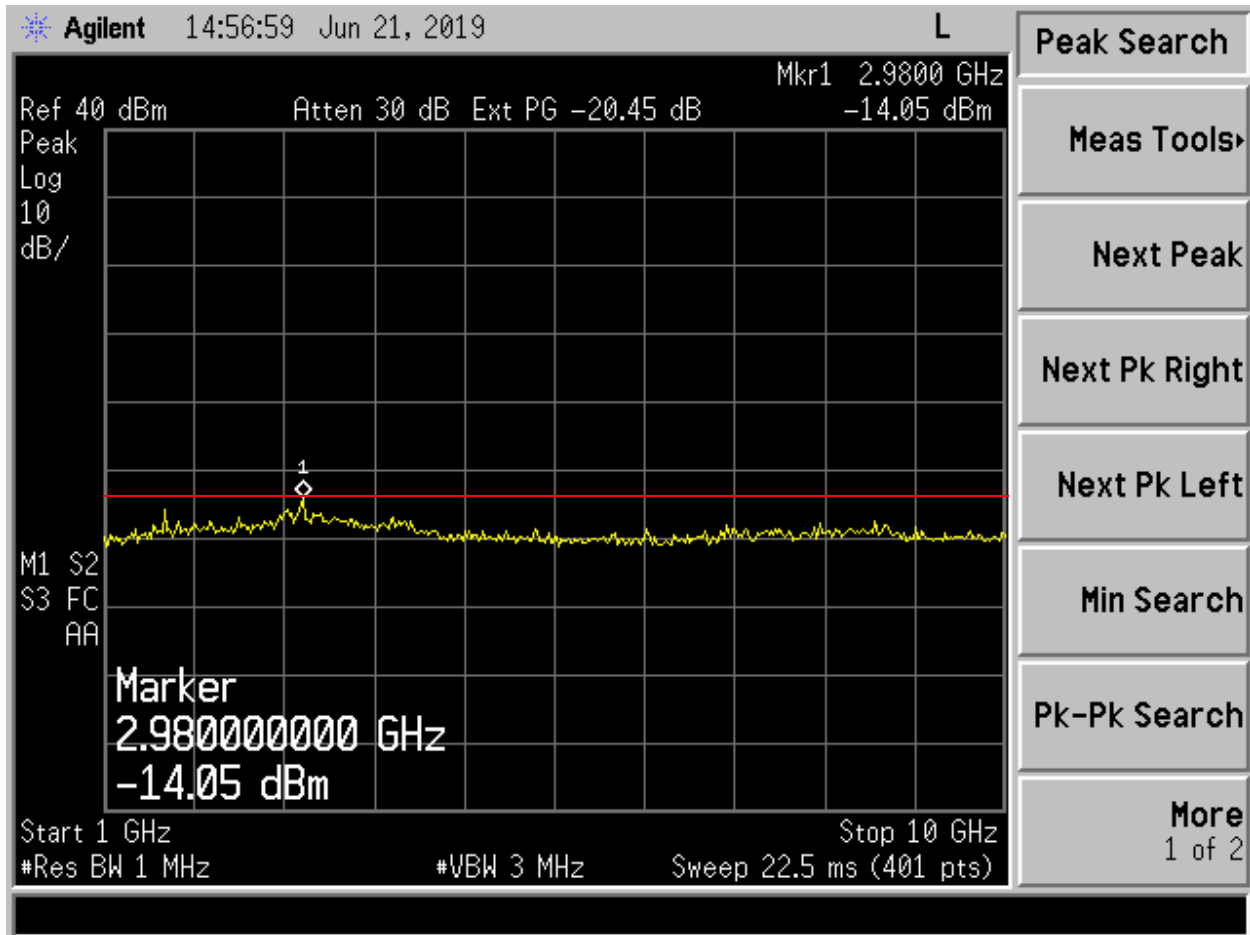


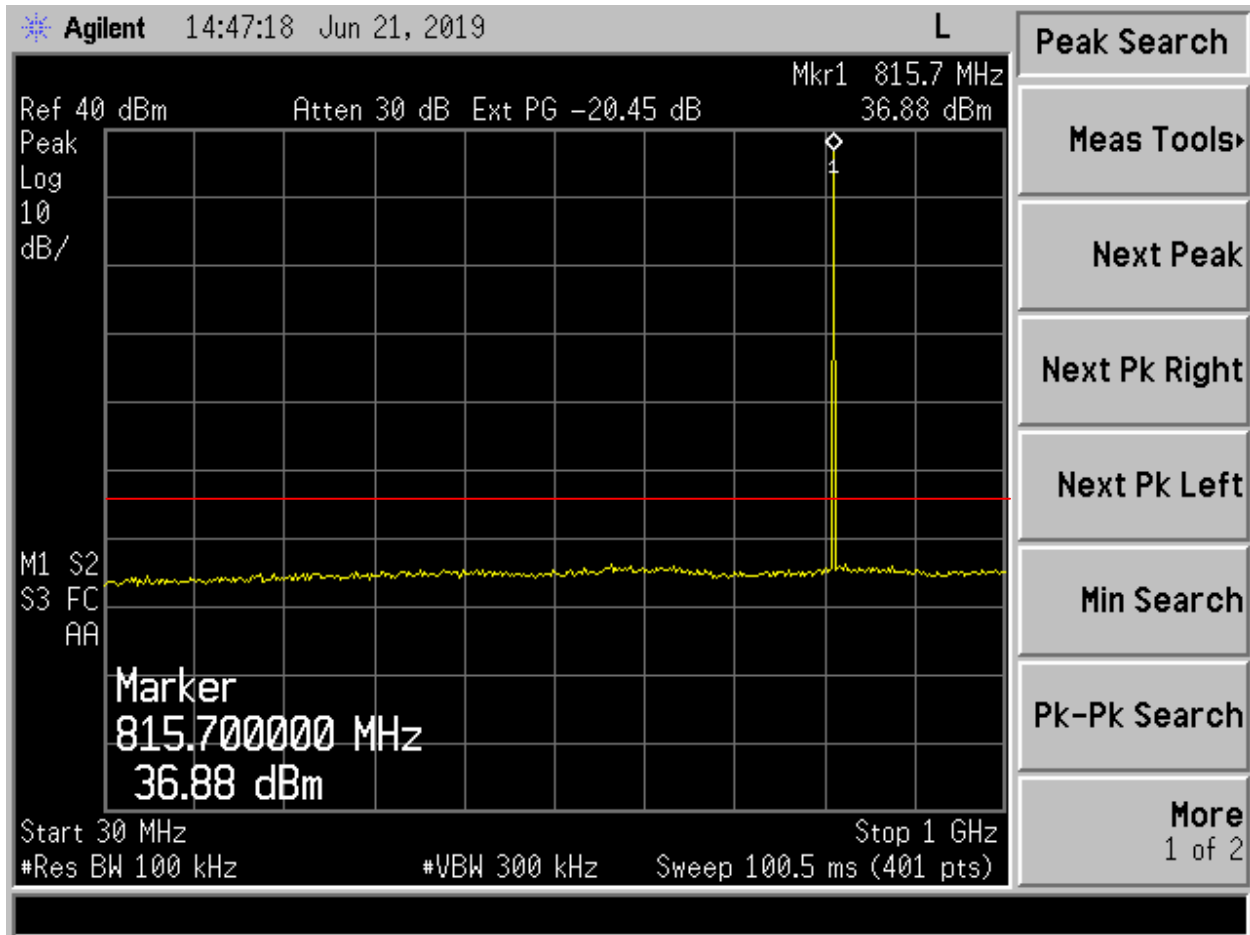
Figure 270. 806 MHz below 1 GHz

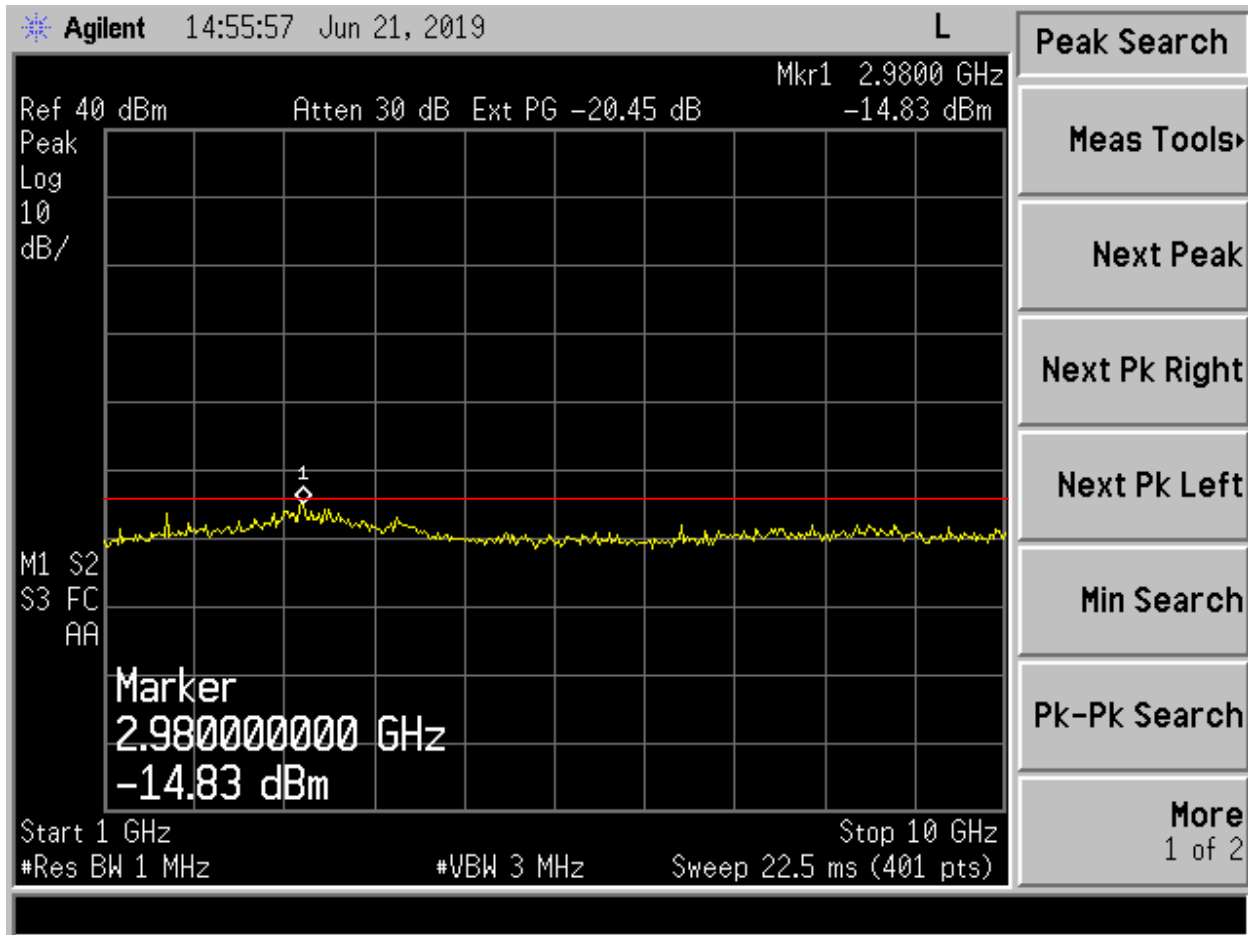
**Figure 271. 806 MHz, 1 – 10 GHz**

**Figure 272. 815 MHz below 1 GHz**

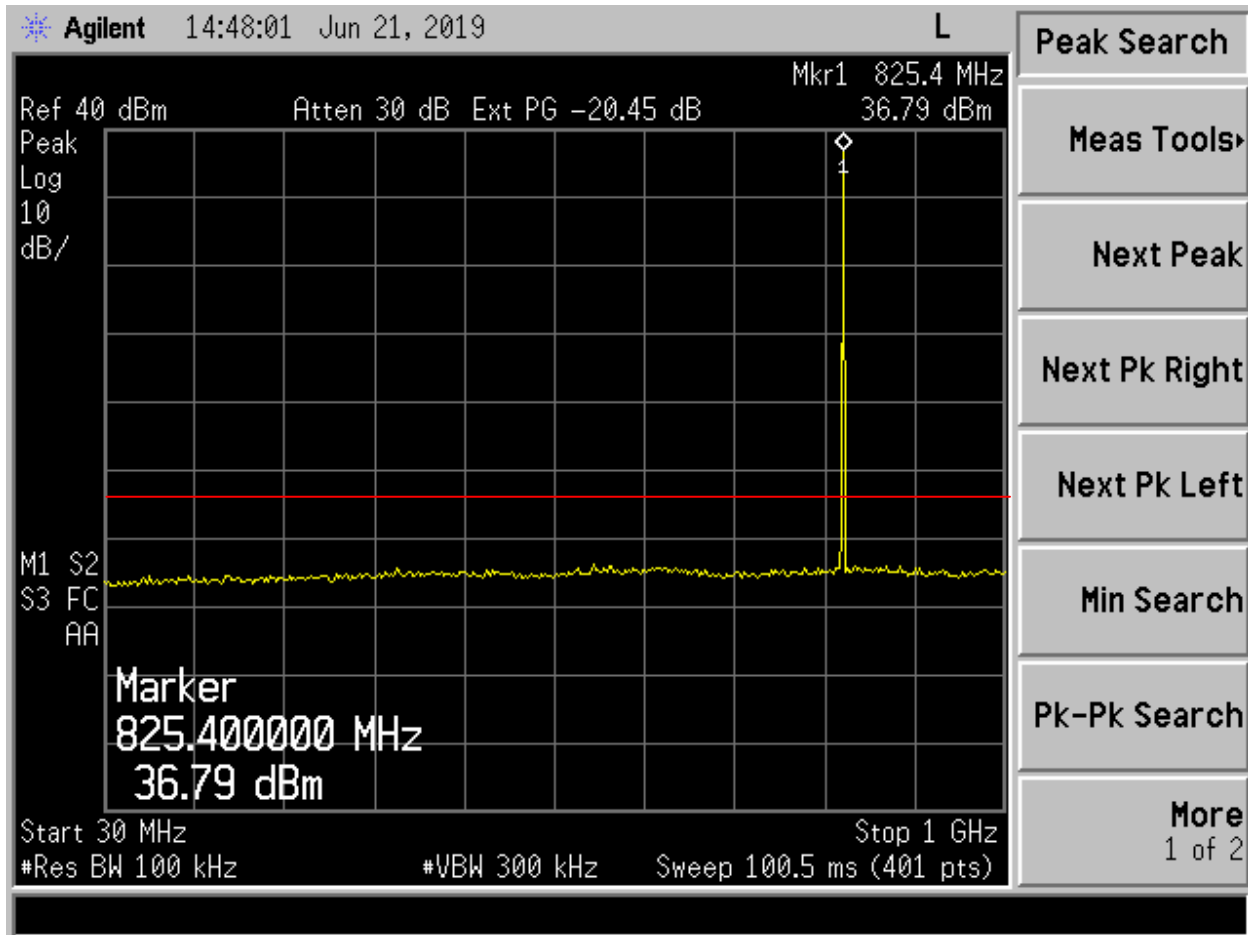

**Figure 273. 815 MHz, 1 – 10 GHz**

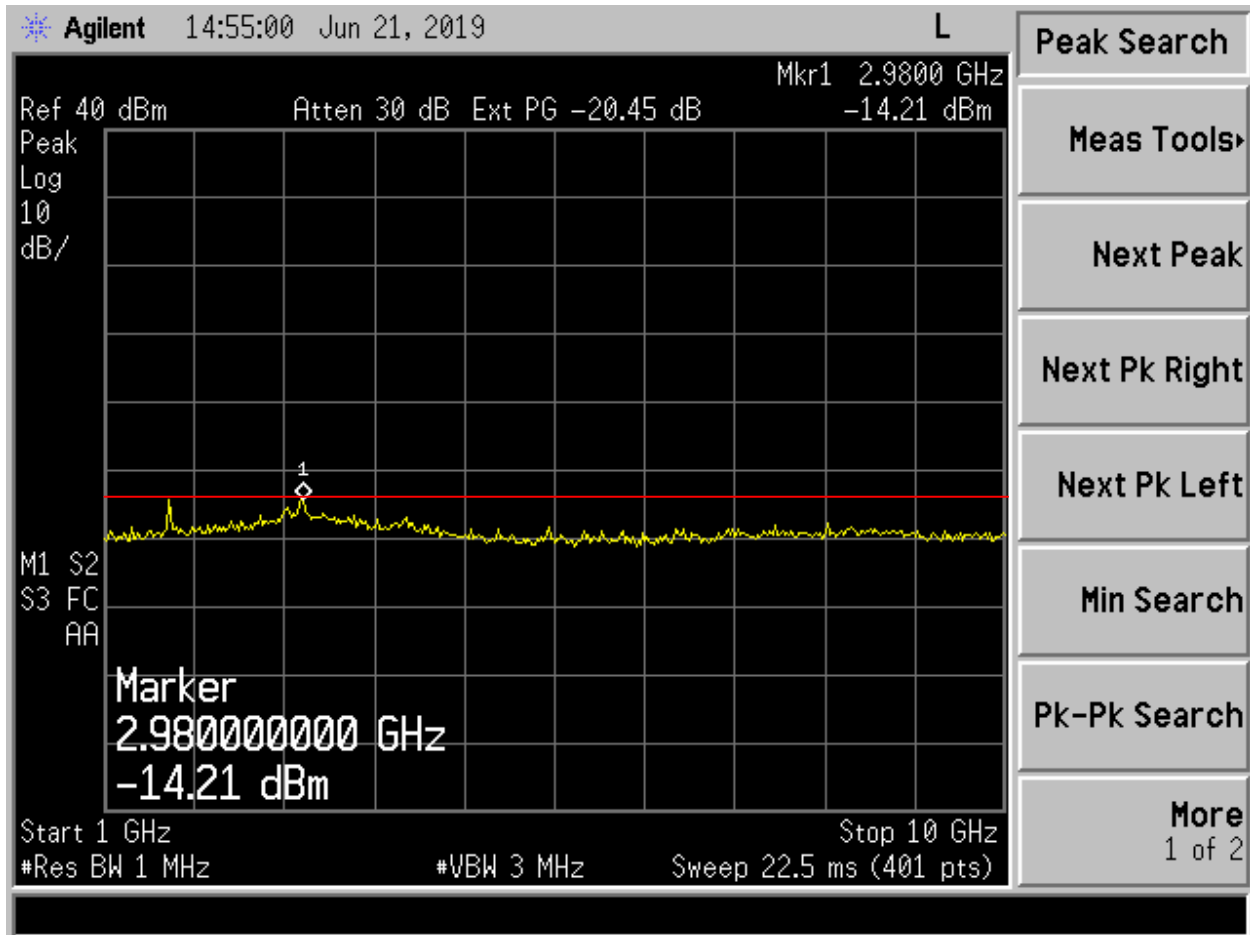

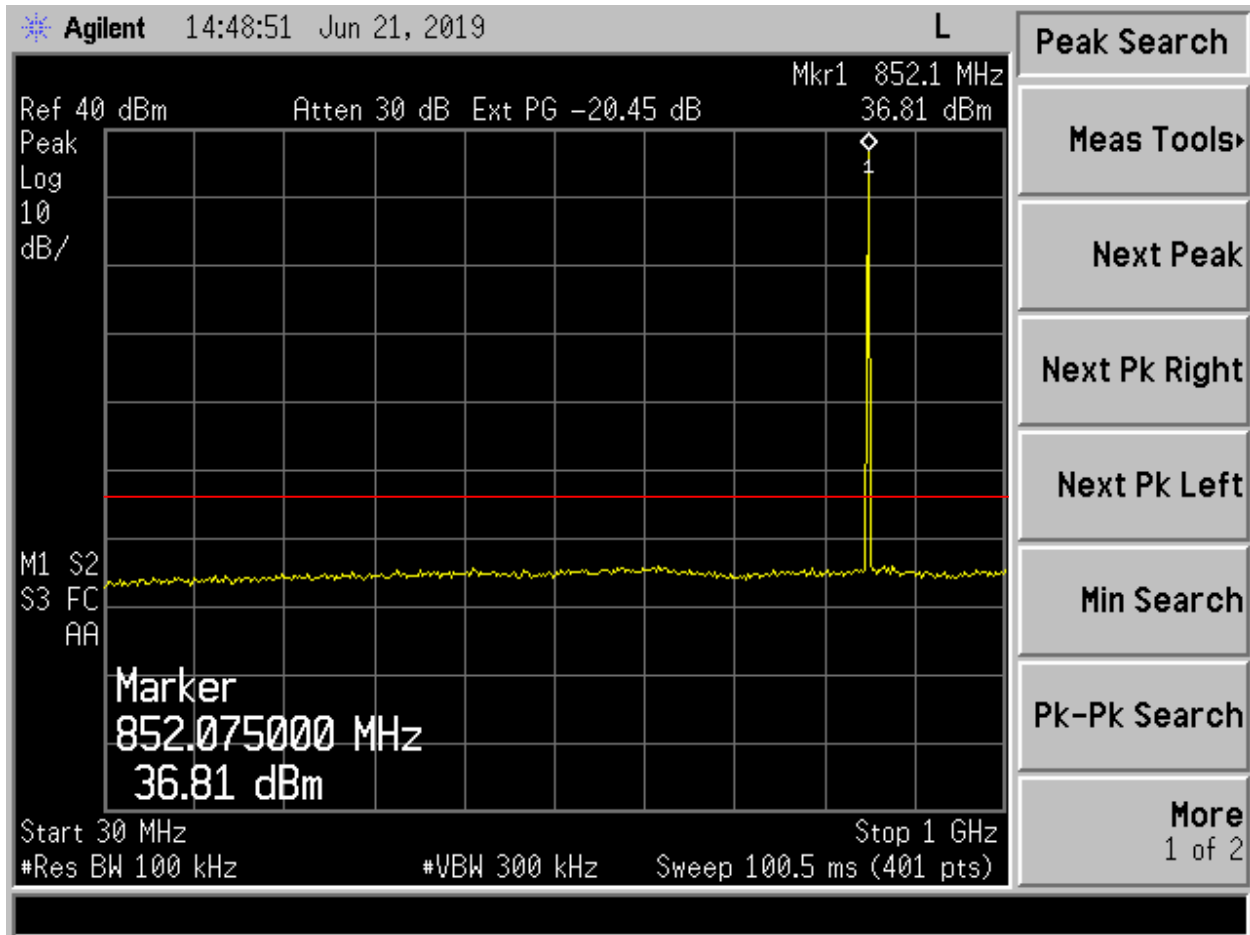
**Figure 274. 824 MHz below 1 GHz**

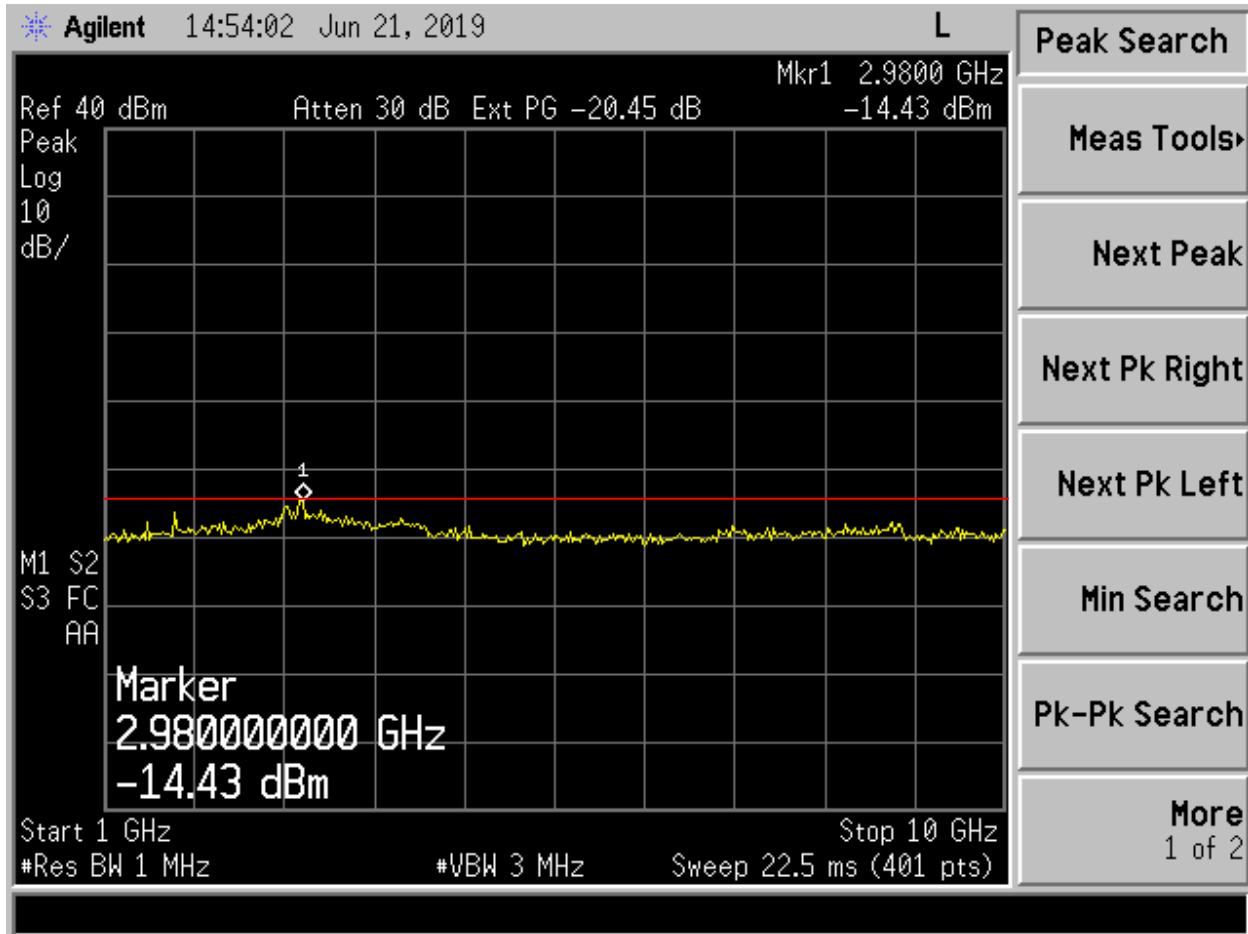
**Figure 275. 824 MHz, 1 – 10 GHz**

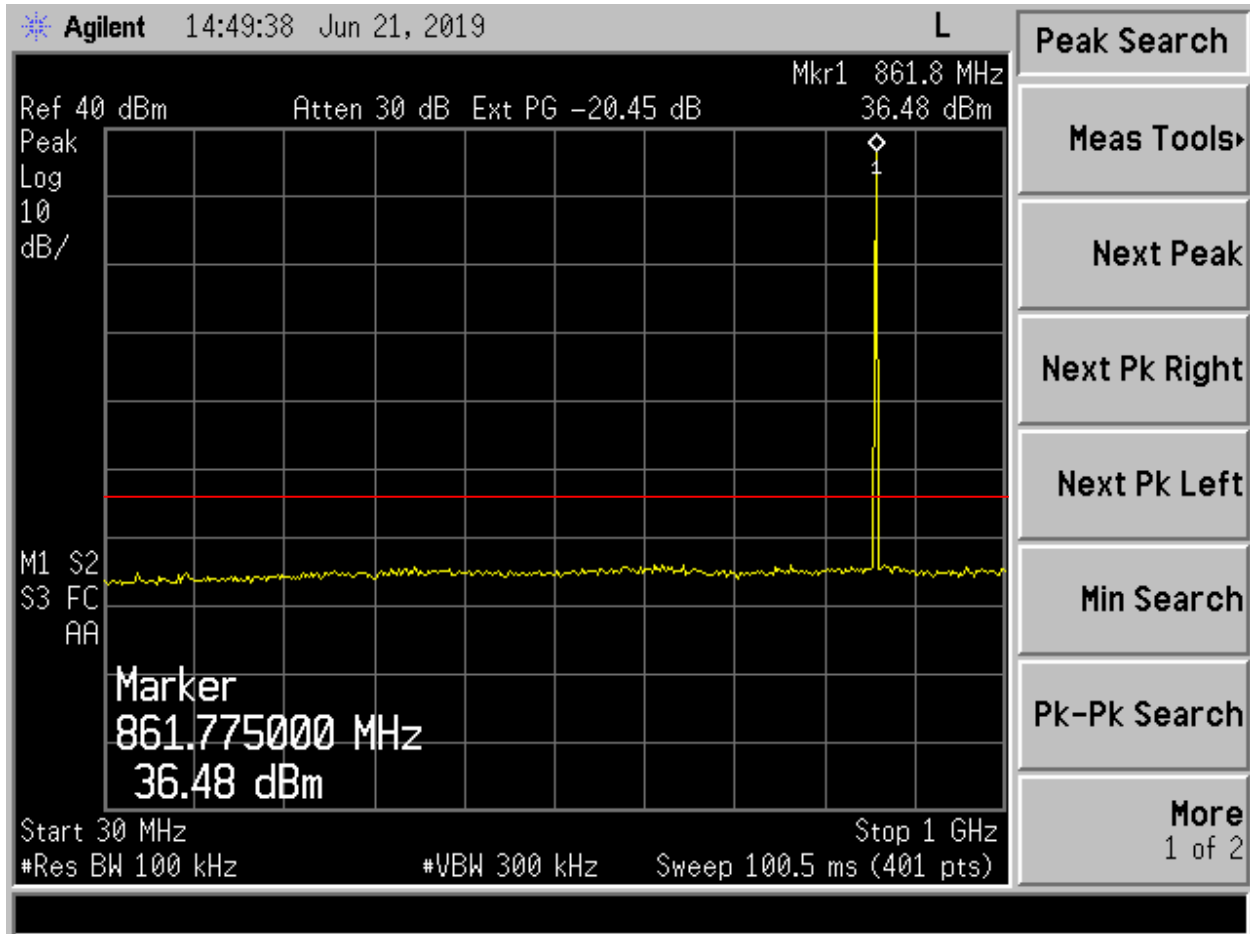
**Figure 276. 851 MHz below 1 GHz**

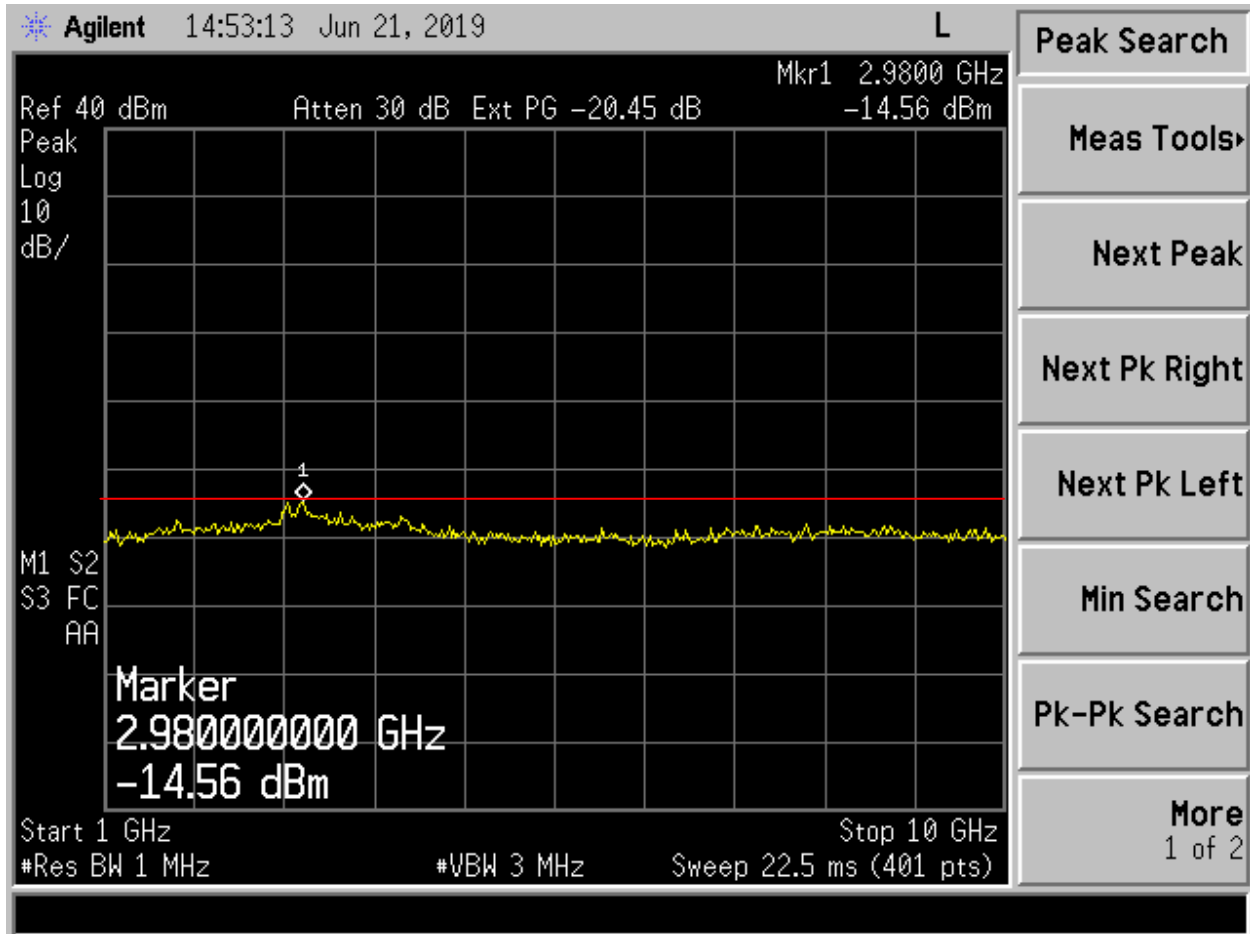
**Figure 277. 851 MHz, 1 – 10 GHz**

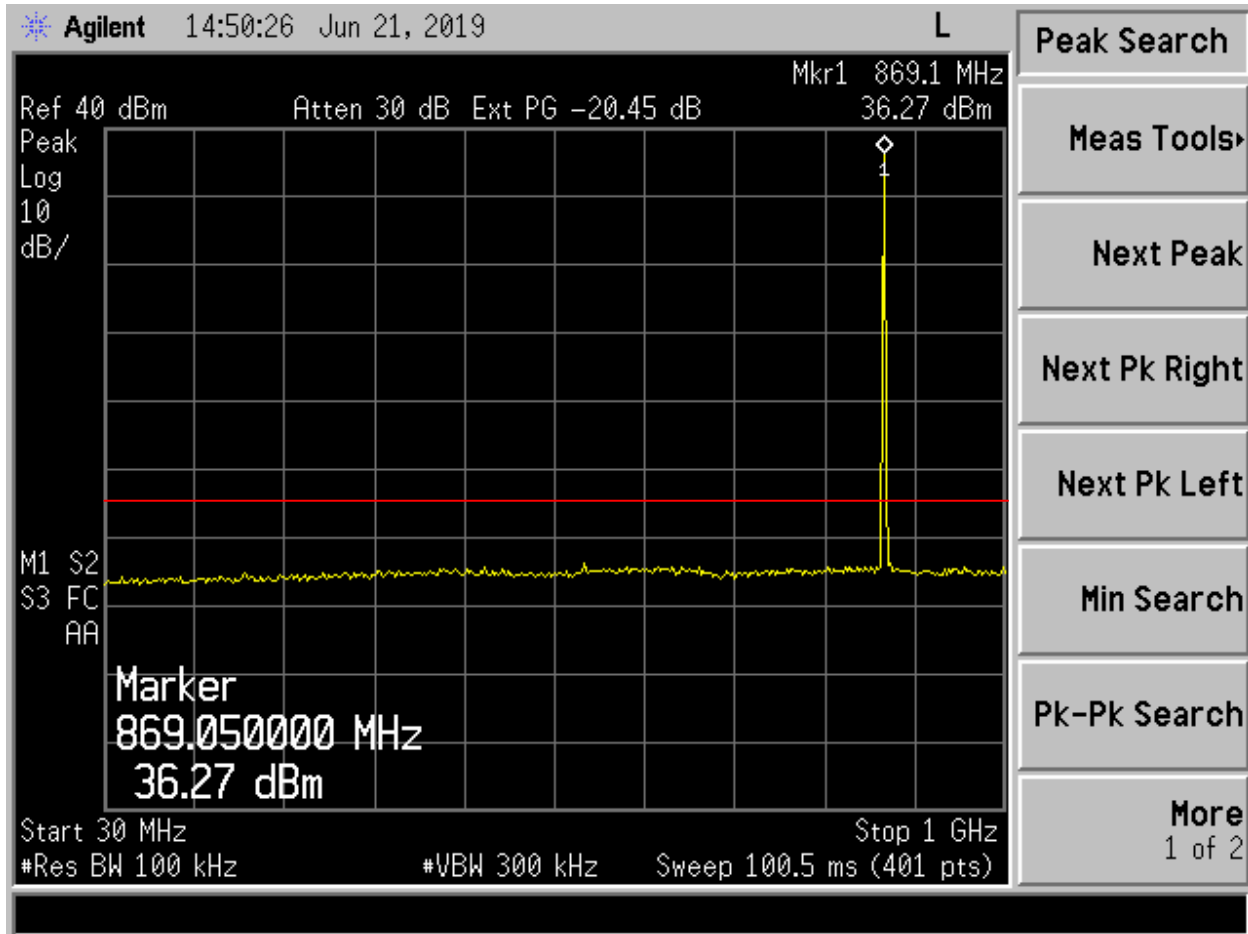
**Figure 278. 860 MHz below 1 GHz**

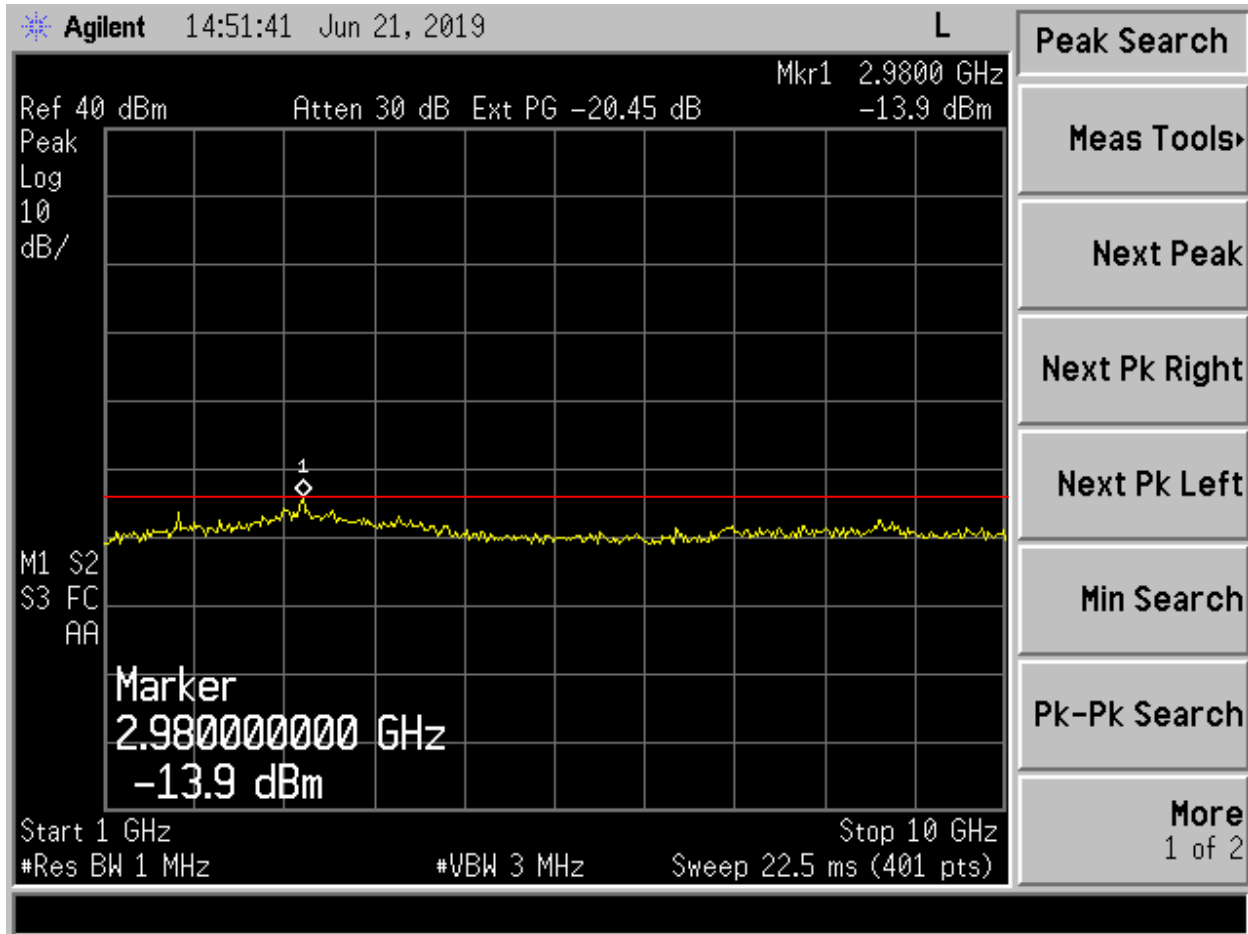
**Figure 279. 860 MHz, 1 – 10 GHz**

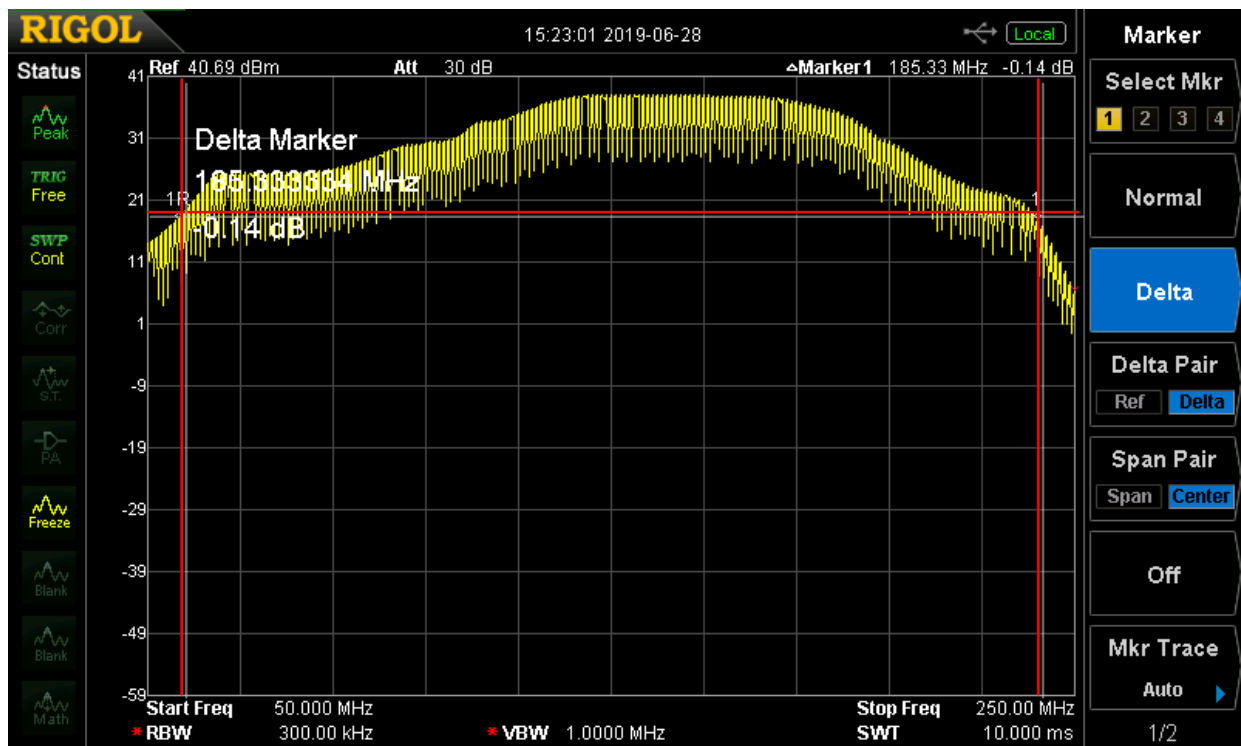


Figure 282. VHF Out of Band Rejection

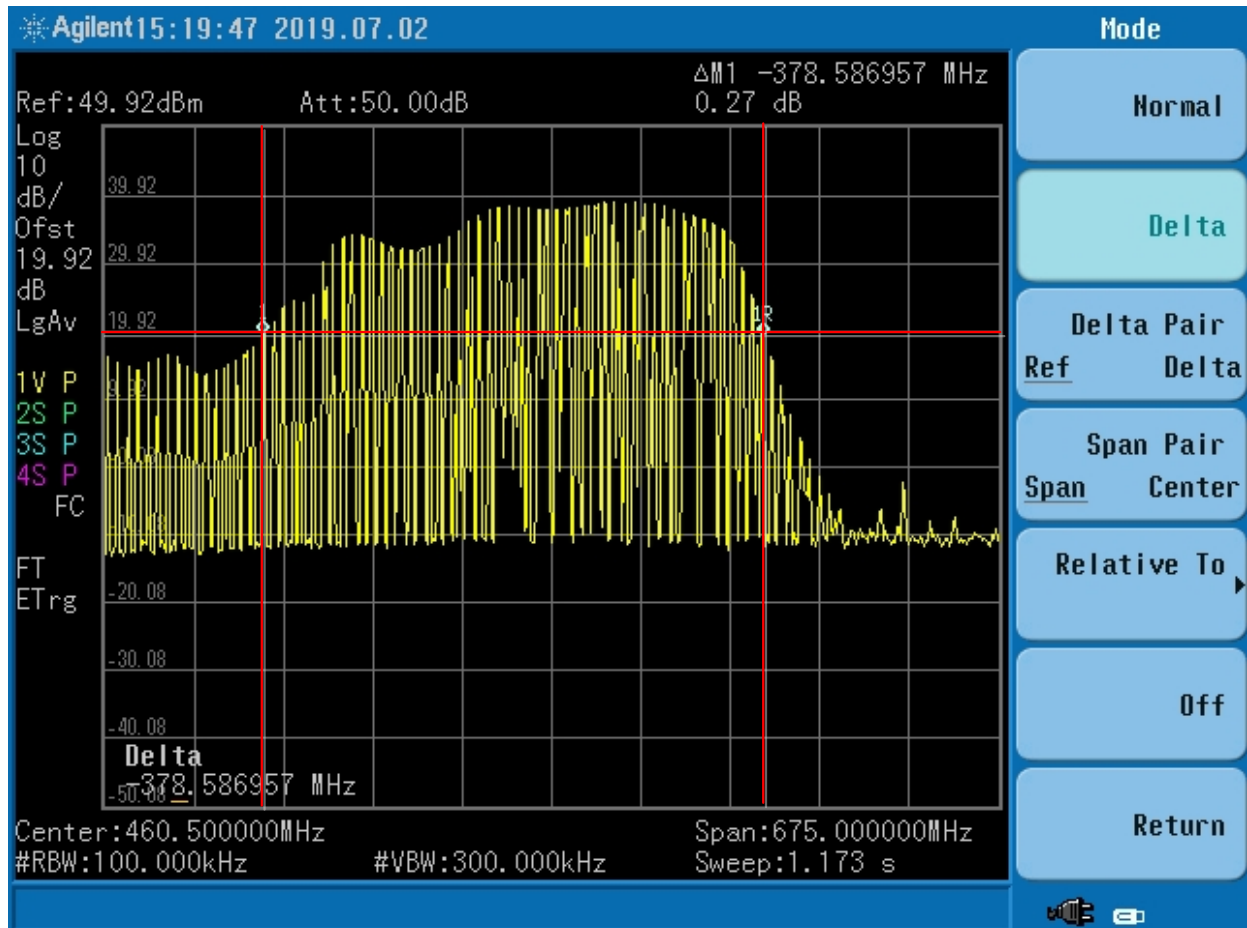


Figure 283. UHF Out of Band Rejection

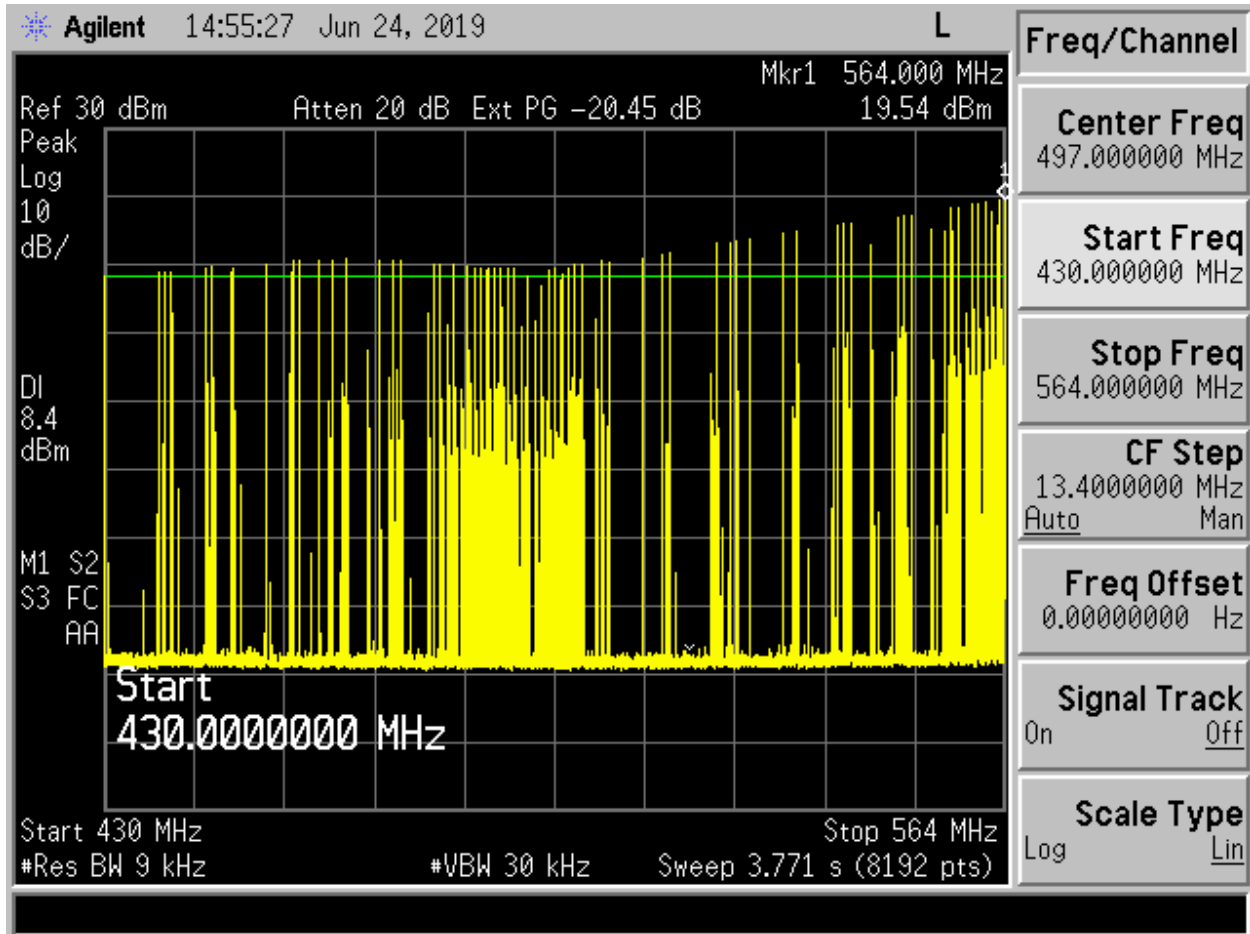


Figure 284. 700/800 MHz Out of band Rejection Plot 1

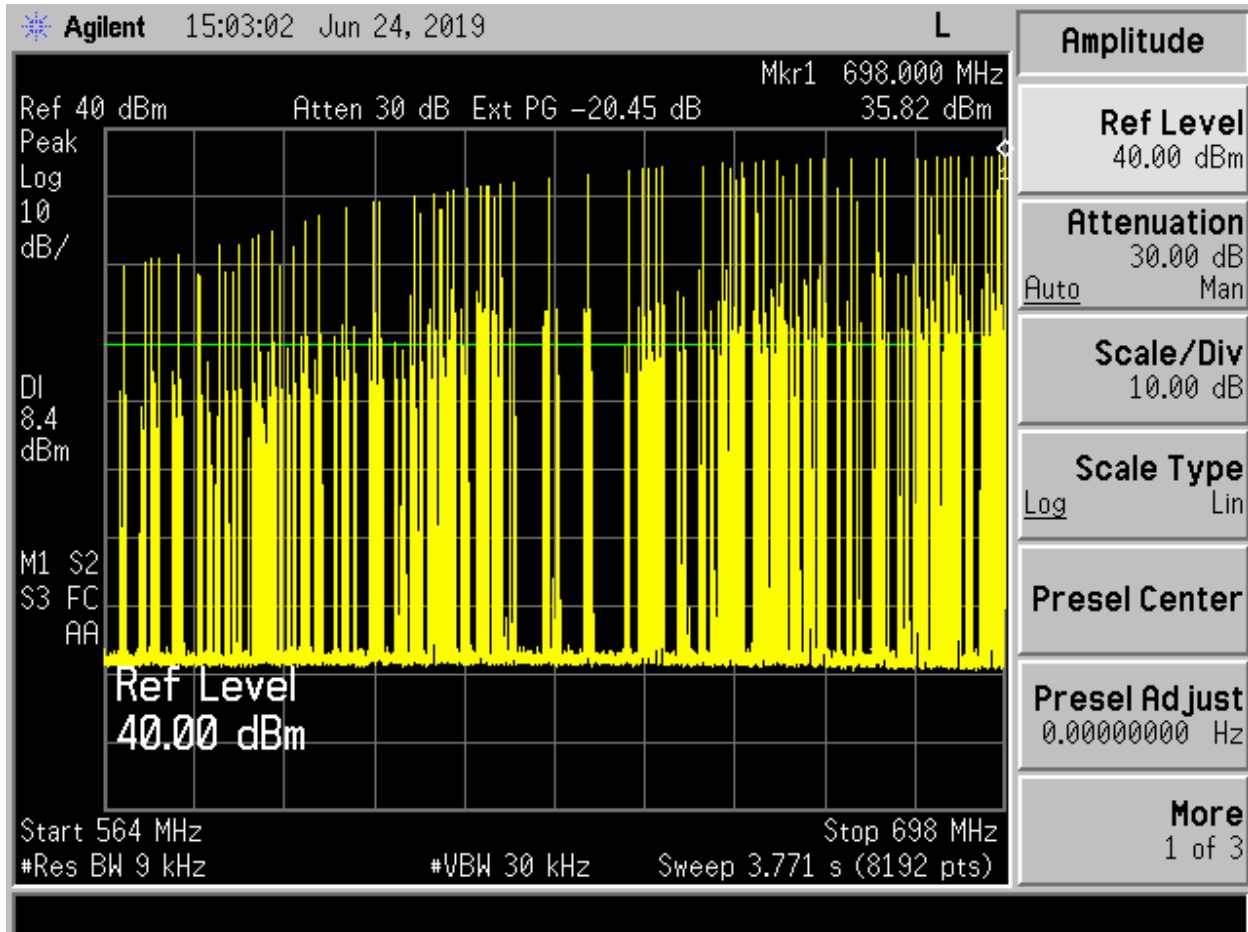


Figure 285. 700/800 MHz Out of band Rejection Plot 2

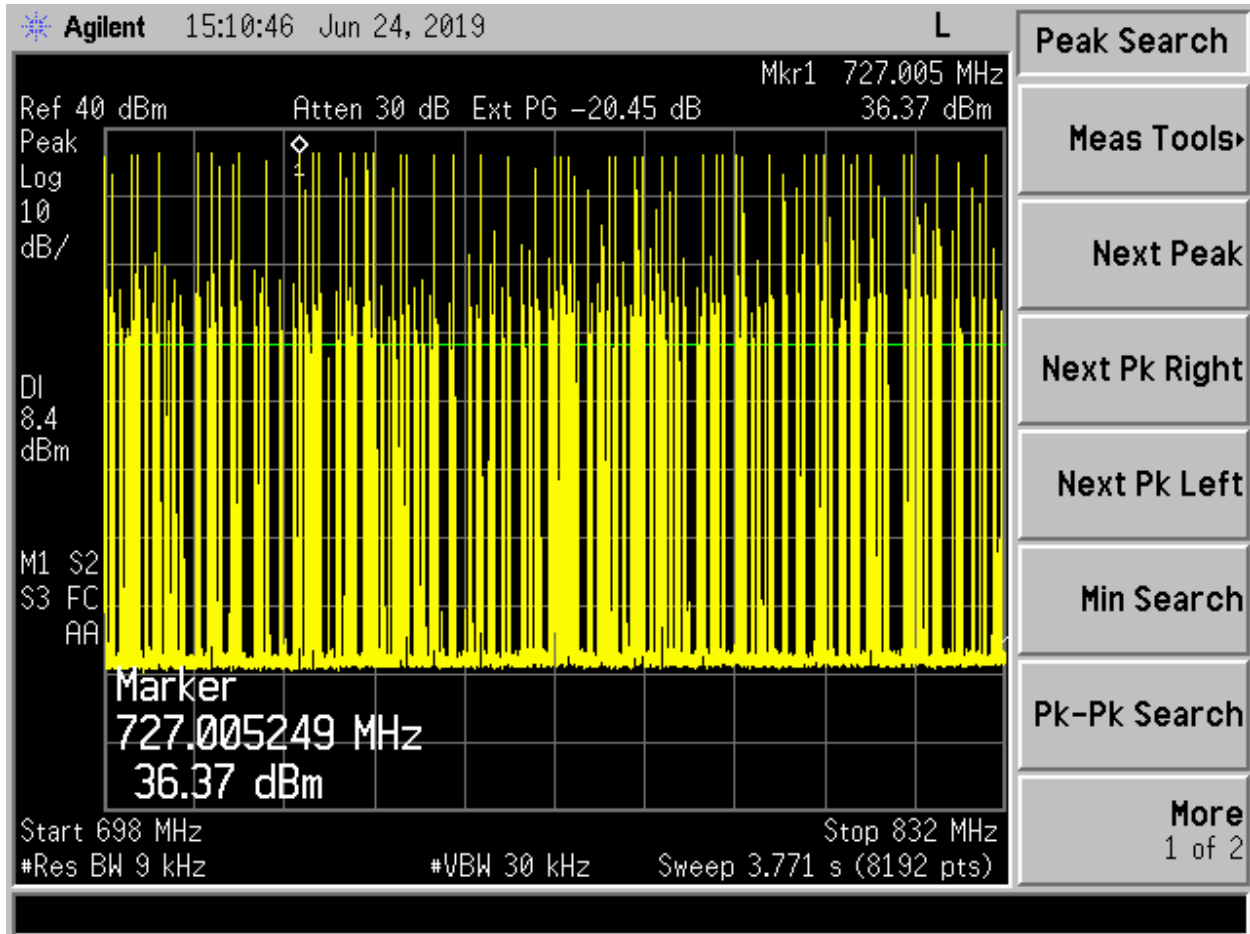


Figure 286. 700/800 MHz Out of Band Rejection Plot 3

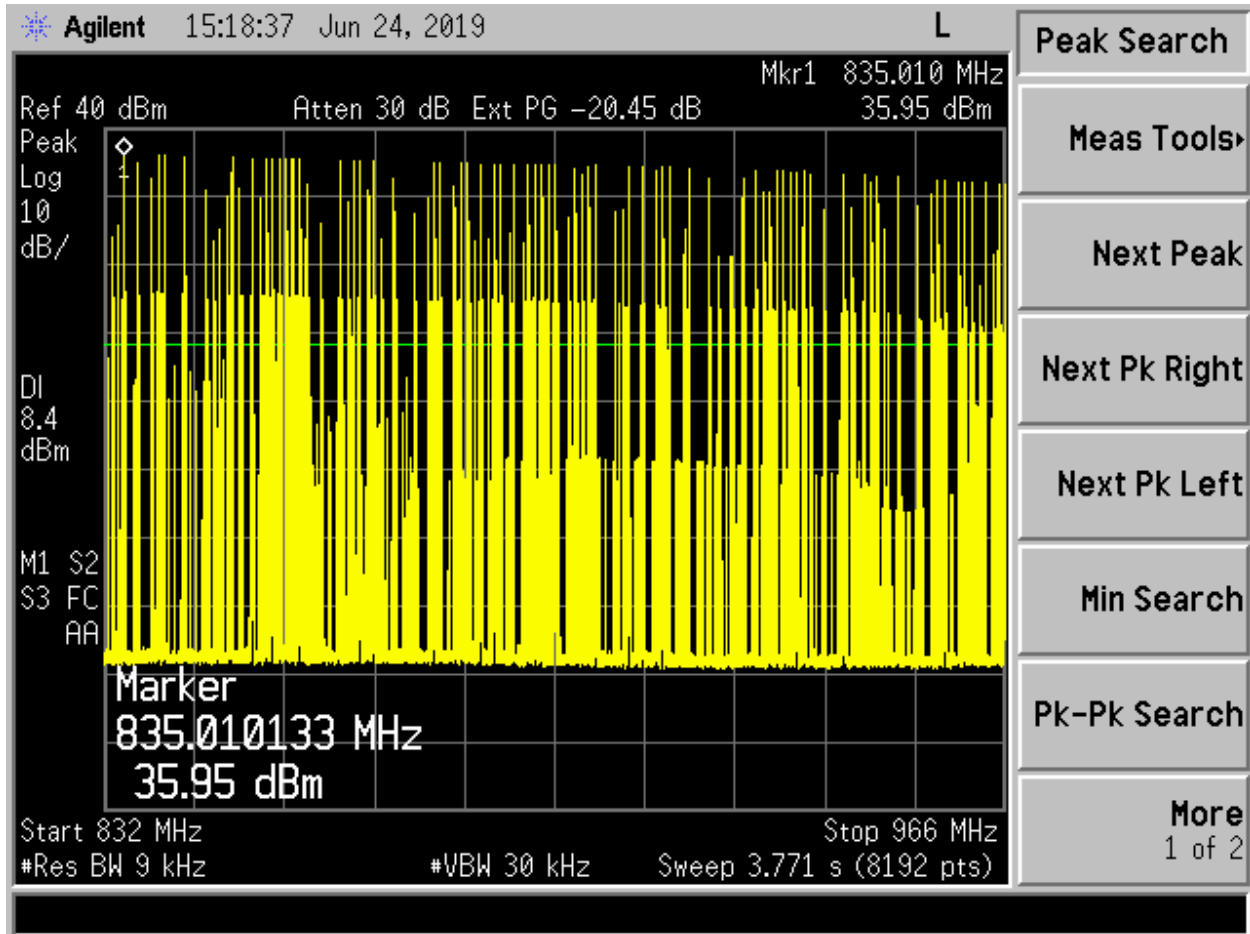


Figure 287. 700/800 MHz Out of Band Rejection Plot 4

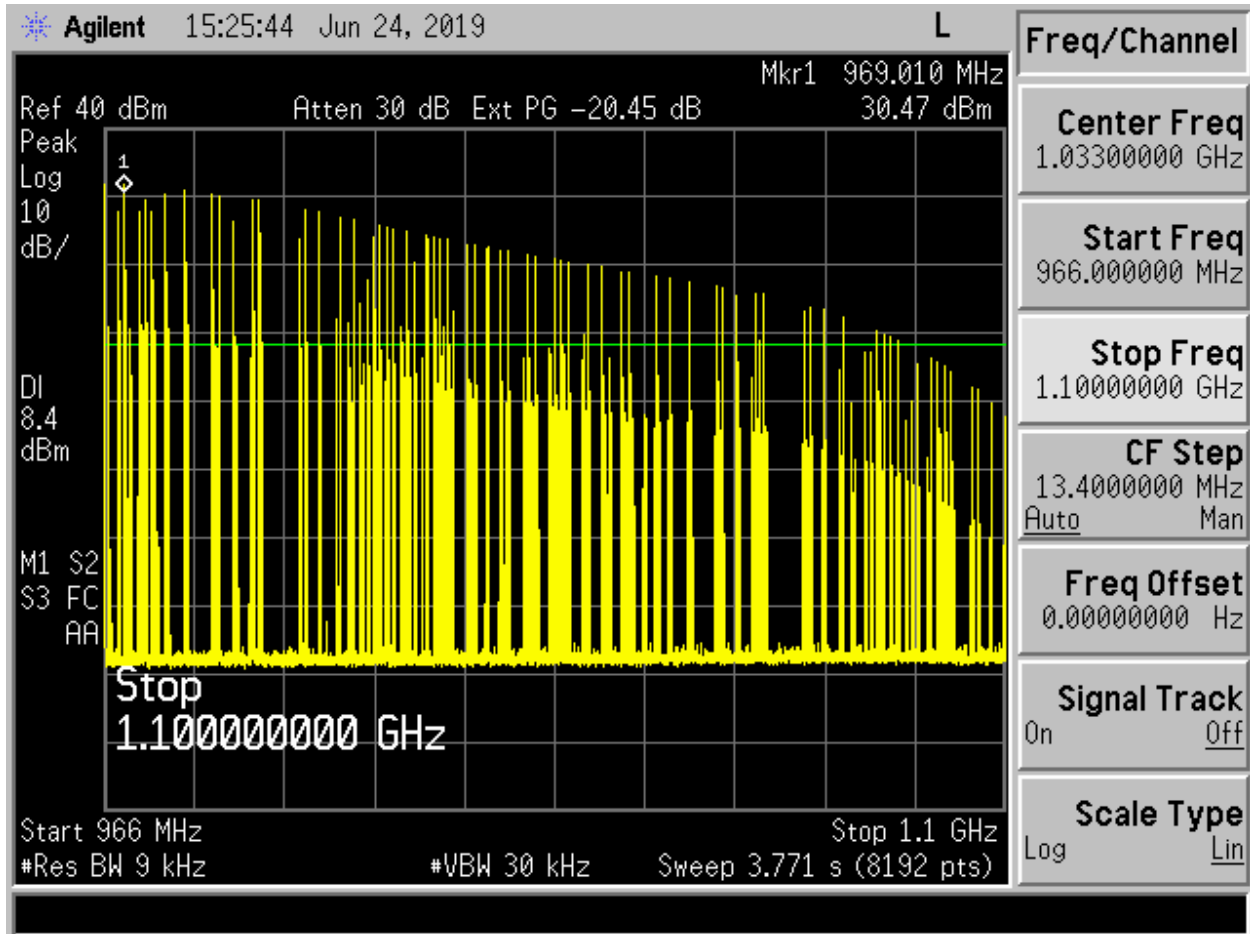


Figure 288. 700/800 MHz Out of Band Rejection Plot 5



## **2.15 Measurement Uncertainty**

### **2.15.1 Radiated Spurious Emissions Measurement Uncertainty**

For a measurement distance of 3 m, the measurement uncertainty (with a 95% confidence level) for this test using a Biconical Antenna (30 MHz to 200 MHz) is  $\pm 5.39$  dB. This value includes all elements of measurement.

The measurement uncertainty (with a 95% confidence level) for this test using a Log Periodic Antenna (200 MHz to 1000 MHz) is  $\pm 5.18$  dB

The measurement uncertainty (with a 95% confidence level) for this test using a Horn Antenna is  $\pm 5.21$  dB (3 m distance).

### **2.15.2 Conducted Radio Emissions Measurement uncertainty**

Measurement uncertainty (within a 95% confidence level) for this test is  $\pm 1.5$  dB.
