#### 4.3 DESCRIPTION OF TEST MODES

The EUT has been tested under its typical operating condition.

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Those data rates (Bluetooth v4.0 with BLE mode :1Mbps) were used for all test.

Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

#### 7 SETUP OF EQUIPMENT UNDER TEST

#### 7.1 RADIO FREQUENCY TEST SETUP 1

The Bluetooth 4.0 DTS component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



#### 7.2 RADIO FREQUENCY TEST SETUP 2

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m.The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 22.

#### Below 30MHz

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.


#### 30MHz-1GHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

#### Above 1GHz:


The EUT is placed on a turntable 1.5 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

#### (a) Radiated Emission Test Set-Up, Frequency Below 30MHz






(b) Radiated Emission Test Set-Up, Frequency Below 1000MHz



(c) Radiated Emission Test Set-Up, Frequency above 1000MHz




#### 7.3 CONDUCTED EMISSION TEST SETUP

The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.

Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.1 m.

According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

#### 8.1 DTS 6DB BANDWIDTH

#### 8.1.1 Applicable Standard

According to FCC Part 15.247(a)(2) and KDB 558074 DTS 01 Meas. Guidance v04

#### 8.1.2 Conformance Limit

The minimum -6 dB bandwidth shall be at least 500 kHz.

#### 8.1.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 8.1.4 Test Procedure

The EUT was operating in Bluetooth 4.0DTS mode and controlled its channel. Printed out the test result from the spectrum by hard copy function.

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously

Set RBW = 100 kHz.

Set the video bandwidth (VBW) =300 kHz.

Set Span=2 times OBW

Set Detector = Peak.

Set Trace mode = max hold.

Set Sweep = auto couple.

Allow the trace to stabilize.

Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

Measure and record the results in the test report.

#### 8.2 MAXIMUM PEAK CONDUCTED OUTPUT POWER

#### 8.2.1 Applicable Standard

According to FCC Part 15.247(b)(3) and KDB 558074 DTS 01 Meas. Guidance v04

#### 8.2.2 Conformance Limit

The maximum peak conducted output power of the intentional radiator for systems using digital modulation in the 2400 - 2483.5 MHz bands shall not exceed: 1 Watt (30dBm).

#### 8.2.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 8.2.4 Test Procedure

#### ■ According to FCC Part15.247(b)(3)

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall utilize a fast-responding diode detector.

The RF output of EUT was connected to the power meter by RF cable and attnuator. The path loss was compensated to the results for each measurement.

Set to the maximum output power setting and enable the EUT transmit continuously.

Measure the conducted output power with cable loss and record the results in the test report. Measure and record the results in the report.

Conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Note: If antenna Gain exceeds 6 dBi, then Output power Limit=30-(Gain - 6) exceeds 6 dBi.

#### 8.3.1 Applicable Standard

#### 8.3.2 Conformance Limit

The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

#### 8.3.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 8.3.4 Test Procedure

This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance

The transmitter output (antenna port) was connected to the spectrum analyzer

Set analyzer center frequency to DTS channel center frequency.

Set the span to 1.5 times the DTS bandwidth.

Set the RBW to: 3 kHz Set the VBW to: 10 kHz. Set Detector = peak.

Set Sweep time = auto couple.

Set Trace mode = max hold.

Allow trace to fully stabilize.

Use the peak marker function to determine the maximum amplitude level within the RBW.




## Power Spectral Density Bluetooth v4.0 with BLE mode Channel 0: 2402MHz

#### 8.4 UNWANTED EMISSIONS IN NON-RESTRICTED FREQUENCY BANDS

#### 8.4.1 Applicable Standard

According to FCC Part 15.247(d) and KDB 558074 DTS 01 Meas. Guidance v04

#### 8.4.2 Conformance Limit

According to FCC Part 15.247(d):

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

#### 8.4.3 Test Configuration

Test according to clause 7.1 radio frequency test setup 1

#### 8.4.4 Test Procedure

The transmitter output (antenna port) was connected to the spectrum analyzer

#### ■ Reference level measurement

Establish a reference level by using the following procedure:

Set instrument center frequency to DTS channel center frequency.

Set the span to = 1.5 times the DTS bandwidth.

Set the RBW = 100 kHz.

Set the VBW  $\geq$  3 x RBW.

Set Detector = peak.

Set Sweep time = auto couple.

Set Trace mode = max hold.

Allow trace to fully stabilize.

Use the peak marker function to determine the maximum PSD level.

Note that the channel found to contain the maximum PSD level can be used to establish the reference level.

#### ■ Emission level measurement

Set the center frequency and span to encompass frequency range to be measured.

Set the RBW = 100 kHz.

Set the VBW =300 kHz.

Set Detector = peak

Sweep time = auto couple.

Trace mode = max hold.

Allow trace to fully stabilize.

Use the peak marker function to determine the maximum amplitude level.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) are attenuated by at least the minimum requirements. Report the three highest emissions relative to the limit.






Spurious Emission in Restricted Band 2483.5-2500MHz

#### 8.7 ANTENNA APPLICATION

#### 8.7.1 Antenna Requirement

Standard Requirement

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is
