4 TEST RESULTS

4.1 OCCUPIED BANDWIDTH (6 DB)

Standard FCC Part 15 Subpart C

The test was performed according to: ANSI C63.10

4.1.1 TEST DESCRIPTION

The Equipment Under Test (EUT) was set up to perform the occupied bandwidth measurements.

The reference level is the level of the highest amplitude signal observed from the transmitter at either the fundamental frequency or first-order modulation products in all typical modes of operation, including the unmodulated carrier, even if atypical.

The results recorded were measured with the modulation which produce the worst-case (smallest) emission bandwidth.

The EUT was connected to spectrum analyzer via a short coax cable with a known loss.

- Video Bandwidth (VBW): 300 kHz
- Span: 3 MHz
- Trace: Maxhold
- Sweeps: 2000
- Sweeptime: 5 ms



4.5 TRANSMITTER SPURIOUS RADIATED EMISSIONS

4.5.1 TEST DESCRIPTION

The test set-up was made in accordance to the general provisions of ANSI C63.10 in a typical installation configuration. The Equipment Under Test (EUT) was set up on a non-conductive table $1.0 \times 2.0 \text{ m}^2$ in the semi-anechoic chamber. The influence of the EUT support table that is used between 30-1000 MHz was evaluated.

The measurement procedure is implemented into the EMI test software EMC32 from R&S. During this action, the value of emission is continuously measured. The turntable azimuth at the highest emission will be recorded and adjusted. In this position, the antenna height will also slowly vary by \pm 100 cm around the antenna height determined. During this action, the value of emission is also continuously measured. The antenna height of the highest emission will also be recorded and adjusted.

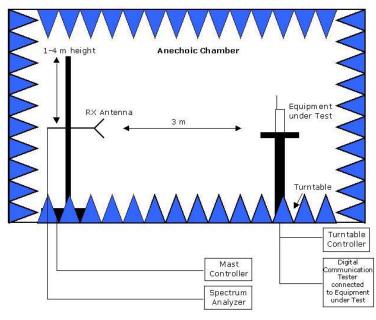


