

Assembling the Ambi Climate



To start up your Ambi Climate, plug in the micro USB plug into the back of the Ambi Climate and attach the USB plug to the power adapter.

Connect the Ambi Climate



Download the Ambi Climate App on the App Store or Google Play Store.

Follow the instructions in the app to connect the Ambi Climate to your phone.

Finding the perfect place for your Ambi Climate

Make sure...



It has direct line of sight to the IR receiver for your AC unit and is close to where you normally are in the room



It sits on a non-insulating flat surface (fabriccovered surfaces are not recommended)



It is within range of your WiFi signal (preferably close to your router if possible)



It isn't near something hot or cold (such as next to a heater, in direct sunlight, or right in front of the AC)

How to care for your Ambi Climate

Care tips:

- Do not drop the device
- · Do not disassemble
- Do not modify the product
- · Do not put objects into the product
- · Do not use with 3rd party USB power supplies/cables
- Do not use USB power supply for any other purpose
- · Do not plug in unapproved USB devices
- Do not expose to high (>50°C) or low (<-10°C) temperatures

Operating limits:

- Indoors
- · In direct line of sight of your AC, within 2-4m
- · In an area with adequate ventilation
- Operating temperature range: 0-40°C
- · Not under direct sunlight
- · Not in a high humidity environment (>90%)
- · Not in or near water
- · Not near other transmitting devices
- Do not cover
- · Not near heat-generating devices
- · Keep out of reach of children and pets
- 100-240V AC
- · Use only the accessories provided by the manufacturer
- The USB power supply should be connected to a mains socket-outlet
- The socket-outlet shall be installed near the equipment and shall be easily accessible
- Frequency range: 2.4GHz 2.4835GHz
- WiFi driver firmware: 2011_0825_RT5350_APSoC_ WiFidriver_v2.6.0
- Maximum RF output power: 20dBm

 - (a) You give written notice by email of the defect to Ambi at support@ambiclimate.com together with the email of the original purchase invoice sent by Ambi within seven days of the time when you discover or ought to have discovered the defect; and
 - (b) After receiving the notice, Ambi is given a reasonable opportunity to examine such Product and you (if asked to do so by Ambi) return such Product to Ambi's place of business at 1903, 19/F, Loon Kee Building, 267-275 Des Voeux Road Central, Sheung Wan, Hong Kong for the examination to take place there.
- 1.3 We provide a warranty that on delivery, and for a period of 24 months from delivery (the "Warranty Period"), the Products shall be free from material defects.
