## 1.0 INTRODUCTION

### 1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

## 1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST Engineering Laboratory facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

#### 1.3 Test Facility / Accreditations

Measurements were performed at PCTEST Engineering Lab located in Columbia, MD 21046, U.S.A.

### 2.2 Device Capabilities

## 2.3 Test Configuration

The EUT was tested per the guidance of ANSI C63.26-2015 and KDB 971168 D01 v03r01. See Section 3.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

The EUT was tested with 2 modules being conducted transmitting and 1 module radiated transmitting. Module 1 (SARA) is always radiated transmitting at Band 8 (CAT-M1). Module 2 (MC7455) is always radiated transmitting on Band 8. Module 3 (EM7511) of the test cases is conducted transmitting. Module 1 and 2 are radiated transmitting unless in cases where both Band 8 needs to be transmitting, which one of the Band 8 will be conducted. The combinations of test cases were tested with Band 8 (SARA and/or MC7455) with low, mid, and high bands (EM7511) for compliance.

### 2.4 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and no modifications were made during testing.

#### 2.5 Software and Firmware

The test was conducted with software/firmware version L0.0.00.00.05.08 installed on the EUT.

## 3.0 DESCRIPTION OF TESTS

### 3.1 Evaluation Procedure

This device was evaluated for compliance to the radiated spurious emissions requirements in the various FCC rule parts governing operation of the supported transmitters and in KDB 996369 for module integrations.

### 3.2 Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to an external DC power adapter and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated spurious emissions measurements, field strength method is used per the guidance of ANSI C63.26-2015. Radiated emissions were measured from the EUT and the field strength was calculated to the ERP or EIRP value with their corresponding limits. At least six of the highest data points were measured and reported.

For radiated spurious emissions measurements and calculations, conversion method is used per the formulas in KDB 971168 Section 5.8.4. Field Strength (EIRP) is calculated using the following formulas:

 $E_{[dB\mu V/m]} =$  Measured amplitude level<sub>[dBm]</sub> + 107 + Cable Loss<sub>[dB]</sub> + Antenna Factor<sub>[dB/m]</sub> And EIRP<sub>[dBm]</sub> =  $E_{[dB\mu V/m]}$  + 20logD - 104.8; where D is the measurement distance in meters.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 414788 D01.

Radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI C63.26-2015.

## Spurious Radiated Emission – LTE Band

#### Example: Middle Channel LTE Mode 2<sup>nd</sup> Harmonic (1564 MHz)

The average spectrum analyzer reading at 3 meters with the EUT on the turntable was -81.0 dBm. The gain of the substituted antenna is 8.1 dBi. The signal generator connected to the substituted antenna terminals is adjusted to produce a reading of -81.0 dBm on the spectrum analzyer. The loss of the cable between the signal generator and the terminals of the substituted antenna is 2.0 dB at 1564 MHz. So 6.1 dB is added to the signal generator reading of -30.9 dBm yielding -24.80 dBm. The fundamental EIRP was 25.501 dBm so this harmonic was 25.501 dBm – (-24.80).

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots shown in Section 7.0 were taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.
- All conducted emissions measurements are performed with automated test software to capture the corresponding plots necessary to show compliance. The measurement software utilized is LTE Automation Version 5.3

## 7.2 Transmitter Conducted Output Power/ Effective Radiated Power

#### **Test Overview**

The transmitter conducted output power is a measure of the total average power contained within 1.4MHz and 3MHz channels as defined in §27.1506. All modes of operation were investigated and the worst-case configuration results are reported in this section.

#### Test Procedure Used

ANSI C63.26-2015 - Section 5.2.4.2

#### **Test Settings**

All conducted powers were measured using the R&S CMW500's Channel Measurement function.

## 7.3 Radiated Spurious Emissions Measurements

#### **Test Overview**

Radiated spurious emissions measurements are performed using the direct field strength conversion method described in ANSI C63.26-2015 with the EUT connected to their corresponding antenna ports. Module 1 or module 2 were connected with shark fin antennas for radiated transmission on Band 8 (LTE or CAT-M1). For conducted transmissions modules were connected with SMA cables Modules 1 and 2 are radiated transmitting unless in cases where both Band 8 needs to be transmitting, which one of the Band 8 will be conducted. The combinations of test cases were tested with Band 8 (module 1 and/or module 2) with low, mid, and high bands (module 3) for compliance. Measurements on signals operating below 1GHz are performed using horizontally and vertically polarized tuned dipole antennas. Measurements on signals operating above 1GHz are performed using vertically and horizontally polarized broadband horn antennas. All measurements are performed as peak measurements while the EUT is operating at maximum power, and at the appropriate frequencies.




Figure 7-2. Test Instrument & Measurement Setup

- 4) The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter. The worst-case emissions are reported.
- 5) Emissions below 18GHz were measured at a 3 meter test distance while emissions above 18GHz were measured at a 1 meter test distance with the application of a distance correction factor.

Plot 7-6. Radiated Spurious Plot (LTE Band 8 / LTE Band 8 / LTE B7)



Plot 7-16. Radiated Spurious Plot (LTE Band 8 / LTE Band 4 / LTE Band 41)



Plot 7-22. Radiated Spurious Plot (LTE Band 12 / LTE Band 8 / LTE Band 12)





#### Plot 7-26. Radiated Spurious Plot (LTE Band 4 / LTE Band 8 / LTE Band 12)


