# Network Dome Cameras Quick Guide

### **Waterproof Requirements**


Please waterproof cables in accordance with the following instructions. User shall assume all responsibility for device damage caused by water due to improper waterproof measures.




- Before you start, connect all the needed cables and cut off the copper wires for the cables that you don't use.
- $\bullet \ \ \mathsf{Please} \ \mathsf{use} \ \mathsf{self-adhesive} \ \mathsf{waterproof} \ \mathsf{tape} \ (\mathsf{supplied} \ \mathsf{with} \ \mathsf{some} \ \mathsf{products}) \ \mathsf{to} \ \mathsf{protect} \ \mathsf{the} \ \mathsf{cables}.$
- Use waterproof components to protect the network cable. Waterproof the power cable separately if you don't use it. The video cable does not need waterproof treatment.
- 1. Use insulation tape (not included in the package) to insulate the connection part of each cable.



- 2. Waterproof the cables with self-adhesive waterproof tape.
  - (1) Fully stretch the waterproof tape at both ends.
  - (2) Wrap the connection part and the cable ends tightly with waterproof tape. Make sure the tape is fully stretched during the process.
- (3) Tighten the tape at both ends to prevent water leakage.



3. Install the supplied waterproof components to the network cable in sequence.





### ( CAUTION!

You need to mount the rubber ring onto the network cable interface first.

 ${\it 4.} \ \, ({\it Optional}) \ \, {\it After the waterproof treatment is completed, put the cables into a waterproof junction box (purchased separately).}$ 

### ( CAUTION!

- $\bullet\,$  The cable connector must not be exposed and must be kept away from water.
- $\bullet\,$  Restore and fasten the device after dismounting.
- Place the power adapter in a power distribution box





### 3 Mount Your Camera

#### 3.1 (Optional) Insert Micro SD Card

You need to install a Micro SD card to use the edge storage function.

4. Replace the card cover and tighten the screws.


Please ensure the sealing ring is in position when replacing the card cover.

#### 3.2 Wall Mount

Take wall mount as an example. Before installation, make sure the wall is strong enough to hold the camera.  $\qquad \qquad -$ 




Hammer the expansion bolts into the holes and ensure that they are tightened up.





- (1) Lead the cables out from the bottom of the bracket.
- (2) Fix the bracket onto the wall using four ST3.5 self-tapping screws.



#### 4. Mount the camera onto the bracket.

- (1) Adjust antenna direction.
- (2) Align the gear of the camera with the bracket gear, and keep the camera upright.
- (3) Tighten the M4 screw.



#### Note:


Hold the camera body while installing or removing the camera module to avoid dropping it.

5. Connect all cables and take necessary waterproof measures.



# 4 Startup

After installation, connect one end of the power adapter to the mains power supply, and then connect the other end to the power interface to start up the device.



# 5 (Optional)Add Camera to App



- The camera can be added only on **2.4G Hz Wi-Fi** network.
- $\bullet\,$  It is recommended to sign up for an account before adding the camera.




Sign up for an account and log in. If you already have an account, log in directly.
