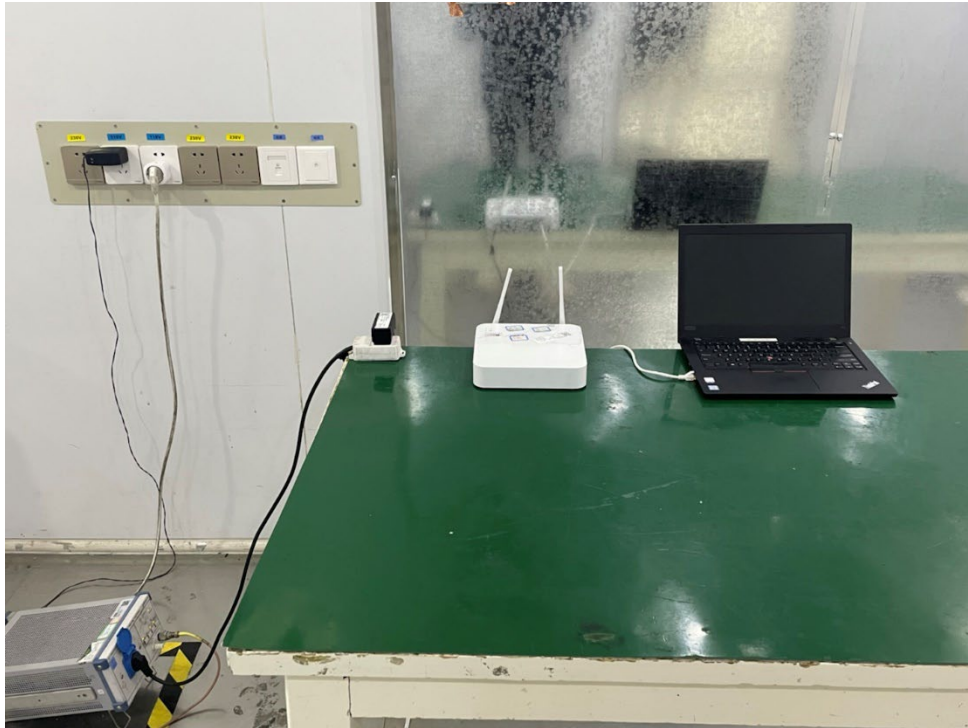

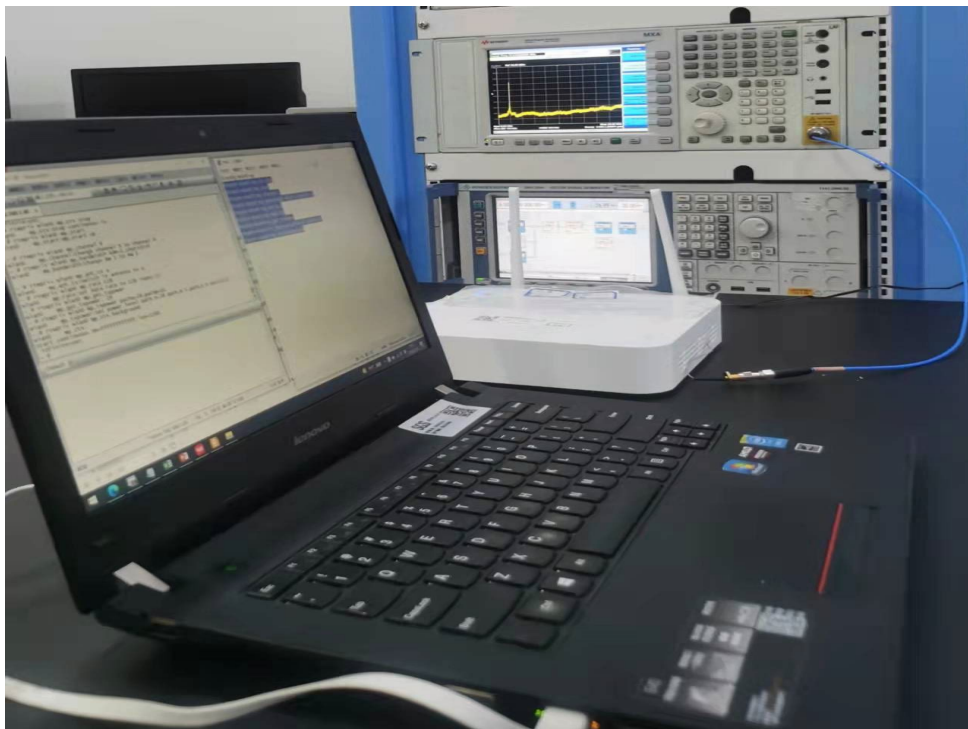

2 RF Conducted Test Setup



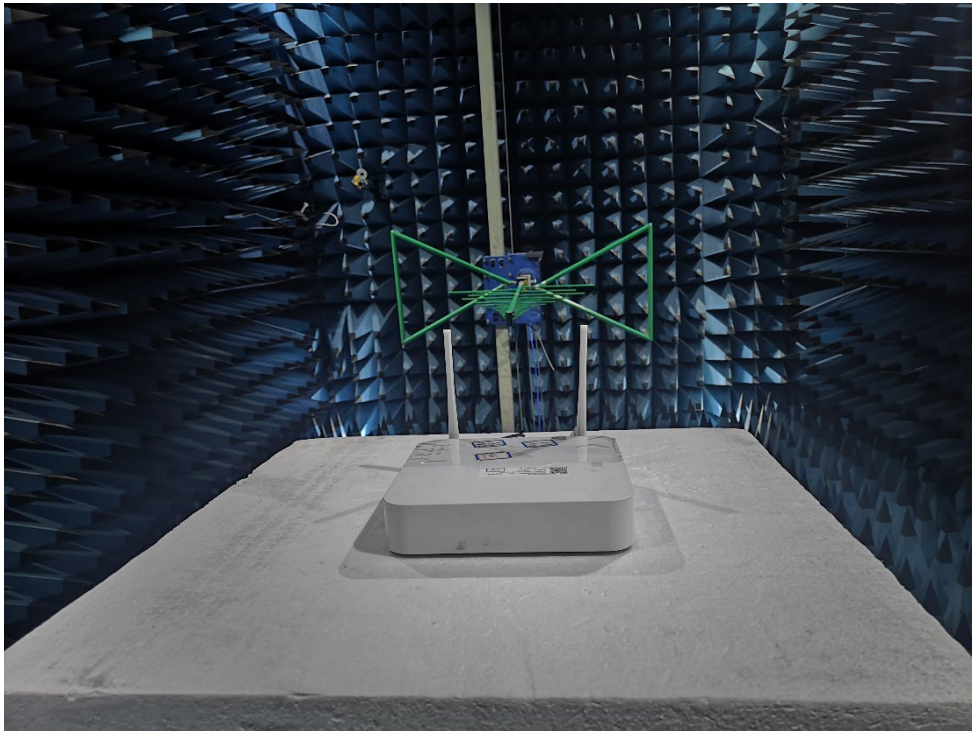

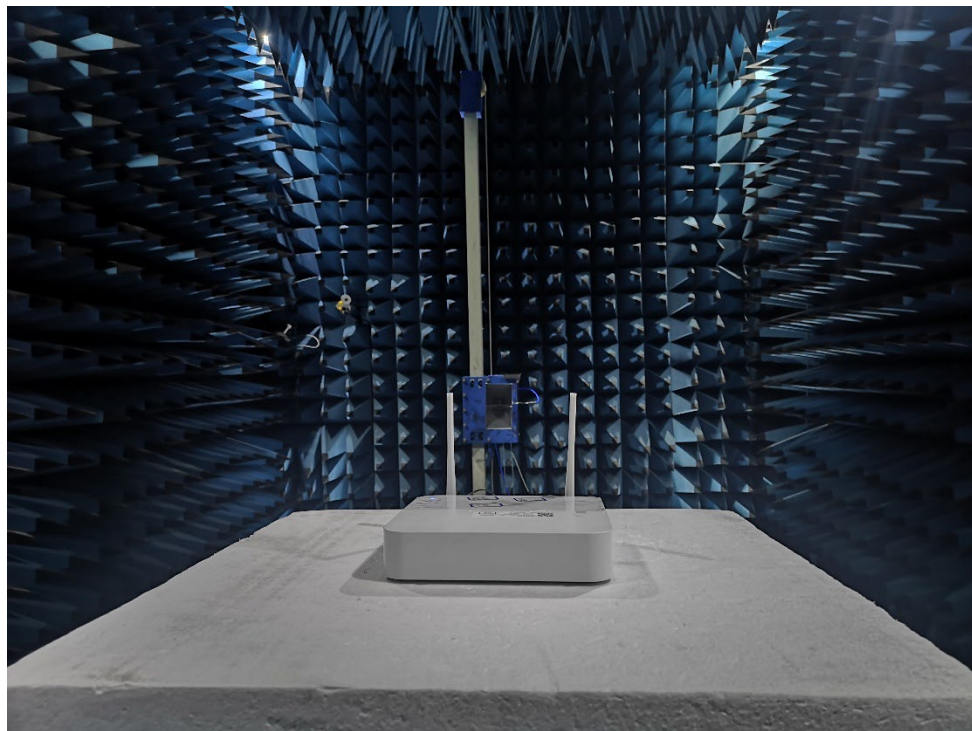

3 Radiated Spurious Emissions From 30MHz to 1GHz



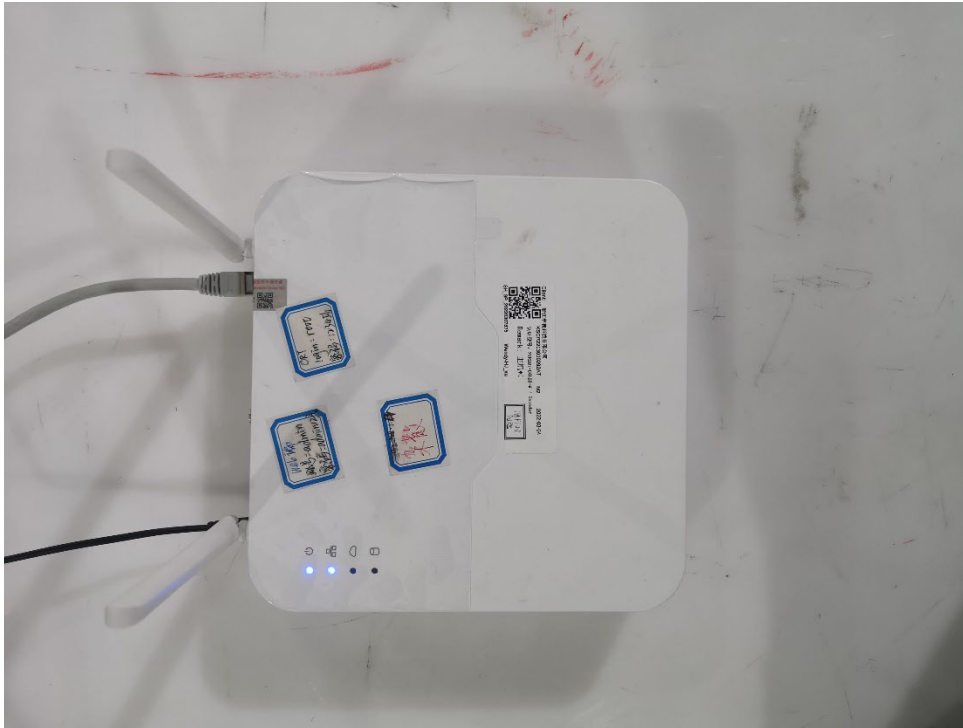
4 Radiated Spurious Emissions Above 1GHz
