
# Banner Bluetooth Speaker

#### What's included:

- 1 x Banner Bluetooth Speaker
- 1 x USB to Micro-USB charging cable
- 1 x 3.5mm Audio cable
- 1 x Instruction Manual

## **Tech Specifications**

- It takes around 2 hours to charge the speaker from 0 to 100%
- LED flash in red while being charged
- LED will turn off when charging complete

#### Instructions:

- 1. Charging the speaker:
- a. Using a regulated USB adapter. Connect a USB cable to a USB adapter. Using the Micro-USB connector, connect the other end of the USB cable to the "DC 5V" port on the speaker. Plug the USB adapter into the outlet to begin charging.
- b. Using your computer. Connect a USB cable to a USB outlet on your computer. Using the Micro-USB connector, connect the other end of the USB cable to an "DC SV" port on the speaker. Make sure the computer is on to begin charging the speaker.
- 2. Connecting the speaker with Bluetooth:
- a. Switch the speaker "ON" using the ON/ OFF switch. Press the Mode button until the speaker announces "Bluetooth Mode". Using a Bluetooth enabled device, search for "Banner" from the list of available pairs. Once selected, the connection should announce it is successful with a chime sound.
- 3. Using the speaker:
- a. When receiving a phone call, the speaker will pause the current audio. Press the Play/ Answer button to answer the call, press this button again to end the call.
- b. Short press rise : play/pause the audio
- c. Short Press V+DE : next track
- d. Long press V+DD : volume increase
- e. Short Press V-Iter : previous track
- f. Long press V-IIII : volume decrease

 Note: In order to charge device use only accessory cable (provided with device) or the cable included with your own device by the manufacturer.
