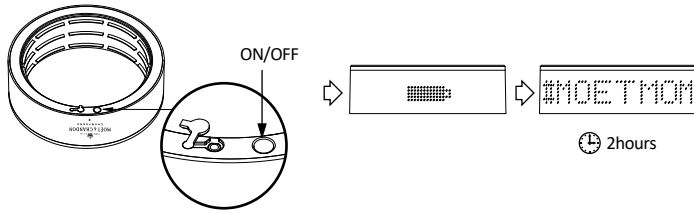
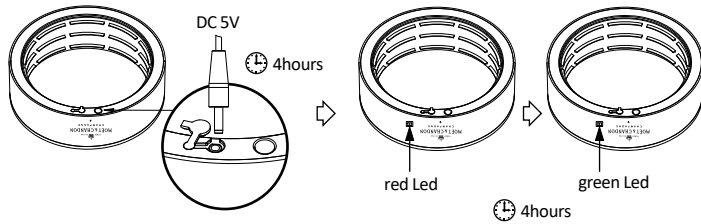

2. Scan the Apple or Android QR code or select the app « Moët Lightup » on the App. Store or Google Play

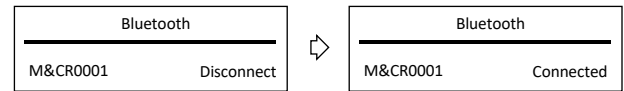


3. Open the app and follow the instructions
